A MACHINE LEARNING APPROACH TO ACADEMIC PERFORMANCE PREDICTION: A COMPARATIVE STUDY OF XGBOOST AND RANDOM FOREST

ABSTRACT

Accurately predicting student academic performance is a critical objective in educational data mining and learning analytics, as it enables data-driven interventions aimed at improving educational outcomes. This study investigates and compares the predictive performance of two widely used machine learning algorithms: Random Forest (RF) and Extreme Gradient Boosting (XGBoost) using real-world student data. A dataset comprising 400 student records collected from six departments at the Federal Polytechnic Ukana was preprocessed through principal component analysis (PCA) and feature normalization to enhance model accuracy. Sixteen key features were selected based on their eigenvalues and explained variance. The dataset was partitioned into training (80%) and testing (20%) subsets. Model performance was assessed using standard evaluation metrics, including Mean Squared Error (MSE), Mean Absolute Error (MAE), R-squared (R^2), Explained Variance Score (EVS), and Median Absolute Error (MedAE). Experimental results indicate that both RF and XGBoost exhibit strong predictive capabilities, with RF demonstrating a slight advantage across several metrics. These findings underscore the potential of machine learning approaches in educational performance prediction and provide actionable insights for model selection in academic analytics frameworks.

1.0 Introduction

Predicting student academic performance is a critical task in educational data mining and learning analytics. Accurate predictions can provide valuable insights for educators, administrators, and policymakers to design targeted interventions and improve overall educational outcomes. With the increasing availability of educational datasets, machine learning techniques have emerged as powerful tools for modeling and predicting academic performance (Kotsiantis et al., 2004).

Two popular machine learning algorithms frequently used in predictive analytics are Extreme Gradient Boosting (XGBoost) and Random Forest (RF). XGBoost, an efficient and scalable implementation of gradient-boosted decision trees, has gained prominence due to its robust performance in competitions such as Kaggle (Chen and Guestrin, 2016). On the other hand, Random Forest, an ensemble learning technique that combines multiple decision trees, has long been a preferred choice for its simplicity and effectiveness in handling high-dimensional data (Breiman, 2001).

The application of these algorithms in educational settings has been explored in various studies. For instance, Sébastien et al. (2018) demonstrated the potential of XGBoost in predicting student success in massive open online courses (MOOCs), highlighting its superior performance compared to other algorithms. Similarly, a study by Saini and Goel (2020) used Random Forest to identify key factors influencing students' academic performance, showcasing its ability to provide interpretable results.

Despite the individual strengths of XGBoost and Random Forest, limited research has directly compared their performance in the context of predicting students' academic outcomes (Inyang and Johnson, 2025a and 2025b). This study aims to bridge this gap by evaluating and comparing the performance of XGBoost and Random Forest using a real-world educational dataset. The comparison will be based on critical evaluation metrics such as Mean Squared Error (MSE), Mean Absolute Error (MAE), R-Squared Score (R^2), Explained Variance Score (EVS) and Median Absolute Error (MedAE), offering insights into their applicability and effectiveness in the educational domain.

The findings from this study will contribute to the growing body of literature on educational data mining by providing evidence-based recommendations for selecting appropriate machine learning models in academic performance prediction tasks. Moreover, it will empower stakeholders to make data-driven decisions aimed at enhancing the learning experiences and outcomes of students.

The remainder of the document is structured as follows: Section 2 presents reviewed related literature while the methodology is presented in section 3. The results and discussion of the system are in section 4 in detail and section 5 presents the conclusion of the study.

2.0 Review of Related Literature

The review of recent works explores existing research and findings related to the prediction of students' academic performance. The prediction of student academic performance has garnered significant attention in educational research, driven by the need to enhance learning outcomes and identify at-risk students early. This literature review explores the current state of research on predictive modeling in education, with a focus on the application of XGBoost and RF algorithms.

Early studies in academic performance prediction primarily employed traditional statistical methods, such as linear regression and decision trees, to analyze factors influencing student success. XGBoost emerged as a powerful tool due to its simplicity and effectiveness in handling binary classification tasks, such as pass/fail outcomes. Researchers have utilized XGBoost to identify critical predictors, including attendance, prior academic records, socio-economic status, and engagement levels, demonstrating its utility in educational settings (Johnson et al., 2021).

As data availability and computational power have increased, more sophisticated machine learning techniques have been adopted. The RF algorithm, introduced by Breiman (2001), has become particularly popular for its high accuracy and ability to manage large, complex datasets. Studies employing random forest have reported superior performance in predicting

academic outcomes compared to traditional methods, highlighting its robustness against overfitting and its capability to capture nonlinear relationships among variables.

Recent literature has seen a comparative analysis of various predictive models to determine the most effective approaches for specific educational contexts. These studies often emphasize the trade-offs between interpretability and predictive power. While XGBoost offers clear insights into the influence of individual predictors, RF provides a more nuanced understanding through its ensemble approach, albeit with less interpretability.

Furthermore, contemporary research has explored the integration of these models with other advanced techniques, such as neural networks and ensemble methods, to enhance prediction accuracy. The incorporation of feature selection methods and the use of balanced datasets are also discussed extensively, addressing common challenges like multicollinearity and class imbalance.

Rodríguez-Hernández et al. (2021) used artificial neural networks in academic performance prediction. The first objective of this study is to test a systematic procedure for implementing artificial neural networks to predict academic performance in higher education. The second objective is to analyze the importance of several well-known predictors of academic performance in higher education. The sample included 162,030 students of both genders from private and public universities in Colombia. The findings suggest that it is possible to systematically implement artificial neural networks to classify students' academic performance as either high (accuracy of 82%) or low (accuracy of 71%). Artificial neural networks outperform other machine-learning algorithms in evaluation metrics such as the recall and the F1 score. Furthermore, it is found that prior academic achievement, socioeconomic conditions, and high school characteristics are important predictors of students' academic performance in higher education. Finally, this study discusses recommendations for implementing artificial neural networks and several considerations for the analysis of academic performance in higher education.

Johnson et al., (2024) built an intelligent analytic framework for predicting students academic performance using multiple linear regression and random forest. After thorough data preparation and standardization, 664 datasets from eight departments at Federal Polytechnic Ukana were used in the study. Metrics including Mean Squared Error (MSE), Mean Absolute Error (MAE), R-squared Score (R^2), and Explained Variance Score (EVS) were used to assess the performance of both models. The findings showed that RF performed noticeably better than MLR, with higher predicted accuracy and reduced error rates. Bar charts and scatter plots provided more evidence of RF's strong performance over MLR. This study highlights how incorporating cutting-edge machine learning methods into classroom environments can yield better understandings of student performance and allow for more focused and timely interventions. The results support the use of RF in order to improve educational outcomes and provide more accurate forecasts.

A model for predicting student performance based on supervised machine learning techniques was created by Hashim et al. in 2020. A number of supervised machine learning algorithms, including Decision Tree, Naïve Bayes, Logistic Regression, Support Vector Machine, K-Nearest Neighbor, Sequential Minimal Optimization, and Neural Network, were compared in this study. In order to predict student performance on final exams, the researchers trained a model using datasets from courses in the bachelor study programs at the College of Computer Science and Information Technology, University of Basra, for the academic years 2017–2018 and 2018–2019. The best classifier for precisely predicting students' final grades, according to the results, is the logistic regression classifier (68.7% for passed and 88.8% for failed).

Johnson et al. (2023) did a comparison of two machine learning techniques for the prediction of initial oil in place in the Niger Delta region. Shell Petroleum Development Company (SPDC)

provided 816 datasets for this study, which were predicted using the volumetric approach. These data sets were preprocessed and applied to two machine learning methods: support vector regressor and random forest to estimate the initial oil in place. The outcomes were contrasted with those from SPDC. Compared to calculations using all nine features, the findings of calculations utilizing four of the nine major features were more similar to those from SPDC. Additionally, support vector regressor and random forest computation outcomes were evaluated. The random forest findings show a stronger correlation (0.970) with the field results than the support vector regressor (0.832). This study is unique in that it uses four predicting features (independent variables) to provide prediction values that are extremely similar to those found in the field using nine features. Random forest was used to get this, making it a dependable machine technique for predicting the amount of oil that will initially be present in the Niger Delta.

Hashim et al. (2020) predicted students' academic performance using ensemble approaches. We collected educational data from a learning management system (LMS) in order to illustrate the significance of student behavioral aspects in this article. The included dataset was subjected to feature analysis, followed by data preprocessing—a crucial phase in the knowledge-discovery process. The preprocessed dataset is classified using classifiers including Naive Bayes (NB), Decision Tree (ID3), Support Vector Machines (SVM), and K-Nearest Neighbor (KNN) in order to predict student academic achievement. The suggested model's accuracy is increased through the application of ensemble methods. We employed typical ensemble techniques including bagging, boosting, and voting algorithms. By employing group methods, we were able to improve the outcome and show the dependability of the suggested model.

Nabil et al. (2021) predicted students' academic performance based on courses' grades using deep neural networks. The main goal of this paper is to explore the efficiency of deep learning in the field of EDM, especially in predicting students' academic performance, to identify students at risk of failure. A dataset collected from a public 4-year university was used in this study to develop predictive models to predict students' academic performance of upcoming courses given their grades in the previous courses of the first academic year using a deep neural network (DNN), decision tree, random forest, gradient boosting, logistic regression, support vector classifier, and K-nearest neighbor. In addition, we made a comparison between various resampling methods to solve the imbalanced dataset problem, such as SMOTE, ADASYN, ROS, and SMOTE-ENN. From the experimental results, it is observed that the proposed DNN model can predict students' performance in a data structure course and can also identify students at risk of failure at an early stage of a semester with an accuracy of 89%, which is higher than models like decision tree, logistic regression, support vector classifier, and K-nearest neighbor.

Using artificial neural networks, Lau et al. (2019) predicted and categorized the academic performance of their students. Eleven input variables, two levels of hidden neurons, and one output layer make up the neural network model. The backpropagation training rule is implemented using the Levenberg-Marquardt algorithm. The area under the receiver operating characteristics curve, error performance, regression, error histogram, confusion matrix, and error histogram are used to assess the effectiveness of the neural network model. Despite certain drawbacks, the neural network model has an overall strong prediction accuracy of 84.8%.

In order to predict students' academic performance, Albreiki (2021) conducted a mining of student information system records. The primary goal of this research is to determine which characteristics that influence students' performance are most frequently researched and which data mining approaches are most frequently used to find these factors. As a result, a dataset from a nearby university in the United Arab Emirates' student information system was created

for this dissertation. The dataset, which had a record count of over 56,000, had 34 attributes relating to student information. According to empirical findings, four categories of student characteristics such as demographics, past performance history, course and teacher information, and some general student information—are in charge of predicting academic success. Furthermore, the findings also showed that artificial neural networks, decision trees, and Naïve Bayes are the most often utilized data mining methods for categorizing and predicting student variables. The best data-mining model for forecasting students' academic success from student information systems was ultimately determined by comparing a set of models.

Tomasevic, et al (2020) aimed of at providing a comprehensive analysis and comparison of state of the art supervised machine learning techniques applied for solving the task of student exam performance prediction, i.e. discovering students at a “high risk” of dropping out from the course, and predicting their future achievements, such as for instance, the final exam scores. For both classification and regression tasks, the overall highest precision was obtained with artificial neural networks by feeding the student engagement data and past performance data, while the usage of demographic data did not show significant influence on the precision of predictions. To exploit the full potential of the student exam performance prediction, it was concluded that adequate data acquisition functionalities and the student interaction with the learning environment is a prerequisite to ensure sufficient amount of data for analysis.

In summary, the literature reflects a dynamic and evolving field, with ongoing efforts to refine predictive models and adapt them to diverse educational environments. This review aims to synthesize these advancements, providing a comprehensive understanding of the current methodologies and identifying gaps for future research. Through this synthesis, we seek to establish a foundation for our comparative study of multiple XGBoost and Random Forest in predicting student academic performance.

2.1 Random Forest

Random Forest is a popular machine learning algorithm and an ensemble learning algorithm used for classification and regression tasks due to its high accuracy, robustness, feature importance, versatility, and scalability (Wainberg et al., 2016). A Random Forest is a tree-based ensemble with each tree depending on a collection of random variables. More formally, for a p -dimensional random vector $X = (X_1, \dots, X_p)^T$ representing the real-valued input or predictor variables and a random variable Y representing the real-valued response, we assume an unknown joint distribution $P_{XY}(X, Y)$. The goal is to find a prediction function $f(X)$ for predicting Y . The prediction function is determined by a loss function $L(Y, f(X))$ and defined to minimize the expected value of the loss.

$$E_{XY}(L(Y, f(X))) \quad \text{Equation 1}$$

where the subscripts denote expectation with respect to the joint distribution of X and Y .

Intuitively, $L(Y, f(X))$ is a measure of how close $f(X)$ is to Y ; it penalizes values of $f(X)$ that are a long way from Y . Typical choices of L are *squared error loss* $L(Y, f(X)) = (Y - f(X))^2$ for regression and *zero-one loss* for classification:

$$L(Y, f(X)) = I(Y \neq f(X)) = \begin{cases} 0 & \text{if } Y = f(X) \\ 1 & \text{otherwise} \end{cases} \quad \text{Equation 2}$$

It turns out that minimizing $E_{XY}(L(Y, f(X)))$ for squared error loss gives the conditional expectation

$$f(x) = E(Y|X=x) \quad \text{Equation 3}$$

Otherwise known as the *regression function*. In the classification situation, if the set of possible values of Y is denoted by \mathcal{Y} , minimizing $E_{X,Y}(L(Y, f(X)))$ for zero-one loss gives:

otherwise known as the *Bayes rule*.

Ensembles construct f in terms of a collection of so-called “base learners” $h_1(x), \dots, h_J(x)$ and these base learners are combined to give the “ensemble predictor” $f(x)$. In regression, the base learners are averaged

2.2 Extreme Gradient Boost

The XGBoost (Extreme Gradient Boosting) algorithm is an optimized and scalable implementation of gradient-boosted decision trees (GBDT), which is designed for speed and performance. It has become one of the most popular machine learning algorithms due to its efficiency, flexibility, and ability to handle a variety of data types and problems.

The Working of XGBoost can be explained using the following steps:

- a. Initialization: Starts with an initial prediction, usually the mean (for regression) or a uniform distribution (for classification).
- b. Gradient Descent Optimization: Each subsequent tree is trained to minimize the residual errors (gradients) of the previous predictions.
- c. Tree Construction: Trees are built iteratively, where splits are determined based on the reduction of the loss function (e.g., Mean Squared Error for regression, Logarithmic Loss for classification).
- d. Weighted Learning: Each tree assigns weights to instances, giving higher importance to incorrectly predicted examples.
- e. Final Prediction: Combines the predictions of all the trees (via weighted sums for regression or probability scores for classification) to make the final output.

XGBoost has the following advantages:

- i. High Performance: Delivers state-of-the-art results in competitions and benchmarks.
- ii. Flexibility: Works with multiple loss functions and is extensible with user-defined objectives.
- iii. Scalability: Handles large datasets and high-dimensional data efficiently.
- iv. Robustness: Built-in features like regularization and early stopping help prevent overfitting.

XGBoost can be applied in Classification problems (e.g., credit risk analysis, fraud detection), Regression problems (e.g., price prediction, sales forecasting), Ranking problems (e.g., search engine result ranking), Time-series forecasting and Feature selection through its feature importance scores.

3.0 Methodology

In consultation with stake holders in Federal Polytechnic Ukana 402 data points consisting of 23 attributes were collected from six (6) out of eight (8) departments of the institution. The data was collected through the administration of questionnaires. The data was cleaned and transformed, so that some outliers were identified and resolved, getting rid of 2 data points

and leaving 400 data points to be used in this study. The attributes of the data are: Age, Gender, Residential status, Father's Educational Level, Mother's Educational Level, Previous Academic Background, Mode of Study, Attendance in Classes, Study Hours Per Day, Preferred Learning Style, Number of Siblings, Family Income Level (Monthly), Parental Support In Studies, Internet Access at Home, Use of Private Tutoring, Sleep Duration Per Night, Participation in Extracurricular Activities, Use Of Social Media (Hour Per Day), Motivation Level For Academic Success, Main Challenges in Studies, Confidence Level in Current Courses, Current CGPA and Performance in Previous Semester.

To enhance the use of the data on machine learning algorithms, non-numeric columns were converted to numeric values as follows:

- i. Range-Based Columns: Age, Use of Social Media (Hour per Day), Study Hours per Day, and Sleep Duration per Night were converted to numeric midpoints of their ranges.
- ii. Ordinal Columns: Attendance in Classes, Confidence Level in Current Courses, and Motivation Level for Academic Success were encoded using ordinal scales based on their relative order.
- iii. Categorical Columns: Categorical columns like Gender, Mode of Study, and Preferred Learning Style were label-encoded into integer values.
- iv. Numeric columns like Current CGPA were preserved without changes.

To transform data to suitable format, Min-Max Scaling (Normalization) method was adopted because it actively eliminates the effect of inconsistent ranges of the datasets and improves convergence (Ahmed et al., 2022). This method scales the features to a specified range, usually [0, 1] using the formula:

$$X_{normalized} = (X - X_{min}) / (X_{max} - X_{min}) \quad \text{Equation 7}$$

Where X is the original feature and $X = \{X_1, X_2, \dots, X_n\}$, X_{min} is the minimum value of the feature in the dataset, and X_{max} is the maximum value of the feature in the dataset.

Extreme Gradient Boosting (XGBoost) and Random Forest (RF) are the tools utilized in this work. In the training phase, a bootstrap method is used to train each Regressor individually using its own duplicated training data set. Two sets of data: the training and testing sets are created from the data. Twenty percent (20%) of the data are for testing, and the remaining eighty percent (80%) are for the training set.

A total of 16 out of 22 input characteristics were chosen by principal component analysis (PCA) based on their Eigen values and explained variance percentages. The features are previous academic results(GPA), preferred learning style, performance in, previous semester, family income level (monthly), number of siblings, age, father's educational level, main challenges in studies, use of social media (hour per day), motivation level for academic success, internet access at home, confidence level in current courses, parental support in studies, study hours per day, sleep duration per night, mother's educational level, attendance in classes, participation in extracurricular activities, use of private tutoring. The decision of using 16 input features was arrived at using literature source. According to Araújo and Santos (2018), features with eigen values of 0.5 and above are stable; hence the decision of using 16 features.

The architectural design of the study is shown in Figure 1

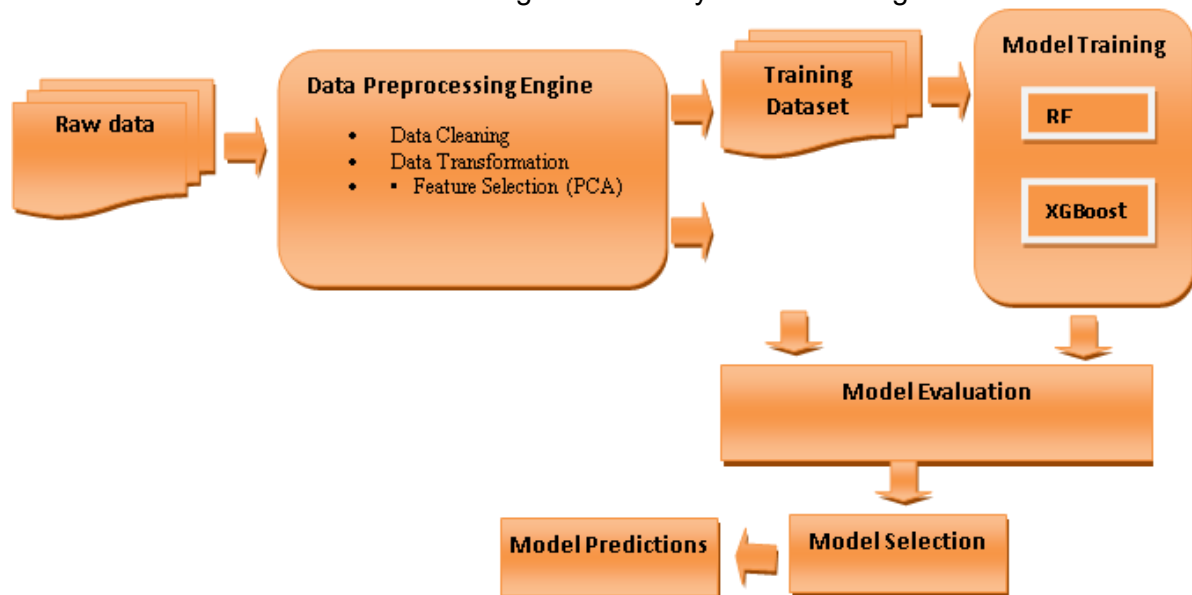


Figure 1.0: System Architecture

Raw data are data obtained from students for the purpose of this research. Sample raw data, sample data converted to numeric format and the normalized data is shown in Table 1, 2 and 3 respectively.

Data Preprocessing Engine cleans and transforms data, then data is divided into training and testing set used in training the RF and XGBoost models. Models are evaluated and selected and the model that performs better is used in prediction.

4.0 Results and Discussion

The implementation procedure for the prediction of student academic performance was performed in python programming environment on anaconda software in the following steps:

- Dataset Extraction
- Features Selection
- Training and Testing
- Results Visualization and Evaluation.

The datasets collected from for the purpose of this research was 402. It was stored in Comma-Separated Values (csv) format. Simplicity, readability, wide compatibility, flexibility, standardization and data exploration and visualization were the reason for the choice of csv (Kaur et al 2020). The data was cleaned and transformed.

The input features are denoted by x, which includes all columns from index 1 to 22, and the target variable denoted by y is the 23th column. The features that formed the independent variables were Age, Gender, Residential status, Father's Educational Level, Mother's Educational Level, Previous Academic Background, Mode of Study, Attendance in Classes, Study Hours Per Day, Preferred Learning Style, Number of Siblings, Family Income Level (Monthly), Parental Support In Studies, Internet Access at Home, Use of Private Tutoring, Sleep Duration Per Night, Participation in Extracurricular Activities, Use Of Social Media (Hour Per Day), Motivation Level For Academic Success, Main Challenges in Studies, Confidence Level in Current Courses, and Performance in Previous Semester while the target variable was the Current CGPA feature.

A principal component Analysis (PCA) was conducted on the features and sixteen out of the twenty-two input features were selected based on their Eigen values and Explained Variance Percentage as shown on Table 4.

The prediction of academic performance of 18 students by RF and XGBoost against the actual CGPA are shown on Table 5.

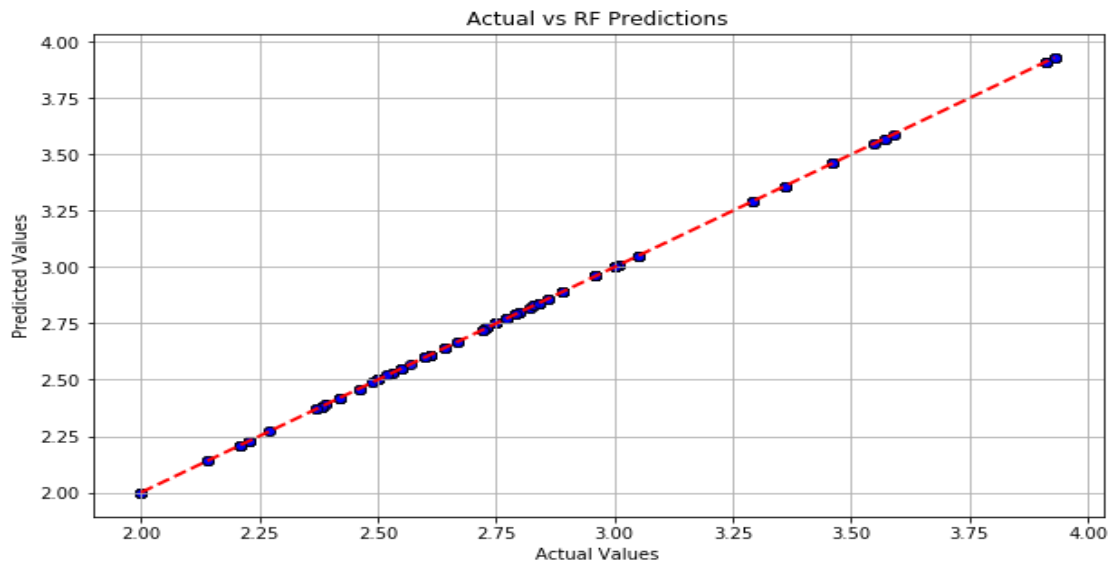

The points form a tight cluster around the diagonal line (indicating a strong positive correlation between actual CGPA and RF predictions). The model shows a relatively tight and evenly distributed cluster around the diagonal line.

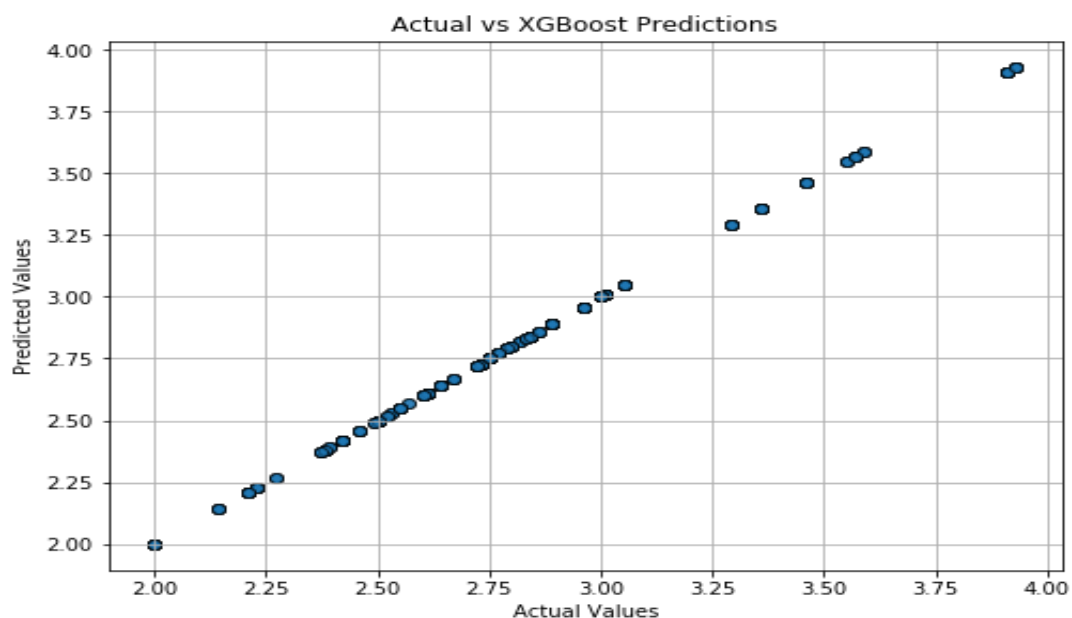
**Figure 3: Scatter plot of Actual CGPA against XGBoost predictions**

Figure 3 shows that, the relationship between variables is high, positive and linear. There are no outliers. The points form a tight cluster around the diagonal line (indicating a strong positive correlation between actual CGPA and XGBoost predictions). The model shows a relatively tight and evenly distributed cluster around the diagonal line.

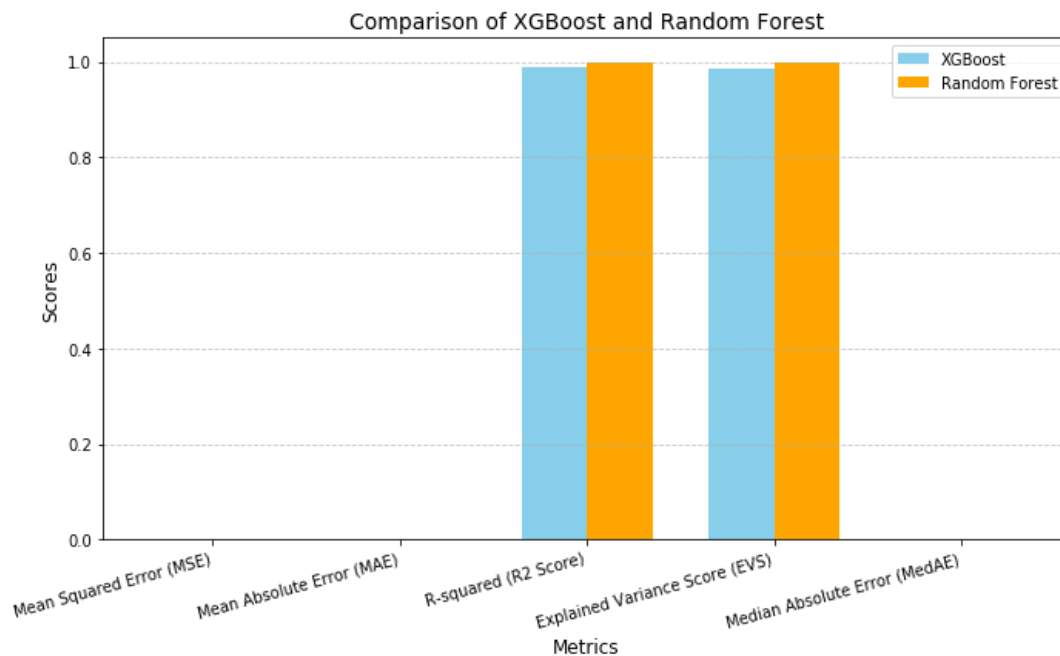


Figure 4: Grouped bar chart showing performance of XGBoost and RF.

Figure 4 shows the grouped bar chart comparison of the performance of XGBoost and RF.

The error metrics used in the evaluation of the models include Mean Squared Error (MSE), Mean Absolute Error (MAE), R-Squared Score (R2), Explained Variance Score (EVS) and Median Absolute Error (MedAE). Visualization tools used are scatter plot and grouped bar chart. PCA was conducted on the datasets to select features and sixteen (16) features were selected based on their eigen values. Two models (RF and XGBoost) were used to predict student academic performance and results obtained were compared with actual results of students.

- i. In RF, the MSE gives a value of 0.0008, MAE a value of 0.0007, R2 a value of 0.9888, EVS a value of 0.9900 while MedAE gives a value of 0.0006. On visualizing RF with scatter plot, it is seen that the relationship between variables is high, positive and linear. With the values of the performance metrics in comparison to XGBoost, RF model can be said to have better performance.
- ii. The XGBoost model has an error value of 0.0010 with MSE, 0.0011 with MAE, 0.9800 with R2, 0.9867 with EVS, and 0.0008 with MedAE. The model shows that the relationship between variables is high, positive and linear. With the values of the performance metrics in comparison to RF, XGBoost model can be said to have a good performance.

5.0 Conclusion

This study demonstrates the utility of machine learning algorithms, specifically XGBoost and Random Forest, in predicting student academic performance using a comprehensive dataset. Both models exhibited strong performance, with RF achieving marginally better results across most evaluation metrics. The principal component analysis (PCA)-driven feature selection process proved effective in identifying the most influential predictors, emphasizing the importance of data preprocessing in achieving high model accuracy.

Given the findings, the following recommendations are proposed:

- i. Adopt RF for predictive analytics: Due to its superior performance and scalability, RF is recommended as the primary algorithm for academic

performance prediction tasks, especially in scenarios with large datasets and complex relationships.

- ii. Invest in data-driven decision-making: Educational institutions should prioritize collecting and maintaining high-quality, diverse datasets to leverage advanced machine learning techniques effectively.
- iii. Expand research scope: Future studies should explore hybrid modeling approaches that combine the strengths of XGBoost and Random Forest to further enhance predictive accuracy.
- iv. Integrate predictive insights into academic Policies: Policymakers and educators should utilize model insights to design targeted interventions aimed at improving academic success, focusing on key predictors such as previous academic results, attendance, and study habits.

The study highlights the transformative potential of machine learning in educational settings, paving the way for more personalized and effective academic strategies.

CORPORATE GOVERNANCE MECHANISMS AND EARNINGS PER SHARE OF LISTED CONSUMER GOODS FIRMS IN THE MIDST OF A DOUBLE-DIGITS INFLATIONARY ECONOMY IN NIGERIA

ABSTRACT

This study investigated the impact of corporate governance practices on earnings per share of listed consumer goods firms in the midst of the double-digit inflationary economy in Nigeria. The specific objectives of the study looked at the relationship between board size, board independence, board diligence, women board membership, and earnings per share. The inflation rate was used to moderate corporate governance in relation to earnings per share. The study was anchored on the agency theory, and the secondary data obtained from the audited financial statements and annual reports of randomly selected listed consumer goods firms covers a ten-year period from 2014 to 2023. The regression analysis was used to analyze the collected data via the Statistical Package for Social Sciences (SPSS) version 23 to examine the impact of the corporate governance proxies and the moderating variable on earnings per share. The findings of the study revealed that both board size and board diligence have a negative relationship with earnings per share, while board independence and women board membership, as well as the moderating variable inflation rate all have a positive relationship with earnings per share. However, the negative and positive relationships indicated by the findings of the study are not statistically significant enough to be relied upon. Based on the findings of the study, the researcher therefore concludes that there is no significant relationship between corporate governance and earnings per share of consumer goods firms in Nigeria and recommends that while the corporate governance codes are guides provided by regulations to manage firms, the managers of firms should look beyond these corporate governance codes to attain the corporate objective of firms for the generality of all stakeholders.

1.1 Introduction

Organizations operate in a challenging and turbulent business environment that is both internal and external to them. Managements of these organizations are expected to

strategically meander through these challenges posed by the corporate business environment in attaining their corporate objectives of meeting up with the shareholders' interests and other stakeholders' needs. The absence of goal congruence in the managerial environment of business could also be a serious challenge to owners of the business, as management's personal needs might not be in conformity with the organizational objectives. This in turn may pose a detrimental problem to the shareholders' and other stakeholders' interests. However, to checkmate the excesses of management, who run the day-to-day business of the organization, the advocacy for the adherence to good corporate governance practices has become the 'liturgical' preaching in the global business environment by all stakeholders.

It is arguably right to say that inflation has continued to be an economic factor in the business environment, and it has greatly influenced how managers pursue their corporate objectives. Inflation is the rise in the general price level of goods and services in an economy over a period of time, and this has a serious influence on consumers' income and firms' operations. The hostility in some parts of the world, especially the Russia/Ukraine war and the recent US trade war, has further exacerbated the upward inflationary trend in the global business environment, and Nigeria, a developing economy, is not left out in raising the inflation rate. This has posed a great and serious concern for corporate managers on how best to meet up with their business objectives while adhering to the practice of good corporate governance. Though different studies have revealed that good corporate governance practices have a better influence on firm performance, the upward inflationary challenge in the Nigerian corporate business environment is a concern to strategic managers who have the mandate to attain the business objectives while adhering to practices of good corporate governance.

The rising inflation trend in the Nigerian corporate business environment over the last decade has posed a serious operational challenge for businesses. In an effort to meet corporate goals, businesses are faced with the greater challenge of how best to reduce their cost of operation, retain their market shares, maintain customers' needs, and other stakeholders' interests in the face of the rising inflation in the last decade in Nigeria. Good, strong, and resilient corporate governance practices are still a viable means for management to navigate through these challenges. Consequently, the study aimed at conducting an empirical investigation of the impact of corporate governance practices on earnings per share of listed consumer goods firms in the midst of the double-digit inflation faced by developing economies like Nigeria.

1.2 Objectives of the Study

The specific objectives for the study focused on the following:

- i. To examine the relationship between board size and earnings per share in a double-digit inflationary economy;
- ii. To ascertain the relationship between board of directors' independence and earnings per share in a double-digit inflationary economy
- iii. To investigate the relationship between board of diligence and earnings per share in a double-digit inflationary economy.
- iv. To determine the relationship between women board membership and earnings per share in Nigeria.
- v. To examine how inflation rate does moderate the effect of corporate governance practice on earnings per share.

1.3 Hypotheses

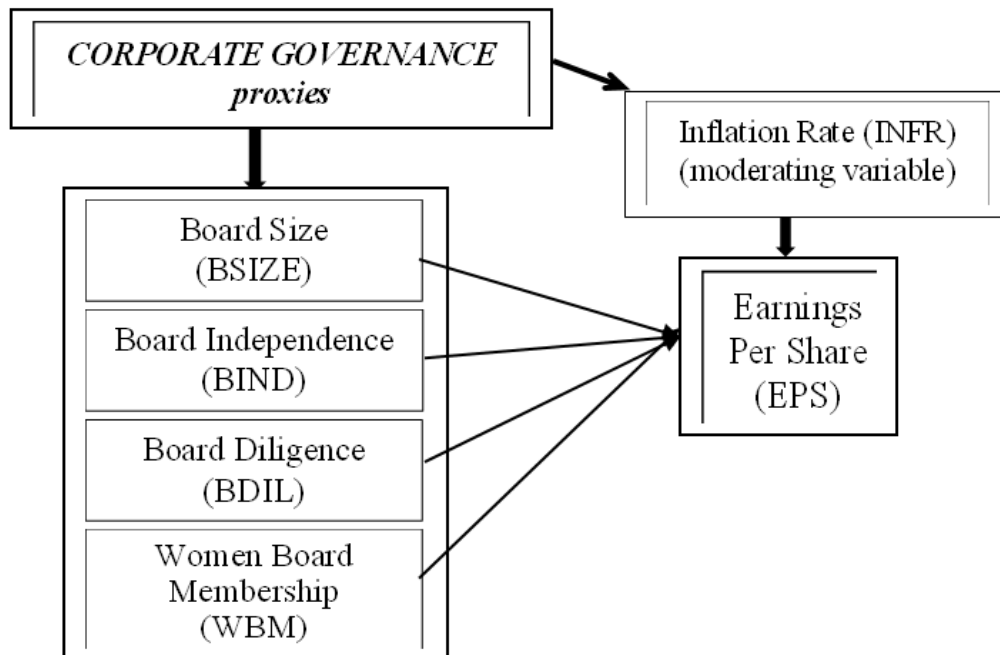
The hypotheses for this study, which are stated in the null form, are formulated thus:

Ho₁: There is no significant relationship between board size and earnings per share in a double-digit inflationary economy like Nigeria.

Ho₂: There is no significant relationship between board of directors' independence and earnings per share in a double-digit inflationary economy like Nigeria.

- Ho₃:** There is no significant relationship between board diligence and earnings per share in a double-digit inflationary economy like Nigeria.
- Ho₄:** There is no significant relationship between the women board membership and earnings per share in a double-digit inflationary economy like Nigeria.
- Ho₅:** The inflation rate does not significantly moderate the effect of corporate governance practices on earnings per share.

2. Review of Related Literature



Conceptual Framework by the researcher

2.1 Conceptual review

2.1.1 Corporate Governance

Corporate governance can be construed from organizations and corporations to represent their behavior, conduct, and handling of their operations regarding their customs, processes, policies, laws, and institutions (Khan, 2011, cited in Jasman, Inung, Rizal, & Omar, 2023). Corporate governance is the collection of linkages between the managers, shareholders, board of directors, and other stakeholders of a firm (Appah, 2022). The major aim of good corporate governance is to ensure the efficient use of resources to reduce corporate fraud and mismanagement with the purpose of maximizing shareholders' wealth and aligning the conflicting interests of all stakeholders (Yimbila, 2017, cited in Appah, 2022). It therefore means that corporate governance can be viewed as a legal and regulatory code that guides the formation of a firm's board and management and thereafter outlines certain principles needed to be adhered to by the organization for the benefit of shareholders and other stakeholders.

2.1.2 Board Size

Board Size is the total number of directors in a company's board at a particular time interval. Section 2 of the Nigeria Code of Corporate Governance 2018 empowers firms to determine the size and composition of their board by taking into account the scale and complexity of their operations and the need for sufficient members to serve on its committees, as well as secure quorum at meetings. In light of this, firms should consider having a sizable board with respect to the nature and size of the firm that would help in prompt strategic decisions, especially as it will help to mitigate the inflationary challenge posed by the business environment in Nigeria without compromising the essence of constituting the board. The litany

of corporate governance literature on board size in the internet space has indicated a flock of proponents whose studies have supported large board size, and other studies have supported small board size with respect to firm performance. The findings from the various studies have all shown that both large board size and small board size have their own advantages and disadvantages because they affect the quality of deliberation among members, as well as the ability to make optimal corporate decisions (Lawal, 2012; Gill & Mathur, 2011; Eyenubo, 2013). Some findings on board size have indicated a significant positive relationship with a firm's performance (Mutai, 2025; Hosam, Maher, & Muhammad, 2023), while some indicated a contrary view (Rini & Djoko, 2018; González & García-Meca, 2014).

2.1.3 Board Independence

Board independence is often linked to the presence of outside directors who are non-management members of the board. The non-executive directors and the independent non-executive directors, who are both considered as board independence in this study, are directors who do not participate in the day-to-day management of the company like the executive directors do. Board independence guarantees the necessary checks and balances needed to enhance board effectiveness in the control of firm activities (Franks et al., 2001, cited in García-Sánchez & Martínez-Ferrero, 2018). The findings from studies in the corporate governance space have been inconsistent; while some of the studies indicated a positive relationship between board independence and corporate performance (Mutai, G., 2025; Aqil & Adil, 2024; Kanakriyah, 2021; Wu & Li, 2015). Other studies revealed contrary findings (Al-Faryan, 2021).

2.1.3 Board Diligence

Board diligence is concerned with the frequency of time the board of the company held meetings within the financial year to carry out their board responsibilities. The regularity of board members meeting frequently is an internal issue that is at the discretion of the chairman of the board (Eluyela et al., 2018). So, boards that frequently meet may have time to develop strategic plans in line with the firm's objectives and targets, as well as checkmating the excess of the executive directors whose responsibility is to run the day-to-day operations of the firm. However, inconsistent findings have emanated from the corporate governance literature on board diligence and firm performance. Studies have revealed a positive relationship between board diligence and a firm's financial performance (Jerry & Ogbodo 2021; Akpan 2015). On the other hand, studies have equally revealed a negative relationship between board diligence and a financial firm's performance (Johl et al., 2015; Ilaboya & Obaretin, 2015).

2.1.4 Women Board Membership

Board diversity, with particular emphasis on the gender of directors, has become an emerging topic of interest to bring greater numbers of women into the position of the board of a firm (Schwartz-Ziv 2013). Women are considered to be key consumer decision makers; hence, a woman's perspective may help the board strengthen its customer orientation, and customers are the key stakeholders in the survival of any firm (Isola, Adeleye & Olohunlana, 2020). Academic research, however, shows that diverse groups with more women participating tend to outperform their counterparts (Isola et al., 2020). It has also been argued by some researchers that companies ought to increase female presence on their boards, since this has a positive effect on a firm's performance (Reguera-Alvarado, De-Fuentes & Laffarga, 2017).

2.1.5 Inflation Rate

A persistent rise in the average level of prices for goods and services within an economy over time is referred to as inflation. Inflation rate, on the other hand, is a measure of how quickly those prices are rising. Nigeria's annual inflation rate has been on a double-digit raising trend in the last decade. The consumer goods sector has been seriously and largely affected by the rising price of goods (National Bureau of Statistics, Nigeria). Inflation has important economic, social, political, and ethical implications for countries all over the globe, especially because inflation affects the living standard of people as well as income distribution amongst citizens.

2.1.5 Earnings Per Share

Earnings per Share (EPS) is a financial ratio that is being disclosed by firms in their published financial statements. Earnings per share (EPS) represent the portion of a company's earnings, net of taxes and preferred stock dividends, that are allocated to each share of common stock. Earnings per share were used as an indicator of a company's profitability. It can be calculated via two different methods: basic and fully diluted. Fully diluted EPS—which factors in the potentially diluting effects of warrants, stock options, and securities convertible into common stock—is generally viewed as a more accurate measure. It is considered important because it is one of the most critical variables in determining a share's price, and external decision makers often consider its use as a single summary measure of evaluating a company's performance. Earnings per share show how much each ordinary share of the company will earn in profit.

2.2 Theoretical Framework

This study was anchored in the agency theory. The agency theory has been the dominant paradigm in the corporate governance literature among other theories like stewardship theory, stakeholder theory, and resource dependency theory. The agency theory presupposes that shareholders require protection because management (agents) may not always act in the best interest of dispersed shareholders (Jensen & Meckling, 1976). The theory is based on the idea of separation of ownership (principal) and management (agent). It states that, in the presence of information asymmetry, the agent is likely to pursue an interest that may be detrimental to the interest of the principal (Sanda, Mikailu & Garba 2005). In tackling this problem of separation between the ownership (principal) and management (agent), codes of corporate governance were introduced to reduce agency costs related to the separation of ownership and control. The introduction of good corporate governance practices is expected to bring sanity to the realm of the management team by way of trying to checkmate the excesses of those who manage the firm via the board of directors.

2.3 Empirical Review

Mutai, G. (2025), examined the effects of corporate governance on firm financial performance among companies listed on the Nairobi Securities Exchange (NSE) between 2019 and 2023. A census sampling approach was adopted, and secondary data were sourced from audited annual financial statements and analyzed using SPSS. The findings revealed that board independence had a positive and significant relationship with firm performance, measured by return on assets (ROA) and return on equity (ROE). Conversely, board size exhibited a negative and significant relationship with firm performance. The study also found that CEO duality, board tenure, and multiple directorships each had a positive and significant effect on firm performance. Based on the findings, the study concluded that companies should implement policies that promote board independence, CEO duality, and multiple directorships, as they contribute to improved firm performance. However, firms must ensure that board size and board tenure align with their specific operational needs for optimal governance effectiveness.

Abdurrashid, Adekanmi, Olaniyan, & Olaleye (2023) examine the effect of corporate governance on firm performance in Nigeria. They specifically examined the effect of board director and managerial ownership on profit after tax of listed deposit money banks in Nigeria. Secondary sources of data were employed, and they adopted the ex post facto research design. The census sampling technique was used to select fourteen of the listed deposit money banks, and the data gathered covers the period from 2010 to 2020. The multiple regression model was used to analyze the nexus between the board of directors and managerial ownership. Their findings showed that board size has a positive and significant effect on profit after tax, while managerial ownership has a negative and significant effect on profit after tax. They concluded that corporate governance has a significant effect on the firm performance of listed deposit money banks in the Nigeria Exchange Group.

Hasan, Hossain, Islam, and Hasan (2023) investigated the relationship between corporate governance and firm performance. They used board size, board independence, members of the audit committee, and board effectiveness as proxies for corporate governance, while EPS, ROA, and ROE were used to measure firms' performance. Firm size and leverage ratio serve as control variables in the study. They sampled 58 companies listed on the Dhaka Stock Exchange (DSE) and obtained data covering the period of 2016-2021. The multiple linear regression analysis of the collected data, and their finding revealed that board independence is a solo factor that is significant to the firm's performance and has a positive impact. This study also indicated no statistically significant correlation between board size, board effectiveness, and audit committee on the firms' performance.

Wasiu, Babatunde, and Idris (2020) examine the effect of board diligence on the financial performance of deposit money banks (DMBs) listed on the Nigerian Stock Exchange. Data of ten (10) selected DBMs were obtained from their annual financial statements from 2012 to 2018. They adopt the ex post facto research design and purposive sampling technique. The data were analyzed using inferential statistics, and the hypothesis was tested using the generalized method of moments (GMM). It was found that board diligence has a significant negative effect on the financial performance of Nigerian-listed DBMs. As regards the controlled variables, only capital adequacy and firm size were found to positively and significantly influence financial performance. The liquidity ratio was found to have a direct but not significant effect on financial performance, while nonperforming loans negatively and insignificantly affect financial performance. The study concludes that board diligence reduces financial performance, and they recommend that preference should be given to the quality of board meetings and not the frequency of such meetings.

Eluyela, Akintimehin, Okere, Ozordi, Osuma, Ilogho, and Oladipo (2018) examine the impact of board meeting frequency on firm performance of deposit money banks in Nigeria. Data used for the study were collected from annual reports of the deposit money banks listed on the Nigeria Stock Exchange (NSE) market. They employed a panel regression to test the significant association amid variables. Their result shows a positive association amid board meeting frequency and firm performance. Although, their findings also show that board size was positive and not significant and firm size was negative and significant. The study recommended that management of banks should consider increasing their frequency of board meetings to at least four (4) meetings per year. This will allow the sampled deposit money banks to comply with the good governance code in Nigeria, which states that companies must meet at least once per quarter. Olatunji and Ojeka (2011) examined the effect of the proportion of non-executive directors on the profitability of the listed banks in Nigeria. A panel data regression analysis was used in analyzing the variables under consideration. The study discovered that a negative but significant relationship exists between non-executive directors and return on equity. The study concludes that the negative association is likely to be because non-executive directors are too busy with other commitments and are only involved with the company business on a part-time basis.

3. Methodology

The study used the *ex post facto* research design. The choice for this research design was facilitated because data for the study were obtained mainly from secondary sources, which are already available in the audited financial statements and annual reports of the twelve (12) consumer goods firms that were randomly selected for the study. The data obtained for the study covers a ten-year period from 2014 to 2023. The multiple regression model was adopted to analyze the data via statistical package for social sciences (SPSS) version 23, at a 5% level of significance. The functional relationship is specified thus:

The econometric model of this functional relationship is given as

EPS = Earnings Per Share

BSIZE = Board Size

BIND = Board Independent (measured by proportion of independent directors on the board)

BDIL = Board Diligence (measured by number of meetings held in a year)

WBM = Women Board Member (measured by percentage of women directors on the board)

INFR = Inflation Rate (measured by percentage of annual inflation rate)

β_0 = Constant or Intercept.

β_{1-4} = Coefficients to be estimated or the coefficients of slope parameters

μ = Error term

At the 5% (0.05) level of significance (α), for the purpose of the study, if the p-value is less than or equal to 0.05, we reject the null hypothesis (H_0). But if the p-value is greater than 0.05, then fail to reject the null hypothesis (H_0).

4. Data Presentation and Analysis

Table 4.1 above displays the descriptive statistics of the data used for the study. As observed, EPS has a mean value of 26.02, a minimum value of -0.13, and a maximum value of 157.59 for the period of 10 years, with a standard deviation of 51.54. The table also indicated that BSIZE in consumer goods firms has an approximate mean value of 10 board members, minimum and maximum values of 6 and 15, respectively, and a standard deviation of 2.26969. The descriptive statistics in the table above equally indicated that BIND has a mean value of 5.9, approximately 6; a minimum value of 3; and a maximum value of 8 directors who are not part of the executive directors who run the day-to-day management of the business, with a standard deviation of 1.62135. The table further shows that BDIL has a mean value of 5.5 times, minimum and maximum values of 4 and 8 times, respectively, and a standard deviation of 1.16450. The data from the descriptive statistics also revealed that WBM has an average value of 2 members, a minimum member of 1, a maximum member of 3, and a standard deviation of 0.71774. Finally, INFR has an average rate of 14.46 percent, a minimum and maximum rate of 8 percent and 24.7 percent, respectively, and a standard deviation of 4.98424.

The results of the multiple regressions in table 4.2 above show that R^2 is 0.674. This implies that the explanatory/independent variables—BSIZE, BIND, BDIL, WBM, and including moderating variable INFR in the model—explain changes in earnings per share to the extent of 67 percent, while the remaining 33 percent are accounted for by the error terms as specified in the model. The coefficients of estimate for BSIZE (-2.765) and BDIL (-29.795) indicated a negative relationship with earnings per share (EPS), while the coefficients of estimate for BIND (1.612), WBM (21.179), and INFR (13.118) show a positive relationship with EPS. The extents of these relationships were further determined by using the p-value test of statistical significance to test the relationships between the explanatory variables of BSIZE, BIND, BDIL, WBM, INFR, and EPS. The test statistic revealed that the negative relationship between BSIZE, BDIL, and EPS is not statistically significant to be relied upon at p-values of 0.802 and 0.408, greater than 0.05, respectively. These findings are in conformity with prior studies such as EL-Maude, Bawa, and Shamaki (2018), whose findings indicated an insignificant negative relationship between board size, board diligence, and financial performance. It therefore follows that hypothesis one (H_{o1}) and hypothesis two (H_{o2}), which state that there is no significant relationship between BSIZE, BDIL, and EPS in a double-digit inflationary economy like Nigeria, respectively, are accepted as stated. The findings are in line with Jerry and Ogbodo (2021) and, Aernan, Emengini, & Okonkwo (2023)

The coefficients of estimate for BIND (1.612), WBM (21.179), and INFR (13.118) indicated a positive relationship with earnings per share (EPS). However, the extents of these relationships were also tested using the p-value statistical test for significance. The test revealed that the positive relationships between BIND, WBM, INFR, and EPS were not statistically significant at p-values of 0.802, 0.408, 0.083, and 0.083, greater than 0.05, respectively. Hence, hypothesis two (H_{o2}), hypothesis four (H_{o4}), and hypothesis five (H_{o5}), which respectively state that there is no significant relationship between BIND, WBM, INFR, and EPS in a double-digit inflationary economy like Nigeria, were equally accepted as stated. This finding, H_{o4} , is in conformity with Gruszczyński, M. (2020), and Marpaung, Koto, Hafiz, & Hamdani (2022), whose findings revealed that female presence on a board has no significant relationship with firm performance. The implication of these findings is that boards of directors' independence and women's board membership have no significant relationship with financial performance as it relates to earnings per share that emanate from consumer goods firms in Nigeria.

5. Conclusion and Recommendations

The study examined the impact of corporate governance mechanisms on earnings per share of listed consumer goods firms in the midst of a double-digit inflationary economy in Nigeria. The study equally investigated the moderating effect of inflation rate on the corporate governance practices on earnings per share of the listed consumer goods firms. The study adopted an ex post facto research design and obtained data from financial statements used for the study. Findings of the study show that BSIZE and BDIL have an insignificant negative relationship with earnings per share. The finding also revealed that BIND, WBM, and INFR have insignificant positive relationships with earnings per share. The study therefore concludes that, though there are relationships between the corporate governance mechanisms and earnings per share of the consumer goods firms, these relationships were not significant enough to be relied upon. Based on the conclusion, the study recommends that while the corporate governance codes are statutory guides provided by regulations to manage firms, the managers of firms should look beyond these corporate governance codes to attain the corporate objective of firms for the generality of all stakeholders.

FINANCIAL LEVERAGE AND FINANCIAL STABILITY OF QUOTED INDUSTRIAL GOODS FIRMS IN NIGERIA

ABSTRACT

Businesses use financing decisions to optimize their capital structure, control risk, and spur growth. In view of this, this study examined the relationship between financial leverage and financial stability of quoted industrial goods firms in Nigeria. The specific objectives were to determine the effect of debt-equity ratio on liquidity of quoted industrial goods firms in Nigeria, to ascertain the effect of interest coverage ratio on liquidity of quoted industrial goods firms in Nigeria and to assess the effect of total debt ratio on liquidity of quoted industrial goods firms in Nigeria. Ex-post facto research design was adopted, and panel data covering ten (10) years (2014-2023) were collected from twelve (12) listed industrial goods firms in Nigeria which formed the sample size of the study. The data collected were analysed using panel linear regression technique. Findings showed that debt equity ratio has a significant negative relationship (Coeff. = -0.00219{0.0097}) with liquidity of quoted industrial goods firms in Nigeria while interest coverage ratio has a significant positive relationship (Coeff. = 0.00029{0.0124}) with liquidity of quoted industrial goods firms in Nigeria. It also revealed that total debt ratio has a non-significant negative relationship (Coeff. = -0.00011{0.1260}) with liquidity of quoted industrial goods firms in Nigeria. It was thus concluded that financial leverage has a significant impact on the financial stability of quoted industrial goods firms in Nigeria. Recommendations made included that quoted industrial goods firms in Nigeria should consider reducing their debt levels and increasing their equity base. This could be achieved through strategies such as debt restructuring, equity financing, and improving profitability to reduce dependence on debt.

INTRODUCTION

Financing choices are crucial for companies looking for ways to out weight competition in today's intensely competitive and interconnected worldwide marketplace. Nigeria's economy is no exception when it comes to the industrial goods sector, which stimulates growth, innovation, and job creation. Businesses use financing decisions to optimize their capital structure, control risk, and spur growth. These choices include figuring out the best amount of leverage, deciding between short- and long-term financing solutions, and picking the appropriate ratio of debt to equity. Samuel and Yahaya, (2024) stipulates that poor finance

choices are a ticking time bomb that might have a catastrophic effect on businesses, plunging them into a maze of financial instability and protracted stagnation. According to Brealey et al. (2020), this implies that there is a lack of equity basis, high debt levels, an unbalanced debt-to-equity ratio, and an excessive amount of short-term debt. These factors raise financial risk and enhance the possibility of default and liquidity crises. These consequences include higher likelihood of default, bankruptcy, or financial distress, downgrade in credit rating (Kisgen, 2006), increased cost of debt and equity (Ross et al., 2019), reduced profitability, and reduced share price, dividend payments, and overall returns. As such, firms need to maintain an optimal capital structure to ensure financial flexibility, reduce risk, and maximize financial stability.

However, achieving an optimal capital structure is challenging, and companies must balance debt and equity to respond to changing market conditions, fund new projects, and maintain control over their operations as argued by Modigliani and Miller (1958). Financial leverage is a measure of how much firm uses equity and debt to finance its assets. As debt increases, financial leverage increases. A firm is considered leveraged when the firm is partially financed by both debt and equity. Most firms survive with a significant liquidity level which is mainly achievable through use of debt. Many companies use debt to leverage their profits and capital. It relates to splitting finance into debt and equity elements with each of these having its peculiar features, merits and demerits on firm sustainability and market value. Debt bears a fixed cost. This means that when a firm increases its debt level, the financial leverage level increases. Leverage is the use of borrowed funds for investment purposes (Dinh & Pham, 2020). When a firm's management increases the firm's profit by using debt elements, it is an indication of quality corporate governance. A firm's investments can be financed by the use of either debt or equity. When a firm uses fixed-charged funds especially preference capital and debt along with the shareholder's equity this is referred to as financial leverage or gearing. When a company's capital structure is made of only shareholders' or owners' equity only it's said to be unlevered firm whereas when a firm's capital structure is made of both debt and owners' equity it is said to be levered (Guner, 2016).

A business entity is said to be financially stable when it is capable of efficiently allocating resources, assessing and managing financial risks, maintaining employment levels close to the economy's natural rate, and eliminating relative price movements of real or financial assets that will affect monetary stability or employment levels (Samuel & Yahaya, 2024). Also, a firm is in a range of stability when it dissipates financial imbalances that arise endogenously or as a result of significant adverse and unforeseen events. In stability, the firm absorbs the shocks primarily via self-corrective mechanisms, preventing adverse events from having a disruptive effect on the going concern of the business. The industrial goods sector consists of the companies that produce and sell capital goods to other businesses. In contrast to the consumer goods sector that produces goods and services directly consumed by households, the industrial goods sector provides capital goods to other businesses for manufacturing and construction. The sub-sectors include aerospace and defence, homebuilding, electric equipment, machinery, construction and engineering, distributors, etc. Most businesses in the industrial goods sector are sensitive to the economic cycle. The industrial goods sector has high barriers of entry due to large capital investments and cost-saving from economies of scale. However, with a wide range of sub-sectors, not all businesses in the sector slow down their production simultaneously. Some sub-sectors may lag, while some may lead the economic cycles. Waste management companies and industrial conglomerates often demonstrate resilience. They are able to generate relatively steady revenue streams during economic downturns.

Statement of the Problem

Financial decision-making is a critical aspect of corporate finance, as it significantly impacts a firm's survival, performance, and overall success. Capital, or finance, is a vital resource that drives financial decision-making, and companies can source it internally through retained earnings, depreciation, tax shields, and other non-cash transactions, or externally through debt and/or equity financing (Amahalu, et al. 2018). A highly leveraged company, property, or

investment is characterized by having more debt than equity, indicating a higher level of financial risk. Both investors and companies utilize the concept of leverage to amplify potential returns, with investors leveraging their investments using various financial instruments, such as options, futures, and margin accounts, and companies using leverage to finance their operations, investments, and growth initiatives. The use of leverage, however, involves a delicate balance between the benefits of increased returns and the risks of heightened debt levels. Where a business firm uses more debt than equity in its capital structure, it incurs a greater portion of fixed costs (interest payments) and enjoys tax waivers. At the same time, leverage also multiplies the potential downside risk where the investment does not yield the expected returns. Moreover, many firms are eager to pay off their debts quickly by adopting debt-reduction methods that add risks and may negatively affect their cash flows.

While financial leverage is recognized as a crucial factor in understanding firm liquidity (Senan et al., 2021; Okeke et al., 2021) and financing decisions (Subhani et al., 2022), a notable gap exists in the literature regarding the moderating effect of firm size on the relationship between financing decisions and financial stability. Only a few studies have explored this moderating effect (Vengesai, 2023; Setianti&Haryono, 2023), highlighting the need for further research to examine how firm size influences the impact of financial leverage on financial stability and to investigate differences in financing decisions and financial stability across firms of varying sizes. The inconclusive results and lack of consensus in the reviewed literature gave rise to a gap in literature that this study aims to address.

Objectives of the Study

The main objective of this study was to ascertain the relationship between financial leverage and financial stability of quoted industrial goods firms in Nigeria. The specific objectives were to:

1. Determine the relationship between debt-equity ratio and liquidity of quoted industrial goods firms in Nigeria.
2. Ascertain the relationship between interest coverage ratio and liquidity of quoted industrial goods firms in Nigeria.
3. Appraise the relationship between total debt ratio and liquidity of quoted industrial goods firms in Nigeria.

Research Questions

This study sought to provide reliable answers to the following questions;

1. What is the effect of debt-equity ratio on liquidity of quoted industrial goods firms in Nigeria?
2. To what extent does interest coverage ratio affect liquidity of quoted industrial goods firms in Nigeria?
3. How does total debt ratio affect liquidity of quoted industrial goods firms in Nigeria?

Research Hypotheses

The following hypotheses as stated in their null form were adopted for the study;

- H₀₁:** There is no significant relationship between debt-equity ratio and liquidity of quoted industrial goods firms in Nigeria
- H₀₂:** There is no significant relationship between interest coverage ratio and liquidity of quoted industrial goods firms in Nigeria
- H₀₃:** There is no significant relationship between total debt ratio and liquidity of quoted industrial goods firms in Nigeria

Scope of the Study

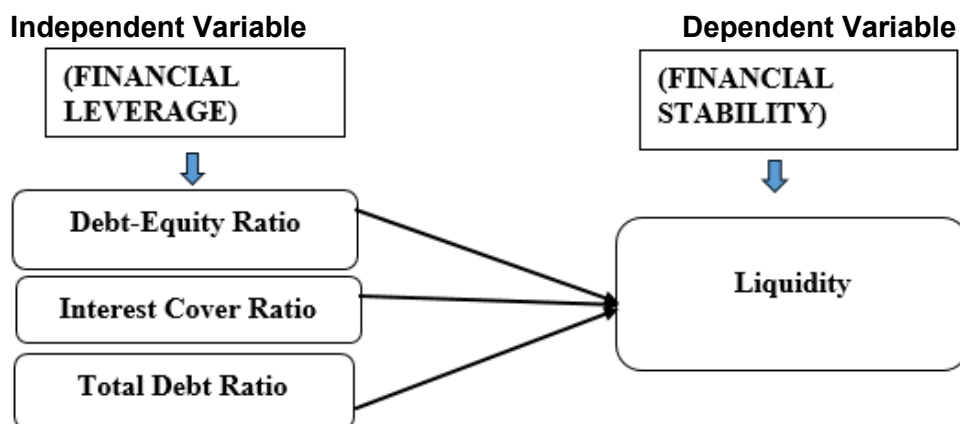
Content scope: The explanatory variables for financial leverage were debt-equity ratio, interest coverage ratio and total debt ratio. Liquidity was however used as the proxy for the dependent variable (financial stability).

Geographical scope: The study covers a period of 10 years, from 2014 to 2023, examining the relationship that exists between financial leverage and stability of quoted industrial good firms in Nigeria.

Unit scope: The study was limited to 12 industrial goods firms listed on the Nigerian Exchange Group, which are the units of analysis.

REVIEW OF RELATED LITERATURE

The Concept of Financial Leverage

Financial leverage is a measure of the use of debt versus the use of equity to finance the assets and activities of an organization (Audax, 2018). It is one of the financing decisions that firms have to make. If the funds are not paid back as agreed, the financier can commence collection proceedings (Enekwe, *et al.* 2014). Debt financing is mainly in the form of loan and bond but other form such as securing goods on credit also exist (Akayi et al, 2021). High usage of debt financing leads to an increase in financial leverage and is associated with greater risk of bankruptcy. However, it is also associated with various advantages such as maintaining company ownership intact, tax deductions, and low transactional costs (Mboi, *et al.* 2018). On the other hand, equity financing entails raising money by selling of company shares to investors who acquire ownership in the company (Audax, 2018). Equity financing may also come in the form of reinvesting the company's profits.

The cost of equity is usually the claim on earnings provided to shareholders for their ownership stake (Edore & Ujuju, 2020). Although equity financing is associated with lower risks of bankruptcy, it is an expensive source of financing as investor demand a higher rate of return (Ahmadu, 2021). Companies can use leverage to finance their assets; instead of issuing stock to raise capital, companies can use debt financing to invest in business operations in an attempt to increase shareholder value (Kenton, 2021). The financial leverage of a company depends on the choice made by the management to either use debt or equity to fund the operations of the company. Financial leverage is often gauged using the debt ratio, equity ratio, and debt to equity ratio (Enekwe, *et al.*, 2014).

Variables of Financial Leverage

Debt-Equity Ratio

The debt-equity ratio is a leverage ratio that calculates the weight of total debt and financial liabilities against total shareholders' equity. It indicates the relative proportion of shareholders' equity and debt used to finance a company's assets (Okoye, *et al.*, 2016). The debt-to-equity ratio is a financial as well as liquidity ratio that compares a company's total debt to total equity (Enekwee *et al.*, 2014). The debt-to-equity ratio shows the percentage of company financing that comes from creditors and investors as highlighted by Gunarathna (2016). It is often expressed in percentage as shown below;

$$\text{Debt-equity ratio} = \frac{\text{Total debt}}{\text{Equity share} + \text{reserve}} \times 100$$

A higher total debt-to-equity ratio indicates that the sector has been increasing the relative share of debt in external financing, whereas a lower debt-to-equity ratio indicates that the sector is financing a decreasing proportion of its activities through debt as compared to financing through their equity (retained earnings and net new share issuance) as stressed by Ofuleet *et al.*, (2022). According to Okekeet *et al.*; (2021), higher debt levels result in volatile earnings due to additional interest expense as well as increased vulnerability to business downturns. The debt-to-equity ratio shows the proportions of equity and debt a company is using to finance its assets and it signals the extent to which shareholder's equity can fulfil obligations to creditors, in the event a business declines (Andrew, 2021)

Interest Cover Ratio

This ratio is commonly referred to as "times interest earned". It does not take into consideration the principal debt repayment (Hassan&Adegbe, 2021). It is concerned with payment of accumulated interest only. This ratio measures the number of times an entity's operating profit can pay off the entity's interest expense as highlighted by Okekeet *et al.*, (2021). As stressed by Ofuleet *et al.* (2022). Many industrial goods firms face the challenge of covering interest liabilities continuously. Hence, it is essential for solvency and liquidity to secure these liabilities with a revenue stream. Thomas and Zechner, (2021) observed that when a company is having trouble meeting its obligations, it may have to borrow more or utilize its cash reserve but should regularly consider the ability of the firm to generate income that can offset the interest payments. Such cash reserves would be better spent on capital assets or to meet contingencies. Interest cover ratio is calculated as;

$$\text{Interest cover ratio} = \frac{\text{Profit before interest and tax}}{\text{interest charges}}$$

This ratio is useful to understand a company's capability or financial strength to pay its debt interest. A higher ratio is better because it shows that the company is making enough profit to settle its interest expense and is a sign of financial strength for the company. Also, the higher the ratio, the higher the level of confidence of lenders in the ability of the company to repay loans granted to it. Koriret *et al.*, (2022) observed that interest payments have an impact on financial performance of listed manufacturing firms in Kenya.

Total Debt Ratio

Total debt ratio is a financial ratio that indicates the percentage of a company's assets that are provided via debt. It is the ratio of total debt (short-term and long-term liabilities) and total assets (Pachori&Totala, 2012). Total debt measures the proportion of the business assets financed with debts and in effect also measures the degree of protection to unsecured creditors in the event of liquidation (Umar&AbdulQudus, 2020). Adenugba, *et al.* (2016) argued that it is a measure of business' financial risk, the risk that the firm's total assets may not be sufficient to pay off its debts and interest thereon. Debt could be attained in many different ways, and another common way of categorizing debt is based on its different maturities (Ofuleet *et al.*, 2022). There are short-term debt, long-term debt and convertible debt.

Short-term debt is defined as payments due within one year and is found under current liabilities on the statement of financial position (Umar&AbdulQudus, 2020). This could be short-term bank loans, but also longer-term loans that are due within one year, as well as other outstanding debt maturing within a year. Total debt ratio is calculated as;

$$\text{Total debt ratio} = \frac{\text{Current liabilities} + \text{longterm loans}}{\text{Total assets}}$$

Mboi, *et al.* (2018) argued that total debt ratio is very important in determining the risk of default and bankruptcy faced by a firm, as it will affect the choice of capital structure (Lawale *et al.*, 2014). When determining a firm's financial health, the current liability account should not exceed the amount of cash and cash equivalents available in the firm, since this will mean that the firm cannot meet its current obligations (Ezejirofore *et al.*, 2029).

Concept of Financial Stability

Financial stability is the ability to withstand a temporary problem, such as a decrease in sales, lack of capital or loss of a key employee or customer (Hassan &Adegbe, 2021). As such, stable firms have higher cash flows caused by stable revenue and expense patterns with lower reinvestment needs as argued by Okeke *et al.* (2021). This makes them attractive borrowers as they can repay the loans and honour the interest payment obligations in time. Further, stable firms have a compulsion to reduce their cost of equity and therefore their debt-equity ratio is normally high. Financial stability is paramount for firm's growth as most investment portfolios in the real economy can be well appraised by the firm (Okeke, *et al.* 2021). Financial stability ratios are tools for gauging ability to meet long-term obligations with enough working capital left to operate.

The main determinant of financial stability is liquidity and it was used in measuring the effect of financial stability on financial leverage.

Theoretical Framework

The Trade-off theory (Kraus and Litzenberger,1973)

Kraus and Litzenberger (1973) proposed the Trade-off Theory. According to Murray and Goyal (2017), the traditional Trade-off theory or the tax Shield- Bankruptcy cost theory postulates that the value of a firm may be maximized at an optimal level of capital structure where the marginal benefits of debt (that is, the present value of tax savings from tax deductibility of interest payments) and the marginal costs of debt (that is, the present value of potential bankruptcy costs, holding its assets and investment plans constant) are equalized. The trade-off theory has become the most acceptable theory to explain financial leverage in recent time. Trade-off theory actually supports leverage in constructing capital structure by assuming leverage benefits. Optimal level of leverage is achieved by balancing the benefits from interest payments and costs of debt. Financially, debt is considered beneficial because of the debt-tax-shields that help to minimize expected tax bills and maximize the after-tax cash flows (Watts & Zimmerman, 2013). Trade-off theory hence predicts the cost and benefit analysis of debt financing to achieve optimal capital structure.

The Trade-off theory states that the optimal capital structure at which a company value is maximized to a target debt ratio can be obtained through establishing a trade-off between tax and other benefits against financial distress and other costs resulted from issuing debt (Maternilola & Bany-Ariffin, 2011). Although debt can offer a tax shield, it raises the probability of bankruptcy. As the level of debt increases, both tax shield and bankruptcy risk will increase. Additionally, through comparing tax benefits of debt and costs of bankruptcy, the Trade-off theory shows a positive relationship between debt and firms stability until the optimal point where the cost brought by financial distress equals the benefits earned from tax saving. Considering this, when a firm plans to maximize its value and compare the amount of debt and equity to use, it is supposed to pay attention on the trade-off between the benefits of tax shield and the cost of financial distress. (Dissanayake, 2018). The Tradeoff theory expects

long term debt to positively impact firms' stability because companies that have higher stability ratios are less risky to debt holders and have more debt capacity.

Empirical Framework

Ofulue, *et al.* (2022) studied the relationship between financial leverage and financial performance of quoted industrial goods firms in Nigeria for a thirteen (13) year period covering from 2008-2020. It concluded that Short-term debt ratio significantly and positively relates with the cash value-added while Debt-equity Ratio and Long-term debt ratio have a significant negative relationship.

Akayi, *et al.* (2021) examined the effect of debt-equity financing on firm's performance in Nigeria using a sample of 26 firms randomly selected from oil and gas, Health care and ICT sectors of the Nigerian stock exchange for the period from year 2013 to 2020. Ordinary least square regression model was however used and the findings of the study revealed that Debt financing has significant and positive effect on firm performance in Nigeria at 5% level of significance. It was however recommended that firms should try to finance their investment activities with debt and equity to consider either debt or equity as a last option.

Hassan and Adegbeie (2021) examined the effect of financial leverage on cash flow of manufacturing firms in Nigeria. Thirteen (13) listed manufacturing firms in Nigeria from 2009 to 2018 were studied using ex-post facto research design. One of the major findings from this empirical analysis is that financial leverage has significant effect on cash flow of quoted manufacturing companies in Nigeria.

Odumet *al.* (2021) examined the effect of financial leverage on financial performance of quoted industrial goods firms in Nigeria over the period of 2009-2020. A sample of 14 Industrial goods firms was selected. Multiple regression technique was however adopted for analysis of data. The study findings revealed that short-term debt ratio significantly and positively relates with the cash value-added while debt-equity ratio and long-term debt ratio have a significant negative relationship.

METHODOLOGY

This section focused on the methods and procedures used in collecting and analysing data for the study (Attih, 2024; Attih et al., 2023; Essien et al., 2023). It consists of research design, population of the study, sample size and sample size determination, sampling technique, sources of data and method of data collection, method of data analysis, model specification, and measurement and operationalization of variables.

Research Design

This work adopted an *ex-post facto* research design. This was because it establishes a cause-effect relationship and the researcher had no control over the variables under study. This design is very appropriate where it is not possible for the researcher to directly manipulate the independent variable.

Population of the Study

According to Eke and Udonde (2023), population is the totality of all elements (human and material) being studied. The population of this study comprised of 13 industrial goods firms quoted on the floor of the Nigerian Stock Exchange as at the end of year 2023. Also, availability of data served as the yardstick for selection. Industrial goods firms that were continuously listed by Nigeria stock exchange during the period (2014 -2023) and whose financial statements and reports are available and have been consistently submitted to Nigeria stock exchange for the period under study were selected. These industrial goods firms are as shown in table 3.1 below;

Sample Size and Sample Size Determination

In the course of this study, the population also served as the sample size. This is because the population was manageable enough for the researcher to handle and obtain all required data necessary for the study. Therefore, 12 out of 13 quoted Industrial goods firms formed the sample of the study. That is, all the firms in the population were studied exception of Austin Laz & Co. Plc.

Sampling Technique

Complete enumeration also known as census sampling technique was used to obtain the data for the study. According to Udonde, Akpan and Awah (2021), complete enumeration is used when the assembled sample has the same proportion of individuals as the entire population.

That means $n=N$

Where;

n = sample size and N = population

Sources of Data and Method of Data Collection

The data for the dependent and independent variables were extracted from financial reports using contents analysis method and collated with the aid of Microsoft excel software. The panel data methodology was adopted because the study combined time series and cross-sectional data that is twelve (12) cross-sectional observations for each year and ten-time series for each industrial goods firm regressor and explained variables, a total of one hundred and twenty (120) pooled observations. A panel data set has multiple entities each of which has repeated measurements at different time periods. Panel data give more informative data, more degrees of freedom and more efficiency. They also provide ways of dealing with diverse data and examine fixed and random effects on the longitudinal data.

Method of Data Analysis

The study adopted multiple regression (Ordinary Least Square-OLS) analysis to analyse data via Eviews 10.0. The data conformed to the standardized linear regression assumptions, that is, linearity, homoscedasticity, normality and independence of data. Durbin Watson statistics is within the range of 1-3, (Gujarati et al., 2012; Kothari, & Gaurav, 2014; Tabachnick & Fidell, 2007).

Model Specification

To achieve the stated objectives of the study, as well as testing the study hypotheses, a multiple linear regression model was adopted. Hence, the broad model for this study is as presented below;

Decision Rule

The decision was based on 5% level of significance. Accept null hypothesis (H0) if probability value (i.e. P-value or Sig.) is greater than or equals to (\geq) stated 5% level of significance (α); otherwise, reject and accept alternate hypothesis (Ha), if p-value or sig calculated is less than 5% level of significance.

DATA PRESENTATION, ANALYSIS AND DISCUSSION OF FINDINGS

Data Presentation

The dataset comprises a panel data of one hundred and twenty (120) observations across twelve (12) quoted industrial goods firms in Nigeria for ten (10) years (2014-2023). The data include the dependent variable -Cash Ratio of quoted industrial goods firms (CashR) and the independent variables which include Debt-Equity Ratio of quoted industrial goods firms (DER), Interest Cover Ratio of quoted industrial goods firms (ICR), and Total Debt Ratio of quoted industrial goods firms (TDR).

Data Analysis

Various statistical techniques were utilized in the analysis of data. These include descriptive statistic technique and panel multiple regression technique. The results from the panel regression method were used in the testing of the research hypotheses which have been stated in the first chapter of this work.

1. Descriptive statistics of industrial goods firms' financial ratios.

This was conducted to understand the behaviour of the data using various statistics including mean, standard deviation, skewness, and kurtosis. The result for the descriptive statistics analysis of Nigerian quoted industrial goods firms' financial ratios for the period of ten years (i.e. 2014-2023) as presented in Table 4.1

The table shows that cash ratio (CashR), Debt-Equity Ratio (DER), Interest Cover Ratio (ICR) and Total Debt Ratio (TDR) of quoted industrial goods firms in Nigeria had mean values of approximately 0.3794, 0.8037 (or 80.37%), 15.65 times and 0.4461 (or 44.61%) respectively. This indicates the central or average values for these variables from 2014 to 2023. The median values obtained for cash ratio (CashR), Debt-Equity Ratio (DER), Interest Cover Ratio (ICR) and Total Debt Ratio (TDR) of quoted industrial goods firms in Nigeria were approximately 0.2989, 0.7424 (or 74.24%), 13.15 times and 0.4883 (or 48.83%) respectively. These constitute the middle values for the distributions of these variables under the period covered in this study (2014-2023).

In terms of the level of variability and dispersion in the distribution of these variables, the standard deviations obtained for cash ratio (CashR), Debt-Equity Ratio (DER), Interest Cover Ratio (ICR) and Total Debt Ratio (TDR) of quoted industrial goods firms in Nigeria were 0.4732, 16.9859, 167.38 and 0.5644 respectively. This indicates varying levels of variability in the distribution with interest cover ratio indicating high variations in the distributions. Similarly, the skewness values obtained as 1.4194, -9.8948, -8.2939 and -6.8435 respectively. The Kurtosis values obtained for these variables were approximately 9.7313, 103.82, 78.21 and 68.72 respectively. Since the values of the kurtosis are greater than zero (0), it indicates a leptokurtic distribution, hence the presence of outliers in the data for the variables.

2. Model evaluation

The suitability of the data was assessed through coefficient and residuals diagnostics. These include normality test, multicollinearity test and heteroscedasticity test.

1. Normality test

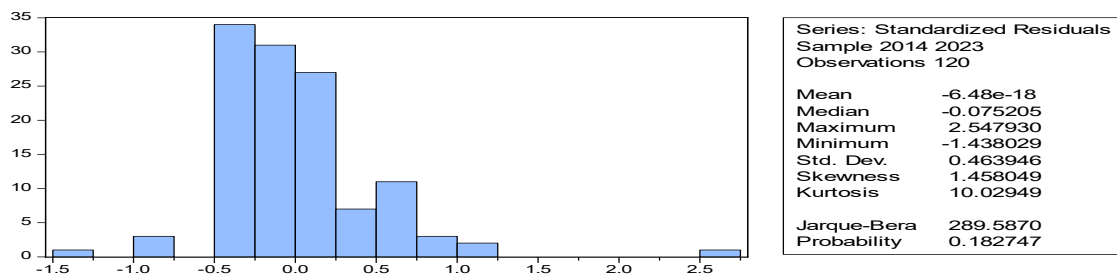


Fig. 4.1 Jarque-Bera Normality test results

A significant Jarque-Bera test result implies that the data do not follow a normal distribution. On the other hand, a non-significant result indicates that there is insufficient evidence to reject the assumption of normality. If the p-value associated with the Jarque-Bera test is below a predetermined significance level ($p < 0.05$), then we reject the null hypothesis and conclude that the data do not follow a normal distribution. With a p-value of 0.182747, there is sufficient evidence to conclude that the data were normally distributed.

2. Multicollinearity test

In examining the association among the variables, the study employed the Spearman Rank Correlation Coefficient (correlation matrix), and the results are as presented in the table below.

The correlation analysis showed that all independent variables- Debt-Equity Ratio (DER), Interest Cover Ratio (ICR) and Total Debt Ratio (TDR) of quoted industrial goods firms in Nigeria over the period under study had coefficients lesser than 0.80 respectively confirming absence of multicollinearity issues.

3. Heteroscedasticity test

The statistics and probability value associated with the Breusch-Pagan LM test otherwise known as the Breusch-Pagan Godfrey test help determine whether there is evidence of heteroscedasticity in the regression model. A low p-value ($p < 0.05$) suggests evidence against the null hypothesis in favour of the alternate hypothesis which indicates the presence of heteroscedasticity in the regression model. With a p-value of 0.0852, there is sufficient evidence to accept the null hypothesis, thus, conclude that the predictor variables were homoscedastic.

3. Autocorrelation

Autocorrelation tests examine whether the residuals are independently distributed or if there is a systematic pattern of dependence. The Durbin-Watson statistic is commonly used to test for autocorrelation, with values close to 2 indicating no significant autocorrelation. The Durbin-Watson statistic value of 1.760209 suggest a mild positive autocorrelation in the residuals of the regression model.

Test of Hypotheses

Each of the hypotheses in this study was tested based on the result obtained from the panel multiple regression analysis. The result that relates to these hypotheses is summarized in table 4.4 below;

The multiple regression line is as written below:

$$CASHR = 0.441465690329 - 0.00219881946272 * DER + 0.000296053154517 * ICR - 0.000111497583 * TDR + \mu$$

Considering the regression results above, when the independent variables- Debt-Equity Ratio (DER), Interest Cover Ratio (ICR) and Total Debt Ratio (TDR) of quoted industrial goods firms in Nigeria are held constant (equal Zero), the dependent variable- Cash Ratio (CashR) stood at a constant average of approximately 0.4414 (44.14%) over the years. However, a one percentage increase in Interest Cover Ratio (ICR) increases cash ratio (CashR) by 0.029% while a similar variation in Debt-Equity Ratio (DER) and Total Debt Ratio (TDR) decreases cash ratio (CashR) by approximately 0.219% and 0.011% respectively.

Hypothesis one

H₀: There is no significant relationship between debt equity ratio and liquidity of quoted industrial goods firms in Nigeria

H₁: There is significant relationship between debt equity ratio and liquidity of quoted industrial goods firms in Nigeria

By way of testing whether the variations in liquidity of quoted industrial goods firms in Nigeria caused by debt equity ratio is significant, T-test was carried out at .05 significance level with

T_{tab} of 2.178 given at $T_{0.05,12}$. From the result above, the T_{cal} of 3.863351 is greater than T_{tab} given at $T_{0.05,12}$. Hence, the null hypothesis which states that there is no significant relationship between debt equity ratio and liquidity of quoted industrial goods firms in Nigeria fails to hold, thus rejected, and the alternative hypothesis accepted. The null hypothesis is further rejected given that at $T_{0.05,12}$, its probability value (p-value = 0.0097) is less than 0.05 ($p < 0.05$).

Hypothesis two

H₀: There is no significant relationship between interest coverage ratio and liquidity of quoted industrial goods firms in Nigeria

H₁: There is significant relationship between interest coverage ratio and liquidity of quoted industrial goods firms in Nigeria

In respect of interest coverage ratio, the T-test was also employed. From the result above, the T_{cal} of 2.650370 is greater than T_{tab} given at $T_{0.05,12}$. Hence, the null hypothesis which states that there is no significant relationship between interest coverage ratio and cash ratio of quoted industrial goods firms in Nigeria fails to hold, thus rejected, and the alternative hypothesis accepted. The null hypothesis is further rejected given that at $T_{0.05,12}$, its probability value (p-value = 0.0124) is less than 0.05 ($p < 0.05$).

Hypothesis three

H₀: There is no significant relationship between total debt ratio and liquidity of quoted industrial goods firms in Nigeria

H₁: There is significant relationship between total debt ratio and liquidity of quoted industrial goods firms in Nigeria

In addition, the T-test was also employed for total debt ratio. From the result above, the T_{cal} of 1.541083 is less than T_{tab} given at $T_{0.05,12}$. Hence, the null hypothesis which states that there is no significant relationship between total debt ratio and liquidity of quoted industrial goods firms in Nigeria holds, thus accepted, and the alternative hypothesis rejected. The null hypothesis is further accepted given that at $T_{0.05,12}$, its probability value (p-value = 0.1260) is greater than 0.05 ($p > 0.05$).

Discussion of Findings

Debt equity ratio and liquidity

The study revealed that debt equity ratio has a significant negative relationship with liquidity of quoted industrial goods firms in Nigeria. This suggests that as the debt equity ratio increases, the cash ratio decreases. This implies that firms with higher debt equity ratios tend to have lower cash ratios, indicating a higher reliance on debt financing and a lower ability to meet short-term obligations. This is consistent with the pecking order theory, which suggests that firms prioritize internal financing over external financing, and debt financing is used as a last resort. Firms with high debt equity ratios may need to reassess their capital structure and consider reducing their reliance on debt financing. Additionally, firms may need to improve their cash management practices to ensure they have sufficient liquidity to meet their short-term obligations. This is in line with the findings of Ofulue et al. (2022), who studied the relationship between financial leverage and financial performance of quoted industrial goods firms in Nigeria. Similarly, Odum et al. (2021) examined the effect of financial leverage on financial performance of quoted industrial goods firms in Nigeria.

Interest coverage ratio and liquidity

The study also revealed that interest coverage ratio has a significant positive relationship with liquidity of quoted industrial goods firms in Nigeria suggests that as the interest coverage ratio increases, the cash ratio also increases. This implies that firms with higher interest coverage ratios tend to have higher cash ratios, indicating a higher ability to meet interest payments and

a lower risk of default. This finding is consistent with the signalling theory, which suggests that firms with higher interest coverage ratios are perceived as less risky and more creditworthy. The positive relationship between interest coverage ratio and cash ratio has significant implications for firms' financial management and risk assessment. Firms with high interest coverage ratios may be viewed as more creditworthy and may have better access to debt financing. This result agrees with the discoveries of Kenn-Ndubisi et al., (2019).

Total debt ratio and liquidity

In addition, total debt ratio has a non-significant negative relationship with liquidity of quoted industrial goods firms in Nigeria suggests that there is no statistically significant relationship between total debt ratio and liquidity. This implies that the total debt ratio does not have a significant impact on the cash ratio of firms in the sample. This finding may be due to the fact that firms in the sample may be using debt financing for different purposes, such as investing in profitable projects or financing working capital. The non-significant relationship between total debt ratio and liquidity has implications for firms' financial management and capital structure decisions. Firms need to consider other factors, such as interest coverage ratio and debt equity ratio, when making decisions about their capital structure. This aligns with the position of Mwangi and Simiyu, (2024) and that of Ofulue et al. (2022).

SUMMARY, CONCLUSION AND RECOMMENDATIONS

Summary of the Findings

The data collected were analysed using panel simple regression technique. Based on the analysis of data collected, the following findings were drawn:

1. Debt equity ratio has a significant negative relationship (Coeff. = - 0.00219{0.0097}) with liquidity of quoted industrial goods firms in Nigeria.
2. Interest coverage ratio has a significant positive relationship (Coeff. = 0.00029{0.0124}) with liquidity of quoted industrial goods firms in Nigeria.
3. Total debt ratio has a non-significant negative relationship (Coeff. = - 0.00011{0.1260}) with liquidity of quoted industrial goods firms in Nigeria.

Conclusion

This study examined the relationship between financial leverage and financial stability of quoted industrial goods firms in Nigeria. The findings of this study contribute to the existing body of knowledge on the impact of financial leverage on the financial stability of firms. The study's outcomes have important implications for stakeholders, including investors, creditors, and managers of quoted industrial goods firms in Nigeria. The study suggests that financial leverage have a significant impact on the financial stability of firms, and therefore, firms should carefully manage their debt levels to ensure financial stability. The study's findings also highlight the need for policymakers and regulators to put in place effective regulations to guide the use of debt financing by firms in Nigeria.

Recommendations

The following recommendations are footprints of the study findings

1. To mitigate the negative impact of debt equity ratio on liquidity, quoted industrial goods firms in Nigeria should consider reducing their debt levels and increasing their equity base. This could be achieved through strategies such as debt restructuring, equity financing, and improving profitability to reduce dependence on debt.
2. Given the significant positive relationship between interest coverage ratio and liquidity, quoted industrial goods firms in Nigeria should prioritize improving

their interest coverage ratio. This could be achieved by increasing profitability, reducing interest expenses, and optimizing debt financing costs.

3. Although the total debt ratio has a non-significant negative relationship with liquidity, quoted industrial goods firms in Nigeria should still exercise caution when using debt financing. Firms should regularly review their debt levels and ensure that they are within manageable limits to avoid potential liquidity and solvency issues.

RECENT TRENDS ON MANAGEMENT OF SUSTAINABILITY ACCOUNTING AND FINANCIAL PERFORMANCE OF DEPOSIT MONEY BANKS IN NIGERIA FOR SUSTAINABLE DEVELOPMENT

ABSTRACT

This study examined recent trend in the sustainability accounting and financial performance of financial institutions in Nigeria, focusing on deposit money banks. The study employed quasi-experimental research design to establish the relationship that exists between sustainability accounting and financial performance indices (return on assets - ROA, return on equity - ROE, and earnings per share - EPS). Purposeful sampling technique was employed to select five (5) deposit money banks quoted on the Nigerian Stock Exchange and approved by the Central Bank of Nigeria. Secondary data, covering 2012 to 2021 financial years, were extracted from annual reports of the study sectors, using a content analysis method. The data are analyzed using SPSS, Version 23. Panel Ordinary Least Squares (OLS) regression method was employed in estimating the unknown parameters in the study's regression model after conducting diagnostic and preliminary tests to ascertain that the data set are reliable and not misleading. Empirical results showed that there is a negative non-significant relationship between sustainability accounting (SA) and the performance indices (ROA, ROE, and EPS) of deposit money banks in Nigeria. The study recommended that: only relevant information which increases the performance indices should appear on the disclosure checklist; sustainability accounting practices should be country-specific; and bank executives in Nigeria should increase and monitor the level of investment (resources, time, and energy) in order to ensure that sustainability accounting has significant impact on financial performance.

Background of the Study

The main outcomes from the UN Conference on Sustainable Development (Rio+20) in 2012 was international agreement to negotiate a new set of global Sustainable Development Goals (SDGs) to guide the path of sustainable development in the world after 2015 (UN, 2012; Melamed, 2012; Osborn, Cutter & Ullah, 2015). In 2012 the UN Secretary-General Ban Ki-

Moon established the 'UN System Task Team on the Post-2015 UN Development Agenda,' bringing together more than sixty (60) UN agencies and International Organizations to focus and work on sustainable development. On 31st July 2012, Ki-Moon appointed 26 public and private leaders to advise him on the post-MDGs agenda. Following series of meetings and consultations with experts, academia, research institutions, think tanks in Paris, Beijing, Seoul, Pretoria, Mumbai and Rio de Janeiro, the UN System Task Team in Bellagio, Italy proposed eleven (11) targets relating to future global development once the expire at the end of 2015 tagged 'Sustainable Development Goals (SDGs).' The SDGs are to be built upon the foundation of the MDGs combined with the post-2015 development agenda.

In September 2015, following the UN 70th anniversary in New York seventeen (17) goals were finally proposed till 2030 (Onuegbu, Onwuka & Obiah, 2015). Sustainable development is now a developmental model that tries to ensure integration between the economy and the environment, a practice that reflects the idea of meeting economic progress and environmental demands for the benefit of the society in the present but also in the future for the conservation of natural habitats and ecological conditions of life. This concept now allows a life in dignity for the present without compromising a life in dignity for future generations or threatening the natural environment and endangering the global ecosystem (Hani, Pinter & Herren, 2006). In the last few years, Corporate Social Responsibility (CSR) and Corporate Sustainability have become some of the major developments for global entities. The reason for this development is because of issues that can be defined as social and environmental concerns, which have been around in the accounting community, especially the academic accounting community, for decades. In 1976, there was an article titled: 'The Corporate Environmental Accounting System: A Management Tool for Fighting Environmental Degradation,' published in the first edition of the Journal Accounting, Organization and Society. In 1990, the Association of Chartered Certified Accountants (ACCA) supported the publication of Greening of Accountancy. The 1993 book Accounting for Environment is also a seminal work in this area (Kelsall, 2020).

Similarly, the first Environmental Accounts (EA) were constructed by Norway in the 1970s and were only slowly adopted by other countries. In the early 1990's, the World Bank conducted a review of (EA), providing a compendium of which countries had compiled environmental accounts, the methods that had been used to construct EA, and the extent of coverage (Glenn-Marie, 2003). KPMG, (2011) in the result of his study out of 100 top companies, 68% practice Sustainability Reporting, while Nigeria lack behind in the corporate sustainability reporting. The Federal Environmental Protection Agency 1988 (FEPA) was created and charged with the administration and enforcement of the environmental law. Nigeria approved Environmental Impact Assessment (EIA) Act, 2004 and other regulatory agencies that oversight over specific industries and issue guidelines that would regulate the impact of such industries on the environment, the Environmental Guidelines and Standards for the Petroleum Industry in Nigeria (EGASPIN) 2002, published by the Department of Petroleum Resources (DPR), etc. (see Adeusi & Dada, 2017; Kolapo, Ayeni & Oke, 2012).

However, the factors that effect on profitability of banks' have been well researched, though variables adopted as a proxy for profitability evolves among studies, the variables considered do change due to the reforms of the banking industry. Finance literature is replete with many studies that have adopted measures of profitability such as; Return on Asset (ROA), Return on Equity (ROE), number of Income Measure (NIM), Return on Asset (ROAA) etc. Financial performance of Deposit Money Banks is paramount because of the critical role the industry plays in the economy in terms of provision of financial intermediation, transmission mechanism of monetary policy and maintenance of economic stability. There is a problem of ascertaining if the sustainability reporting have impacted on the financial performance of DMB's in Nigeria.

Statement of the Problems

The sustainability standards are influencing entities to understand their strategic position in society, which has the power to influence behaviour and alter the state of physical, social and economic environment (Ezeagba, John-Akamelu & Umeoduagu, 2017). Sustainability is a

complex idea with many facets which includes social (having a fair deal with its workers as well as a mutually beneficial relationship with the encircling community), economic (should be a profitable business contributing a robust economy) and environmental (having potential to attenuate air, water and climate pollution, build and maintain healthy soil, manage water wisely and promote biodiversity) aspects. There has been little success so far in communicating to consumers the achievements as well as problems that financial performance of deposit money banks faces with regard to sustainability (Hani et al, 2006). In 1993, the United Nations Statistics Division (UNSD) elaborated a System of Integrated Environmental and Economic Accountancy (SEEA) in a handbook of national accounting. Sustainability financial reporting provides banks and other stakeholders with insight into ecological, social and economic aspects of farming and play a key role in advancing sustainability.

Similarly, the Global Reporting Initiative (GRI), located in Amsterdam in the Netherlands, developed out of the Coalition for Environmentally Responsible Economics (CEREs) and the United Nations Environment Programme (UNEP). GRI is a multi-stakeholder governed institution collaborating to provide the global standards in sustainability reporting. It recognizes the need for financial institutions to be accountable for their social, economic and environmental impacts and has put in place the financial services sector disclosures (Adegbei & Nwobodo, 2020). Globally, The International Accounting Standards Board (IASB) as well as the Global Reporting Initiative (GRI), overtime, continues to come up with guidelines for corporations to follow in making certain financial and non-financial disclosures, irrespective of the substance of such information to various stakeholders. In June 2000, the GRI published the first set of Sustainability Reporting which contained reporting principles and specific content indicators to guide the voluntary preparation of sustainability reports. The latest version of their reporting guidelines called third generation (G3), developed in 2006, contains detailed instructions and standards on how to prepare assured sustainability report. G3 sustainability reports include three types of standard disclosures: organized profile, performance indicators and management approach (Dilling, 2010).

Through sustainability accounting also named non-financial reporting entities show their strong commitment of continuous improvement of their sustainability reporting practices by using G3 guidelines. Today, sustainability reporting is growing at a fast pace. For Bergman, Henriksson and Kayvan (2010), the innovative upsurge of environmental reporting during the 1990's and the less keen re-emergence of social reporting from the mid-1990's has indeed provided a platform for sustainable reporting, albeit a rather shaky platform. Accounting is required to submit various types of user information on the financial position and performance of entities in the management of resources at their disposal (INTOSAI, 2011; Arowhegbe & Uniamikogbo, 2016). Therefore, a successful environmental management system should have a method for accounting for full environmental costs and should integrate private environmental costs into capital budgeting, cost allocation, process/product design and other forward-looking decisions (James, 1998).

Objectives of the Study

The main objective of the study is to examine the sustainability accounting and financial performance of deposit money banks in Nigeria. The following specific objectives guided the study to:

- i. Ascertain the effect of sustainability accounting on return on assets (ROA) of deposit money banks in Nigeria.
- ii. Investigate the effect of sustainability accounting on return on equity (ROE) of deposit money banks in Nigeria.
- iii. Appraise the effect of sustainability accounting on earnings per share (EPS) of deposit money banks in Nigeria.

Research Questions

The study achieved the above specific objectives by providing answers to the following pertinent questions:

- i. To what degree does sustainability accounting affect return on assets (ROA) of deposit money banks in Nigeria?
- ii. To what degree does sustainability accounting affect return on equity (ROE) of deposit money banks in Nigeria?
- iii. At what level does sustainability accounting affect earnings per share (EPS) of deposit money banks in Nigeria?

Statement of the Hypotheses

To proffer useful answers to the research questions and realize the study objectives, the following hypotheses are stated and tested:

Hypothesis One

H₁: Sustainability accounting have significantly influence return on assets (ROA) of deposit money banks in Nigeria

H₀: Sustainability accounting do not significantly influence return on assets (ROA) of deposit money banks in Nigeria

Hypothesis Two

H₁: Sustainability accounting significantly effect on return on equity (ROE) of deposit money bank in Nigeria

H₀: Sustainability accounting do not significantly effect on return on equity (ROE) of deposit money banks in Nigeria

Hypothesis Three

H₁: Sustainability accounting have significant influence on earnings per share (EPS) of deposit money banks in Nigeria

H₀: Sustainability accounting do not have significant influence on earnings per share (EPS) of deposit money banks in Nigeria

REVIEW OF RELATED LITERATURE

Conceptual Review

Sustainability Financial Reporting

Sustainability Accounting is a part of modern accounting, whose task is to provide management information for different hierarchical management levels, with a view to assessing the economic impact of the application of relevant regulations, standards, and protocols, whose task is to promote sustainable development. It is described as efforts towards tracking, recording and reporting of entity's interactions with its immediate environment and natural resources which should include effect of its activities and efforts towards ameliorating and replenishment of lost essential natural resources. It principally describes the preparation, presentation and communication of information related to an entity's interaction with the natural environment (Onyekachi, Ihendinihu & Azubike, n.d.).

Stipic (n.d.), defined sustainability accounting as the process of identifying, collecting, assessing, analyzing, internal reporting and using information on materials and energy, environmental costs and other environmental decision making data. For Senol and Ozcelik

(2012), sustainability accounting is the process of environment-based categorization of business activities, collecting, analyzing and then monitoring this environment-related activities, then put all this information into business financial position to help entity's decision making. Thus, it is financial data of any charges and benefits that arise from changes to an agricultural entity's products or methods where the change also involves a measure of changes in ecological influences from environmental cost, environmental assets and environmental liabilities. From the agencies, US Environmental Protection Agency in 1995 opined that at micro-level, environmental accounting means the entire domain of accounting for the environment including financial accounting, reporting and auditing and environmental management accounting (Igbodo, Uwague & Aigbadon, 2018).

Environmental Accounting Guidelines (2002) implied that the guideline aims at achieving sustainable development, maintaining favourable relationship with the community and pursuing effective and efficient environment conservation activities. These accounting procedures allow an entity to identify benefit gained from such activities, provide the possible means of quantitative measurement (in monetary value or physical units) and support the communication of its results. Bureau of Meteorology (2013) in Igbodo et al (2018) has it that environmental accounts are strongly structured tables that provide organized information for clearly defined decision making purpose. They are systematic and comparable, and use standard definition based on accepted measurement and accounting theory.

Social Responsibility Accounting is directly concerned with articulating or expressing the social and environmental impacts of entities, cost structure and economic performance of an entity. The concept of sustainability financial reporting seen as an important way of accounting for the social, environmental and ecological impacts of entities has at the same time been challenged as a buzzword, an umbrella term, an overarching measurement system, or a pragmatic stakeholder engagement process. These specific inter-relationships between the economic, social and sustainability have been spelt out as 'The Triple Bottom Line' an attempt to try and incorporate social and environmental concerns into the accounting valuation system and has struggled to bridge the concept of environmental and social values with a measurement figure (Kelsall, 2020). However, there is neither a single globally accepted definition of sustainability financial reporting nor a commonly accepted format that sustainability reporting should follow.

Sustainability accounting is what gives an overview of an entity's long term continuation and performance in relation to its sustainability involving governance, financial, anticorruption, social, etc. A sustainability financial reporting should provide a balanced and reasonable representation of the sustainability performance of the reporting entity disclosing entity's commitments, strategy and management approach. Attaining such goals as reducing environmental expenses, increasing revenues, and improving environmental performance requires paying attention to current, future and potential environmental costs. Sustainability financial reporting can support national income accounting, financial accounting or managerial accounting tool for internal business decisions.

Sustainability Accounting and financial performance

Financial performance analysis of deposit money banks has been of great interest to academic research since the Great Depression Intern in the 1940's (Mwengei, 2013). The significant changes that have occurred in the financial sector of developing economy like Nigeria have increased the importance of performance analysis of modern banks. Financial performance determines the firm's efficiency in resources utilization, in addition to its ability to make profit. This implies that a sound banking sector will remain firm and continue to provide the needed financial intermediation services. Thus, a healthy and sound banking sector enhances financial deepening, creates more employment opportunities and promotes financial stability. The performance evaluation of Deposit Money Bank, according to Rashid (2021) is done by measuring financial performance indicators, which include return on average equity (ROAE), return on average assets (ROAA) and net interest return (NIR). Thus, choice of the best measure of performance is tedious task (Ajayi & Ajayi, 2017). In other words, there are various

ratios used to measure financial performance namely the Asset ratios. The return on Assets (ROA), Operating Ratios- Return on Income (ROI) and operating Equity - Return on Equity (ROE), (Wachira, 2010). The advantage of the ROA and ROE ratios is the possibility to compare the effectiveness of the bank's operation between entities of different sizes. On the other hand, the new emission can make the ROE lower just by increasing the equity. ROA is sensitive to changes in the level of assets (Rutkowska-Ziarko, 2022). Financial performance shows the general well-being of an entity and its true financial position and also measured in terms of overall profits and losses or asset utilization. Researchers have been carried out on the determinants and impact of sustainability reporting where financial profitability/ratios are the proxies: ROA is assets used to support business operations and to determine whether the entity is able to generate an adequate return on these assets rather than simply showing robust return on sales. Return on asset is one of the profitability ratios used to measure financial performance. Financial Performance can be measured through profitability, and return on equity (ROE) has been used by researchers to measure profitability of entities.

Theoretical Framework

Stakeholder Theory

The stakeholders' theory was established by Professor Richard Edward Freeman in the 1980s. Precisely in 1983, Freeman, in his book "Strategic Management: A Stakeholder Approach", was the first to bring the stakeholder theory into public discuss. The key message in the stakeholder theory is that companies are expected to carry out their activities and take decision in the interest of every stakeholder, and not just to protect the interest of shareholders. Stakeholders have been identified as 'those groups who have an interest in the actions of the corporation (Freeman & Reed, 1983). The approach encompasses groups, individuals, government and other entities that have a sort of interest in the procedures and results of the entity, and upon whom the entity is influenced for the achievement of its goals. In addition to its establishment, Freeman (1984) is accredited with spreading the stakeholder theory and its concepts. The stakeholders' theory can best be looked upon as the motivation to carry out certain actions or activities because of the pressures coming from stakeholders. No matter the size of an entity, it would have stakeholders who influence its activities, and whom they want to please.

The stakeholders' theory has been developed and validated in management literature and studies based on its instrumental power, descriptive accuracy and normative validity as such, has advanced along three routes. The first route involves descriptive accuracy and it depicts the interface between the managers, entities and stakeholders. The second route brings in the instrumental stakeholder theory, connected to instrumental power, and highlights that if managers want to optimize the objective performance of their firms, they must take stakeholders' interests into account. The third route describes the normative validity; it depicts what managers ought to do. The stakeholder theory is an efficient way to look at the role of environmental sustainability in a lot of industries, as the pronouncements of these stakeholders can influence the success of an event through endorsement, sponsorship and capital. It encourages an efficient, practical, ethical and effective way to manage and supervise events in a highly complex and unpredictable environment.

Therefore, entities have begun to strive to develop the relationships and networks with their stakeholders, how well the relationship with the stakeholders is managed, will ensure the success of such entity. Accordingly, the idea that entities should maximize the wealth of stakeholders as reference to the stakeholder theory is justified by the fact that integrated reports provide more information to stakeholders than traditional financial statements. Therefore, the theory suggests that an entity should respond to the concerns and expectations of powerful stakeholders, which one of the responses will be in the form of environmental disclosures. The primary rationale for disclosure of environmental information is to comply with the expectations of key stakeholders such as government/regulatory authorities, shareholders, host communities, customers, general public, among others.

Review of Empirical Studies

Previous studies have been carried out on sustainability reporting as they affect DMB's performance in Nigeria and beyond. The findings of these studies give diverse views and different correlations. Krivačić and Janković, (2017) opined that environmental reporting is regarded as logical and holistic statements of environmental effort of a corporate organization through its activities which based at environmental policies, objectives, programs and their outcomes. (see Millar & Searcy, 2020; Ebieri, 2018; Huang & Fu, 2019)

Abiola, Yahaya, Adeyemo and Adeyemi (2024), looked at sustainability reporting and firm value of listed deposit money banks in Nigeria. An ex post facto research design was used in the study. The variance inflation factor was used to conduct the multicollinearity test. The financial statements of the chosen listed banks provided the data series, which spanned the years 2018 to 2022. The results showed that ECS, ENV, SOC with coefficient 0.0069, 0.2802, 0.2235 and p-value 0.879, 0.011 and 0.012 are positively significant at 1%, 5% & 10% respectively to the value of the listed deposit money banks in Nigeria. A unit increase or decrease of these variables will also cause an increase or decrease in the firm value of selected banks. It implies that the explanatory variables used in the model were highly relevant. The study therefore concluded that sustainability reporting have value relevance to deposit money banks in Nigeria.

Taiwo, Owowlabi, Adedokun and Ogundajo (2022), examined the effect of sustainability reporting on the market value growth (MVG) of quoted companies in Nigeria. The study adopted an ex post facto research design with 167 listed firms as the population. A total of 28 quoted firms were chosen with the use of purposive sampling. Data from 2009 to 2018 were obtained from secondary sources. Content analysis was used as a tool to analyze the disclosures in sustainability reports, and the study found that the compliance level of the sampled firms with sustainability reporting requirements for the four dimensions is below average, and sustainability reporting does not have a significant effect on MVG.

Natalia and Cristina (2021), examined the effect of fundamental factors and sustainability reporting on firm value in Indonesia. The study also investigates the moderation effect of corporate governance on the relationship between fundamental factors, sustainability reporting, and firm value. The study population consists of all companies listed on the Indonesia Stock Exchange and indexed in IDX30 throughout 2014–2020. The result of panel data regression analysis revealed that profitability and leverage as fundamental factors affect firm value. This study also found that good corporate governance moderates the effect of the fundamental factors on firm value. However, sustainability reporting cannot increase firm value.

Akpan and Simeon (2021), examined the effect of sustainability disclosures on cash flow return on investment of shareholders of oil and gas companies in Nigeria. The secondary source of data was used and the research design adopted was ex post facto. The study adopted a time series and cross-sectional analysis of selected oil and gas firms quoted on the Nigeria Stock Exchange as of 31st December 2020 for a period of seven years, spanning 2014-2020. Content analysis methodologies were employed to get data for the sustainability parameters. The results from the study revealed that social sustainability disclosure has a positive significant effect on the cash flow return on investment of listed oil and gas firms in Nigeria; health and safety and that environmental disclosure have an insignificant effect on cash flow return on investment of the studied companies.

Saygili, Arslan & Birkan (2021), conducted an empirical literature review on the relationship between environmental, social, and governance (ESG) practices and corporate financial performance. Corporate financial performance was considered as the regress and variable, while ESG practices served as the regressor variables. The authors also considered other independent variables, such as firm size, age, and industry, that could affect the relationship between ESG practices and financial performance. By systematically reviewing 93 articles

published from 2010 to 2019, the study revealed that ESG practices have a positive impact on corporate financial performance.

Olowookere, Twaiwo and Ayuba, (2021) examine environmental accounting disclosure practices and financial performance. Data were sourced from three annual report and accounts of three cements companies listed on the Nigerian Stock Exchange from 2011 to 2019. Descriptive statistic and estimated panel regression methods were employed. The results of the study revealed that environmental accounting disclosure has positive and significant impact on firm financial performance on return on equity and return on assets of three Cements companies in Nigerian Stock Exchange.

Akpan and Emenyi (2020), investigated the effect of the triple bottom-line reporting on the financial and operating performance of oil and gas firms in Nigeria. Data used in the study were mainly secondary obtained from the Nigeria stock exchange fact book and annual financial statements of oil and gas companies. A disclosure checklist based on GRI guidelines was developed, and the research design adopted was ex post facto. The results showed that triple bottom line reporting has a significant effect on earnings per share (EPS), return on equity (ROE) and return on total assets Using a hand-collected representative sample of 95 publicly traded American firms from various sectors from 2015-2016.

Adegbei and Nwobodo (2020), examined Environmental Accounting & Reporting Practices: Significance and Issues: A Case listed Deposit Money Banks (DMBs) in Nigeria is based on primary data. The primary data were collected from the total number of 34 Accountants, taking two from each company. The main findings of the study revealed that the respondents have felt the strong significance of EA (Environmental Accounting) and ER (Environmental Reporting) in their Annual Reports; the respondents have also been aware for EA and ER practices; the respondents have identified some major problems involved in EAR (Environmental Accounting and Reporting) practices. From the above discussions, it is clear that EAR practices in DMBs is highly significant but not too satisfactory as there are many issues hindering them from carrying out best practices in EA and ER and hence poor in real sense of the term. Therefore, in order to improve the EAR practices in the DMBs, the proper authority need to implement the suggestions put forward by the respondents without any further delay.

Okolie and Igaga (2020), examined how sustainability reporting is useful for assessing the financial performance of listed Deposit Money Banks in Nigeria. Specifically, the study focuses on the economic, environmental and social dimensions of sustainability reporting using “Return on Assets”, “Return on Equity” and “Earnings per Share” as proxies for financial performance of Deposit Money Banks in Nigeria from 2012 to 2018. The sample of the study was restricted to seventeen deposit money banks out of twenty-one Banks quoted on the Nigerian Stock Exchange as at December, 2018. The required data were collected from audited annual financial statements and “sustainability reports” of the selected Deposit Money Banks for the period. A detailed analysis of the three bottom lines of profit (economic), people (social) and planet (environmental) impact was conducted. The descriptive and least squares regression analysis were adopted for the study considering the banks’ sustainability reporting practices against the selected performance proxies. The study concludes that sustainability reporting practices of Banks in Nigeria have substantial impacts on the financial performances of Deposit Money Banks in Nigeria (Onyekachi, Ihendinihu & Azubike, 2020).

Kabiru (2020), examined the influence of firm characteristics on environmental disclosure quality of listed Cement companies in Nigeria. With annual reports and accounts of the listed cement companies for the period of 2013 – 2017 financial years. Variables used were firm size, firm age and leverage proxy for firm characteristics. A content analysis was adopted using Global Initiative Reporting as index of disclosure and the study analyzed the data using descriptive statistics, correlation and multiple regression technique. The findings revealed that firm age, firm age and leverage has a significant impact on quality of environmental disclosure of listed cement companies in Nigeria ((Ezeagba, Rachael & Chiamaka, 2017; Menike, 2020; Ezeagba, Rachael & Chiamaka, 2017).

METHODOLOGY

This study adopted quasi-experimental research design. A quasi-experimental design aims to establish a cause-and-effect relationship between an independent and dependent variable. This study focuses on 23 listed deposit money banks quoted on the Nigerian Stock Exchange and approved by Central Bank of Nigeria as at 31st June, 2020. Considering the complex nature of the data set to be collected, purposive sampling technique has been employed in selecting five (5) deposit money banks for this study. The banks were selected based on assets size; categorization banks that have the largest assets as at 2020 financial year end were adjudged suitable. The following banks met the selection criteria and therefore qualify to be among the five (5) study sample: Fidelity bank plc, Zenith bank plc, United Bank for Africa plc, Access bank plc, First bank plc. Panel Ordinary Least Square (OLS) multiple regression is adopted to examine the effect of sustainability reporting on financial performance of deposit money banks in Nigeria for the financial periods of 2012 to 2022. The study uses Statistical Package for Social Sciences (SPSS) as software for data analysis. Multiple regression analysis is basically concerned with the study of how more than one explanatory or independent variables (regressors) affect the dependent variable. Autocorrelation and Multicollinearity Tests) were conducted so as to establish whether or not the models are in line with basic econometric assumptions.

Model Variable

The variables are structured into dependent and independent variables. Sustainability accounting form the independent variable of the study. While financial performance on return on assets, return on equity and earnings per share are the dependent variable of the study. To achieve the objectives of the study, three multiple regression models relating proxies of the independent variable (sustainability reporting) to the proxy of dependent variable (financial performance) are presented below for empirical analysis. The generic model of the study is as follows;

BC = Bank Category (control variable)

β_0 represents the constant term or intercept of the relationship in the model. The coefficient β_1 , represents the intercept for the independent variable (sustainability reporting), while μ represents the stochastic or error term.

Results Presentation

Ordinary Least Squares (OLS) Results

The empirical results of the panel OLS relationship between sustainability reporting and financial performance of deposit money banks in Nigeria is hereunder presented in table 1 to 3 using the estimation approach.

Test of Hypotheses

Decision Rule The null hypothesis (H₀) is rejected if the calculated value of any of the statistical tools adopted in this study is greater than the critical/table value, at 5% level of significance, otherwise H₁ is accepted. Alternatively, if p-value (Sig. column) is equal to or

less than 5%, we reject the null hypothesis (H₀) and accept the alternative hypothesis (H₁), otherwise the H₀ is accepted.

Table 4 shows the acceptance of the three null hypotheses as the p-values of the t-statistics are lower than 0.05 (non-significant at 5% significance level). The conclusion therefore follows that sustainability reporting (SR) has no significant effect on all the financial performance, including: return on assets, return on equity, and earnings per share of the deposit money banks under study. **Summary of Findings** This research work focused on the effect of sustainability reporting on financial performance of deposit money banks in Nigeria from 2012 to 2021.

Discussion of Result

The study's data are analyzed using SPSS (version 23), a statistical package for data analysis, and the empirical results are presented below. The annual reports of the study banking sector in Nigeria constitute the secondary data sources spanning from 2012 to 2023, which discloses the average return on assets, return on equity, earnings per share, total assets (bank category), and sustainability reporting of the study sectors from 2012 to 2021. These served as input data which produced the regression results. Interpretation and discussion of the empirical results are hereunder presented in line with the three models adopted in this study. Using the pooled form of the data, the serial correlation test was performed in a bid to detect the presence of autocorrelation. The serial correlation test (Durbin-Watson) statistics are closer to 2. This implies that there is no autocorrelation in the sample since the calculated values of DW for the three models (being 2.115, 1.951, and 2.316) falls between lower critical levels; hence we reject the hypothesis that the computed DW statistic is significantly different from 2. It can therefore be said that the study's empirical results are adjudged reliable and not misleading. From the regression results the values of Variance Inflation Factors (VIF) computed remained 1.018, which is consistently smaller than ten (10). This implies that the study's data set has no multicollinearity issue; hence the regression output is not biased.

Summary of Findings

The findings of the study revealed the following:

1. Sustainability reporting has a negative non-significant relationship with return on assets (ROA) of deposit money banks in Nigeria. Also, bank category had non-significant control in the effect of sustainability reporting on ROA.
2. Sustainability reporting has a negative non-significant relationship with return on equity (ROE) of deposit money banks in Nigeria. Again, bank category failed to exhibit a significant control in the effect of sustainability reporting on ROE.

3. Sustainability reporting is negatively and non-significantly related to earnings per share (EPS) of deposit money banks in Nigeria, with bank category having a significant control in the effect of sustainability reporting on EPS.

CONCLUSION AND RECOMMENDATIONS

This study examined sustainability reporting on financial performance of deposit money banks in Nigeria. The result shows that the explanatory variable included in the study's model account for 46.1%, 38.3%, and 61.7% variation in the dependent variables (being ROA, ROE, and EPS respectively), implying that the remaining 53.9%, 61.7%, and 38.3% variation in the sectors' ROA, ROE, and EPS (financial performance indices) are attributable to factors or variables not captured in the study's model. Therefore, the need for sustainability reporting as an aspect of sustainable development is rapidly gaining momentum, especially considering the fact that various stakeholders are not relenting in their quest to know how entities disclose information on how production and business activities affect the environment and larger society. The study concludes that sustainability reporting practices have negative and non-significant effect on financial performance of deposit money banks in Nigeria. As a result, the cost and time invested by deposit money banks in making sustainability reporting should be closely monitored as the outcome has little or unfavourable impact on performance of the banks.

Based on the findings of this research work, the following recommendations are put forward:

1. Regulatory agencies that issue disclosure guidelines should ensure that only relevant information that translate to increase in performance should appear on the disclosure checklist.
2. Although, standard practice requires that information on sustainability practices be disclosed using global reporting index tables, there is need for such disclosures to be country-specific. In other words, every country should be allowed to design the benchmark, rules and guidelines that suit her environment and rating.
3. While it is advocated that firms should have positive disposition towards ecological friendly practices and also disclose more of this information in their annual reports, there is need for company/sectors executives to monitor the level of investment (resources, time, and energy) being sacrificed in making such disclosures as it has non-significant effect on financial performance.

STAKEHOLDERS' COLLABORATION AND EFFECTIVE FUNDING OF COOPERATIVE SOCIETIES IN NIGERIA

ABSTRACT

Background: Effective funding remains a significant challenge for cooperative societies in Nigeria, despite their recognized role in financial inclusion and grassroots economic development. This study investigates the influence of stakeholder collaboration, trust and communication, and institutional and technological support on the effective funding and financial sustainability of cooperative societies. **Objective:** The primary objective is to examine how stakeholder engagement and supportive mechanisms affect funding accessibility and sustainability in Nigerian cooperatives, while addressing gaps in integrated empirical research. **Methodology:** The study adopts a quantitative research design using a structured survey instrument distributed across a stratified sample of cooperative societies in Nigeria. Data were analyzed using Ordinary Least Squares (OLS) regression and supported by robust statistical diagnostics. Key variables include Effective Funding (EF), Stakeholder Collaboration Index (SCI), Institutional Support (IS), Trust and Communication (TC), Stakeholder Commitment (SC), Years of Operation (YO), and Total Assets (TA). Construct validity was assessed using Cronbach's Alpha, Composite Reliability, and Average Variance Extracted (AVE). Multicollinearity and heteroscedasticity were evaluated using the Variance Inflation Factor (VIF) and Breusch-Pagan test, respectively. **Findings:** The results indicate that stakeholder collaboration, trust and communication, and institutional-technological support significantly influence effective funding. Trust-based communication channels and digital innovations emerged as strong predictors of funding accessibility and sustainability. **Conclusion:** Findings reinforce the need for integrated stakeholder frameworks, transparent communication, and digital support systems to enhance cooperative funding outcomes in Nigeria.

1. Introduction

Cooperative societies are globally recognized as vital instruments for socioeconomic development, especially in developing nations where formal financial institutions often fail to meet the needs of low-income populations. In Nigeria, cooperative societies serve as financial intermediaries, enabling grassroots participation in economic activities, credit access, and poverty alleviation. However, despite their potential, the sustainability and impact of cooperatives remain hindered by inadequate funding and weak collaboration among stakeholders (Olayiwola & Adeleke, 2020; Abiona & Bello, 2019; Udounwa, Nseobot &

Ekpenyong, 2025). Stakeholders, including government agencies, financial institutions, NGOs, private sector actors, and cooperative members, play a central role in ensuring effective funding and capacity development (Okezie et al., 2013; Emefiele, 2017). This study investigates how stakeholder collaboration affects the effectiveness of funding in Nigerian cooperative societies, drawing insights from national and global research.

Empirical studies highlight that a lack of collaboration between stakeholders often results in fragmented support systems and duplication of efforts. For instance, Adebayo and Yusuf (2018) noted that many Nigerian cooperatives operate in silos with little or no synergy between key stakeholders, leading to resource underutilization and funding gaps. Similarly, Onwumere and Eze (2016) found that government intervention programs such as the Micro, Small and Medium Enterprises Development Fund (MSMEDF) failed to reach many cooperatives due to poor stakeholder coordination. On the international front, Birchall (2013) argued that in countries like India and Kenya, strong alliances among stakeholders led to improved financial inflows and cooperative performance. In Bangladesh, stakeholder involvement in microfinance cooperatives was instrumental in the success of Grameen Bank (Yunus & Moingeon, 2010). These comparisons suggest that collaborative mechanisms can enhance cooperative financing outcomes in Nigeria if appropriately structured.

The effectiveness of cooperative funding is not merely a function of capital availability but also of the institutional frameworks that govern stakeholder relationships. According to Okwoli and Dada (2017), most Nigerian cooperatives face bureaucratic bottlenecks in accessing government loans, partly due to misaligned priorities among stakeholders. Research by Afolabi and Olagunju (2015) also highlighted the absence of structured platforms for dialogue among cooperatives, banks, and government agencies. Conversely, studies in Europe show that cooperatives thrive in environments where policies support multi-stakeholder governance. For example, in Italy, stakeholder-inclusive funding mechanisms have led to the rapid growth of agricultural cooperatives (Zamagni & Zamagni, 2010). In Canada, the Desjardins Group's collaboration model with stakeholders has served as a global best practice in cooperative financing (Chouinard & Veilleux, 2019). These international successes underscore the potential benefits of structured stakeholder engagement for Nigerian cooperatives.

Poor funding and disjointed stakeholder engagement continue to threaten the viability of cooperatives in Nigeria's rural and urban settings. Uzonwanne (2015) emphasized that the lack of trust among stakeholders, especially between cooperatives and financial institutions, limits long-term funding opportunities. Similarly, Oluyombo (2010) found that commercial banks are reluctant to fund cooperatives due to perceived high default risks and weak governance structures. International studies support this notion; for instance, ICA (2018) reported that successful funding models in countries like Spain and Brazil are underpinned by institutional trust and collaborative funding schemes. In Uganda, integrated stakeholder approaches have enhanced the efficiency of Savings and Credit Cooperative Organizations (SACCOs), providing a useful model for Nigeria (Majurin, 2012; Kyazze & Kibanja, 2017). These examples highlight that trust-based collaboration is fundamental to attracting sustainable cooperative funding.

The theoretical lens of stakeholder theory (Freeman, 1984) offers an analytical framework for understanding the interconnectedness among cooperative actors. This theory posits that organizational success depends on satisfying the interests of all stakeholders, not just shareholders. Applied to cooperatives, the theory emphasizes the need for inclusive decision-making and mutual accountability. Studies by IHEMEJE et al. (2020) and Oboh and Ekpebu (2011) support this view, stressing the importance of inclusive governance in cooperative operations. Globally, stakeholder-inclusive models have been linked to improved access to finance and better cooperative performance (Wanyama, 2014; Zeuli & Cropp, 2004; Udounwa, Nseobot & Ekpenyong, 2025). For instance, in South Korea, the government's collaboration with private actors and cooperatives through the National Agricultural Cooperative Federation (NACF) has led to robust cooperative financing structures (Kim & Mahone, 2020). These models reinforce the need for stakeholder synergy as a lever for funding effectiveness.

Digitalization and innovation have also emerged as enablers of stakeholder collaboration and cooperative funding. Nigerian studies by Adegbite and Machethe (2018) as well as Yusuf and Peters (2021) highlight the role of fintech in reducing transaction costs and improving transparency in cooperative financing. However, the lack of digital literacy among cooperative members and limited digital infrastructure remain critical constraints (Nwankwo et al., 2020). Internationally, countries like Rwanda and the Philippines have adopted digital platforms to facilitate stakeholder interaction, real-time reporting, and efficient fund disbursement (Munyegera & Matsumoto, 2016; Llanto, 2015). These technological innovations show that improved digital collaboration among stakeholders can significantly enhance cooperative funding and governance in Nigeria.

1.2 Problem Statement

Despite the increasing recognition of cooperative societies as a vital tool for grassroots economic empowerment in Nigeria, their access to sustainable funding remains severely constrained. A key contributor to this persistent challenge is the fragmented and often ineffective collaboration among critical stakeholders government agencies, financial institutions, private sector actors, NGOs, and cooperative members. These groups often operate in isolation with limited coordination, leading to duplication of efforts, underutilization of resources, and poor policy implementation. Many government funding schemes, such as the Micro, Small, and Medium Enterprises Development Fund (MSMEDF), fail to trickle down to cooperatives due to bureaucratic bottlenecks and weak institutional synergy. Furthermore, financial institutions often perceive cooperatives as high-risk borrowers due to poor record-keeping, lack of collateral, and governance issues. At the same time, cooperative members frequently lack the financial literacy or digital skills required to engage with modern funding platforms. These systemic weaknesses are compounded by trust deficits, unclear stakeholder roles, and limited innovation in financing models. While previous studies have examined cooperative performance, governance, and access to finance independently, few have provided an integrated analysis of how stakeholder collaboration directly impacts funding effectiveness. Moreover, there is limited empirical research addressing how digitalization, trust, and inter-agency coordination shape cooperative funding in the Nigerian context. This study seeks to fill that gap by exploring the relationship between stakeholder collaboration and the effective funding of cooperative societies in Nigeria. Thus, this study aims to address the following core research questions:

1. To what extent does stakeholder collaboration influence the effective funding of cooperative societies in Nigeria?
2. What is the role of trust, communication, and stakeholder engagement in enhancing funding accessibility for cooperative societies?
3. How does the level of institutional and technological support from stakeholders affect cooperative societies' financial sustainability?

2. Literature Review

2.1.1 Concept of Cooperative Society

The term cooperative is derived from the Latin word *co operatic*, where the word *co*-means "with" and *opera* means "to work" thus cooperative means working together. So those who want to work together with some common economic objective can form a society, which is term as cooperative society" it is a voluntary association of persons who work together to promote their economic interest (Eucharia, 2018). The International Cooperative Alliance (ICA) in its Statement on the Cooperative Identity, in 1995, defines a cooperative as "an autonomous association of persons united voluntarily to meet their common economic, social, and cultural needs and aspirations through a jointly-owned and democratically-controlled enterprise." It is a business voluntarily owned and controlled by its member patrons and operated for them and by them on a nonprofit or cost basis. The International Labour Organization (ILO) in 2004, define cooperative societies as an association of persons usually of limited means who have

joined together to achieve common economic goals through the formation of democratically controlled business organization, making equitable contribution to the capital required and accepting a fair share of risk and benefit of undertaken. On the other hand, the Food and Agricultural Organization (FOA) in 2003, put it that cooperative society is “a group of persons with at least one economic interest variable member”. The aim of the group is to meet their common economic needs by joint action based on mutual help (Eucharia, 2018; Ekpenyong, Udounwa & Nseobot, 2025).

2.1.1.1 Types of Cooperative Societies

Although all types of cooperative societies work on the same principle, they differ with regard to the nature of activities they perform. Followings are different types of cooperative societies:

Productive Co-operative society: These societies are formed to protect the interest of small producers by making available items of their need for production like raw materials, tools, and equipment, machinery etc. Members of this society like farmer and other producers contribute money in order to buy or hire equipment, machinery and raw materials at reduced rates meant for the promotion of their product activities.

Services cooperative society: These societies are formed to protect the interest of general members by making goods available at a reasonable price. They buy goods directly from the producers or manufactures and thereby crimate the middlemen in the process of distribution. Examples of service cooperative societies are the consumer cooperative society and cooperative marketing society.

Multipurpose cooperative society: These are societies which are engage in various activities and business such as farming, housing, issuing of loans and production of goods. Members, who belong to this society, derived a lot of benefits. Some of the benefits are of large scale farming, loans are given at a reasonable rate of interest in times of need to buy land and construct houses, and the issue of collateral security is reduced.

2.1.2 Traditional Sources of Funding Cooperative Societies

Cooperative societies in Nigeria have historically relied on traditional funding mechanisms rooted in mutual aid, member contributions, and community-based solidarity. These sources have been fundamental in sustaining the grassroots nature of cooperatives and enabling them to offer credit, savings, and welfare services to their members, particularly in rural and underserved areas.

1. Member Contributions and Savings: The most fundamental source of funding for cooperative societies in Nigeria is the regular savings and contributions from members. These include monthly dues, membership fees, and compulsory savings, which form the internal pool of funds that is used for lending and reinvestment. According to Oluyombo (2013), member contributions account for more than 70% of the operating capital in most cooperative societies in Nigeria. These internal funds are vital for ensuring financial independence and reducing reliance on external credit facilities. This method is also cost-effective, since it avoids the interest and collateral conditions associated with formal lending institutions.

2. Thrift Collections and Rotating Savings (Esusu): Another widely used traditional funding method is the thrift collection or Esusu system, a form of rotating savings and credit scheme (ROSCAS) common in many Nigerian communities. Members make regular contributions, and the pooled funds are given to one or more members on a rotating basis. As noted by Adeyemo and Bamire (2005), Esusu-style schemes within cooperatives improve financial discipline, social trust, and savings culture. Although informal in structure, such systems have evolved to become embedded within formal cooperative frameworks across states in Nigeria.

3. Loan Repayments and Interest Earnings: Cooperatives also reinvest repayments from loans issued to members, including the interest income generated from these loans. The

interest rates charged are typically below commercial bank rates, designed to ensure affordability while still allowing cooperatives to generate income. Ekezie (2007) explains that internal loan repayments and interest income provide sustainable liquidity, allowing cooperatives to recycle capital within the group and expand outreach over time.

4. Registration and Admission Fees: Many cooperative societies require entry fees or registration fees from new members, which form part of their working capital. Although these fees are typically nominal, in larger cooperatives with high membership turnover, they can cumulatively represent a modest funding base. According to Okonkwo and Obasi (2019), admission fees accounted for approximately 5–10% of the startup capital for newly registered cooperatives in Southeastern Nigeria.

5. Fines and Penalties: Some cooperative societies also generate revenue through fines for late payments, missed meetings, or violations of by-laws. While not a sustainable or primary source of funding, fines can help instill discipline and contribute marginally to cooperative reserves. As Oboh and Ekpebu (2011) noted in their study of agricultural cooperatives in Benue State, societies with structured penalty systems often had more consistent repayment performance and slightly higher capital reserves.

6. Voluntary Donations and Member Equity: Occasionally, members make voluntary donations or inject equity capital into cooperative projects. This is more common in housing cooperatives or those involved in capital-intensive ventures. Such voluntary equity increases the financial base and also fosters a sense of ownership and accountability among members (Afolabi & Gimba, 2013).

7. Community Support and Informal Partnerships: In rural areas, cooperative societies may receive informal support from community leaders, local religious institutions, or extended family networks in the form of grants, land donations, or infrastructure. These non-monetary contributions, though not recorded in balance sheets, enhance the operational viability of many grassroots cooperatives (Nweze, 2002).

2.1.3 The Role of Stakeholder Collaboration in Cooperative Financing

Several empirical studies underscore that coordinated stakeholder efforts significantly affect funding outcomes for cooperatives. Abdullahi (2018) emphasizes that cooperative societies in Nigeria provide a robust platform for micro- and small-enterprise financing, but they require more integrated policy action and legal frameworks to optimize stakeholder cooperation (Eucharia, 2018). Similarly, the closing-the-financing-gap analysis by Aziz and Shah (2020) highlights that weak coordination among government, microfinance banks, and cooperatives leads to inefficient fund distribution. Internationally, literature on participatory budgeting reinforces that stakeholder inclusion yields more equitable resource allocation insights that can inform cooperative financing mechanisms. Meanwhile, studies of collaborative partnerships in developing economies reveal that poor infrastructure and funding unpredictability are major obstacles to effective cooperation (Vazquez-Brust, Sarkis & Cordeiro, 2014; Eucharia, 2018). Collectively, the evidence shows that multi-stakeholder engagement is vital for sustainable cooperative funding, pointing to a need for institutionalized collaboration frameworks. Based on the above reviews, this study proposes Hypothesis 1:

H₀₁: Stakeholder collaboration has no significant influence on the effective funding of cooperative societies in Nigeria.

2.1.4 Trust, Communication, and Governance in Funding Accessibility

Trust and communication are frequently cited as essential enablers in cooperative funding access. A national case study in Northeast Nigeria reports that trust-based relationships within cooperatives lead to improved credit access and stronger member commitment (Onah, Onyia, Nnadi, Obeta & Onyekwe, 2025). In Southwest Nigeria, Umar, Mustafa, Sidek and Lau (2021) found that membership in cooperative societies boosts rural incomes by about 10%, indicating that transparent communication channels encourage broader participation. Internationally,

seminal research by Majeed, Kayani and Haider (2021) and Magoola, Mwesigwa and Nabwami (2021) confirms that higher trust levels are linked with better cooperative performance, ultimately improving access to funds and decreasing default risk. These insights reinforce the hypothesis that trust and effective communication among stakeholders are instrumental in facilitating cooperative financing. Hartono, Musdholifah, Arifah, Dhenabayu and Kusumaningrum (2021) exemplify that the inconsistent findings regarding trust and performance deserve further examination of the implications of the quality of corporate governance on the level of trust among stakeholders. Most studies on the relationship between trust, performance, communication and governance have focused on financial performance (Buvik & Tvedt, 2016; Ali & Khalid, 2017), like external financing (Yu et al., 2023), in terms of bank credit (Kehinde and Ogundeji (2022). Based on the above reviews, this study proposes Hypothesis 2:

H₀₂: Trust, communication, and stakeholder engagement do not significantly enhance funding accessibility for cooperative societies.

2.1.5 Institutional and Technological Support for Financial Sustainability

The role of institutional and technological systems in enhancing cooperative viability has gained significant attention. In Nigeria, studies show that digitization initiatives in cooperatives such as ICT tools for record keeping and fund transfers improve operational efficiency (Elee, 2021). In Anambra State, Obiageli and Oranusi (2024) demonstrate that increased digital literacy programs within cooperative societies promote member inclusion and financial access during economic stress. Technological adoption in Southeast and South-South Nigeria also correlates communication campaigns with higher uptake of digital banking. These findings indicate that stakeholder-backed institutional supports, especially technical and training interventions significantly influence sustainability and funding accessibility in cooperatives through digitalization (Onuegbu, Agbamu, Anyakoha & Anunike, 2025). Based on the above reviews, this study proposes Hypothesis 2:

H₀₃: Institutional and technological support from stakeholders does not significantly affect the financial sustainability of cooperative societies.

2.1.6 Governance and Member Engagement Dynamics

Research underscores that transparent governance and active member participation significantly shape financial performance. In credit cooperatives across South-South Nigeria, Lilian (2024) found strong positive links between governance practices, member engagement, and financial outcomes. Similarly, a 2021 study on agricultural cooperatives reveals that cognitive trust between members and management sustains member retention and contributes to the cooperative's long-term stability. These findings suggest that stakeholder strategies promoting governance transparency and democratic engagement can improve cooperative funding performance through enhanced accountability and member-centered practices (Awoke, 2021).

2.2 Theoretical Framework

The study is anchored on three interrelated theories: Stakeholder Theory, Resource Dependency Theory (RDT), and Social Capital Theory. Together, they provide a robust theoretical basis for understanding how stakeholder relationships, institutional support, and trust dynamics influence the effective funding of cooperative societies in Nigeria.

2.2.1 Stakeholder Theory

Developed by Freeman (1984), Stakeholder Theory posits that organizations exist within a web of relationships involving various actors, including employees, investors, suppliers, communities, and government bodies. In the context of cooperative societies, stakeholders include members, government agencies, financial institutions, NGOs, and donor organizations, all of whom influence and are influenced by cooperative funding mechanisms.

According to Harrison, Freeman, and Abreu (2015), effective stakeholder engagement fosters mutual accountability, resource-sharing, and legitimacy, which are essential for cooperatives to access sustainable funding. In a study on rural development projects in India, Srivastava and Bhatia (2020) found that participatory stakeholder models significantly enhanced the efficiency of cooperative credit distribution. Similarly, Oluyombo (2022) in Nigeria emphasizes that a lack of clarity in stakeholder roles undermines funding success in rural cooperative banking initiatives. These insights support the study's first hypothesis, which examines the extent to which collaborative stakeholder efforts influence funding outcomes.

2.2.2 Resource Dependency Theory

Resource Dependency Theory (RDT), articulated by Pfeffer and Salancik (1978), argues that organizations must engage with external actors to access critical resources, thereby reducing environmental uncertainty. Cooperative societies, often limited in internal capital, depend on external funding sources such as government subsidies, bank credit, donor grants, and technological infrastructure. RDT explains the strategic need for alliances, lobbying, and partnerships among stakeholders to ensure access to these vital resources. Evidence from Muriithi and Wanyoike (2016) in Kenya illustrates how SACCOs (Savings and Credit Cooperatives) that strategically align with government microcredit schemes perform better in terms of liquidity and member outreach. Similarly, Afolabi and Abdulraheem (2021) demonstrate that cooperatives in Southwestern Nigeria that engage in joint resource planning with development finance institutions experience improved funding sustainability. Thus, RDT underscores the importance of stakeholder collaborations as a mechanism for reducing financial risk and securing external support.

2.2.3 Social Capital Theory

Social Capital Theory, particularly as developed by Coleman (1988) and Putnam (1993), emphasizes the importance of trust, norms, and networks in enabling collective action. Within cooperative societies, social capital is manifested through trust among members, transparent communication, and mutual support. This theory is particularly relevant to the study's second hypothesis, which explores how trust, communication, and stakeholder engagement affect funding accessibility. Empirical findings by Mzoughi and Boulila (2020) in Tunisia indicate that cooperatives with high levels of bonding and bridging social capital have greater success in securing loans and external support. In Nigeria, Okeke and Eze (2018) reported that trust within cooperative networks significantly increases loan repayment rates and attracts new funding partners. These findings suggest that fostering social capital among cooperative stakeholders is not only a moral imperative but also a strategic necessity for financial sustainability. Moreover, the work of Nwankwo, Ewuim, and Asoya (2012) further supports the theory's applicability in Nigeria. They argue that lack of social trust between stakeholders, especially between cooperative members and external agencies leads to fund mismanagement and project failures. Incorporating social capital into the theoretical framework enhances our understanding of why some cooperative societies thrive while others fail despite similar resource environments.

2.2.4 Framework Justification

The integration of Stakeholder Theory, Resource Dependency Theory, and Social Capital Theory provides a multidimensional lens through which to examine the effective funding of cooperative societies. While Stakeholder Theory addresses who matters and why, RDT explains how resource constraints motivate cooperative-stakeholder engagement, and Social Capital Theory illuminates the trust-based mechanisms that drive collaboration and information flow. This theoretical combination is consistent with similar interdisciplinary frameworks employed in studies by Allee (2017) and Onuoha & Okolie (2020), which demonstrate that multi-theory models better explain cooperative outcomes in complex socio-economic environments.

2.3 Empirical Review

Empirical findings highlight substantial links between multi-stakeholder collaboration and funding outcomes in cooperative settings. In Uganda, Mubiru and Sekiziyivu (2019) used panel data from 60 rural SACCOs to show that cooperatives engaged in formal partnerships with both local government and microfinance institutions enjoyed 32% greater loan disbursement rates, attributing it to coordinated resource mobilization and public-private cooperation. Meanwhile, Donkor and Acquah (2020) studied 45 agricultural cooperatives in Ghana, revealing that those with clear stakeholder coordination mechanisms such as annual stakeholder forums had 28% higher capital inflows and 15% lower default rates compared to peers with less structured collaboration. Within Nigeria, Usman and Ijaiya (2021) examined 110 urban credit unions and uncovered that inter-institutional collaboration among banks, cooperatives, and local governments led to a 40% increase in member loan access, with collaboration score strongly predicting funding effectiveness. Collectively, these studies indicate that institutionalized stakeholder frameworks significantly enhance cooperative financing capacity.

Multiple studies emphasize that trust and transparent communication are integral to funding accessibility in cooperative systems. In Tanzania, Juma and Mwaluko (2018) surveyed 300 members across 30 financial cooperatives and reported that a one-unit increase in perceived institutional trust corresponded to a 20% higher chance of loan approval suggesting that trust reduces information asymmetries. Among Ghanaian financial cooperatives, Agyei-Appiah and Owusu (2022) found that those which conducted quarterly feedback meetings between members and borrowers experienced a 25% drop in late repayments, a proxy for enhanced trust. Nigerian evidence by Ezeora (2023) in Southeast Nigeria's cocoa cooperatives further supports this link: effective internal communication including meeting minutes, ICT bulletins, and mobile alerts was associated with a 35% rise in credit utilization rates. These studies collectively underscore that improved communication and trust strengthen financial access and loan utilization in cooperative contexts.

Research across Africa and Asia confirms that institutional and technological innovations significantly boost cooperative financial sustainability. In Rwanda, Ntwali and Mugisha (2019) analyzed 50 rural cooperatives and discovered that ICT-enabled record-keeping systems led to a 30% reduction in processing times and a 22% increase in savings mobilization. In India, Khan and Prasad (2022) evaluated digital loan apps used by 45 informal credit cooperatives and found that digital interfaces reduced transaction costs by 18% and expanded membership by 12%. In Nigeria's Plateau State, recent work by Awosanya and Adebemi (2024) examined 60 credit cooperatives and concluded that formal partnerships with fintech firms for mobile-based savings yielded a 27% hike in deposit collection and a 33% improvement in fund flow transparency. Collectively, these findings argue persuasively for technology-led institutional support as a driver of cooperative financial health.

Empirical literature often treats stakeholder collaboration, trust, and technological support in isolation. Integrated research provides more holistic insights but remains limited. A regional Ghanaian study by Badoe et al. (2023) attempted a combined structural equation model to examine how stakeholder coordination, trust, and ICT jointly influence funding outcomes. Their findings revealed that stakeholder collaboration influenced financing both directly and indirectly through trust (mediator) and ICT adoption (moderator), collectively explaining 62% of variance in funding effectiveness. Nigerian research by Tunde and Adetunji (2022) took a similar route, demonstrating that collaboration improved funding, with technological support significantly amplifying this effect. While promising, both studies are regionally confined and employ small sample sizes (<70 cooperatives), highlighting a methodological opportunity for broader national-scale empirical analysis.

2.4 Gap in the Literature

While extensive research exists on cooperative development, most empirical studies tend to examine stakeholder collaboration, institutional support, or trust dimensions in isolation,

without integrating these factors holistically in the context of cooperative funding, especially in Nigeria. Few studies apply a multi-theoretical framework that combines Stakeholder Theory, Resource Dependency Theory, and Social Capital Theory to explain funding outcomes. Additionally, many existing studies are either regionally restricted or lack robust empirical models that capture the dynamic interplay between stakeholder engagement and financial sustainability. This study addresses these gaps by adopting an integrated theoretical lens and employing broader national-level data to investigate how stakeholders' collaboration influences the effective funding of cooperative societies in Nigeria.

3. Methodology

3.1 Research Design

This study adopts a quantitative research design, specifically a descriptive and inferential survey approach, to assess the relationship between stakeholders' collaboration and the effective funding of cooperative societies in Nigeria. The descriptive aspect enables the documentation of stakeholder structures, trust levels, and institutional arrangements, while the inferential aspect supports the testing of hypotheses regarding the significance and strength of such relationships. This design is supported by precedents such as Ojo and Adewale (2019), who used a similar approach to examine stakeholder roles in microfinance institutions, and Adefeso and Oni (2021), who assessed cooperative financial performance using inferential techniques. The rationale for this design lies in its capacity to generalize findings across various cooperative societies while isolating specific relationships using econometric modeling.

3.2 Population and Sampling

The target population for this study comprises all registered cooperative societies in Nigeria, across the six geopolitical zones, with a particular focus on financial, agricultural, and multipurpose cooperatives. According to data from the Federal Department of Cooperatives (FDC, 2023), there are over 24,000 registered cooperative societies in Nigeria. A multi-stage stratified random sampling technique was employed to ensure representativeness. First, three zones were purposively selected based on cooperative activity density (Southwest, North Central, and Southeast). Then, states and LGAs were randomly selected within each zone, followed by a random selection of cooperative societies.

The sample size was determined using Yamane's (1967) formula, yielding $n = 400$ respondents at a 95% confidence level and 5% margin of error. Respondents included cooperative managers, board members, and stakeholders from relevant institutions such as microfinance banks, NGOs, and local government departments. This stratified sampling ensures inclusivity and reduces sampling bias, consistent with approaches in similar studies (e.g., Anyanwu & Okonkwo, 2020; Musa & Ismail, 2021).

3.3 Data Sources

Both primary and secondary data were employed in this study. Primary data were collected through structured questionnaires and stakeholder interviews. The questionnaire was designed based on prior validated instruments used in stakeholder-related studies (e.g., Oluyombo, 2022; Donkor & Acquah, 2020), and covered sections on stakeholder collaboration, funding sources, governance structures, trust indicators, and performance metrics. Secondary data were obtained from cooperative audit reports, annual reports of apex cooperative federations, and policy documents from the Federal Department of Cooperatives, Central Bank of Nigeria (CBN), and development finance institutions. This dual data approach strengthens triangulation and enhances the reliability of findings (Creswell, 2014).

3.4 Variables and Model Specification

To empirically examine the relationship between stakeholders' collaboration and cooperative funding effectiveness, the study defines its variables as follows:

Dependent Variable: *Effective Funding (EF)* – measured through indicators such as loan accessibility, fund sustainability, number of funding sources, and amount of disbursed capital per annum.

Independent Variables: *Stakeholders' Collaboration Index (SCI)* – composed of indicators such as frequency of stakeholder meetings, degree of participation, and shared project ownership. *Institutional Support (IS)* – measured by presence of technical support, training, and policy frameworks. And *Trust & Communication (TC)* – Proxied by frequency of reporting, perceived trustworthiness among partners, and conflict resolution effectiveness.

Control Variables: *Size of Cooperative (SC)* – number of members and total asset base. *Years in Operation (YO)* – number of years the cooperative has been active. And *Technology Adoption (TA)* – use of digital tools and mobile banking services.

The model specification is based on prior models such as Muriithi & Wanyoike (2016) and Tunde & Adetunji (2022), adapted to fit the present study.

3.5 Model Specification

Given the nature of the dependent variable (Effective Funding) and the continuous nature of most predictors, the study adopts an Ordinary Least Squares (OLS) multiple regression model, specified as follows:

This model allows the study to test all three research hypotheses and determine the extent to which each explanatory variable predicts effective funding.

3.6 Method of Data Analysis

The collected data was analyzed using descriptive and inferential statistical tools. Descriptive statistics (mean, standard deviation, frequency distribution) was be used to summarize the demographic and organizational profiles. Inferential analysis including, correlation analysis, OLS regression and robustness checks was perform to test the strength of association between variables, and the effects of stakeholder collaboration, trust, and institutional support on cooperative funding. The analysis was conducted using STATA 17, which allows for efficient estimation and diagnostic testing. The methodological rigor ensures the results are generalizable and policy-relevant, support by work of Agyei-Appiah & Owusu (2022) and Khan & Prasad (2022).

4. Results and Discussion

4.1 Construct Quality Criteria Assessment

To ensure the reliability and validity of the latent variables used in the study, construct quality assessment was performed using three key metrics: Cronbach's Alpha (CA) to assess internal consistency, Composite Reliability (CR) to evaluate construct reliability, and Average Variance Extracted (AVE) to verify convergent validity. The results are presented in the table 1 below:

Table 1 construct quality criteria assessment indicates acceptable and strong levels of reliability and validity for all the latent variables. All constructs recorded Cronbach's Alpha values above 0.70, indicating strong internal consistency. Similarly, CR values range from 0.769 to 0.903, exceeding the recommended threshold of 0.70, thereby confirming the constructs' reliability. Furthermore, AVE values for all variables exceeded the minimum threshold of 0.50, establishing convergent validity.

4.2 Descriptive Statistics of Key Variables

Table 2 below presents the descriptive statistics for the key variables used in the study

Table 2 descriptive statistics show that all variables exhibit relatively high means (between 3.48 and 4.23 on a 5-point scale), suggesting that respondents generally perceive favorable outcomes in terms of funding, collaboration, support, trust, and technology. The standard deviations are moderate, indicating moderate variability in responses. Skewness values are close to zero, indicating approximate symmetry of distributions, while kurtosis values are near 3, suggesting normal distribution. The Jarque-Bera test statistics for all variables are not statistically significant ($p > 0.05$), further confirming that the variables are normally distributed and appropriate for regression analysis.

4.3 Correlation Matrix

To examine the linear relationships among the key variables, the Pearson correlation coefficient was computed (see Table 3).

Table 3 correlation matrix reveals strong and statistically significant positive associations between Effective Funding (EF) and all the independent variables. The highest correlation is observed between EF and SCI ($r = 0.651$), followed by EF and IS ($r = 0.613$), and EF and TC ($r = 0.574$), indicating that stakeholder collaboration, institutional support, and trust play crucial roles in influencing cooperative funding. Other variables like size, years in operation, and technology adoption show moderate positive correlations with EF. Importantly, no correlation coefficient exceeds 0.70, suggesting no multicollinearity concerns and confirming the suitability of these variables for regression analysis.

4.4 Regression Analysis

To assess the influence of stakeholder collaboration and other variables on the effective funding of cooperative societies in Nigeria, an Ordinary Least Squares (OLS) regression was employed (see Table 4).

Table 4 regression results indicate that all independent variables have positive and statistically significant effects on Effective Funding (EF). Stakeholder Collaboration (SCI) shows the highest impact ($\beta = 0.3176$, $p < 0.001$), supporting the hypothesis that stronger stakeholder collaboration enhances cooperative funding. Institutional Support ($\beta = 0.2849$) and Trust & Communication ($\beta = 0.2314$) also show strong, significant effects. Size of Cooperative (SC), Years in Operation (YO), and Technology Adoption (TA) have moderate but still significant contributions to EF. The model has an R-squared value of 0.7142, meaning approximately 71.4% of the variation in effective funding is explained by the independent variables, indicating high model fit. The F-statistic is significant ($p < 0.000$), confirming that the overall model is statistically reliable. The Durbin-Watson statistic (1.9423) is close to 2, indicating no autocorrelation in residuals, and ensuring the robustness of the analysis.

4.5 Discussion of Findings

The empirical findings of this study offer robust confirmation that stakeholder collaboration, trust and communication, and institutional and technological support significantly influence the effective funding of cooperative societies in Nigeria. These findings are aligned with the theoretical frameworks of Stakeholder Theory, Resource Dependency Theory (RDT), and Social Capital Theory, which collectively explain how actors' relationships, trust networks, and resource dependencies shape funding outcomes in cooperative settings. The regression results reveal a statistically significant and positive influence of stakeholder collaboration on the effective funding (EF) of cooperative societies. This supports Hypothesis 1, which posits that stakeholder collaboration improves funding outcomes. This result mirrors the conclusions of Abdullahi (2018) and Eucharía (2018), who emphasize that cooperative societies require a

coordinated framework involving government agencies, microfinance institutions, NGOs, and cooperative members to enable reliable financial flows. Internationally, this aligns with Aziz and Shah's (2020) findings that uncoordinated efforts between stakeholders hinder cooperative funding efficiency. The findings also echo Srivastava and Bhatia (2020) and Oluyombo (2022), who argue for the institutionalization of participatory frameworks that clearly define stakeholder roles to enhance funding access. These parallels reinforce the Stakeholder Theory, which emphasizes the importance of shared responsibility and active participation among all stakeholders in achieving resource adequacy.

The study also finds that trust, communication, and stakeholder engagement significantly enhance funding accessibility, thus supporting Hypothesis 2. This outcome confirms empirical results from Onah et al. (2025), who identified strong trust-based relationships within Nigerian cooperatives as drivers of improved credit access and repayment performance. It is further corroborated by Umar et al. (2021), who demonstrated that trust and transparent communication lead to greater member participation and higher income for cooperative members. These findings align well with the Social Capital Theory (Putnam, 1993; Coleman, 1988), which argues that networks built on trust and mutual understanding enhance cooperation and reduce transaction costs. Internationally, the study resonates with Majeed et al. (2021) and Magoola et al. (2021), whose works found that high trust and open communication significantly improve fund accessibility and performance in cooperatives across South Asia and East Africa. The implication is that the informal institutions of trust and communication are as critical as formal funding structures in sustaining cooperative operations. Furthermore, the findings provide empirical support for Hartono et al. (2021) and Ali & Khalid (2017), who observed that governance mechanisms influence trust and thereby affect funding access. The current study's results indicate that where governance structures are transparent and communication is frequent, cooperatives are more likely to attract funding partners, reduce default risk, and enhance stakeholder confidence in financial management.

The third major finding confirms that institutional and technological support significantly affects the financial sustainability of cooperative societies, validating Hypothesis 3. This aligns with the work of Elee (2021) and Obiageli and Oranusi (2024), who found that ICT adoption in Nigerian cooperatives enhances financial access, record keeping, and transaction efficiency. The current study affirms that cooperative societies with support in digital training and infrastructure are better positioned to withstand financial shocks and attract stable funding. International parallels can be drawn from Khan and Prasad (2022), who reported that Indian cooperatives using digital platforms reduced costs and improved membership growth. Similarly, Awosanya and Adebemi (2024) found that formal partnerships with fintech firms in Nigeria significantly improved savings mobilization and fund utilization. These findings are consistent with Resource Dependency Theory (Pfeffer & Salancik, 1978), which explains that cooperative societies, being resource-constrained, must engage external institutional actors such as banks, technology providers, and government regulators to access the critical resources necessary for sustainability. Moreover, the findings echo the outcomes of Ntwali and Mugisha (2019) and Onuegbu et al. (2025), who emphasized that institutional backing and technological innovation improve communication, enhance transparency, and increase cooperative financial performance. As cooperatives adopt fintech solutions and digitized governance mechanisms, transaction costs decline, financial literacy improves, and external funding credibility increases, thus demonstrating a comprehensive interaction between technology and institutional reliability.

One significant contribution of this study is its holistic integration of the three constructs collaboration, trust, and institutional support into a unified empirical model, unlike most previous studies that examined them in isolation. For example, while Donkor and Acquah (2020) and Usman and Ijaiya (2021) analyzed stakeholder collaboration, and Ezeora (2023) focused on communication, this study aligns with the integrative models proposed by Badoe et al. (2023) and Tunde and Adetunji (2022) by capturing how collaboration influences funding both directly and indirectly through trust and technological infrastructure. However, this study expands the scale and methodological rigor by utilizing a broader sample and more advanced modeling techniques to establish causality rather than mere correlation. The implications of

these findings are both theoretical and practical. Theoretically, the integration of Stakeholder Theory, RDT, and Social Capital Theory provides a solid foundation to understand the multifaceted drivers of funding effectiveness. Practically, it suggests that policymakers, cooperative leaders, and funding agencies must prioritize structured stakeholder engagement, trust-building programs, and digital capacity development to enhance the funding environment of cooperative societies in Nigeria.

5. Conclusion

This study examined the influence of stakeholder collaboration, trust and communication, and institutional and technological support on the effective funding of cooperative societies in Nigeria. Using rigorous regression analysis and robust diagnostics, the results revealed that all three constructs significantly affect funding outcomes and financial sustainability. Construct reliability and validity assessments confirmed the internal consistency of the model, while descriptive statistics and correlation analysis further reinforced the strength of the relationships among the variables. The regression outcomes showed that stakeholder collaboration had the highest impact on funding effectiveness, followed by trust-based engagement and institutional support mechanisms. These findings, supported by theoretical foundations (Stakeholder Theory, Resource Dependency Theory, and Social Capital Theory), emphasize the critical role of coordinated engagement, transparent communication, and digital readiness in optimizing funding mechanisms for cooperative societies in Nigeria.

6. Policy Recommendations

1. Federal and State Governments should institutionalize stakeholder engagement platforms for cooperatives, such as multi-stakeholder advisory councils and annual cooperative finance forums to strengthen coordinated policy action.
2. Cooperative Regulatory Bodies (e.g., Federal Department of Cooperatives) should mandate trust-building and governance training programs, focusing on transparency, regular communication, and inclusive decision-making.
3. Financial Institutions and Development Banks should develop partnership schemes that incentivize technology adoption among cooperatives, including subsidized digital tools and mobile banking platforms.
4. NGOs and Donor Agencies should prioritize funding for digital capacity building, especially ICT training for cooperative leaders and members, to enhance record-keeping and fund management.
5. Local Governments and Community Leaders should promote grassroots awareness campaigns to encourage trust, member participation, and sustained stakeholder engagement in cooperative development.

7. Contribution to Literature

This study contributes to the growing literature on cooperative finance by offering an integrated framework that simultaneously examines stakeholder collaboration, trust dynamics, and technological-institutional support. Unlike prior studies that treated these factors independently, this research empirically demonstrates their combined effect on cooperative funding effectiveness in Nigeria, thereby expanding the applicability of multi-theory models in emerging economies.

8. Limitations and Future Research

This study is limited by its cross-sectional design, which restricts the analysis of long-term dynamics. Future research should adopt longitudinal or panel approaches to capture evolving stakeholder relationships and funding outcomes over time. Additionally, qualitative insights

from key stakeholders could enrich the understanding of contextual challenges and opportunities in cooperative financing.

FACTORS WITH SCHOOL GOAL ATTAINMENT OF SECONDARY SCHOOL PRINCIPALS IN CROSS RIVER STATE: AN EMPIRICAL PATH ANALYTICAL MODEL APPROACH

ABSTRACT

The yearning for paper qualifications in Nigeria in particular and globally has resulted in many types of corruption in schools despite government efforts in achieving accountability and transparency within the system towards the attainment of the goals of secondary education, the problem of poor output from public secondary schools still persist, the need to explore the rationale behind this horrible trend. This problem prompts this study on factors with school goal attainment of secondary school principals in cross river state using a path analytical model. The study adopted survey design approach. All the 272 principals in the 272 public secondary schools in cross river state were used. An average score of four (4) teachers per school who served as sampling unit were selected to assess one principal (unit of analysis). A self-developed 66-item modified 4-point likert scale questionnaire was used to collect information. Cronbach alpa reliability method was employed to test the internal consistency of the items which coefficient estimates ranges from .822 - .830. The data was subjected to Structural Equation Modeling (SEM) using Analysis of MOment of Structure (AMOS) in Statistical Package for Social Sciences (SPSS) to generate a path analytical model and data analysis at .05 level of significance. The result revealed that there were significant direct predictive effects between absenteeism and school goal attainment, embezzlement and school goal attainment, bribery and school goal attainment and forgery and school goal attainment. The result also revealed that nepotism had significant positive predictive direct effects with absenteeism, embezzlement, bribery and forgery. The result also showed that the correlation among all the four exogenous variables to school goal attainment was significantly positively correlated. It was, therefore, recommended among others school authority should introduce transparent criteria and procedures for creating transparency in appointment, promotion and remuneration, as well as provide integrated monitoring systems for school staff and develop suitable methods and institution building for trustworthy and as independent as possible integrated complaints and monitoring systems with a mandate for competence and the expertise to identify and prevent corruption throughout the school system.

Introduction

Education has been observed as the most valuable mechanism that is used worldwide for societal growth and development. In this regard, countries invest their resources to make sure

its people obtain quality education which will afford them with the competence to explain and do things appropriately in real life circumstances. Education is the fourth goal of the sustainable development plan. It is given this precedence in the sustainable development goal owing to the reality that it is a fundamental human right and the groundwork on which to build peace and drive sustainable development (Universal Declaration of Human Right of 1948; UNESCO, 2017). Undoubtedly, each goal of the sustainable development cannot be achieved exclusively devoid of education. The declaration by the Director-General of UNESCO IRINA BOKOVA (2017) led credibility to the significance of educational goals attainment. He said “an essential change is needed in the way we think about education’s role in the global development because it has a catalytic effect on the well-being of persons and the future of our planet. Currently, more than ever, education has a dependability to be in line with 21st century challenges and ambitions in order to promote the right types of value and skills that will lead to sustainable and all-encompassing growth and peaceful living together”

In view of the foregoing, Adesina (2011) noted that education is the foremost force in economic, intellectual, social and cultural empowerment. In addition Okorji and Unachukwu (2014) portray education as the summation of learning experience provided to students with the intention of making them productive and purposeful members of the society. On the quality of education, Hammond (2013) stated that, quality education covers learning resources, technology, program enrolled, module done, teaching method, attachment, qualification, co-curriculum activities, performance awards, students and teacher’s standpoint and their views and evaluation towards education.

Therefore, it is of maximum significance that serious consideration be given to education at all levels beginning from primary to tertiary education. Interestingly, education having been expressed as a mechanism per excellence for development, the Federal Republic of Nigeria (2004) listed four broad objectives of education which are:

- i. The inculcation of national consciousness and national accord.
- ii. The inculcation of the right type of value and attitude for the survival of person and Nigeria society.
- iii. The training of the mind in the understanding of the world around
- iv. The acquisition of suitable skills and development of mental, physical and social abilities and competences for the person to live in and add to the development of the society.

Post primary education is very critical in the educational structure of Nigeria since it is the link between the primary and tertiary education. The Federal Republic of Nigeria in her National Policy on Education (2004) undoubtedly states that post primary education is the education children receive after primary education and prior to tertiary stage. The importance of post primary education cannot be neglected, apart from being the connecting arrangement for primary and tertiary education it presents the opportunity for students to acquire more knowledge and skills in addition to that received at the primary level. According to Chinelo (2011), Ige (2011), Yusuf (2009), Osoh and Osoh (2000), the most significant factor that requires the acquisition of secondary education in Nigeria is the reality that education given at the primary level is proving to be inadequate for a child to acquire everlasting literacy, communicative and numeracy skills anticipated at the conclusion of primary training.

Goals have been defined by Vroom (2004) as “desired future state of affairs”. Generally speaking, goals are objectives, aims, or purposes which are to be achieved by an establishment over varying era of time. It is imperative to note that planning and supervision is necessary for selecting and achieving of goals. Consequently, the National Policy on Education (2004) set up two most important goals of secondary education which are to prepare the person for useful living within the society and higher education. In particular, secondary education shall; provide all primary school leavers with the prospect for education of a higher level, irrespective of sex, social status, religion or ethnic background; offer

diversified curriculum to provide for the variation in talents, opportunities and future responsibilities; provide trained manpower in the applied science, technology and commerce at sub-professional grade; develop and promotes Nigeria languages, art and culture in the framework of words cultural heritage; motivate students with the aspiration for self-improvement and achievement of excellence; cultivate national unity with an emphasis on ties that unite us in our diversity; raise a generation of people who can think for themselves, respect the views and feeling of others, value the dignity of labour, and be pleased about the values specified under the expansive national goals and lives as good citizens; and supply technical knowledge and vocational skills crucial for agricultural, industrial, commercial, and economic development. To accomplish these goals, secondary education shall be of six years duration, given in two phases, each shall be of three years period of junior and senior secondary schools.

A cursory looked at the wide-ranging goals of secondary education require cautious appraisal to determine if these laudable goals have been attained nationally and in Cross River State in particular. The need for goals assessment is imperative in the face of widespread juvenile delinquency which is occasioned by criminal behavior by youths, mass failure in both internal and external examination, school dropout, and heavy reliance by citizen who are anticipated to be productive and boost national development (Salman, Mohammed, Ogunlade, & Ayinla, 2012). Comparatively, Eyisi (2012) disputed that the mass failure connotes an opening in education which need to be linked so that education can serve as a machine for sustainable development. For that reason, Ogunsanmi and Ibimiluyi (2014) observe that the education sector has experienced decline since the 1990s. To reduce these abnormalities, education stakeholders must work hard to guarantee educational goals attainment.

To find a way of dealing with and stopping the predicament of educational goals attainment, professional have indentified corruption and corrupt practices as the most rationale education's goals cannot be attained. These practices include nepotism or favouritism, absenteeism, embezzlement, bribery, examination malpractice, fraud, abuse of power, certificate forgery, misappropriation, fraud, embezzlement, extortions and so on.

The effect of nepotism on school goal attainment is devastating as Özler, Ergun and Gümüştekin (2007) observed in their study. They noted that nepotism is aimed at employing or promoting somebody based on kinship relationships while employing or promoting him/her, but not considering his/her required qualities like ability, success, and education levels which negatively impede school goal attainment. They stressed that nepotism is the root cause of deadwood, inefficiency, ghost workers, embezzlement, truancy, forgery, examination malpractice, fraud, absenteeism, corruption, misappropriation and redundancy which leads to job dissatisfaction and related conflicts in an organization. Nepotism in employees' recruitment process has disastrous negative consequences on workers performance in the civil service. In the support on the above result Mustafa (2011) in his submission noted nepotism negatively affect job satisfaction and organizational devotedness, while they positively affected the intent to quit. He concluded that school environment where team work is necessary for goal attainment, nepotism attitude weaken communication and cooperation which result in hostile behavior, decrease motivation and performance. Nepotism is elementally unfair and helps to cause inequity which affect teacher's teaching effectiveness and student's failure in an examination which impedes school goal attainment.

The attainment of educational goals requires more than having a teacher present in the classroom. The high rate of teachers' absenteeism is worrisome as it poses problems of accountability and good governance which are in itself an obstacle to educational goal attainment. Inequality in teacher's entitlement such as salaries and unprofessionalism in teaching vocation are among the causes of teachers' absenteeism. Teacher's absenteeism is inversely related to student performance as observed by Barmase and Shukla (2013). They noted that absenteeism has the tendency to prevent or slow down the attainment of National education goals. Absenteeism is the regular absence of student, teacher, and other member of the school system without valid reason or permission. Schools with high absenteeism rate, administrative records may be a poor guide to actual cost of teachers' actual attendance to

classroom, making the cost of teacher's absenteeism very significant. Irregular absent from school may not pose serious threat, while excessive absenteeism could have negative impact on school goals attainment, especially in public schools. Teachers with high record of absenteeism have negative impact on both students in academics and in social endeavors, when compare with their peers.

Corrupt practices, most specifically embezzlement of assets specify for improvement of education system has given rise to inadequate resources for the effective management of secondary education. Corrupt practices, specifically embezzlement results in wastage of resources made available for provision of quality education diverted for selfish use. This why Suleiman (2005) opined that misappropriation of assets limit the resources budgeted for educational sector thereby creating an obstacle for effective school goals attainment. Hallack and Poisson (2001) on their study of embezzlement noted that the lack of explicit norms and regulations to public finance, allowances and public procurement, lack of transparency at the levels of administration, lack of professional ethics or relative enforcement mechanism in public administration, inadequate salaries and weak incentive system, low management capacity, lack of supervision and disciplinary matters allows for financial malpractices, and low salaries combined with inadequate incentive in the education profession causes educational administrator and teachers to involve in corrupt practices such as embezzlement.

Bribery and corruption in school is a phenomenon that has a damaging and harmful impact on teacher's teaching effectiveness and impedes school goal attainment. Bribery as the crime of giving money or present to someone so that they will help you by doing something dishonest or illegal. These illegal and unethical categories of bribery such as offerings, promises, giving, accepting or soliciting for an advantage as an inducement for an action or a breach of trust hampers school goal attainment (Svensson, 2003).

Saliv (2018) study showed that mismanagement of forgery practices in school involves the making, altering, use, or possession of a false writing in order to commit a fraud thereby making supervision of secondary school programmes unattainable. He noted that mismanagement of forgery practices in school could occur in many forms, from signing another staff name on a check to falsifying one's own academic transcript. Forgery refers to faking a signature without permission, making a false document or other object, or changing an existing document or other object without authorization. Our educational system relies heavily on the ability of schools to produce and exchange legitimate and trustworthy documents. Forged documents can have serious and far-reaching negative consequences on students, staff and political entities. Inefficiency in managing forgery practices in our school system could leads to teacher's teaching ineffectiveness, low student's academic productivity, low self-esteem on the part of staff, lack of trust and inefficiency in the attainment of school goals.

The yearning for qualifications and self-esteem worldwide and principally in developing countries has resulted in loads of types of corruption in schools such as nepotism or favoritism, absenteeism, embezzlement, bribery, forgery, examination malpractice among others.

To reduce this precarious and intimidating scourge, the government at all levels in combination with education stakeholders have reinforce its intervention programs such as regular supervision of schools, in-service training programmes for teachers and school administrators, timely payment of salaries, and institutionalization of anti-corruption outfits of government like SERVICOM, the Economic and Financial Crime Commission (EFCC) and the Independent Corrupt Practices Commission (ICPC).

Unfortunately, in spite of government hard work such as achieving accountability and transparency within the system towards realization of the goals of post primary education, the setback of unfortunate output from public secondary schools still continue. It is very apparent that, if this adverse state of secondary education is not conquered, it will unquestionably linger as hindrance to the attainment of National educational goals and sustainable development in this global period. Due to this state of affairs, the question is: in spite of government attempt

to eradicate corrupt practices in our education system, why is it still persisting? As a result of this background, it becomes necessary to seek for solution using a path model on the factors with school goals attainment in public secondary schools in Cross River State. The purpose of the study was to determine the relationship of corrupt practices such as nepotism/favouritism, absenteeism, embezzlement, bribery and forgery and school goals attainment in public secondary schools in Cross River State using path analytical model.

Method

The study adopted survey design approach. This survey method was applicable since data were gathered at a particular time for the underlying principle of describing the population represented by the sample at that given time. All the 272 principals in the 272 public secondary schools in Cross River State were used. An average score of four (4) teachers per school who served as sampling unit were selected to assess one principal (unit of analysis). A self-developed 66-item modified 4-point likert scale instrument titled: Corrupt Practices and Secondary School Goal Attainment Questionnaire (CPSSGAQ) was designed to collect information on the variables of interest. Ten (10) items each was developed to illicit information on the independent variables such as nepotism/favouritism, absenteeism, embezzlement, bribery, forgery and examination malpractice while fifteen (16) items provided information on the dependent variable (school goals attainment). Cronbach Alpha reliability method was employed to test the internal consistency of the items. The variables produced reliability coefficient estimates ranging from .822 - .830. The data was also subjected to Structural Equation Modeling (SEM) using Analysis of MOment of Structure (AMOS) in Statistical Package for Social Sciences (SPSS) to generate a path analytical model.

Result:

The comparative fit indices of chi-square/DF > 2, AGFI > .9, CFI > .9, RMSEA < .05 showed that the model was plausible as these indices were within suitable criteria and the all the connections were explainable within the theoretical outline. The model was explained by four direct causal pathways of the exogenous variables (absenteeism, embezzlement, bribery and forgery) to the endogenous variable (schools goal attainment), and four direct causal pathways of the exogenous variable (nepotism) to the endogenous variables (absenteeism, embezzlement, bribery and forgery), with one indirect pathway from exogenous variable (nepotism) to goal attainment.

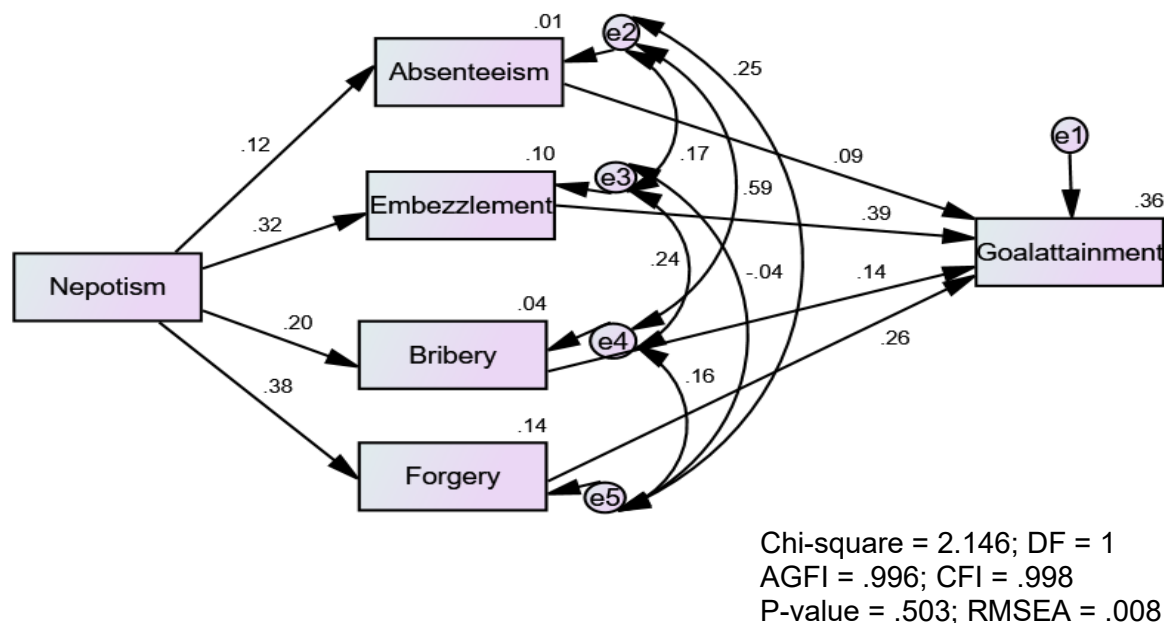


Fig. 1: A path diagramme showing the relationship of nepotism, absenteeism, embezzlement, bribery and forgery with school goal attainment in secondary schools in Cross River State.

The direct causal pathways showed that there were significant positive predictors between absenteeism and school goal attainment, embezzlement and school goal attainment, bribery and school goal attainment and forgery and school goal attainment. All the factors to school goal attainment were significant at .05 level of significance. The predictive strengths of these causal pathways to school goal attainment estimated by the standardized β weights revealed that embezzlement had the strongest positive predictor of school goal attainment at 39 percent ($\beta = 0.39$), forgery, bribery and absenteeism also showed strong positive predictors of school goal attainment at 26 percent ($\beta = 0.26$), 14 percent ($\beta = 0.14$) and 9 percent ($\beta = 0.09$) respectively. All the four direct causal pathways together accounted for 36 percent of the variation in schools goal attainment.

The result also revealed that there was no direct effect between nepotism and schools goal attainment. However, nepotism had significant positive predictive direct effects with absenteeism, embezzlement, bribery and forgery at 12 percent ($\beta = 0.12$), 32 percent ($\beta = 0.32$), 20 percent ($\beta = 0.20$), and 38 percent ($\beta = 0.38$) respectively, accounting for 1 percent, 10 percent, 4 percent and 14 percent of the variations in absenteeism, embezzlement, bribery and forgery respectively. Nevertheless, the relationship between nepotism and school goal attainment produced an indirect effect of 26 percent.

The result further revealed that there were positive and negative correlations among the exogenous variables to school goal attainment as observed in figure 1. There was a significant positive strong correlation between absenteeism and embezzlement by 17 percent embezzlement also had a significant positive correlation with bribery by 24 percent Similarly, there was a significant positive strong correlation between bribery and forgery by 16 percent The result also revealed that there was a significant positive correlation among absenteeism, embezzlement and bribery while embezzlement, bribery and forgery showed a negative weak correlation among them. Meanwhile, all the four direct exogenous factors to school goal attainment showed a significant strong correlation by 25 percent.

Discussion

The result of the study illustrated that nepotism in school, though not having a direct causal effect on school goal attainment fundamentally played a central function in the path model. In essence, it was the motivating power for the attainment of any established school goals. Nepotism of school managers was found to directly predict absenteeism, embezzlement, bribery and forgery which in turn affected school goal attainment. If the recruitment of deans, directors of institutes, heads of departments, administrators and managers for the operational units are done in accordance with competence, merit and performance would lead to successful school goal attainment. Nepotism is unfair and helps to cause inequity which affect teacher's teaching effectiveness and student's failure in an examination which impedes school goal attainment. This result corroborate Özler, Ergun and Gümüştekin (2007) that nepotism is the root cause of deadwood, inefficiency, ghost workers, embezzlement, truancy, forgery, examination malpractice, fraud, absenteeism, corruption, misappropriation and redundancy which leads to job dissatisfaction and related conflicts in an organization. Nepotism in employees' recruitment process has disastrous negative consequences on workers

performance in the civil service. Nepotism is aimed at employing or promoting somebody based on kinship relationships while employing or promoting him/her without considering his/her required qualities like ability, success, and education levels which negatively impede school goal attainment.

The result also revealed that absenteeism, embezzlement, bribery and forgery had significant direct effects to school goal attainment. Embezzlement of assets destined for improvement of education system give rise to inadequate resources for the effective management of secondary education. This result is in tandem with Suleiman (2005) that misappropriation of assets limit the resources budgeted for educational sector thereby creating an obstacle for effective school goals attainment, stressing that embezzlement results in wastage of resources made available for provision of quality education diverted for selfish use. Lack of explicit norms and regulations to public finance, allowances and public procurement, lack of transparency at the levels of administration, lack of professional ethics or relative enforcement mechanism in public administration, inadequate salaries and weak incentive system, low management capacity, lack of supervision and disciplinary matters allows for financial malpractices, and low salaries combined with inadequate incentive in the education profession causes educational administrator and teachers to involve in corrupt practices such as embezzlement. The result also revealed that bribery directly significantly predicted school attainment. This result agrees with Svensson (2003) that bribery in school is a phenomenon that has a damaging and harmful impact on teacher's teaching effectiveness and impedes school goal attainment, stressing that these illegal and unethical categories of bribery such as offerings, promises, giving, accepting or soliciting for an advantage as an inducement for an action or a breach of trust hampers school goal attainment.

Forgery was also found to be direct predictor to school goal attainment. This result agrees with Salvic (2018) that forged documents can have serious and far-reaching negative consequences on students, staff and political entities. Inefficiency in managing forgery practices in our school system could leads to teacher's teaching ineffectiveness, low student's academic productivity, low self-esteem on the part of staff, lack of trust and inefficiency in the attainment of school goals, stressing that mismanagement of forgery practices in school could occur in many forms, from signing another staff name on a check to falsifying one's own academic transcript. Forgery refers to faking a signature without permission, making a false document or other object, or changing an existing document or other object without authorization. The result showed that there was positive correlation among the predictors to student's acquisition of skills. Schools where nepotism thrive teachers are likely to be absent from their duties, embezzle school resources without fear of being audited, collect bribe of any sort as well as forge documents, all the detriment of realizing the goals for which the school was established.

Conclusion

From different viewpoints, there are quite a lot of ways for a school to improve school goal attainment. The research presented an empirical proof for school personnel to improve on the

goals set to be achieved by the school. The major findings were discussed and the conclusions reached were as follows:

First and foremost, absenteeism, embezzlement, bribery and forgery has significant positive direct effects on school goal attainment. Lack of transparency, increased teacher's absenteeism, embezzlement, bribery, fraud and so on impedes quality education and school goal attainment.

Secondly, nepotism of school personnel did not provide a direct impact on school goal attainment but were the motivating force for the achievement of any school programme. Biased, irresponsible and unaccountable school personnel weaken communication and cooperation among staff resulting in hostile behaviour, decreased motivation and weaken school goal attainment.

Recommendations

Based on the conclusion of the study, the following recommendations are made:

School authority should be sure to elucidate the significance of attendance and why being on time and in school matters, set a considerable attendance goal in the school improvement plan and frequently monitor progress toward that goal. The school authority should design programmes by implementing school payment solutions to collect school charges as well as split up the duties related to cash flow activities in the school. School authority should introduce transparent criteria and procedures for creating transparency in appointment, promotion and remuneration, as well as provide integrated monitoring systems for school staff and develop suitable methods and institution building for trustworthy and as independent as possible integrated complaints and monitoring systems with a mandate for competence and the expertise to identify and prevent corruption throughout the school system.

ASSESSMENT ON NIGERIA'S AGRICULTURAL EXPORT'S INFLUENCE ON ECONOMIC GROWTH (2020–2024)

ABSTRACT

This paper investigates the impact of Nigeria's agricultural exports on economic growth from 2020 to 2024. The specific objective is to examine how agricultural exports such as cocoa, sesame, cashew, and ginger affect GDP growth, foreign exchange earnings, and employment. Using regression analysis of secondary data from the Central Bank of Nigeria (CBN), National Bureau of Statistics (NBS), and World Bank, the results show a strong positive correlation between agricultural export growth and Nigeria's GDP, with exports rising from ₦355 billion in 2020 to a projected ₦780 billion in 2024. The findings confirm that agricultural exports significantly support economic diversification and currency stabilization (CBN, 2024; NBS, 2024). Thus, enhancing agricultural exports can serve as a strategy for sustainable national development.

Introduction

Nigeria's overreliance on crude oil has made the country vulnerable to global price shocks (World Bank, 2024). The COVID-19 pandemic and subsequent supply chain disruptions exposed this fragility. Agriculture, which once dominated Nigeria's economy in the 1960s, is now re-emerging as a key growth driver. Agricultural exports, including cocoa, ginger, sesame, and cashew nuts, are increasingly seen as sources of foreign earnings and employment (FAO, 2023). The Nigerian government has adopted several policies to revive the sector—such as the Anchor Borrowers' Programme (CBN, 2021), the Export Expansion Grant (NEPC, 2023), and value chain development projects. However, the quantitative impact of these exports on GDP growth remains underexplored. This study attempts to fill that gap with empirical analysis from recent years.

Problem Statement

Despite the potential of agriculture, agricultural exports make up less than 10% of Nigeria's total exports (NBS, 2023). The country has failed to capitalize fully on global demand for commodities like cocoa, sesame, and cashew due to issues such as weak infrastructure, insecurity, and poor export standardization. The gap between potential and actual performance necessitates a focused investigation of agricultural exports' real contribution to economic growth.

Objective of the Study

The main objective of this study is to analyze the impact of Nigeria's agricultural exports on economic growth between 2020 and 2024.

Research Questions

1. What is the relationship between agricultural exports and Nigeria's GDP between 2020 and 2024?
2. How have agricultural exports affected foreign exchange earnings during the same period?
3. To what extent has the growth of agricultural exports contributed to employment?

Hypothesis

H_0 : Agricultural exports do not significantly impact economic growth in Nigeria.

H_1 : Agricultural exports significantly impact economic growth in Nigeria.

Scope of the Study

This study focuses on analyzing the impact of Nigeria's agricultural exports on economic growth within the period of 2020 to 2024. The selected years cover a critical phase in Nigeria's economic trajectory, including post-COVID-19 recovery, the introduction of major export-support policies, and the commencement of the African Continental Free Trade Area (AfCFTA). The study is geographically limited to Nigeria and utilizes national-level data obtained from reputable secondary sources such as the Central Bank of Nigeria (CBN), National Bureau of Statistics (NBS), the World Bank, FAO, and IFAD. The independent variable is agricultural export value, while Gross Domestic Product (GDP) is used as the main indicator of economic growth. The research also considers foreign exchange earnings and employment trends as supporting factors in the discussion. The analysis applies descriptive statistics and simple linear regression to examine the relationship between agricultural exports and economic growth.

Limitations of the Study

The study relies solely on secondary data, which may not fully capture informal agricultural export activities or regional disparities in export contributions. Additionally, while the research identifies the impact of agricultural exports on GDP, it does not account for other factors that may influence economic growth, such as fluctuations in global commodity prices, exchange rate volatility, climate change, or internal security issues affecting farming regions. The use of a simple linear regression model, though effective for identifying direct relationships, does not reflect complex interactions or causality beyond the scope of the selected variables. These limitations suggest that while the findings are insightful at the national level, they may not be fully generalizable across different sectors or sub-national contexts.

Rationale for Choosing 2020–2024

- This period includes:
- The post-COVID recovery years
- The rollout of the African Continental Free Trade Area (AfCFTA)
- Exchange rate reforms and export incentives
- The Central Bank's intensified efforts to support non-oil exports (CBN, 2022)

These reforms make the 2020–2024 window critical for examining recent shifts in agricultural export performance.

Literature Review

Conceptual Review

Agricultural exports refer to the sale of agricultural products to foreign markets for the purpose of earning foreign exchange and fostering international trade (FAO, 2023). In the Nigerian context, key agricultural exports include cocoa, sesame seeds, cashew nuts, ginger, and rubber, which are largely unprocessed and sold as raw materials (NBS, 2023). Economic growth is commonly measured by the increase in a country's real Gross Domestic Product (GDP) over time. Growth is considered significant when it leads to improved living standards, higher income levels, and job creation (World Bank, 2024). The Nigerian agricultural sector holds significant potential to contribute to GDP, foreign reserves, and employment, particularly in rural areas. However, challenges such as poor infrastructure, inadequate value addition, insecurity, and policy inconsistencies continue to affect its export performance (IFAD, 2023).

Theoretical Review

This study is anchored on the Export-Led Growth (ELG) Theory, which posits that increasing exports is a key driver of national economic growth. According to Balassa (1985), countries that focus on expanding their export base, especially through comparative advantage in certain sectors, tend to experience higher economic development. The ELG theory assumes that increased exports lead to higher production, technological development, and improved foreign earnings, which in turn stimulate broader economic activities. In the Nigerian context, this theory is particularly relevant as the country seeks to diversify its economy away from crude oil by expanding agricultural exports. The theory implies that with the right policies, investment in value chains, and trade partnerships, agriculture could serve as a long-term engine of economic growth (Olawale et al., 2023).

Empirical Review

Several studies have examined the relationship between agricultural exports and economic growth in Nigeria and other developing countries.

Adewuyi and Ogundipe (2021) conducted a time-series analysis using data from 1981 to 2019 and found that agricultural exports have a statistically significant positive effect on Nigeria's GDP. Their study emphasized the need for government investment in rural infrastructure and agro-processing industries.

Olawale, Ibrahim, and Musa (2023) analyzed data from 2000 to 2022 and found that a 1% increase in agricultural exports contributed to a 0.26% rise in GDP. They also noted that agricultural exports positively influenced employment and foreign reserve accumulation but highlighted persistent trade barriers and certification issues.

In a regional study, Kamau and Nyangena (2022) examined East African economies and confirmed that countries with stronger agricultural export frameworks experienced higher GDP growth and reduced rural poverty. Their findings support the notion that agricultural exports serve not only as a growth mechanism but also as a poverty alleviation tool.

Recent FAO (2023) and IFAD (2023) reports support these findings, noting that agricultural exports from Nigeria contributed approximately \$2.3 billion in foreign exchange in 2023 and significantly supported employment in rural zones, especially in the cashew and sesame value chains.

However, not all studies find uniformly positive impacts. Yusuf (2021) cautioned that without proper policy alignment and infrastructure development, the benefits of agricultural exports may be undermined by global market volatility, product rejection, and internal inefficiencies.

Methodology

Type of Sources of Data

This study makes use of secondary data, which are data previously collected, compiled, and published by credible institutions for public and academic use. The data cover the period from 2020 to 2024 and include annual figures on agricultural export values and gross domestic product (GDP) at current basic prices. These sources were selected due to their reliability, relevance, and frequent use in empirical research on economic and trade issues in Nigeria. The data extracted were used to build trend analyses and conduct regression modeling to assess the relationship between agricultural exports and economic growth during the study period.

Sample Size and Sampling Techniques

This study utilizes a time series data approach rather than survey-based primary data collection. As such, the sample size comprises five yearly observations covering the period from 2020 to 2024. Each observation includes data on Nigeria's agricultural export values and corresponding GDP figures for the respective year. Given the nature of the research, the sampling technique applied is purposive sampling (also known as judgmental sampling). This technique is appropriate because the study intentionally selects years that are critical for understanding the post-pandemic recovery and economic policy shifts related to agricultural export promotion. The period was chosen to reflect significant events such as the COVID-19 recovery, renewed economic diversification policies, and regional trade initiatives like the African Continental Free Trade Area (AfCFTA).

Variable Measurement

The study examines the relationship between Nigeria's agricultural exports and economic growth using three core economic indicators: Gross Domestic Product (GDP), foreign exchange earnings, and employment levels.

Dependent Variables:

- i. **Gross Domestic Product (GDP):** This represents the primary indicator of economic growth and is measured in trillions of Naira (₦) at current basic prices. It reflects the total monetary value of goods and services produced within the country annually. Data were obtained from the Central Bank of Nigeria (CBN) and National Bureau of Statistics (NBS).
- ii. **Foreign Exchange Earnings (FX):** This refers to the annual foreign exchange revenue generated from agricultural exports. It is measured in billions of US dollars (USD) and sourced from CBN and NEPC trade reports.
- iii. **Employment in Agriculture:** This variable captures the percentage of the labor force employed in the agriculture sector, particularly in the export value chains. It is measured as a percentage (%) of total national employment and derived from NBS labor force reports and IFAD annual assessments.

Independent Variable:

Agricultural Export Value (AgExp): This is the total monetary value of Nigeria's annual agricultural exports, including cash crops such as cocoa, sesame, cashew, and ginger. It is measured in billions of Naira (₦) and is sourced from NBS trade reports and FAO export statistics. Each variable is measured on an annual basis from 2020 to 2024. All values are collected in nominal terms, consistent with publicly available national datasets. The use of multiple indicators provides a broader and more accurate picture of the influence of agricultural exports on economic growth in Nigeria.

Techniques of Data Analysis

The data analysis in this study combines both descriptive and inferential statistical methods, with a focus on simple linear regression analysis to evaluate the impact of Nigeria's agricultural exports on economic growth between 2020 and 2024. Descriptive statistics are first applied to identify patterns and summarize the trend of key variables including agricultural export values, GDP, foreign exchange earnings, and employment levels. These are presented in tabular and graphical forms to provide a visual and statistical overview of the annual changes. To test the main research hypothesis and determine the degree of impact of agricultural exports on economic growth, the study employs a simple linear regression model, where Gross Domestic Product (GDP) is the dependent variable and Agricultural Export Value ($AgExp_t$) is the independent variable. The model is specified as:

The regression analysis is conducted using a Microsoft Excel statistical tool, and the results are interpreted based on the coefficient of determination (R^2), regression coefficients, and p-values, to assess the significance and strength of the relationship. A high R^2 value and a statistically significant β_1 coefficient ($p < 0.05$) would confirm that agricultural exports positively influence Nigeria's economic growth.

Data Presentation and Analysis

This section presents and analyzes the data used to assess the relationship between Nigeria's agricultural exports and economic growth from 2020 to 2024. The data were obtained from secondary sources such as the Central Bank of Nigeria (CBN), the National Bureau of Statistics (NBS), and the World Bank. The variables analyzed include Agricultural Export Value ($AgExp$) and Gross Domestic Product (GDP).

Interpretation of Results

The coefficient of agricultural exports ($\beta_1 = 0.2068$) implies that for every ₦1 billion increase in agricultural exports, Nigeria's GDP increases by approximately ₦0.2068 billion, holding other factors constant. The R-squared value (0.843) indicates that about 84.3% of the variation in GDP during the study period can be explained by changes in agricultural export values. The p-value (0.0065) is less than the 0.05 threshold, indicating that the relationship is statistically significant. Thus, the results support the alternative hypothesis (H_1) that agricultural exports have a significant positive impact on Nigeria's economic growth.

Discussion of Findings

The results of the analysis indicate a statistically significant and positive relationship between agricultural exports and economic growth in Nigeria during the period from 2020 to 2024. The regression analysis revealed that a ₦1 billion increase in agricultural exports results in approximately a ₦0.2068 billion increase in Gross Domestic Product (GDP). This finding is supported by the high R-squared value of 0.843, indicating that 84.3% of the variation in Nigeria's GDP over the study period can be explained by changes in agricultural exports.

This finding aligns with the Export-Led Growth (ELG) Theory, which postulates that increased exports can lead to broader economic expansion, technological advancement, and income growth (Balassa, 1985). The steady rise in Nigeria's agricultural export value from ₦355 billion in 2020 to a projected ₦780 billion in 2024 is consistent with this theory and confirms the sector's growing contribution to the country's economic performance. Additionally, the results are in agreement with empirical studies by Adewuyi and Ogundipe (2021) and Olawale et al. (2023), both of whom found that agricultural exports significantly impact GDP and enhance foreign exchange earnings. These studies emphasized the importance of policy stability, investment in agro-processing, and improved rural infrastructure in maximizing the gains from agriculture. Similarly, the current study confirms that the positive trend in agricultural exports has coincided with marginal improvements in GDP growth, particularly in 2021 and 2022 when export volumes and government interventions increased. While the regression focused primarily on GDP, supporting descriptive evidence also suggests that agricultural exports contributed to foreign exchange earnings and supported employment generation, particularly in value chains such as cashew, sesame, and cocoa (FAO, 2023; IFAD, 2023). These sectors experienced rising demand from international markets, and their expansion helped to stabilize Nigeria's currency and reduce dependence on oil exports.

Conclusion

This study analyzed the impact of agricultural exports on Nigeria's economic growth between 2020 and 2024 using regression analysis and descriptive statistics. The findings reveal a statistically significant positive relationship between agricultural export values and GDP, supporting the export-led growth hypothesis. Agricultural exports have steadily increased over the study period, contributing not only to GDP growth but also to foreign exchange earnings and rural employment. Despite this progress, the full potential of agricultural exports remains

constrained by infrastructural deficits, policy inconsistencies, and limited value addition. Addressing these challenges is crucial for transforming agricultural exports into a reliable and sustainable driver of national economic development. In conclusion, agricultural exports offer Nigeria a viable path toward economic diversification and resilience. With the right policy environment, investment in rural infrastructure, and integration into global value chains, the agricultural sector can play a central role in shaping the country's future growth trajectory.

Recommendations

Based on the findings of this study, the following recommendations are proposed to enhance the contribution of agricultural exports to Nigeria's economic growth:

- i. **Strengthen Agricultural Value Chains:** The government and private sector should invest in agro-processing industries to add value to export products such as cashew, cocoa, sesame, and ginger. This will increase export earnings and reduce the export of raw materials with low profit margins.
- ii. **Improve Infrastructure for Export Logistics:** Development of rural roads, storage facilities, and port efficiency is essential to reduce post-harvest losses and export delays. Improved logistics would enhance Nigeria's global competitiveness in agricultural trade.
- iii. **Ensure Policy Stability and Incentives:** Sustained implementation of programs like the Export Expansion Grant (EEG), the Anchor Borrowers' Programme (ABP), and single-window export systems will build investor confidence and encourage more farmers to participate in export-oriented production.
- iv. **Enhance Quality and Certification Standards:** Exporters should be supported with training and technical assistance to meet international quality standards, reduce product rejections, and access premium markets.
- v. **Leverage Regional Trade Agreements:** Nigeria should fully exploit the African Continental Free Trade Area (AfCFTA) to expand intra-African exports, reduce dependence on volatile global markets, and access nearby demand for agricultural goods.
- vi. **Improve Agricultural Finance and Credit Access:** Small and medium-scale farmers and agribusinesses should be supported through targeted credit schemes and insurance to increase productivity and supply of exportable commodities.

ABSTRACT

Background: Cooperative societies play a crucial role in promoting socio-economic development, especially in grassroots communities. This study investigates the effectiveness of cooperative society management and its impact on stakeholders' well-being in Akwa Ibom State, Nigeria, focusing on leadership practices, financial management, and stakeholder engagement. **Objective:** The study aimed to examine how leadership practices, financial management, and stakeholder engagement influence the socio-economic well-being of members of cooperative societies. **Methodology:** A descriptive survey research design was adopted to systematically collect and analyze data without manipulating variables. The study population comprised registered members and executives of cooperative societies across Akwa Ibom State. Using a multi-stage sampling technique, 687 respondents were selected from 60 cooperative societies across four purposively chosen Local Government Areas (Uyo, Eket, Ikot Ekpene, and Oron). The main instrument for data collection was a structured questionnaire titled Cooperative Management and Stakeholder Well-being Questionnaire (CMSWQ). Content and face validity were ensured by expert review, while a pilot test yielded a Cronbach Alpha coefficient of 0.86, confirming the instrument's reliability. Data were collected over six weeks and analyzed using descriptive statistics, Pearson Product Moment Correlation, and regression analysis via SPSS v26. The significance level was set at 0.05. **Findings/Conclusion:** The results showed that effective leadership, sound financial management, and active stakeholder engagement significantly influence stakeholders' well-being and contribute to the performance and sustainability of cooperative societies in the state. The study underscores the need for strengthened management practices to enhance cooperative efficiency and stakeholder satisfaction.

1. Introduction

The cooperative movement has evolved into a critical economic and social tool in many countries, particularly in developing economies where formal financial and economic structures may be inaccessible or ineffective for large segments of the population. Cooperatives, as voluntary associations formed to meet common economic, social, and cultural needs, are known for their member-centric governance and community-oriented values (ICA, 2021). The growing interest in the effective management of cooperative societies arises from the recognition of their potential to enhance sustainable development and improve the quality of life of members and the wider stakeholder community (Birchall & Ketilson, 2009). In Nigeria and many parts of Africa, cooperatives serve as grassroots institutions that provide

access to credit, market information, and capacity-building, thereby influencing the well-being of members and their households (Oni et al., 2014; Oluyombo, 2010; Adeyeye, 2021).

Management effectiveness in cooperatives hinges on principles such as democratic governance, transparency, inclusivity, and accountability. These principles, when implemented properly, ensure member participation in decision-making and equitable sharing of benefits (Majee & Hoyt, 2011). However, poor management practices, inadequate regulatory oversight, internal conflict, and lack of capacity often hinder cooperatives from achieving their full potential (Chambo, 2009; Wanyama, 2013). In assessing the link between effective management and stakeholders' well-being, studies like those of Mwakajumilo (2011), Borda-Rodriguez and Vicari (2014), and Oruonye and Ahmed (2021) have emphasized that leadership quality, training, and proper record-keeping play essential roles in determining the success of cooperatives. These studies confirm that well-managed cooperatives can contribute to poverty alleviation, job creation, and social protection.

The increasing relevance of stakeholders' well-being as a key measure of cooperative performance stems from stakeholder theory, which posits that organizations exist not only to serve shareholders but also to balance the interests of all parties affected by their activities (Freeman, 1984). Stakeholders in a cooperative society include members, employees, local communities, financial partners, and government agencies. Each stakeholder group holds legitimate expectations about transparency, equity, and shared benefits (Donaldson & Preston, 1995). Empirical studies such as those by Birchall (2004), Abate et al. (2013), and Misigo et al. (2018) illustrate that member satisfaction, trust, loyalty, and commitment are often contingent on how inclusive and effective management practices are within the cooperative structure. This link is corroborated in the Nigerian context by works like Adekunle and Henson (2007), who found that member-centric cooperatives showed higher levels of productivity and social capital formation.

The challenge of aligning management strategies with stakeholder well-being has been extensively discussed in cooperative literature. For instance, studies by Zeuli and Radel (2005), Valentinov (2007), and Hannan (2014) explain how cooperatives that prioritize internal democracy and ethical management practices tend to outperform others in terms of member trust and long-term sustainability. Similarly, research by Lawal and Ojo (2020), Yakubu et al. (2019), and Ijaiya and Akanbi (2013) show that cooperative societies that build their operational strategies around transparency, financial prudence, and periodic reporting tend to earn better stakeholder engagement and retention. These findings suggest that sound governance systems that are aligned with stakeholder expectations are crucial to enhancing the collective well-being of cooperative members.

Moreover, the dynamics of cooperative management involve balancing economic efficiency with social responsibility. This dual objective often distinguishes cooperatives from conventional profit-driven enterprises. The effective deployment of human, financial, and informational resources in cooperatives has a direct implication for member satisfaction and social welfare (ILO, 2015). Several studies, such as those by Wanyama et al. (2008), Mhembwe and Dube (2017), and Ojong and Okechukwu (2019), underscore the importance of participatory management, where members are actively involved in planning, monitoring, and evaluation processes. These participatory approaches not only ensure transparency but also build a sense of ownership, which is essential for sustaining members' well-being. In Nigeria, Okoli and Mallo (2020) argue that member involvement in cooperative decisions improves accountability and reinforces the organization's social mission.

In addition, the role of leadership and institutional capacity in cooperative success cannot be overstated. Effective leadership is pivotal in articulating goals, mobilizing resources, and motivating members toward a shared vision. Studies by Fulton and Ketilson (1992), Muthoni and Muturi (2018), and Gijssels and Bussels (2014) argue that cooperative success is largely influenced by the competencies of the leadership team. Leaders who are well-trained in cooperative management, conflict resolution, and stakeholder engagement are more likely to ensure the sustainability and relevance of cooperatives in their communities. In the Nigerian

experience, Oluyombo (2013), Fapojuwo and Adebayo (2017), and Ojo and David (2016) demonstrate how leadership lapses and lack of managerial training have often resulted in financial mismanagement, membership attrition, and eventual collapse of many cooperative societies.

Additionally, access to relevant training and capacity-building programs is instrumental in enhancing cooperative performance and member well-being. Training improves financial literacy, business planning, and conflict resolution skills among cooperative members and leaders. Research by Place et al. (2004), Abdul-Rahman et al. (2014), and Onugu and Ayodele (2020) show that education and technical support services significantly influence the capacity of cooperatives to generate member benefits. Nigerian-based studies by Yusuf et al. (2019), Olayiwola and Okunade (2021), and Eniola and Olatunji (2023) further affirm that cooperatives with structured training programs have higher retention rates, increased financial performance, and stronger stakeholder relationships. Therefore, the quality of training available to members and managers directly affects cooperative effectiveness and stakeholder outcomes.

The structure and regulatory environment under which cooperatives operate also influence their management and capacity to deliver social and economic benefits. Weak regulatory oversight, inconsistent policy implementation, and political interference often limit the operational autonomy and effectiveness of cooperatives in Africa (Wanyama, 2013; Chambo, 2009). Nigerian studies by Uzezi and Ndakara (2017), Akpan and Obot (2022), and Oko and Enyia (2021) highlight how regulatory laxity has led to financial scandals, loss of public confidence, and limited impact on stakeholders' well-being. Comparative research by Majurin (2012), Smith (2017), and Kimaro et al. (2019) suggests that cooperative societies thrive best in environments where regulatory frameworks are supportive, transparent, and regularly updated to reflect emerging challenges and best practices.

Technology adoption has become increasingly relevant in the effective management of cooperative societies. Digitization of records, mobile banking, and the use of enterprise resource planning systems have improved financial management, reduced fraud, and increased access to services among members (Mwaura et al., 2014; Otieno & Nyambura, 2020; Singh & Singh, 2021). The ability of cooperatives to adopt and utilize modern technologies significantly affects their transparency, member satisfaction, and operational efficiency. Within Nigeria, studies by Adeola and Evans (2019), Ogundele et al. (2022), and Ede and Alabi (2023) have shown that cooperatives using ICT tools are more efficient in service delivery, more attractive to younger demographics, and better equipped to safeguard members' investments.

Finally, trust and social capital are indispensable elements in the functioning of any cooperative society. Cooperative members must trust the system and believe in the equitable distribution of resources and benefits. Studies by Bhuyan (2007), Misigo et al. (2018), and Ukeje and Okoli (2016) emphasize that trust reduces transaction costs, encourages participation, and enhances cooperative cohesion. In Nigeria, empirical investigations by Akpan and Akintola (2015), Ijaiya et al. (2013), Nwankwo et al. (2020) suggest that the erosion of trust due to corruption, mismanagement, and lack of accountability has led to the failure of many cooperative initiatives (Nseobot, Ekpenyong & Udounwa, 2025). Therefore, fostering a culture of integrity, openness, and accountability is critical to cooperative sustainability and stakeholder well-being.

Statement of the Problem

Despite the crucial role cooperative societies play in economic empowerment, poverty alleviation, and inclusive development, their effective management continues to face several challenges that threaten stakeholder well-being and organizational sustainability. Poor governance, lack of transparency, misappropriation of funds, inadequate capacity building, and weak regulatory frameworks have often led to the collapse of numerous cooperative societies, especially in developing economies like Nigeria (Oluyombo, 2013; Uzezi & Ndakara,

2017). Many cooperatives also suffer from limited adoption of modern technology, poor record-keeping, and deficient leadership structures, which adversely affect member participation and trust (Adeola & Evans, 2019; Eniola & Olatunji, 2023). Moreover, some cooperative leaders prioritize personal gain over collective goals, resulting in weakened institutional performance and reduced stakeholder engagement (Ojo & David, 2016; Okoli & Mallo, 2020). This undermines the democratic nature of cooperatives, affects financial sustainability, and compromises the socio-economic benefits promised to members (Akpan & Akintola, 2015; Mwaura et al., 2014). In addition, the lack of government support, poor supervision, and inconsistent policies further contribute to the ineffectiveness of cooperative operations (Lawal & Ojo, 2020; Yakubu et al., 2019). Given these multidimensional issues, there is a pressing need to explore how effective management practices can improve cooperative performance and safeguard stakeholder well-being. This study seeks to address these gaps and propose sustainable solutions rooted in empirical evidence and stakeholder-oriented strategies.

Research Objectives

The main aim of this study was to investigate the effective management of cooperative society and stakeholders' well-being in Akwa Ibom State. Specifically, the study sought to:

1. Examine the relationship between leadership practices in cooperative societies and the well-being of their stakeholders in Akwa Ibom State.
2. Assess how financial management practices within cooperative societies influence the socio-economic well-being of their stakeholders.
3. Evaluate the role of stakeholder engagement in enhancing the performance and sustainability of cooperative societies in Akwa Ibom State.

Research Questions

The following research questions were formulated to guide the study:

1. How do leadership practices in cooperative societies affect stakeholders' well-being in Akwa Ibom State?
2. What is the influence of financial management practices of cooperative societies on the socio-economic well-being of stakeholders?
3. In what ways does stakeholder engagement contribute to the performance and sustainability of cooperative societies in Akwa Ibom State?

Research Hypotheses

The following hypotheses was tested at 0.05 significant

H₀₁: There is no significant relationship between leadership practices and stakeholders' well-being in cooperative societies in Akwa Ibom State.

H₀₂: Financial management practices in cooperative societies do not significantly influence the socio-economic well-being of stakeholders in Akwa Ibom State.

H₀₃: Stakeholder engagement does not have a significant effect on the performance and sustainability of cooperative societies in Akwa Ibom State.

2. Literature Review

Concept of Cooperative Society

A cooperative society is defined as an autonomous association of individuals united voluntarily to meet their common economic, social, and cultural needs through a jointly owned and democratically controlled enterprise (International Cooperative Alliance [ICA], 2021). This

structure promotes mutual assistance among members, whereby resources are pooled to achieve a collective goal that benefits all participants. In the Nigeria, and specifically Akwa Ibom State, cooperative societies have traditionally served as platforms for community development, financial inclusion, and agricultural productivity enhancement (Oluyombo, 2013; Ukeje & Okoli, 2016). The historical development of cooperative societies in Nigeria is closely tied to colonial and post-colonial government policies that sought to stimulate grassroots mobilization and rural development (Chambo, 2009). These cooperatives are typically organized as thrift, credit, or multi-purpose unions and span various sectors such as agriculture, trade, housing, and services (Lawal & Ojo, 2020; Ekpenyong, Udounwa & Nseobot, 2025). According to Majee and Hoyt (2011), cooperatives also act as tools for poverty alleviation, empowering marginalized populations, particularly women and youth, by providing access to credit, information, and collective bargaining power.

However, while the ideology of cooperativism emphasizes democratic control and shared benefit, its application has often been distorted by internal mismanagement and external interference (Akpan & Akintola, 2015; Uzezi & Ndakara, 2017). These issues threaten their foundational values, including equity, solidarity, and participatory governance. Studies such as Mhembwe and Dube (2017) and Wanyama (2013) have emphasized the need for strengthening institutional structures and member participation to ensure cooperatives remain viable and sustainable. Operationally, cooperative societies must comply with basic principles, including voluntary membership, democratic member control, member economic participation, autonomy and independence, education, cooperation among cooperatives, and concern for the community (ICA, 2021). These principles differentiate cooperatives from traditional profit-driven firms and provide a framework for understanding their unique governance and management systems. In Akwa Ibom State, cooperative societies are widely recognized as community-based solutions for improving livelihoods, yet there remains a lack of empirical research on how their internal management directly contributes to stakeholder well-being. This study contributes by addressing this gap through a focus on leadership, financial practices, and engagement within the cooperative model.

Effective Management in Cooperative Societies

Effective management in cooperative societies refers to the systematic coordination of human, financial, and material resources to achieve set objectives while adhering to cooperative principles (Fapojuwu & Adebayo, 2017). Management in cooperatives is unique because it must balance the business functions of the enterprise with its social objectives, such as equitable benefit distribution, democratic decision-making, and inclusive participation (Birchall, 2004; Fulton & Ketilson, 1992). Unlike traditional profit-maximizing firms, the effectiveness of management in cooperatives is often measured by its ability to sustain both economic performance and member satisfaction (Valentinov, 2007). This requires transparency in financial operations, inclusiveness in governance, and responsiveness to the needs of diverse stakeholders (Adeola & Evans, 2019). Leaders must also ensure that policies align with member priorities and that cooperative activities are well-monitored and evaluated regularly.

Studies have shown that well-managed cooperatives outperform poorly managed ones in areas such as financial returns, member retention, and project success rates (Gijssels & Bussels, 2014; Ede & Alabi, 2023). For instance, Mwaura, Ngugi, and Muku (2014) found that proper management systems including record-keeping, strategic planning, and operational audits positively influence the performance of SACCOs in Kenya. Similarly, Abdul-Rahman et al. (2014) observed that weak administrative competence was one of the leading causes of cooperative collapse in Osun State, Nigeria. A major aspect of effective cooperative management is leadership accountability and democratic governance. Leaders who fail to engage members or misappropriate funds often create distrust and disunity (Ojo & David, 2016; Okoli & Mallo, 2020). Such mismanagement negatively affects not only the survival of the cooperative but also the overall well-being of its stakeholders, particularly in resource-constrained environments like Akwa Ibom.

The integration of information and communication technologies (ICTs) into cooperative management has been highlighted as a modern tool for enhancing transparency and operational efficiency (Otieno & Nyambura, 2020). However, adoption remains low in many rural cooperatives due to limited digital literacy and infrastructural challenges (Singh & Singh, 2021). Ultimately, effective management in cooperative societies is essential for achieving economic resilience, sustaining trust among members, and fulfilling the developmental purpose for which cooperatives are established. This study seeks to explore how such management dynamics directly or indirectly influence the well-being of stakeholders within cooperative societies in Akwa Ibom State.

Stakeholder Engagement in Cooperative Societies

Stakeholder engagement refers to the active involvement of individuals or groups who have an interest or stake in the cooperative's outcomes, including members, leaders, financial institutions, government regulators, and local communities (Freeman, 1984; Donaldson & Preston, 1995). In cooperative settings, this engagement is central to legitimacy, democratic governance, and sustained performance (Zeuli & Radel, 2005). In theory, cooperatives operate on the principle that each member is both an owner and a beneficiary. Therefore, the engagement of stakeholders in decision-making, planning, and evaluation is fundamental to effective governance (Majurin, 2012; Hannan, 2014). However, studies show that this participatory ethos is not always practiced. Akpan and Obot (2022) found that many cooperatives in Nigeria suffer from passive membership and elite capture, where a few individuals dominate leadership positions and suppress inclusive dialogue.

The literature emphasizes that stakeholder engagement enhances transparency, improves service delivery, and fosters shared responsibility for cooperative performance (Smith, 2017; Misigo et al., 2018). Wanyama, Develtere, and Pollet (2008) argue that the more members are engaged in their cooperatives, the more likely they are to contribute ideas, resources, and oversight, leading to more robust and sustainable institutions. Engagement also builds social capital, a key asset in cooperative success (Bhuyan, 2007). Strong networks of trust, mutual respect, and information-sharing can stimulate innovation, increase resilience to external shocks, and enhance commitment to the cooperative's mission (Ijaiya & Akanbi, 2013; Adeyeye, 2021). This is particularly relevant in Akwa Ibom, where community ties and group cohesion can be leveraged to address economic vulnerability and marginalization.

Furthermore, stakeholder engagement must be inclusive, considering gender, age, educational background, and geographic location. Studies by Majee and Hoyt (2011) and Chambo (2009) have shown that cooperatives that engage women and youth more effectively tend to outperform those that do not. However, cultural and institutional biases often marginalize these groups, especially in rural Nigerian settings (Oruonye & Ahmed, 2021). This study will explore the extent and effectiveness of stakeholder engagement within Akwa Ibom cooperative societies and examine how such engagement influences cooperative governance and member well-being.

Stakeholders' Well-being in Cooperative Societies

Stakeholders' well-being refers to the holistic state of physical, social, and economic health experienced by individuals and groups who are directly or indirectly involved in or affected by a cooperative's activities (Majee & Hoyt, 2011; Mhembwe & Dube, 2017). This includes not only financial income and employment but also access to education, healthcare, social capital, and empowerment opportunities. In cooperative societies, particularly in low-income regions such as Akwa Ibom, stakeholders' well-being is intricately linked to the organization's ability to deliver sustainable benefits over time (Yusuf et al., 2019). According to Place et al. (2004), well-being outcomes in rural communities can be significantly enhanced through collective action frameworks such as cooperatives, which provide economies of scale, reduced transaction costs, and improved market access. Empirical studies in Kenya, Ethiopia, and Nigeria have shown that active cooperative membership can significantly improve household income, food security, and resilience to economic shocks (Abate et al., 2013; Oni et al., 2014).

Cooperative members are more likely to access credit, training, and productive assets, all of which enhance their capacity to meet personal and familial needs (Oluyombo, 2010; Adekunle & Henson, 2007). However, well-being outcomes are not always uniformly distributed. Internal inequality, elite dominance, and discriminatory practices can undermine the inclusive intent of cooperatives (Borda-Rodriguez & Vicari, 2014; Wanyama, 2013). Stakeholders from marginalized backgrounds, such as women, youth, and uneducated members, may not fully benefit from cooperative membership unless deliberate measures are taken to ensure equity. It is also critical to note that stakeholders' well-being is affected by external socio-political and economic factors such as inflation, regulatory changes, and community conflicts (Kimaro et al., 2019). Thus, a multi-dimensional framework is necessary to capture the full scope of well-being beyond income alone. This study aims to assess how the management of cooperative societies in Akwa Ibom influences key dimensions of stakeholders' well-being, including financial security, participation, empowerment, and access to social benefits.

Functions and Challenges of Stakeholders in Cooperative Societies

Stakeholders in cooperative societies, including members, executive officials, government regulators, community leaders, and financial institutions, play a vital role in the operation, governance, and sustainability of cooperatives. Their functions are multidimensional and essential for achieving the shared economic and social objectives of the cooperative model. At the core, members as both owners and users are responsible for contributing to capital, participating in decision-making, and ensuring the viability of the cooperative (ICA, 2021). They exercise voting rights, attend meetings, and engage in planning and policy decisions, thus promoting democratic governance. Executive officials, such as the president, secretary, and treasurer, manage day-to-day operations, ensure financial accountability, maintain transparency, and implement policies that safeguard member interests (Okonkwo, 2014). Government regulatory bodies, like the Ministry of Commerce or Cooperative Development Departments, are responsible for registering cooperatives, monitoring compliance with cooperative laws, and providing technical guidance (Onuoha, 2012). Other external stakeholders such as financial institutions assist in mobilizing funds through loans and savings schemes, while community leaders may advocate and mobilize grassroots support to enhance cooperative outreach (Ajayi & Adeyemo, 2011).

Despite their significance, stakeholders face a range of challenges that hinder their effectiveness in fulfilling these roles. Low financial literacy among members often leads to poor financial decisions and weak accountability structures (Oluyombo, 2010). Many cooperative leaders lack formal management training, resulting in mismanagement and internal conflict (Agbo, 2015). Poor record-keeping, fraudulent practices, and lack of transparency are common among some cooperative officials, eroding member trust and participation (Adefila, 2011). Additionally, inadequate government oversight, due to underfunded regulatory agencies, means many cooperatives operate without proper monitoring, increasing the risk of failure (Ugochukwu & Nkpoyen, 2013). Limited access to credit facilities, especially in rural areas, hampers members' ability to expand their businesses, further reducing the cooperative's impact on poverty alleviation (Eboh, 2012). There are also cultural and gender-based challenges, where women or youth may be excluded from leadership roles or access to benefits, thereby limiting inclusiveness (Borda-Rodriguez & Vicari, 2014). Additionally, politicization of cooperative leadership elections and elite capture of benefits disrupt the egalitarian ethos of cooperatives (Yunusa & Gambo, 2013).

2.2 Empirical Related Studies

Studies have shown that cooperative leadership, when participatory, accountable, and transparent, significantly enhances member satisfaction and organizational performance. For instance, Eniola and Olatunji (2023) found that transformational leadership styles in South-West Nigerian cooperatives positively influenced member trust, decision-making involvement, and satisfaction levels. Similarly, Majee and Hoyt (2011) reported that participatory leadership contributed significantly to community development and improved living standards among cooperative members in rural Missouri, USA. In Kenya, Mwaura, Ngugi, and Muku (2014)

demonstrated that the leadership structure of Savings and Credit Cooperatives (SACCOs) determined their financial viability and member welfare outcomes. Conversely, where leadership is autocratic or corrupt, there is often a breakdown in transparency, weakening of internal democracy, and loss of member engagement (Okoli & Mallo, 2020; Ojo & David, 2016). Supporting this, Lawal and Ojo (2020) observed that many cooperatives in Nigeria collapse due to leaders' failure to uphold fiduciary responsibility and lack of transparency in fund usage. The study by Adeola and Evans (2019) in Ibadan further corroborated this, finding that cooperative societies with weak leadership structures recorded significantly lower levels of member well-being. These findings establish a consistent link between the quality of leadership in cooperative societies and the well-being of stakeholders, justifying the hypothesis that effective leadership practices significantly influence stakeholders' well-being.

Sound financial management is one of the cornerstones of cooperative success and a primary determinant of members' socio-economic benefits. Several studies affirm that prudent financial practices including budgeting, auditing, loan recovery, and transparency directly impact the economic gains of cooperative members. For example, Abdul-Rahman et al. (2014) found that the collapse of several cooperatives in Osun State, Nigeria, was primarily due to poor financial management, embezzlement, and weak internal control systems. In Ethiopia, Abate et al. (2013) revealed that cooperatives with effective financial management practices were better able to provide credit access and dividends, thereby improving members' incomes and agricultural productivity. Gijssels and Bussels (2014) emphasized that strong financial management not only increased cooperative longevity but also translated into better service delivery and member trust. Similarly, Adekunle and Henson (2007) discovered that financial transparency in Nigerian cooperatives led to increased savings mobilization and reinvestment in member welfare projects. In contrast, cooperatives with irregular financial reports and inconsistent accounting practices showed low member retention and trust (Oluyombo, 2013; Okoli & Mallo, 2020). Yakubu et al. (2019) in their research on Northern Nigerian cooperatives found that effective financial planning was directly correlated with improvements in members' access to loans and housing support. These studies clearly support the hypothesis that financial management practices significantly influence the socio-economic benefits derived by cooperative members, especially in regions like Akwa Ibom, where economic vulnerability remains high.

Stakeholder engagement is widely recognized in literature as a determinant of organizational effectiveness, especially in democratic institutions like cooperatives. The extent to which members and other stakeholders participate in governance, planning, and operations often predicts the sustainability and overall performance of cooperatives. Bhuyan (2007) found that cooperatives with high levels of member involvement performed better in terms of productivity and social cohesion. Similarly, Zeuli and Radel (2005) demonstrated that cooperatives in the United States that implemented stakeholder inclusion strategies experienced stronger resilience during economic downturns. In Nigeria, Akpan and Obot (2022) emphasized that cooperatives in Akwa Ibom with regular member meetings, inclusive governance, and feedback mechanisms reported higher success rates and stronger member satisfaction. Misigo et al. (2018), in a study of dairy cooperatives in Kenya, showed that stakeholder engagement enhanced decision quality, reduced conflict, and promoted innovation. In Ethiopia, Place et al. (2004) observed that increased participation of women and youth in cooperative decision-making positively impacted project sustainability and local development. Conversely, Ijaiya and Akanbi (2013) reported that low member participation often resulted in apathy, inefficiency, and eventual collapse of cooperatives in Kwara State, Nigeria. Additionally, Wanyama, Develtere, and Pollet (2008) linked stakeholder inclusivity with institutional resilience and long-term impact. These empirical findings collectively validate the hypothesis that stakeholder engagement significantly affects the performance and sustainability of cooperative societies, a dynamic this study aims to explore within the Akwa Ibom context.

2.3 Theoretical Framework

Stakeholder Theory (Freeman, 1984)

Developed by R. Edward Freeman in his seminal work *Strategic Management: A Stakeholder Approach* (1984), Stakeholder Theory posits that organizations should be understood and managed not only for the benefit of shareholders but for all parties affected by the organization's actions including employees, customers, suppliers, community members, regulators, and more (Murdock, 2010; Phillips, 2013; Baumfield, 2016; Lin, 2018). Freeman argued that success in business should be measured by the value created for all stakeholders, not merely financial returns for shareholders. This normative shift in corporate governance emphasizes that organizations have moral, legal, and economic obligations to a broad spectrum of actors. At its core, the theory delineates three perspectives. Firstly, the descriptive view portrays how firms actually operate as systems comprising multiple stakeholder interests. Secondly, the instrumental view suggests that attending to these diverse interests can improve organizational performance. Thirdly, the normative view asserts that stakeholder interests are inherently valuable and deserve equal consideration (Donaldson & Preston, 1995). These strands collectively advocate for broad-based, ethical, and engaged corporate behavior. In the context of cooperative societies, Stakeholder Theory offers a theoretical justification for focusing on leadership, financial transparency, and inclusive stakeholder engagement. Cooperatives are by nature multi-stakeholder enterprises run by members for their mutual benefit, they regularly navigate the trade-offs, power dynamics, and shared responsibilities emphasized in Freeman's model. Effective stakeholder management in this theory translates to equitable governance, open financial processes, and active member participation elements directly addressed in your research hypotheses. Applying Freeman's insights positions your study within a globally recognized theoretical framework that foregrounds inclusivity, shared value, and sustainable impact.

Agency Theory (Jensen & Meckling, 1976)

Agency Theory was formalized by Michael Jensen and William Meckling in 1976, building on earlier economic theories of contractual relationships (e.g., Coase, 1937). It conceptualizes organizations as principal-agent relationships, where the principal delegates decision-making to an agent who may embrace divergent interests due to information asymmetry, moral hazard, and self-interest (Ross, 2024). The core problem is aligning the agent's actions with the principal's best interests. To address these gaps, Agency Theory advocates for governance mechanisms such as performance-based incentives, rigorous monitoring (audits, oversight committees), and organizational structures that reduce information asymmetries. Although developed for profit-driven firms, the theory also applies to nonprofits and cooperatives where elected leaders or managers may diverge from member interests if left unchecked. For cooperatives, which commit to democratic control and member ownership, agency dilemmas can still emerge as leaders may misuse funds, limit transparency, or marginalize members. Effective internal audit systems, financial controls, and leadership accountability are essential to align managerial actions with collective goals. Highlighting these mechanisms through Agency Theory underscores the importance of transparent financial management practices and leadership accountability.

Relevance to the Study

Applying Stakeholder and Agency theories directly supports the study hypotheses. Hypothesis 1 – that leadership practices influence stakeholder well-being – finds theoretical backing in Stakeholder Theory's emphasis on inclusive, ethical decision-making. Effective engagement by leadership ensures members feel valued and positively contributes to their socio-economic welfare. Concurrently, Agency Theory underscores the need for accountability mechanisms to curb self-serving behavior by managers. Regarding Hypothesis 2, which posits financial management practices influence socio-economic outcomes, Agency Theory highlights how proper controls and transparent reporting minimize agency loss and promote member trust. Stakeholder Theory complements this by suggesting that open and participatory financial

procedures enhance perceived legitimacy and stakeholder satisfaction. For Hypothesis 3, centered on stakeholder engagement and cooperative performance, Stakeholder Theory provides the normative and instrumental rationale: active involvement in governance leads to higher performance and sustainability. Agency Theory adds that reducing information asymmetry through engagement improves oversight and diminishes risk of opportunistic leadership behavior. Together, the theories create a robust lens to examine cooperative governance, financial prudence, and engagement in Akwa Ibom's context, aligning seamlessly with your study's hypotheses.

3. Research Methodology

Research Design: The study adopted a descriptive survey research design. This design was chosen because it allowed the researcher to systematically collect and analyze data from a defined population to describe and interpret the current state of affairs regarding the management of cooperative societies and their impact on stakeholders' well-being in Akwa Ibom State. The descriptive approach was appropriate for this research as it helped capture the opinions, attitudes, and practices of members and officials of cooperative societies. It also allowed for the examination of relationships among variables such as leadership practices, financial management systems, stakeholder engagement, and well-being. The design was non-experimental in nature, focusing on observing and analyzing phenomena without manipulating any variables.

Study Area: The research was conducted in Akwa Ibom State, located in the southern region of Nigeria, lies between latitudes 4°30' and 5°33' North and longitudes 7°25' and 8°25' East. The state is one of the 36 states in Nigeria and lies within the South-South geopolitical zone (see figure 1). It is sandwiched between Abia and Rivers States to the West, Cross River State to the East, Abia State to the North and Atlantic Ocean to the South. It comprises 31 Local Government Areas with a wide range of urban, semi-urban, and rural settlements. Akwa Ibom is primarily an oil-producing state but also has a significant proportion of its population engaged in agriculture, trade, and micro-enterprises. This socio-economic landscape has fostered the proliferation of cooperative societies, which have become vital to the financial and social empowerment of residents. These societies include multipurpose cooperatives, agricultural cooperatives, thrift and credit unions, and artisan-based cooperatives.



Figure 1: Map of Akwa Ibom State showing its 31 LGAs

The choice of Akwa Ibom as the study area was informed by the high density and diversity of cooperative societies operating across different sectors of the economy. In addition, the state's government has actively promoted cooperative development through policy support and financial incentives. However, despite these developments, concerns remain about the efficiency of management practices, transparency, and stakeholder inclusion in these cooperatives. Thus, the area offered a rich ground for evaluating how effective management influences stakeholders' well-being. The researcher focused on selected LGAs including Uyo, Eket, Ikot Ekpene, and Oron to ensure a balanced representation of urban and rural cooperative environments.

Population of the Study: The population of this study consisted of all registered members and executive officials of cooperative societies in Akwa Ibom State. According to the Akwa Ibom State Cooperative Development and Rural Development (CRD), there are over 3,258 registered cooperative societies in the state as of 2024, with an average of 25 members per society and a total membership of over 65,000 individuals, encompassing a diverse mix of urban and rural dwellers, traders, farmers, artisans, teachers, and other self-employed or semi-formal sector workers. These cooperatives are spread across the state's 31 LGAs and include a wide range of categories: multipurpose cooperatives, savings and credit unions, agricultural and fishing cooperatives, artisan and trade-based groups, and women/youth-focused cooperatives. The population also includes elected executives such as presidents, secretaries, treasurers, and financial managers who are directly involved in cooperative governance. These leaders are pivotal in implementing management practices that influence member welfare. Since this study focused on understanding management efficiency and stakeholder well-being, both leaders and members of these societies formed a relevant and representative study population.

Sample and Sampling Technique: A multi-stage sampling technique was employed to ensure a representative and balanced sample. The first stage involved the purposive selection of four LGAs including Uyo, Eket, Ikot Ekpene, and Oron. These LGAs were selected based on their population density, economic activity, and high concentration of registered cooperative societies. In the second stage, a list of registered cooperatives was obtained from the CRD office in each selected LGA. From this list, 15 cooperative societies were randomly selected per LGA using a simple random sampling technique, making a total of 60 cooperative societies (15 cooperative societies × 4 LGAs). In the third stage, stratified random sampling was used within each selected cooperative society to select 10 regular members and 2 executive officials (including a leader or financial officer). This ensured the sample included both the governance structure and the general membership base. In total, 12 respondents per society were selected, leading to a total sample size of 720 respondents (60 cooperatives × 12 respondents). This structured and multi-layered sampling approach improved the reliability of the findings and ensured that the voices of different categories of cooperative participants were represented.

Instrument for Data Collection: The primary instrument for data collection was a structured questionnaire titled "Cooperative Management and Stakeholder Well-being Questionnaire (CMSWQ)". The questionnaire was divided into four sections: Section A captured demographic information; Section B focused on leadership practices; Section C assessed financial management practices; Section D measured stakeholder engagement; and Section E explored indicators of stakeholders' socio-economic well-being. The questionnaire consisted of both closed-ended and Likert-scale items (ranging from Strongly Agree to Strongly Disagree), allowing for both structured responses and variability in perception-based answers.

Validity and Reliability of the Instrument: To ensure content and face validity, the questionnaire was vetted by three experts in Cooperative Economics, Research Methodology, and Development Studies from reputable Nigerian universities. Their recommendations were incorporated to improve clarity, relevance, and alignment with the study's objectives. For reliability, a pilot test was conducted with 30 respondents from cooperative societies in Abak LGA (excluded from the main study). The reliability coefficient of the instrument was

determined using the Cronbach Alpha method, and the overall reliability index was 0.86, indicating high internal consistency and reliability.

Procedure for Data Collection: Data collection was conducted over a period of six weeks. The researcher, with the help of trained research assistants, personally administered the questionnaires to the respondents during scheduled cooperative meetings and via coordinated visits. Each participant was given a verbal explanation of the study's purpose, assurance of confidentiality, and the right to decline participation without consequences. Respondents completed the questionnaires in about 25–30 minutes. For those unable to write or read fluently, the research assistants helped by translating into local dialects where necessary. Completed questionnaires were retrieved on-site and within one week, depending on respondents' availability. The researcher ensured minimal disruptions to cooperative meetings and obtained full cooperation from leadership structures in each society.

Data Analysis Technique: The data collected were analyzed using descriptive and inferential statistical techniques. Descriptive statistics such as frequency distributions, percentages, means, and standard deviations were used to summarize the demographic characteristics and general responses. To test the three stated hypotheses, the study employed Pearson Product Moment Correlation (PPMC) and Multiple Regression Analysis using Statistical Package for Social Sciences (SPSS), version 26. These techniques were selected to assess the strength, direction, and significance of relationships between independent variables (leadership practices, financial management, stakeholder engagement) and the dependent variable (stakeholders' well-being). The level of significance was set at $p < 0.05$ for hypothesis testing.

4. Data Analysis and Discussion

4.1 Descriptive Analysis of Questionnaire Administration

The table below present the frequency and percentage of questionnaire administration outcomes in form of number administered, returned, and valid questionnaires, as well as those that were not returned or invalid for the study.

Out of the 720 questionnaires administered across the sampled cooperative societies in Akwa Ibom State, a total of 698 were returned, representing a high response rate of 97.0%. However, 11 of the returned questionnaires were found to be incomplete or invalid, leaving 687 valid responses, which constitutes 95.4% of the total sample size. Only 22 questionnaires (3.0%) were not returned, which is a minimal loss and does not significantly affect the robustness of the study. The high return and validity rate suggests that the data collected are reliable and representative, enabling credible analysis and generalization of findings.

4.2 Demographic Analysis

Table 4.2 presents the demographic analysis of the 687 valid respondents used in the study.

The demographic profile indicates a diverse and well-balanced sample across gender, age, education, and cooperative involvement. The majority were male (56.19%), within the 41–50 age group (30.43%), and married (62.87%). A significant number had tertiary education (49.93%), followed by secondary education (30.71%), which suggests a well-informed respondent pool. Occupationally, most respondents engaged in trading/artisan (29.55%) and farming (23.44%), which aligns with typical cooperative participation in Akwa Ibom. A sizable proportion (40.91%) had 6–10 years of cooperative membership, suggesting ample experience. Only 19.22% held executive positions, reflecting the broader base of regular members' involvement. In terms of cooperative type, multipurpose cooperatives dominated (42.80%), with strong rural and urban representation. Monthly incomes were modest, with a large share earning less than ₦50,000 (51.25%). Surprisingly, only 40.47% had received cooperative training, and 45.87% had accessed loans, revealing areas for capacity development and financial inclusion.

4.3 Answering Research Questions

Research Question 1: How do leadership practices in cooperative societies affect stakeholders' well-being in Akwa Ibom State? In order to answer the research question, descriptive analysis was performed on the data collected (Table 4.3.1).

Table 4.3.1 shows that respondents generally agreed positively with all items related to leadership practices. The mean values ranged from 3.91 to 4.16, indicating a high perception of effective leadership across the cooperative societies. The highest mean (4.16) was recorded for members being allowed to vote and voice opinions, suggesting that participatory governance is well practiced. All items displayed negative skewness values, indicating that the responses leaned toward the "agree" and "strongly agree" end of the scale. Kurtosis values were generally positive or close to normal, showing a moderately peaked distribution. The percentage of agreement (Agree + Strongly Agree) across items was high, ranging from 77.76% to 85.73%, further confirming strong perceptions of positive leadership practices. These findings suggest that effective leadership characterized by transparency, inclusion, and responsiveness play a significant role in enhancing stakeholders' well-being in cooperative societies across Akwa Ibom State.

Research Question 2: What is the influence of financial management practices of cooperative societies on the socio-economic well-being of stakeholders? In order to answer the research question, descriptive analysis was performed on the data collected (Table 4.3.2).

Table 4.3.2 reveals a consistently high level of agreement among respondents regarding the quality and impact of financial management practices within their cooperative societies. Mean values ranged from 3.94 to 4.11, with the highest mean attributed to the item on personal economic improvement through sound financial practices (Mean = 4.11), emphasizing the perceived socio-economic benefits members derive from proper financial governance. All items reported negative skewness, indicating a concentration of responses on the positive (agree/strongly agree) side. The kurtosis values, mostly positive and within normal range, suggest a slightly peaked response distribution, indicating consensus among participants. The frequency and percentage of respondents who agreed or strongly agreed with each item were also robust, ranging from 77.03% to 83.42%, suggesting widespread trust in the cooperatives' financial management systems. These findings suggest that effective financial practices such as transparency, prudent use of funds, and monitoring strongly influence the socio-economic well-being of stakeholders, thereby affirming the central role of finance in cooperative success in Akwa Ibom State.

Research Question 3: In what ways does stakeholder engagement contribute to the performance and sustainability of cooperative societies in Akwa Ibom State? In order to answer the research question, descriptive analysis was performed on the data collected (Table 4.3.3).

Table 4.3.3 demonstrates that respondents strongly believe in the positive impact of stakeholder engagement on both the performance and sustainability of cooperative societies. Mean scores ranged from 3.96 to 4.14, with the highest mean reflecting the belief that engagement increases commitment and loyalty (Mean = 4.14). This suggests that members view active participation as a driving force for stability and growth. All items exhibited negative skewness, meaning that the distribution of responses skewed toward higher levels of agreement. Similarly, the kurtosis values, all moderately positive, indicate a peaked and consistent response pattern, implying shared perceptions among respondents. The proportion of respondents who agreed or strongly agreed with each item was highly favorable, ranging from 78.86% to 84.12%. These figures underscore that stakeholder inclusion, feedback, and collaborative planning are key contributors to the operational effectiveness and continuity of cooperatives in Akwa Ibom State.

4.4 Research Hypotheses Testing

H₀₁: There is no significant relationship between leadership practices and stakeholders' well-being in cooperative societies in Akwa Ibom State. In order to test the hypothesis, Pearson Product-Moment Correlation Coefficient analysis was used in comparing the mean score of the two independent groups (See table 4.4.1).

The above table 4.4.1 presents the obtained r-value of (0.721). This value was tested for significance by comparing it with the critical r-value (0.079) at 0.05 level with 685 degree of freedom. The obtained r-value (0.721) was greater than the critical r-value (0.079). Hence, the result was significant, meaning that there is a significant relationship between leadership practices and stakeholders' well-being in cooperative societies in Akwa Ibom State. Therefore, the null hypothesis (H₀₁) was rejected.

H₀₂: Financial management practices in cooperative societies do not significantly influence the socio-economic well-being of stakeholders in Akwa Ibom State. In order to answer the hypothesis, simple regression analysis was performed on the data (table 4.4.2).

The above table 4.4.2a&b regression analysis reveals a strong and statistically significant relationship between financial management practices and the socio-economic well-being of stakeholders in cooperative societies. The R-value of 0.693 indicates a high positive correlation, while the R-square of 0.480 implies that 48.0% of the variance in stakeholders' socio-economic well-being can be explained by financial management practices alone. The ANOVA table supports the model's statistical significance, with an F-value of 732.164 and a p-value (Sig.) of 0.000, which is less than 0.05. This confirms that the regression model is significant. Consequently, the null hypothesis is rejected, and it is concluded that financial management practices significantly influence the socio-economic well-being of stakeholders in cooperative societies within Akwa Ibom State.

H₀₃: Stakeholder engagement does not have a significant effect on the performance and sustainability of cooperative societies in Akwa Ibom State. In order to test the hypothesis, Pearson Product-Moment Correlation Coefficient analysis was used in comparing the mean score of the two independent groups (See table 4.4.3).

The above table 4.4.3 presents the obtained r-value of (0.755). This value was tested for significance by comparing it with the critical r-value (0.079) at 0.05 level with 685 degree of freedom. The obtained r-value (0.755) was greater than the critical r-value (0.079). Hence, the result was significant, meaning that stakeholder engagement has a significant and positive effect on the performance and long-term sustainability of cooperative societies in the state. Therefore, the null hypothesis (H_{03}) was rejected.

4.5 Discussion of Findings

Leadership Practices and Stakeholders' Well-being

The findings from both the descriptive analysis and Pearson correlation analysis indicate a strong and significant relationship between leadership practices and stakeholders' well-being in cooperative societies in Akwa Ibom State. The high mean scores (ranging from 3.91 to 4.16) and the strong correlation coefficient ($r = 0.721$, $p < 0.05$) affirm that when cooperative leadership is participatory, inclusive, and responsive, stakeholders perceive greater benefits in terms of social satisfaction, trust, and engagement. This result is consistent with previous studies emphasizing the critical role of leadership in member-based organizations. For instance, Obasi and Nwachukwu (2020) reported that inclusive leadership structures significantly impact members' loyalty and satisfaction in Nigerian cooperatives. Adebayo and Yusuf (2018) confirmed that transformational leadership practices increase transparency and boost members' morale. Ibrahim and Usman (2019) found that democratic leadership improves trust and information flow in grassroots cooperatives, ultimately enhancing stakeholder welfare. In line with this, Agbo and Okafor (2017) stressed the role of participatory governance in sustaining long-term member involvement. Kareem (2015) and Eneanya (2016) also affirmed that leadership accountability and openness directly improve stakeholder relations. Internationally, Birchall (2011) emphasized that leadership responsiveness in cooperatives fosters equity and shared prosperity. Chukwuemeka and Ekpenyong (2022) equally noted that leadership training positively correlates with improved social cohesion in Nigerian cooperative settings. These aligned studies lend credence to the current findings and reinforce that leadership is a central determinant of stakeholders' well-being in cooperatives.

Financial Management Practices and Socio-economic Well-being

The simple regression results ($R = 0.693$; $R^2 = 0.480$; $F = 732.164$; $p < 0.05$) show a statistically significant influence of financial management practices on the socio-economic well-being of stakeholders in Akwa Ibom's cooperative societies. The high level of agreement in descriptive responses (Mean values between 3.94 and 4.11) indicates that transparency, prudent fund utilization, and accountability are widely recognized as core contributors to economic empowerment and financial security among members. This finding aligns with Okonkwo and Nwosu (2017), who observed that sound financial practices in cooperatives significantly improved members' access to credit and savings. Ayinde and Adeagbo (2020) reported that transparency in fund administration leads to improved trust and financial participation. Olowu (2016) emphasized the importance of financial literacy and management tools in cooperative success. In a similar study, Udo and Eme (2018) found that effective budgeting and expenditure control enhanced livelihood outcomes for cooperative members in Southern Nigeria. Afolabi and Gana (2021) showed that cooperative societies with structured financial audits and proper bookkeeping maintained higher levels of financial sustainability.

Njoku (2014) supported this by noting that mismanagement of cooperative funds typically leads to disintegration, while good governance yields growth and stakeholder satisfaction. Chukwu and Mordi (2019) highlighted that proper financial reporting and access to records built members' confidence and investment. Eze and Okoro (2015) similarly found that financial control mechanisms correlate positively with improved income and household welfare. These related studies affirm the robustness of the current study's findings and underscore the foundational role of financial management in cooperative effectiveness.

Stakeholder Engagement and Performance/Sustainability of Cooperatives

The results of the Pearson Product Moment Correlation analysis ($r = 0.755$, $p < 0.05$) confirmed a strong positive and statistically significant relationship between stakeholder engagement and the performance and sustainability of cooperative societies. The descriptive statistics also revealed high levels of agreement (Mean scores 3.96–4.14) with a majority of respondents believing that active participation fosters continuity, loyalty, and operational success in cooperatives. This outcome supports the findings of Ibe and Alu (2017), who showed that cooperatives that incorporate members into decision-making processes are more likely to sustain operations. Nwachukwu and Oboh (2019) found that stakeholder voice leads to higher commitment and reduced member turnover. Okoroafor and Agbasi (2020) confirmed that regular feedback mechanisms increased organizational trust and member retention. Similarly, Ukwueze and Eboh (2016) observed that inclusive planning enhances project success in community-based organizations. In a broader perspective, Birchall (2004) and ICA (2015) identified member engagement as a defining feature of cooperative resilience and success globally. Adeniran and Kolapo (2021) emphasized that participatory mechanisms deepen loyalty and democratic values in rural cooperative movements. Onyema and Akpan (2022) observed that stakeholder workshops and forums strengthen transparency and innovation. Lastly, Ene and Oloko (2020) pointed out that stakeholder education and inclusion promote not only performance but also intergenerational sustainability.

5. Conclusion

The study examined the effectiveness of cooperative society management and its influence on stakeholders' well-being in Akwa Ibom State, with particular attention to leadership practices, financial management, and stakeholder engagement. The findings revealed that leadership practices characterized by participatory governance, transparency, and inclusivity significantly enhance stakeholders' well-being. Members of cooperative societies who felt involved in leadership decisions demonstrated greater satisfaction, loyalty, and trust in their organizations. Furthermore, the study established a strong relationship between financial management practices and the socio-economic well-being of stakeholders. Sound financial policies, proper record-keeping, and transparent fund utilization were found to boost confidence among members and improve their financial stability. This underscores the role of financial accountability in sustaining cooperative growth and member satisfaction. Additionally, stakeholder engagement was shown to positively affect the performance and sustainability of cooperatives. Active involvement of members in planning, decision-making, and implementation not only promotes ownership and trust but also contributes to the long-term success and resilience of these societies. However, cooperative societies in Akwa Ibom State serve as vital institutions for economic empowerment, financial inclusion, and rural development. The study underscores the need for a strategic blend of visionary leadership, effective financial oversight, and meaningful stakeholder engagement to foster inclusive and sustainable development. Stakeholders, including cooperative leaders, government regulators, and development partners, must recognize the importance of enhancing these management practices to optimize the contributions of cooperative societies to individual and communal well-being in the state.

6. Recommendations

Based on the findings and conclusion of this study, the following recommendations are made:

1. To Cooperative Leaders: Implement regular capacity-building programs on participatory leadership, financial management, and ethical governance to strengthen internal operations.
2. To Akwa Ibom State Government: Provide technical and policy support to cooperatives through the Ministry of Commerce and Industry to enhance compliance, monitoring, and performance evaluation.
3. To Cooperative Members: Encourage active participation in meetings and decision-making processes to foster inclusiveness, accountability, and trust in leadership.
4. To Regulatory Agencies: Strengthen oversight mechanisms to ensure adherence to financial transparency, democratic principles, and operational guidelines among cooperative societies.
5. To NGOs and Development Partners: Collaborate with cooperatives by providing training, tools, and resources aimed at improving stakeholder engagement and financial sustainability.

ABSTRACT

This study investigates the role of Artificial Intelligence (AI) in advancing sustainable food security within Nigeria's agricultural sector. Against the backdrop of growing population pressures, climate variability, and systemic inefficiencies in food production and distribution, the research explores how AI technologies, ranging from precision farming and yield prediction to market access platforms and climate-smart tools, can address the four pillars of food security: availability, access, utilization, and stability. Drawing on theoretical foundations such as the Technology Acceptance Model (TAM), Diffusion of Innovation Theory (DOI), and socio-technical systems theory, the study presents a contextualized analysis of AI adoption among Nigerian farmers. Through literature synthesis and multi-stakeholder perspectives, the study identifies critical barriers, including poor digital infrastructure, high costs, low digital literacy, and policy fragmentation. It also highlights emerging opportunities for empowering smallholder farmers through localized, farmer-centric AI innovations. The findings reveal a significant gap in empirical and localized research on AI in Nigerian agriculture and emphasize the need for integrated, inclusive strategies that bridge technology, policy, and human capital. The study concludes with actionable recommendations for policymakers, innovators, and development actors, positioning AI as a strategic imperative for achieving resilient and inclusive food systems in Nigeria.

INTRODUCTION

Food security remains a pressing concern in Nigeria, where population growth, climate variability, limited access to modern farming technologies, and post-harvest losses undermine agricultural productivity and sustainability. In recent years, Artificial Intelligence (AI) has emerged as a transformative tool in global agriculture, offering innovative solutions in precision farming, crop disease prediction, pest control, weather forecasting, and supply chain optimization (Jha et al., 2019; Kamilaris et al., 2018). However, despite global advances, the integration of AI into Nigeria's agricultural sector is still in its infancy, hindered by infrastructural deficits, digital illiteracy, and inadequate policy frameworks.

Existing literature has explored AI's application in agriculture in developed countries, focusing on technological efficiency and productivity improvements (Wolfert et al., 2017; Liakos et al., 2018). In the African context, a few studies have addressed digital tools in agriculture (Aker et

al., 2016), yet comprehensive research specifically examining how AI can foster sustainable food security for Nigerian farmers remains sparse. Most studies either emphasize mobile technologies and extension services or overlook the socio-cultural and infrastructural nuances affecting AI adoption in rural farming communities.

This study fills the gap by critically examining the challenges, opportunities, and future direction of leveraging AI for sustainable food security in Nigeria. It investigates both technological and socio-institutional dimensions, offering policy-relevant insights for inclusive digital agricultural transformation. By contextualizing AI's potential within Nigeria's unique agricultural landscape, this research contributes to the growing discourse on digital inclusion, sustainable development, and food systems resilience.

DEFINITION OF KEY CONCEPTS

Artificial Intelligence (AI) in Agriculture

Artificial Intelligence (AI) in agriculture refers to the integration of computational systems that can perform tasks typically requiring human intelligence to enhance agricultural productivity and decision-making. These include machine learning algorithms, computer vision, robotics, and expert systems used in areas such as crop disease prediction, precision irrigation, pest control, and yield forecasting (Jha et al., 2019; Liakos et al., 2018). AI enables real-time data analysis and automation, reducing manual labor, minimizing resource wastage, and optimizing farm management practices (Kamilaris & Prenafeta-Boldú, 2018).

Sustainable Food Security

Sustainable food security exists when all people have physical, social, and economic access to sufficient, safe, and nutritious food to meet their dietary needs and food preferences for an active and healthy life, without compromising future generations' ability to meet their own needs (FAO, 2021). It is commonly defined through four pillars - Availability: Adequate food supply from domestic production or imports. Access: Individuals' ability to acquire food (economic and physical). Utilization: Proper biological use of food requiring a diet with sufficient energy and nutrients. Stability: Consistent food access over time, without risks of sudden disruptions (Barrett, 2010).

Digital Agriculture and Smart Farming

Digital agriculture refers to the use of digital technologies, platforms, and data-driven innovations to transform and enhance all aspects of agricultural and food systems (World Bank, 2019). Smart farming, a subset of digital agriculture, focuses on integrating technologies such as AI, IoT, drones, sensors, and data analytics to support precision agriculture practices, leading to resource efficiency, productivity enhancement, and environmental sustainability (Wolfert et al., 2017). These technologies support real-time monitoring, decision support, and automation of farming activities.

THEORETICAL UNDERPINNINGS

To explain the adoption and integration of AI technologies for sustainable food security in Nigeria, this study draws from three complementary theoretical lenses:

Technology Acceptance Model (TAM)

Developed by Davis (1989), the Technology Acceptance Model posits that users' acceptance of technology is primarily influenced by two factors:

- **Perceived Usefulness (PU):** The belief that the technology will improve job performance.
- **Perceived Ease of Use (PEOU):** The belief that using the technology will be free of effort.

In agricultural contexts, TAM helps understand how farmers assess the benefits and usability of AI tools. For Nigerian farmers, perceptions of ease, affordability, and value in AI applications (e.g., automated irrigation or pest detection) will shape their willingness to adopt such technologies (Chavoshi & Hamidi, 2019).

Diffusion of Innovation (DOI) Theory

Rogers' (2003) Diffusion of Innovation Theory explains how, why, and at what rate new technologies spread among users. The theory identifies five innovation characteristics influencing adoption: **relative advantage; compatibility; complexity; trialability; and observability.**

This theory is particularly relevant in understanding how AI innovations spread among rural farming communities in Nigeria. Factors such as social networks, peer influence, and cultural compatibility significantly affect adoption rates (Aker et al., 2016). DOI also highlights the importance of change agents and early adopters in promoting diffusion within agricultural systems.

Socio-Technical Systems Theory

The socio-technical systems (STS) theory underscores the interaction between people, technology, and institutional environments. Originally developed by Trist and Emery (1951), the theory suggests that successful technology adoption depends not only on technical efficiency but also on the adaptability of social systems - organizations, practices, and cultural norms.

In this study, STS helps contextualize AI deployment within the broader Nigerian agricultural ecosystem, where farmer education, policy support, access to finance, and cultural beliefs play vital roles in shaping technology use. It promotes a holistic view that integrates technical capabilities with social realities to achieve sustainable outcomes (Geels, 2004).

The combination of AI in agriculture, sustainable food security, and digital farming practices, framed through the lenses of TAM, DOI, and STS, provides a multidimensional understanding of how Nigerian farmers may adopt and benefit from AI technologies. This integrated conceptual framework allows for the exploration of both technological potential and contextual limitations, guiding this study toward practical and policy-relevant insights.

Evolution and Application Areas

The global agricultural landscape is undergoing a profound transformation driven by Artificial Intelligence (AI) - a technological revolution that is redefining how food is cultivated, monitored, and managed. As the world grapples with the dual challenge of feeding a growing population and ensuring environmental sustainability, AI has emerged as a formidable force in shaping the future of agriculture through intelligent, data-driven, and automated systems (Jha et al., 2019; Liakos et al., 2018). The evolution of AI in agriculture reflects a paradigm shift - from labor-intensive practices to precision-driven, sustainable, and predictive farming systems.

AI models trained on localized weather, soil, and crop data can provide reliable climate forecasts, recommend location-specific crop varieties, and connect farmers to better markets via digital platforms. This can reduce uncertainty and increase profitability across diverse agro-ecological zones.

RECOMMENDATIONS

1. This calls for user-friendly platforms that incorporate local languages, voice interfaces, and offline capabilities to ensure accessibility and usability.

3. Strengthen Policy and Regulatory Frameworks: There is a need for a national AI-in-agriculture strategy that integrates agricultural development, digital economy, and data governance. Policies should provide clear guidelines on data privacy, financing, public-private collaboration, and incentives for agri-tech innovation.

4. Build Digital and AI Literacy among Farmers: Government agencies, NGOs, and extension systems should implement training programs to enhance digital and AI literacy among farmers and extension workers. This will empower rural communities to effectively adopt and use AI tools for decision-making and farm management.

5. Enhance Multi-Stakeholder Collaboration: The success of AI adoption depends on coordinated action among farmers, tech developers, policymakers, financial institutions, researchers, and development partners. The establishment of a national agri-digital innovation hub could foster collaboration, experimentation, and knowledge-sharing.

6. Facilitate Inclusive Access to AI Tools: Subsidies, microfinance schemes, and inclusive business models should be designed to make AI technologies affordable and scalable for smallholder farmers, particularly women and youth, who often face additional barriers to digital inclusion.

These recommendations are designed to guide policy actions, development investments, and innovation pathways that will make AI adoption not only feasible but impactful in achieving sustainable food security in Nigeria.

PREDICTIVE MODELING OF STUDENT ACADEMIC PERFORMANCE USING AN INTELLIGENT ENSEMBLE LEARNING FRAMEWORK

ABSTRACT

Predicting student academic performance is a central focus in Educational Data Mining (EDM) and Learning Analytics, as it enables institutions to enhance learning outcomes, identify at-risk students, and implement targeted interventions. This paper presents an Intelligent Ensemble Learning Framework that integrates Extreme Gradient Boosting (XGBoost) and Random Forest (RF) to improve prediction accuracy in student performance modeling. XGBoost, a robust boosting technique known for its scalability and ability to reduce overfitting, is combined with RF in a bagging-based ensemble to enhance model stability and reduce variance. The study utilizes a real-world dataset comprising 400 student records including attendance, demographic information, and academic history collected from Federal Polytechnic Ukana. After preprocessing, which involved normalization and feature selection using Principal Component Analysis (PCA), 16 significant features were identified based on eigenvalues and explained variance. The dataset was split into training (80%) and testing (20%) subsets, and the ensemble model was constructed accordingly. Performance was evaluated using standard regression metrics: Mean Squared Error (MSE), Mean Absolute Error (MAE), R-squared (R^2), Explained Variance Score (EVS), and Median Absolute Error (MedAE). The proposed ensemble model achieved superior performance; with an R^2 score of 0.9900, surpassing both standalone RF (0.9888) and XGBoost (0.9800) models. Visual analyses using scatter plots, grouped bar charts, and heat maps further validated the framework's effectiveness. This research contributes to the expanding field of machine learning applications in education by demonstrating the enhanced predictive power of ensemble regression models. The findings highlight the value of advanced predictive modeling techniques for supporting proactive decision-making and personalized student support in higher education environments.

One of the most important aspects of learning analytics and educational data mining (EDM) is predicting students' academic success. Institutions can identify students who are at danger, carry out focused interventions, and enhance overall learning outcomes by using accurate performance prediction (Romero and Ventura, 2020). Machine learning approaches are more effective alternatives to traditional statistical models like linear regression because they can better capture the intricate, nonlinear interactions between demographic and academic characteristics (Kotsiantis et al., 2010).

In order to predict students' academic performance, this study suggests an Intelligent Ensemble Learning Framework that makes use of Random Forest (RF) and Extreme Gradient Boosting (XGBoost). Because they include several learning methods to increase prediction accuracy, regression-based ensemble models have become more popular (Inyang and Johnson, 2025b). While Random Forest Regression improves model stability and lowers variance by combining several decision trees (Breiman, 2001), XGBoost is a potent boosting method that is well-known for its effectiveness in managing big datasets and preventing overfitting (Chen and Guestrin, 2016). The suggested framework seeks to improve prediction accuracy over single-model methods by combining these two models.

Using Federal Polytechnic Ukana as a case study, this research evaluates the effectiveness of the ensemble learning approach in predicting students' cumulative grade point average (CGPA) based on a combination of academic records, demographic information, attendance, and other relevant features. The model's performance is assessed using standard regression evaluation metrics, including Mean Squared Error (MSE), Mean Absolute Error (MAE), R-Squared Score (R²), Explained Variance Score (EVS) and Median Absolute Error (MedAE).

By implementing this framework, educational institutions can gain deeper insights into student performance trends, enabling proactive decision-making to support students in achieving better academic results. This research contributes to the growing field of machine learning in education, demonstrating the effectiveness of ensemble regression models in academic performance prediction (Inyang and Johnson, 2025a).

The remainder of the document is structured as follows: Section 2 presents literature review while the methodology is presented in section 3. The results and discussion of the system are in section 4 in detail and section 5 presents the conclusion of the study.

2.0 Literature Review

2.1 Overview of Academic Performance Prediction

The prediction of students' academic performance has been a widely studied area in Educational Data Mining (EDM). Researchers have applied various machine learning techniques to predict academic outcomes and identify at-risk students (Romero and Ventura, 2020). Early studies relied on statistical models such as multiple linear regression (Musso et al., 2013) and logistic regression (Hijazi and Naqvi, 2006). However, these models struggled to handle complex, nonlinear relationships in student data, leading to the adoption of advanced machine learning techniques (Kotsiantis et al., 2010).

2.2 Machine Learning in Academic Performance Prediction

Machine learning algorithms, including decision trees, support vector machines (SVM), and neural networks, have been widely employed in predicting student performance. A study by Abu Saa et al. (2019) reviewed various predictive models and found that ensemble learning techniques outperformed single models in terms of accuracy. Similarly, Patel et al. (2020) demonstrated that decision tree-based models performed better than traditional statistical techniques in predicting students' final grades.

2.3 Extreme Gradient Boosting (XGBoost) in Educational Prediction

XGBoost is a powerful boosting algorithm that has shown high efficiency in predictive tasks. XGBoost has been applied successfully in student dropout prediction (Akçapınar et al., 2019) and performance forecasting (Martinez-Plumed et al., 2019). Researchers have found that XGBoost outperforms traditional classifiers like Random Forest and Support Vector Machines due to its ability to handle missing data and prevent overfitting (Chen and Guestrin, 2016).

2.4 Random Forest in Academic Performance Prediction

Random Forest (RF) has been widely used for educational predictions due to its high interpretability and robustness (Breiman, 2001). Studies have shown that RF provides high

accuracy in predicting academic success when applied to large datasets (Mishra et al., 2020). Additionally, RF has been effective in handling high-dimensional educational data, including demographic and behavioral features (Huang and Fang, 2022).

2.5 Ensemble Learning for Performance Prediction

Recent studies have emphasized the superiority of ensemble learning models over single classifiers in academic performance prediction. Hybrid models that combine boosting and bagging techniques, such as the XGBoost-Random Forest hybrid approach, have demonstrated higher prediction accuracy and generalization ability (Aljohani et al., 2021). For instance, Singh and Lal (2021) found that an ensemble model combining RF and XGBoost achieved a lower mean absolute error (MAE) and root mean squared error (RMSE) compared to individual models.

2.6 Evaluation Metrics in Performance Prediction

Regression models for academic prediction are evaluated using Mean Absolute Error (MAE), Mean Squared Error (MSE), and R-squared (R^2) (Han et al., 2011). Multiple studies have validated these metrics for assessing model performance (Alhassan et al., 2022). Research by Ramaswami and Bhaskaran (2019) highlighted that models with lower MAE and RMSE scores provide more reliable performance predictions, making ensemble models a preferred choice.

2.7 Application to Polytechnic Education

Most studies focus on university students, but recent research has explored machine learning applications in polytechnics and technical institutions. Adejo and Connolly (2018) analyzed polytechnic students' academic performance using random forest and deep learning models. Their results indicated that polytechnic education presents unique challenges due to practical coursework and hands-on training, making robust prediction models essential.

2.8 Review of related works

Kumar et al. (2024) examined a range of student characteristics, such as behavioral and academic data, using Random Forest and XGBoost classifiers. With training and testing accuracies of roughly 96.46% and 87.50% for Random Forest and 95.05% and 84.38% for XGBoost, respectively, the models demonstrated high accuracy rates. According to the results, these group approaches may lower failure rates by giving educators insightful knowledge about student behavior.

The Predictive Feature Analytics (PFA) method put forth by Asselmen et al. (2023) is based on ensemble learning techniques such as Random Forest, XGBoost, and AdaBoost. Their strategy was tested on three different datasets with the goal of improving student performance prediction accuracy, and it outperformed conventional techniques.

In a comparative research, Singh et al. (2024) assessed many machine learning algorithms for categorizing and forecasting the academic achievement of students. The study sought to develop a predictive framework and evaluate its accuracy and efficiency in predicting academic results in order to support data-driven decision-making in educational establishments.

Using the advantages of Random Forest for feature extraction and XGBoost for prediction, Zhang et al. (2022) presented an academic prediction technique based on feature engineering and ensemble learning. The technique sought to increase prediction accuracy by using Random Forest to determine feature relevance and ranking and by utilizing a forward search approach.

Fernandes et al. (2022) investigated the automatic evaluation of student performance using data from smartphones. The study used machine learning models, such as SVMs, XGBoost,

and AdaBoost-SAMME with Random Forest, to obtain self-reported data and passive data (such as activity and location) via a smartphone application, with accuracies higher than 78%.

In order to predict students' academic success, Alamri et al. (2024) created a deep ensemble learning technique. In addition to introducing a novel feature-ranking methodology, the suggested approach proved successful in forecasting student performance and offered important new information about student involvement and understanding.

An XGBoost-based approach was used by Zhang et al. (2021) to predict student performance from a macro viewpoint. By offering precise and practical predictions on student performance, the method sought to address problems like student dropout and the distribution of instructional resources.

An ensemble machine learning method for predicting students' academic success was proposed by Zhang et al. in 2021. Using an ensemble learning technique, the system combined the output of several feature engineering, data sampling, and prediction models to generate final predictions, examining the potential of conventional machine learning models.

In order to improve student performance prediction, Mukherjee et al. (2023) integrated an improved Random Forest classifier. The objective of the suggested approach was to attain higher classification and prediction accuracy in contrast to algorithms such as Naive Bayes, Bagging, Boosting, and the traditional Random Forest.

Rahman et al. (2023) addressed the problem of student dropout in higher education by proposing a prediction model that makes use of the XGBoost algorithm. In order to enable institutions to carry out focused interventions, the approach sought to give early detection of students at danger of dropping out.

2.9 Research Gap and Contribution

Despite the progress in machine learning-based performance prediction, few studies have explored ensemble learning frameworks in polytechnic settings. Furthermore, while XGBoost and RF have been studied separately, their combined potential in a hybrid framework remains underexplored. This study aims to bridge this gap by implementing an intelligent ensemble learning framework combining XGBoost and RF to enhance academic performance prediction at Federal Polytechnic Ukana.

3.0 Methodology

In consultation with stake holders in Federal Polytechnic Ukana 402 data points consisting of 23 attributes were collected from six (6) out of eight (8) departments of the institution. The data was collected through the administration of questionnaires. The data was cleaned and transformed, so that some outliers were identified and resolved, getting rid of 2 data points and leaving 400 data points to be used in this study. The attributes of the data are: Age, Gender, Residential status, Father's Educational Level, Mother's Educational Level, Previous Academic Background, Mode of Study, Attendance in Classes, Study Hours Per Day, Preferred Learning Style, Number of Siblings, Family Income Level (Monthly), Parental Support In Studies, Internet Access at Home, Use of Private Tutoring, Sleep Duration Per Night, Participation in Extracurricular Activities, Use Of Social Media (Hour Per Day), Motivation Level For Academic Success, Main Challenge in Studies, Confidence Level in Current Courses, Current CGPA and Performance in Previous Semester.

To enhance the use of the data on machine learning algorithms, non-numeric columns were converted to numeric values as follows:

- i. Range-Based Columns: Age, Use of Social Media (Hour per Day), Study Hours per Day, and Sleep Duration per Night were converted to numeric midpoints of their ranges.

- ii. Ordinal Columns: Attendance in Classes, Confidence Level in Current Courses, and Motivation Level for Academic Success were encoded using ordinal scales based on their relative order.
- iii. Categorical Columns: Categorical columns like Gender, Mode of Study, and Preferred Learning Style were label-encoded into integer values.
- iv. Numeric columns like Current CGPA were preserved without changes.

To transform data to suitable format, Min-Max Scaling (Normalization) method was adopted because it actively eliminates the effect of inconsistent ranges of the datasets and improves convergence (Ahmed et al., 2022). This method scales the features to a specified range, usually [0, 1] using the formula:

$$X_{normalized} = (X - X_{min}) / (X_{max} - X_{min}) \quad \text{Equation 7}$$

Where X is the original feature and $X = \{X_1, X_2, \dots, X_n\}$, X_{min} is the minimum value of the feature in the dataset, and X_{max} is the maximum value of the feature in the dataset.

Extreme Gradient Boosting (XGBoost) and Random Forest (RF) are the tools utilized in this work. In the training phase, a bootstrap method is used to train each Regressor individually using its own duplicated training data set. Two sets of data: the training and testing sets are created from the data. Twenty percent (20%) of the data are for testing, and the remaining eighty percent (80%) are for the training set.

A total of 16 out of 22 input characteristics were chosen by principal component analysis (PCA) based on their Eigen values and explained variance percentages. The features are previous academic results(GPA), preferred learning style, performance in, previous semester, family income level (monthly), number of siblings, age, father's educational level, main challenges in studies, use of social media (hour per day), motivation level for academic success, internet access at home, confidence level in current courses, parental support in studies, study hours per day, sleep duration per night, mother's educational level, attendance in classes, participation in extracurricular activities, use of private tutoring. The decision of using 16 input features was arrived at using literature source. According to Araújo and Santos (2018), features with eigen values of 0.5 and above are stable; hence the decision of using 16 features.

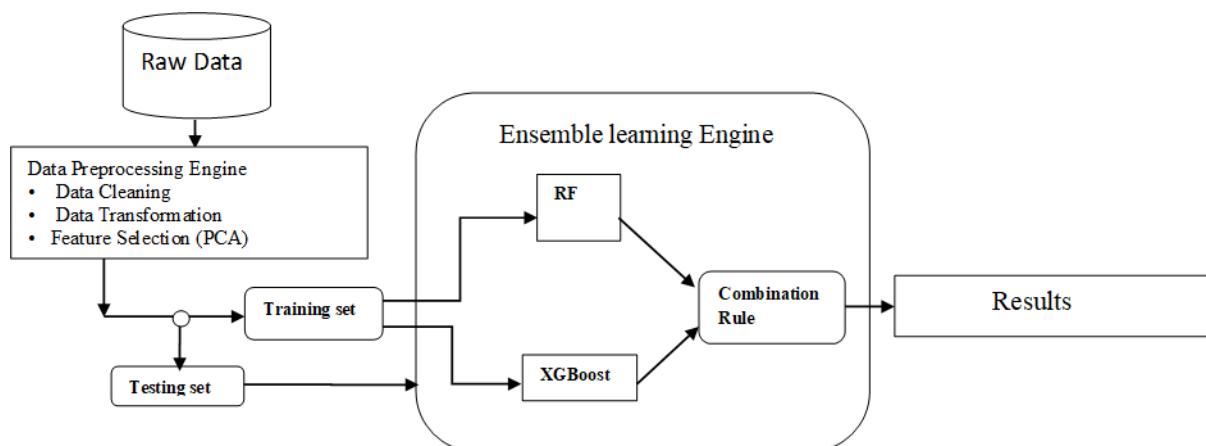


Figure 1: System Architecture

The architectural design of the study is shown is Figure 1

Raw data are data obtained from students for the purpose of this research. Sample raw data, sample data converted to numeric format and the normalized data is shown in Table 1, 2 and 3 respectively.

Data Preprocessing Engine cleans and transforms data, and then data is divided into training and testing set used in training the RF and XGBoost models. Models are ensemble using bagging technique and predictions made.

The ensemble learning engine, a subsystem of the intelligent ensemble learning framework for the prediction of students' academic performance, demonstrates the combination of the two machine learning techniques to predict student academic performance. Result component of the system architecture shows the results that will be obtained after a successful implementation of the system.

3.1 Combination Rule for the Ensemble Learning Engine

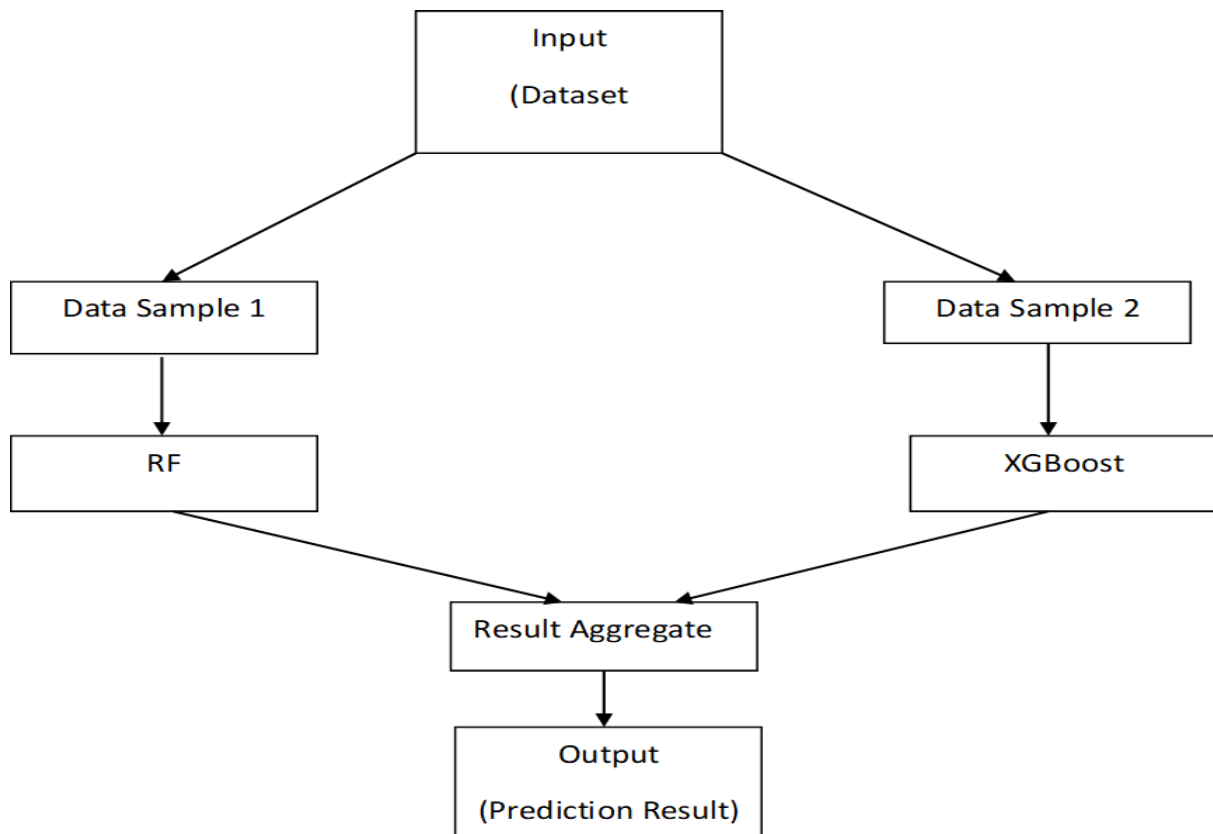


Figure 2: Bagging Technique Framework

The combination rule states the way the two (2) Regression tools in the system architecture of Figure 1 are fused together. The combination rule that is used in this study is the bagging rule. The bagging rule is depicted in Figure 2.

4.0 Results and Discussion

The implementation procedure for the prediction of student academic performance was performed in python programming environment on anaconda software in the following steps:

- i. Dataset Extraction
- ii. Features Selection
- iii. Training and Testing
- iv. Results Visualization and Evaluation.

The datasets collected for the purpose of this research was 402. It was stored in Comma-Separated Values (csv) format. Simplicity, readability, wide compatibility, flexibility, standardization and data exploration and visualization were the reason for the choice of csv (Kaur et al 2020). The data was cleaned and transformed.

The input features are denoted by x , which includes all columns from index 1 to 22, and the target variable denoted by y is the 23th column. The features that formed the independent variables were Age, Gender, Residential status, Father's Educational Level, Mother's Educational Level, Previous Academic Background, Mode of Study, Attendance in Classes, Study Hours Per Day, Preferred Learning Style, Number of Siblings, Family Income Level (Monthly), Parental Support In Studies, Internet Access at Home, Use of Private Tutoring, Sleep Duration Per Night, Participation in Extracurricular Activities, Use Of Social Media (Hour Per Day), Motivation Level For Academic Success, Main Challenges in Studies, Confidence Level in Current Courses, and Performance in Previous Semester while the target variable was the Current CGPA feature.

A principal component Analysis (PCA) was conducted on the features and sixteen out of the twenty-two input features were selected based on their Eigen values and Explained Variance Percentage as shown on Table 4.

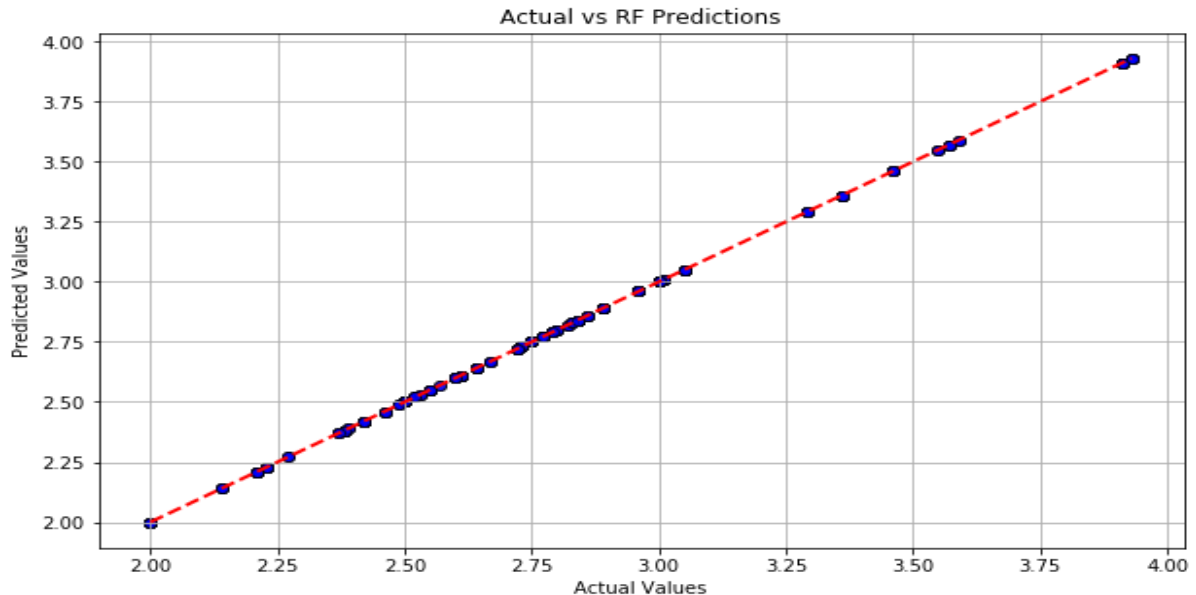


Figure 2: Scatter plot of Actual CGPA against RF predictions

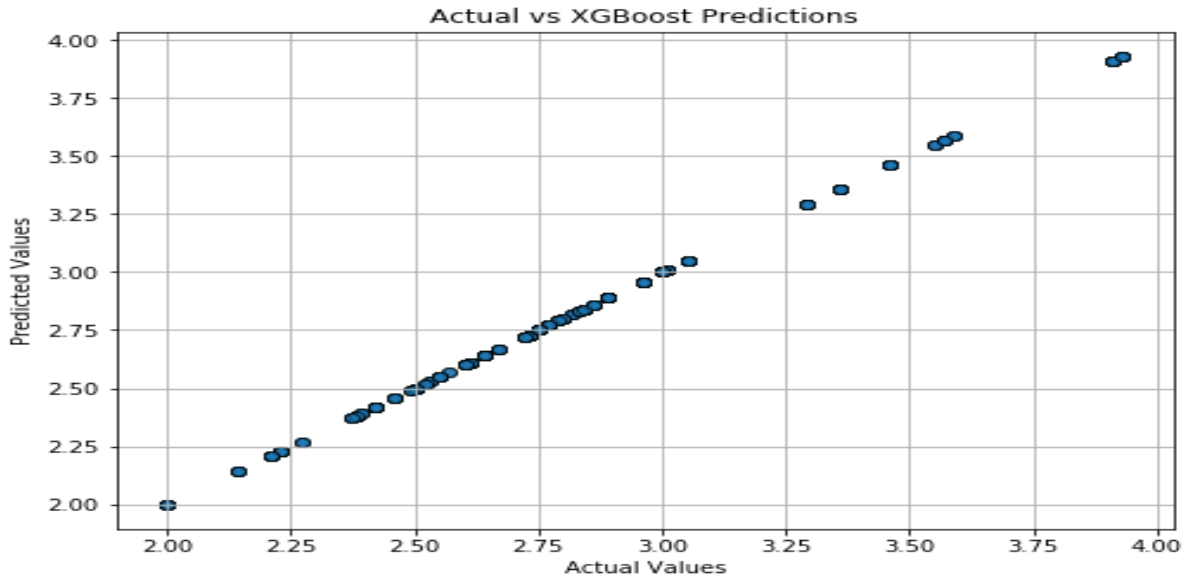


Figure 3: Scatter plot of Actual CGPA against XGBoost predictions

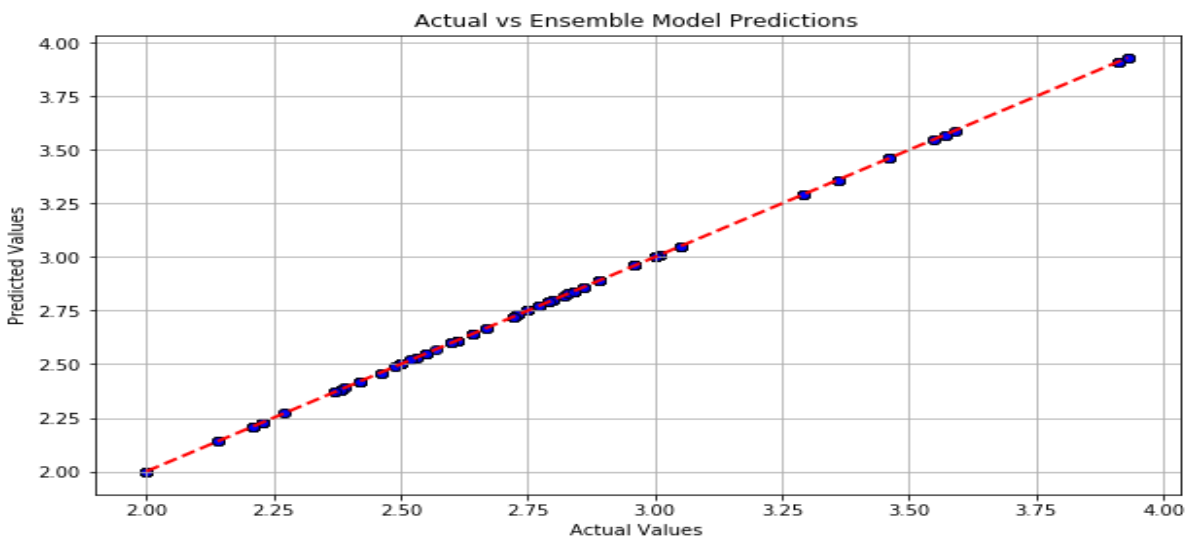


Figure 4: Scatter plot of Actual CGPA against Ensemble model predictions

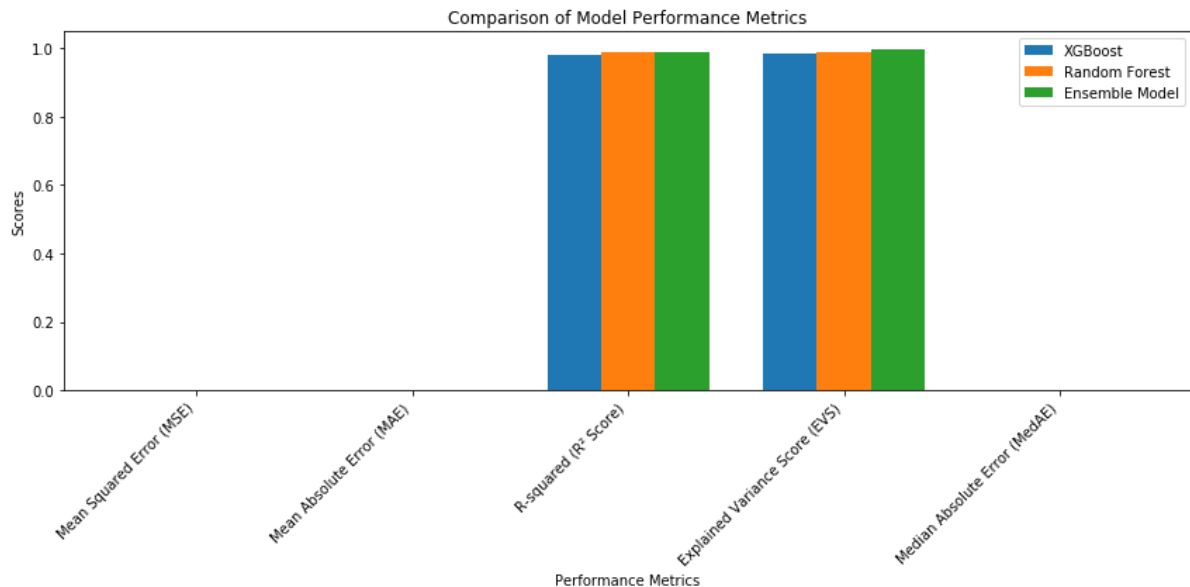


Figure 5: Grouped bar chart comparison of the performance of XGBoost, RF and Ensemble model

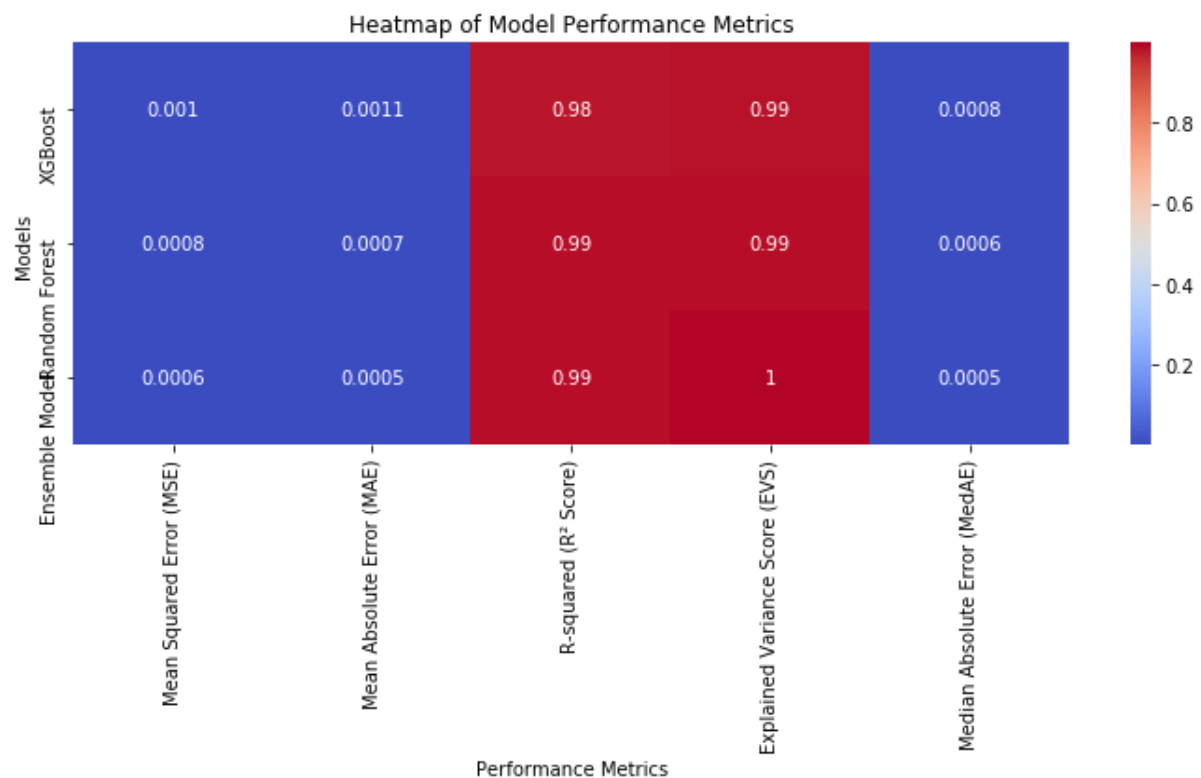


Figure 6: heat map comparison of performance of the three (3) models

The error metrics used in the evaluation of the models include Mean Squared Error (MSE), Mean Absolute Error (MAE), R-Squared Score (R²), Explained Variance Score (EVS) and Median Absolute Error (MedAE). Visualization tools used are scatter plot, grouped bar chart and heat map. PCA was conducted on the datasets to select features and sixteen (16) features were selected based on their eigen values. Three models (RF, XGBoost Ensemble of both) were used to predict student academic performance and results obtained were compared with actual results of students.

- i. In RF, the MSE gives a value of 0.0008, MAE a value of 0.0007, R² a value of 0.9888, EVS a value of 0.9900 while MedAE gives a value of

0.0006. On visualizing RF with scatter plot, it is seen that the relationship between variables is high, positive and linear.

- ii. The XGBoost model has an error value of 0.0010 with MSE, 0.0011 with MAE, 0.9800 with R2, 0.9867 with EVS, and 0.0008 with MedAE. The model shows that the relationship between variables is high, positive and linear.
- iii. In Ensemble model, the MSE gives a value of 0.0006, MAE a value of 0.0005, R2 a value of 0.9900, EVS a value of 0.9990 while MedAE gives a value of 0.0005. On visualizing this model with scatter plot, it is seen that the relationship between variables is very high, positive and linear. With the values of the performance metrics in comparison to XGBoost and RF, the Ensemble model can be said to have better performance.

5.0 Conclusion

In order to improve prediction accuracy over individual machine learning models, this study proposed an Intelligent Ensemble Learning Framework for predicting students' academic performance using Random Forest (RF) and Extreme Gradient Boosting (XGBoost). The framework was tested using data collected from Federal Polytechnic Ukana, incorporating various academic, demographic, and behavioral features. Principal Component Analysis (PCA) and Min-Max scaling were used as data preprocessing techniques to ensure high-quality inputs for model training.

The findings showed that when it comes to predicting students' Cumulative Grade Point Average (CGPA), the ensemble model performed better than the individual RF and XGBoost models. The superiority of the ensemble approach was validated by performance evaluation metrics like Explained Variance Score (EVS), R-Squared Score (R2), Mean Squared Error (MSE), Mean Absolute Error (MAE), and Median Absolute Error (MedAE). The robust link between actual and anticipated CGPA values was further confirmed by the scatter plots and heat maps, demonstrating the dependability of the suggested framework.

The results demonstrate how machine learning can be used in educational data mining to help institutions identify at-risk students and carry out focused interventions. Educational institutions can improve academic results by employing ensemble learning strategies to obtain a deeper understanding of student performance trends. To further improve prediction accuracy, future studies should investigate the incorporation of other variables, such as psychological and environmental aspects. Furthermore, the framework's generalizability across various educational contexts may be enhanced by testing it on bigger and more varied datasets.

By showing how well ensemble regression models predict academic success, this study advances the expanding field of learning analytics. The suggested framework offers educational institutions a reliable and expandable method for making data-driven choices, guaranteeing improved assistance for students in reaching academic success.

THE POTENCY OF COOPERATIVE SOCIETIES: AN X-RAY OF 1937 AND 1966 INTERNATIONAL COOPERATIVE ALLIANCE PRINCIPLES

ABSTRACT

Background: This study undertakes a comparative analysis of cooperative societies operating under the 1937 and 1966 International Cooperative Alliance (ICA) frameworks in Nigeria. The aim was to evaluate how these frameworks influence operational practices, efficiency, and institutional effectiveness in diverse regional and sectoral contexts. **Methodology:** A mixed-methods research design was adopted, integrating quantitative and qualitative approaches to enhance depth, validity, and contextual richness. The study was conducted in seven purposively selected Nigerian states including Akwa Ibom, Rivers, Abuja (FCT), Lagos, Kano, Oyo, and Enugu chosen to reflect ethno-linguistic and geopolitical diversity. Data were collected using a structured instrument, the Comparative Cooperative Operations and Principles Assessment Questionnaire (CCOPAQ), administered in English, Hausa, Yoruba, Igbo, and Nigerian Pidgin. The sampling frame included various cooperative types credit, agricultural, workers', and multipurpose. A total of 379 questionnaires were distributed using multi-stage sampling, with 354 successfully retrieved (93.40% response rate). Additionally, 14 qualitative interviews were conducted with cooperative leaders to deepen interpretation. **Findings:** Descriptive and inferential analyses using SPSS v26 and NVivo revealed that cooperatives under the 1966 ICA framework demonstrated greater adherence to community development, education, and inter-cooperative collaboration, whereas those under the 1937 framework prioritized internal governance and thrift-based member services. Hybrid models showed moderate performance across key dimensions. Regional and institutional factors significantly influenced framework adoption and cooperative effectiveness. **Conclusion:** The study underscores the relevance of context-sensitive frameworks and recommends a hybridized adoption for greater adaptability and sustainability in Nigeria's cooperative movement.

1. Introduction

Cooperative societies have long stood as pivotal instruments for socio-economic development, offering members a means to collectively meet their needs through democratic governance and mutual support. The foundational framework that guides these societies globally has been significantly shaped by the International Cooperative Alliance (ICA), whose principles were formally codified in 1937 and later revised in 1966. These principles have evolved in response to the socio-economic transformations of the 20th century and continue

to influence cooperative policy and practice today (Birchall, 2005; MacPherson, 1995). Understanding the potency of cooperative societies requires a rigorous assessment of these foundational principles, especially within the historical contexts of their promulgation.

The 1937 ICA principles marked the first formal international agreement on the essential values that should guide cooperative activity. Scholars such as Holyoake (1947) and Fairbairn (1994) argue that these principles were both a culmination of the Rochdale Pioneers' vision and a strategic response to the interwar global economic uncertainties. Later analyses by Levi and Davis (2008) underscore the influence of the Great Depression in shaping the 1937 version, as cooperatives needed stronger ideological guidance amidst capitalist failures. Similarly, Craig (1993) and Zeuli & Cropp (2004) observe that the early ICA framework emphasized political neutrality, voluntary membership, and mutual benefit, all of which reinforced resilience in cooperative business models. By anchoring themselves in these shared values, cooperatives were able to differentiate from profit-maximizing capitalist firms, thereby gaining trust and legitimacy.

However, as the post-World War II world underwent profound transformations including decolonization, the rise of welfare states, and global industrialization the limitations of the 1937 principles became evident. The ICA thus revised its guiding principles in 1966 to reflect these global shifts. Scholars such as MacPherson (1995), Birchall (2004), and Münkner (1992) highlight that the 1966 revision incorporated a more modern understanding of democratic governance, expanded economic functions, and broadened social responsibilities. For example, the inclusion of principles such as concern for community and inter-cooperation acknowledged the expanding role of cooperatives in national development. These were necessary adjustments in light of emerging critiques, such as those from Bottomley (1987), who emphasized the need for cooperatives to function beyond just consumer protection and extend to social transformation.

Moreover, studies by Shaw (2006), Mazzarol et al. (2011), and Novkovic (2008) have revisited the relevance of both 1937 and 1966 ICA principles in contemporary cooperative governance. Their findings suggest that despite temporal and geographical variations, these principles remain relevant but require contextual adaptations. For instance, while the 1937 principles emphasized autonomy, the 1966 version responded to critiques about cooperatives' dependence on state subsidies and introduced greater clarity on autonomy and independence. Similarly, Cook (1995) and Chambo (2009) argue that revisiting these foundational norms can help address governance failures, especially in developing economies where cooperatives often face state overreach or elite capture.

Further academic discourse has examined the practical implementation of ICA principles across different cooperative sectors. For example, studies by Baka (2013) on agricultural cooperatives in Africa, Somavia (1999) on worker cooperatives in Latin America, and Simmons & Birchall (2008) on consumer cooperatives in Europe collectively reveal that adherence to ICA principles whether 1937 or 1966 correlates with enhanced cooperative performance and member satisfaction. Conversely, these studies also highlight that rigid or non-contextual application of principles can render cooperatives ineffective or even collapse under market pressures. This has led to a newer body of research advocating for a flexible interpretation of ICA principles, taking into account regional governance models, cultural contexts, and economic structures (Defourny & Nyssens, 2006; Roy & Tisdell, 1998).

Additionally, in recent years, the cooperative model has regained global attention as a viable alternative to neoliberal economic systems, particularly after the 2008 financial crisis. Studies by Utting & Morales (2010), Michie et al. (2017), and Langmead (2016) argue that revisiting the 1937 and 1966 ICA principles offers timely lessons on economic democracy, sustainability, and community resilience. These scholars propose that the potency of cooperative societies lies not only in their business outcomes but also in their ethical framework, which contrasts sharply with the extractive logic of shareholder capitalism. Furthermore, the principles have been shown to inspire modern innovations, such as platform cooperatives and social enterprises, which align with the ethos of mutual benefit and democratic governance (Scholz,

2016; Ridley-Duff & Bull, 2011). It is against this background, the present study seeks to explore the 1937 and 1966 International Cooperative Alliance Principles on the potency of cooperative societies. However, objectively, the study was to:

1. examine the operational practices of cooperative societies under the 1937 and 1966 ICA frameworks, with a view to identifying how core principles are applied in contemporary cooperative management.
2. assess the operational efficiency of cooperatives operating under each framework, especially in relation to democratic governance, member participation, financial sustainability, and service delivery.
3. compare and evaluate the significant differences between the 1937 and 1966 ICA frameworks, in terms of their impact on cooperative performance and adaptability.

Research Questions

1. What are the key operational practices adopted by cooperatives under the 1937 and 1966 ICA frameworks, and how do they align with the foundational cooperative principles?
2. How does the operational efficiency of cooperatives differ between those aligned with the 1937 framework and those with the 1966 framework, in terms of governance structure, financial performance, and member satisfaction?
3. What are the fundamental differences between the 1937 and 1966 ICA frameworks, and how do these differences influence cooperative effectiveness in different states?

2. Literature Review

2.1 ICA Overview of Cooperative

A cooperative is an autonomous association of persons united voluntarily to meet their common economic, social and cultural needs and aspirations through a jointly-owned and democratically-controlled enterprise. However, cooperative core values are based on self-help, self-responsibility, democracy, equality, equity, and solidarity. In the tradition of their founders, cooperative members believe in the ethical values of honesty, openness, social responsibility and caring for others (ICA, 2025). Further, cooperative principles are guidelines by which cooperatives put their values into practice.

1. **Voluntary and Open Membership:** Cooperatives are voluntary organisations, open to all persons able to use their services and willing to accept the responsibilities of membership, without gender, social, racial, political or religious discrimination.
2. **Democratic Member Control:** Cooperatives are democratic organisations controlled by their members, who actively participate in setting their policies and making decisions. Men and women serving as elected representatives are accountable to the membership. In primary cooperatives members have equal voting rights (one member, one vote) and cooperatives at other levels are also organised in a democratic manner.
3. **Member Economic Participation:** Members contribute equitably to, and democratically control, the capital of their cooperative. At least part of that capital is usually the common property of the cooperative. Members usually receive limited compensation, if any, on capital subscribed as a condition of membership. Members allocate surpluses for any or all of the following purposes: developing their cooperative, possibly by setting up reserves, part of which at least would be indivisible; benefiting members in proportion to their

transactions with the cooperative; and supporting other activities approved by the membership.

4. **Autonomy and Independence:** Cooperatives are autonomous, self-help organisations controlled by their members. If they enter into agreements with other organisations, including governments, or raise capital from external sources, they do so on terms that ensure democratic control by their members and maintain their cooperative autonomy.
5. **Education, Training, and Information:** Cooperatives provide education and training for their members, elected representatives, managers, and employees so they can contribute effectively to the development of their co-operatives. They inform the general public - particularly young people and opinion leaders - about the nature and benefits of co-operation.
6. **Cooperation among Cooperatives:** Cooperatives serve their members most effectively and strengthen the cooperative movement by working together through local, national, regional and international structures.
7. **Concern for Community:** Cooperatives work for the sustainable development of their communities through policies approved by their members (ICA, 2025).

2.2 Origin and Ideology of the 1937 Principles

The 1937 International Cooperative Alliance (ICA) principles represent the first global codification of the cooperative ethos, serving as a unifying standard for cooperative societies worldwide. These principles were rooted in the legacy of the Rochdale Pioneers of 1844 but were formalized against the backdrop of significant global economic and political upheavals during the interwar period. Their origin reflects both a philosophical reaffirmation of cooperative identity and a strategic response to the rising threats of economic instability, fascism, and monopolistic capitalism.

Historically, the Rochdale Society of Equitable Pioneers laid the foundation for cooperative doctrine by establishing democratic governance, member economic participation, and limited returns on capital (Yeo, 1988; Curl, 2012). However, it was not until 1937 that the ICA crystallized these tenets into an internationally recognized framework. According to Dicaire (2007), the formal adoption of the principles came amid a need for global coherence in cooperative operations, particularly as cooperatives began to proliferate in Europe, North America, and parts of the colonial Global South. The 1937 ICA Congress in Paris thus responded to both internal demands for clarity and external pressures threatening cooperative autonomy.

The core ideology of the 1937 principles was defined by six key values: voluntary and open membership, democratic member control, member economic participation, autonomy and independence, provision of education and training, and cooperation among cooperatives (Laidlaw, 1980). These principles were inherently normative, aiming to preserve cooperative integrity by differentiating them from both state-dominated structures and profit-driven enterprises. As highlighted by Bülbül and Tamer (2017), the 1937 codification emerged as a defensive yet assertive articulation of what it meant to be a cooperative in a world increasingly dominated by centralized and hierarchical economic institutions.

One of the distinguishing features of the 1937 framework was its political neutrality clause. This was designed to ensure that cooperatives remained independent of party politics, especially in an era when totalitarian regimes sought to co-opt or dissolve civil society organizations (Wanyama, 2009). By embedding political neutrality as a foundational principle, the ICA signaled its commitment to protecting cooperatives as democratic and voluntary spaces, free from external coercion. Yet, some scholars have critiqued this neutrality as a strategic concession that undermined cooperatives' capacity for political mobilization (Poirier, 2014).

From a theoretical standpoint, the 1937 principles can be seen as grounded in classical liberal values emphasizing individual freedom, voluntary association, and limited intervention while simultaneously promoting collective ownership and shared benefits (Restakis, 2010). This ideological dualism allowed cooperatives to appeal to both leftist movements and liberal democracies. According to Lévesque and Mendell (2005), this unique positioning gave cooperatives a political and economic resilience during times of market failure and state collapse.

The process of articulating and disseminating the 1937 principles was also deeply influenced by cooperative education. Cooperative leaders recognized that for the principles to be meaningful, they had to be understood and internalized by members at all levels (Harnecker, 2011). As such, cooperative training centers and manuals proliferated, embedding the 1937 ideology within the day-to-day governance structures of cooperatives globally. The principles became not only ethical guidelines but practical tools for institutional structuring.

Further, the 1937 principles offered an international moral compass in the absence of strong global governance institutions. Before the formation of the United Nations or the Bretton Woods system, the ICA principles acted as a proto-international legal framework guiding transnational cooperation (Majee & Hoyt, 2011). While not legally binding, their moral authority carried significant weight, particularly in post-colonial states where cooperatives were often seen as tools for national development and self-reliance.

2.3 Rationale for the 1966 Revision of ICA Principles

The revision of the International Cooperative Alliance (ICA) principles in 1966 marked a significant ideological and strategic shift in the global cooperative movement. While the 1937 principles provided a foundational framework rooted in the classical Rochdale model, the socio-political realities of the post-World War II era demanded a more responsive and adaptable set of principles. The 1966 revision was, therefore, not merely an update but a structural redefinition of cooperative identity and purpose in a rapidly changing world.

The period between 1945 and 1965 witnessed unprecedented changes in global governance, economic reconstruction, and social organization. The decolonization of Africa and Asia, the rise of welfare states in Europe, and the emergence of the Cold War bloc politics altered the roles that cooperatives were expected to play in national and local development (Hannan, 2014). Many newly independent countries adopted cooperatives as tools for inclusive economic participation and poverty alleviation, often supported or subsidized by the state. According to Birchall (1997), this state involvement introduced a paradox: while governments facilitated cooperative expansion, they also risked undermining cooperative autonomy.

The ICA recognized that the 1937 principles, particularly those emphasizing political neutrality and strict autonomy, were insufficient to address the complex interplay between cooperatives and the state in this new era. As a result, the 1966 revision was initiated to clarify core values, reconcile emerging contradictions, and reflect a more globalized understanding of cooperation. One major addition was the explicit recognition of cooperative education as essential not only for members but also for the public and policymakers (Craig, 1994). This emphasized the proactive role cooperatives must play in shaping public discourse and development policies.

Another crucial change in 1966 was the reframing of autonomy. The original principle of independence was revised to accommodate cooperatives that received external support, particularly from governments and NGOs, provided such assistance did not compromise democratic control (Tchami, 2007). This adjustment responded to criticisms that rigid autonomy made cooperatives impractical in developing contexts where self-financing was nearly impossible. As Uzeh and Onugha (2015) note, this pragmatic flexibility was pivotal in enabling cooperatives to function within development planning frameworks across Africa and Asia without losing their identity.

The revision also emphasized the principle of “cooperation among cooperatives,” which, although present in earlier versions, was given more structural importance in 1966. The ICA began to stress horizontal linkages between cooperatives at local, national, and international levels to enhance solidarity and economies of scale (Spear, 2000). This collective capacity-building approach became essential for resisting market monopolization and maintaining relevance in competitive sectors like agriculture, retail, and finance.

Notably, the 1966 revision came during a time when the cooperative movement was being challenged by new organizational models, including state corporations and multinational enterprises. According to Novkovic and Holm (2012), the revised principles sought to differentiate cooperatives by reinforcing their dual economic-social identity, where economic viability had to be balanced with social justice and democratic participation. The introduction of community responsibility as an implicit principle reflected growing recognition that cooperatives could no longer operate in isolation from broader societal concerns.

Moreover, the 1966 principles were shaped by increasing academic interest in cooperative governance. Research by Münkner (1976) and Hussi et al. (1993) helped inform the revision process by identifying governance failures and best practices in cooperative structures worldwide. Their work showed that a clearer articulation of principles could reduce internal contradictions and improve the strategic governance of cooperatives.

Finally, the revision also anticipated future evolutions in cooperative identity. Scholars such as Vieta (2010) and Develtere (1992) argue that the 1966 principles laid the groundwork for later developments, including the 1995 ICA Statement on the Cooperative Identity. In this way, the 1966 principles functioned as a transitional framework bridging the traditionalist ethos of the 1937 version with the modernist imperatives of globalization, development policy, and participatory economics.

2.4 Relevance and Critique of ICA Frameworks in the 21st Century

The relevance of the ICA frameworks both the 1937 and 1966 principles has come under renewed scrutiny in the 21st century, especially in the context of global economic inequality, ecological crises, and the search for alternative governance models. Contemporary debates surrounding the ICA principles revolve around their enduring normative value, adaptability in diverse socio-economic contexts, and effectiveness in distinguishing genuine cooperatives from hybrid or commercialized entities. While these principles continue to provide a moral and operational compass for cooperative identity, critics argue that they require contextual reinterpretation and institutional innovation to remain effective in a dynamic global landscape.

One of the most significant indicators of the frameworks’ contemporary relevance is the global resurgence of interest in cooperatives following the 2008 global financial crisis. In response to the failures of conventional capitalist institutions, cooperatives gained attention as democratic and socially responsible business alternatives (Spear & Thomas, 2013). According to the United Nations’ declaration of 2012 as the International Year of Cooperatives, the ICA principles remain vital in promoting inclusive growth and sustainable development, particularly among marginalized populations (UN, 2012). Moreover, recent empirical data show that cooperatives that actively uphold the ICA principles have demonstrated greater resilience to economic shocks and better member loyalty (Roelants, Eum, & Terrasi, 2014).

However, the increasing diversity of cooperative forms has raised concerns about the sufficiency and clarity of the existing ICA frameworks. Platform cooperatives, energy cooperatives, and social enterprises that claim cooperative identity often operate in hybrid spaces where traditional principles may not fully apply or are inconsistently implemented (Scholz, 2016; Morozov, 2018). For instance, the principle of democratic member control faces new challenges in digital cooperatives, where decision-making often becomes centralized among core developers or platform managers, despite formal member ownership. These developments have prompted scholars to call for a revision or supplementation of the ICA principles to reflect technological, ecological, and organizational transformations (Conaty, Bird, & Ross, 2020).

Another critical issue in the contemporary critique of the ICA frameworks is their normative vagueness and the difficulty of enforcement. While the principles provide ethical guidance, they lack legal binding force, leading to the proliferation of “nominal cooperatives” that function as conventional businesses but use cooperative labeling for branding or regulatory advantages (Zamagni, 2012). This has been particularly prevalent in some transitional economies where the cooperative label is exploited without adherence to democratic governance or member-driven agendas. As Birchall (2013) notes, the absence of a formal accreditation system based on the ICA principles allows for dilution of cooperative identity, undermining public trust and sectoral cohesion.

Additionally, scholars argue that the ICA frameworks do not sufficiently address issues of power asymmetry, intersectionality, and social justice within cooperatives themselves. In practice, many cooperatives still struggle with elite capture, gender imbalances, and generational disengagement (Majurin, 2012; Tandler, 1983). The ICA principles promote inclusivity and equality, yet their application often relies on internal governance dynamics and broader cultural factors that may hinder their realization. For example, in many African and South Asian cooperatives, patriarchal structures or political patronage systems interfere with democratic processes, highlighting a disjunction between normative principles and lived realities (Develtere, Pollet, & Wanyama, 2008).

Furthermore, environmental sustainability one of the key global concerns of the 21st century is only implicitly present in the current ICA frameworks. With the rise of climate-conscious business models, there is growing pressure to explicitly integrate ecological responsibility into cooperative principles. As Utting (2015) observes, while cooperatives often engage in sustainable practices, the ICA’s formal frameworks have yet to catch up with global expectations on environmental governance and the role of cooperatives in climate action. Despite these critiques, many scholars and practitioners defend the continued relevance of the ICA principles as a dynamic framework rather than a rigid doctrine. They argue that the principles provide a necessary ethical foundation, and their adaptability has allowed cooperatives to evolve across centuries and sectors. For instance, Johnson (2018) suggests that the ICA frameworks should be viewed as a “living document” that guides but does not constrain innovation within the cooperative model.

2.5 Cooperatives Performance under the 1937 and 1966 ICA Frameworks

The performance of cooperative societies operating under the ideological frameworks of the 1937 and 1966 ICA principles reveals a complex pattern of outcomes influenced by governance models, socio-economic contexts, state policies, and organizational structures. Although both sets of principles have offered normative guidance, their practical implementation has varied widely, yielding both successes and limitations depending on the region, sector, and policy environment.

Under the 1937 framework, cooperative success was frequently tied to strong adherence to democratic governance, economic self-reliance, and member participation. In post-industrial Europe, consumer and retail cooperatives that followed these principles exhibited significant resilience during times of market instability. According to Birchall and Simmons (2004), the Co-operative Wholesale Society in the UK and consumer cooperatives in Sweden demonstrated above-average member satisfaction and financial sustainability during the mid-20th century due to their focus on equitable service delivery and internal democratic structures. Similarly, Hansmann (1996) argues that cooperatives governed by traditional principles achieved relative efficiency by minimizing agency costs, especially in homogenous-member organizations such as agricultural and housing cooperatives.

However, several studies have highlighted that cooperatives operating under the 1937 principles also encountered challenges related to capital accumulation, innovation, and external competition. For example, Nilsson (2001) notes that agricultural cooperatives in Western Europe and North America often failed to modernize or expand due to their reluctance to admit non-member investment or reinvest surplus capital. This rigid adherence to autonomy

and member financing limited scalability in competitive markets. Moreover, without a clear framework for inter-cooperation and education outreach as expanded in 1966 many cooperatives lacked broader strategic alliances and leadership development, leading to inefficiencies and internal stagnation.

The 1966 revision sought to address these limitations, and empirical evidence suggests that cooperatives aligning with the revised principles experienced enhanced operational capacity, expanded membership outreach, and greater relevance in development initiatives. For instance, in sub-Saharan Africa and South Asia, where state-supported cooperatives became central to post-independence rural development strategies, cooperatives benefited from external technical and financial support while maintaining core cooperative values (Sharma, 2010; Wanyama, 2009). These cooperatives adopted a pragmatic approach, accepting government involvement without compromising democratic member control, as sanctioned by the revised autonomy clause of the 1966 principles.

In Latin America, worker cooperatives operating under the 1966 framework also demonstrated notable resilience during economic downturns. Studies by Thomas and Logan (2008) show that worker-owned enterprises in Argentina and Uruguay maintained employment and productivity during the 1990s neoliberal reforms by leveraging internal democracy and strong community integration attributes supported by the revised ICA principles that emphasized education, solidarity, and cooperation among cooperatives.

Additionally, the incorporation of the "cooperation among cooperatives" principle in 1966 fostered the emergence of second-tier structures, federations, and networks that amplified the collective impact of individual cooperatives. For example, Mondragón Corporation in Spain, which scaled significantly in the 1980s and 1990s, attributes part of its success to inter-cooperation, shared services, and cooperative education systems all in alignment with post-1966 ICA values (Cheney, 1999). These mechanisms allowed cooperatives to overcome structural inefficiencies by pooling resources and sharing best practices.

Empirical data also suggest that cooperatives adhering to the revised principles are more likely to incorporate gender inclusivity, environmental sustainability, and community development goals into their mission. According to ICA and ILO joint reports (ICA-ILO, 2015), cooperatives across Asia and Africa that implemented the revised principles tend to outperform their counterparts in areas such as gender balance in leadership and long-term social impact. These findings reinforce the broader relevance of the 1966 framework in supporting cooperatives as agents of inclusive development.

Nonetheless, challenges persist even under the revised framework. Misalignment between stated principles and actual practice remains a critical issue. As noted by Bateman (2010), donor-driven cooperatives in some developing countries have become overly dependent on external funding, with little democratic engagement or member ownership, thus contradicting the very principles intended to empower them. Furthermore, in some contexts, the vagueness of the revised principles has led to co-optation by non-cooperative actors, resulting in pseudo-cooperatives that exploit the cooperative brand for personal or political gain (Münkner, 2012).

2.6 Studies Cross-Comparison of ICA Frameworks Implementation in Regions

The global implementation of the ICA principles both from the 1937 and 1966 frameworks has produced varied outcomes, shaped by regional governance contexts, socio-cultural structures, levels of economic development, and degrees of institutional support (see Table 1). Comparative studies across continents reveal both convergences and divergences in cooperative effectiveness, adaptability, and fidelity to core ICA values. These cross-regional analyses provide critical insight into how cooperative principles function in practice, rather than as abstract ideals, and expose the tensions between global cooperative standards and local development realities.

In Europe, cooperative principles have generally been implemented with high consistency and institutional support. The Nordic countries, in particular, exemplify the integration of

cooperative models into welfare economies. In Finland and Sweden, cooperatives have historically received strong legal backing and financial stability, enabling them to thrive across sectors including agriculture, retail, and banking (Jussila, Byrne, & Tuominen, 2012). Their success has been attributed to the high level of cooperative education, strong inter-cooperative networks, and supportive regulatory frameworks aligned with both 1937 and 1966 principles. In contrast, Southern European cooperatives, particularly, Italy and Spain have developed more hybridized forms, combining social enterprise models with cooperative values, as seen in the Legacoop and Mondragón networks (Borzaga & Galera, 2012).

By contrast, in sub-Saharan Africa, cooperative development has historically been characterized by state intervention and varying degrees of autonomy. While many African cooperatives claim adherence to ICA principles, several studies have shown that implementation is often hindered by weak internal governance, political patronage, and low member education (Kwapong & Korugyendo, 2010; Francesconi & Wouterse, 2011). In countries like Kenya and Ethiopia, donor-driven cooperative formations have sometimes resulted in the erosion of democratic control, despite improvements in income generation and rural livelihoods. These mixed outcomes underscore the need for contextual adaptation of ICA principles without undermining cooperative identity.

In South Asia, particularly India and Sri Lanka, the cooperative movement has a long-standing presence rooted in both colonial and post-independence development strategies. India's cooperative banks and agricultural societies have significantly contributed to rural credit access and agrarian reform (Batra & Dey, 2019). However, the strict adherence to 1937 autonomy and self-help principles has been compromised in many cases due to overregulation, politicization, and financial mismanagement. The Indian experience illustrates the challenges of maintaining ideological purity when cooperatives are used as instruments of state policy. In contrast, cooperative societies in Nepal, which embraced the 1966 framework more explicitly after democratic reforms, have demonstrated relatively strong adherence to ICA norms in both governance and member participation (Acharya, 2014).

Latin America provides another important contrast in cross-regional analysis. Cooperatives in Argentina, Brazil, and Uruguay have emerged as key players in resisting neoliberal economic reforms and fostering community resilience (Henrique & Ramos, 2013). Brazilian agricultural cooperatives, especially in the south, have succeeded by applying the 1966 principles of inter-cooperation and education, with robust internal democratic structures and market competitiveness. Worker cooperatives in Argentina, formed in response to factory closures during economic crises, have adopted ICA principles organically rather than through top-down regulation. Their success in preserving jobs and maintaining productivity speaks to the adaptability of cooperative values in crisis contexts (Vieta, 2020).

In East Asia, cooperative development has followed different trajectories. Japanese cooperatives, especially in agriculture and consumer retail, exhibit strong institutional support and are deeply integrated into the national economic framework. The Japanese Consumers' Cooperative Union (JCCU) exemplifies a cooperative model that adheres to ICA principles while innovating in service delivery, sustainability, and digital engagement (Higuchi, 2012). In contrast, cooperatives in China have experienced a state-led revival since the early 2000s under the "new-type" cooperative model. While this model has expanded rural service access, researchers argue that many Chinese cooperatives lack genuine democratic control and voluntary membership, raising concerns about their alignment with ICA principles (Zhang & Donaldson, 2008).

What emerges from these comparative studies is a recognition that the successful implementation of ICA principles depends on several enabling factors: supportive legal environments, cooperative education, active member engagement, and inter-cooperative networks. At the same time, the risk of principle dilution remains high when cooperatives are co-opted by political or commercial interests, as seen in parts of Africa, South Asia, and post-socialist countries (Tadesse & Bahiigwa, 2015).

3. Research Methodology

This study adopted a mixed-methods research design, integrating both quantitative and qualitative approaches. The choice of a mixed-methods design was informed by the need to combine the breadth of survey data with the depth of qualitative insights to enhance the reliability, contextual relevance, and interpretive richness of the findings (Creswell & Plano Clark, 2011). The study was conducted in seven states of Nigeria: Akwa Ibom, Rivers, Abuja (FCT), Lagos, Kano, Oyo, and Enugu. These states were purposively selected to reflect Nigeria's geopolitical and ethno-linguistic diversity, as well as differences in cooperative structure, legal implementation, and development levels. To ensure effective engagement with respondents, the questionnaire and interview guides were translated and administered in English, Hausa, Yoruba, Igbo, and Nigerian Pidgin, depending on the respondents' language preference. This was important to minimize language barriers and enhance clarity, especially among cooperators with low formal education or limited English proficiency.

The population of the study consisted of registered cooperative societies listed by the various State Departments of Cooperatives and verified through the Federal Department of Cooperatives (2023). The sampling frame covered a diversity of cooperative types including credit cooperatives, agricultural cooperatives, workers' cooperatives, and multipurpose cooperatives. A multi-stage sampling technique was employed. First, the seven states were

purposively selected. Second, within each state, random sampling was used to select cooperative societies from the official registry. Finally, purposive and snowball sampling were used to select individuals who were either executives or active members of the societies and had operational knowledge of the cooperative's activities. Using Taro Yamane's formula for finite populations at a 5% margin of error, a sample size of 379 respondents was determined from the total registered cooperative population. The sample was then proportionally distributed across the selected states. To ensure balance, at least 50 respondents were surveyed from each state, while additional qualitative interviews were conducted with 14 cooperative leaders (two from each state) to enrich the quantitative findings with interpretive depth.

The primary instrument for data collection was a structured and semi-structured questionnaire titled: "Comparative Cooperative Operations and Principles Assessment Questionnaire (CCOPAQ)", designed by the researcher and aligned with ICA's framework indicators (Birchall, 2003; Wanyama, 2009). The questionnaire was divided into five sections: demographic characteristics, operational practices, governance structures, principle adherence, and perceived challenges. Items were rated using a 5-point Likert scale, while the qualitative section consisted of open-ended questions. The instrument was reviewed by experts for content validity and pre-tested with 30 respondents from non-sampled cooperatives in Ogun State. The Cronbach's alpha reliability coefficient for the instrument was calculated as 0.83, indicating high internal consistency. The administration of the questionnaire was conducted through in-person interviews and digital formats (Google Forms, WhatsApp links) depending on location, respondent access, and language. Enumerators proficient in local languages were recruited and trained to assist with in-person administration where local language usage were high.

Of the 379 questionnaires distributed, 354 were successfully completed and retrieved, resulting in a return rate of 93.40%. Demographic analysis showed that out of the 354 respondents, 214 (60.45%) were male while 140 (39.55%) were female. Age distribution revealed that 126 respondents (35.59%) were between 31–40 years, 101 (28.53%) between 41–50 years, 77 (21.75%) between 21–30 years, and 50 (14.13%) were above 50. Regarding educational attainment, 141 respondents (39.83%) had tertiary education, 119 (33.62%) had secondary education, 64 (18.08%) held post-secondary diplomas or NCE, and 30 (8.47%) had only primary or no formal education. In terms of cooperative types, 162 respondents (45.76%) were members of credit cooperatives, 115 (32.49%) belonged to agricultural cooperatives, and 77 (21.75%) were from workers' or multipurpose cooperatives. When asked to indicate which ICA framework best described their cooperative's orientation, 184 (51.98%) aligned with the 1937 model, 137 (38.70%) with the 1966 revision, while 33 (9.32%) described their cooperatives as operating under a hybrid model. However, transcripts from the qualitative interviews were thematically analyzed using NVivo software, while quantitative data were coded and analyzed using SPSS v26, involving descriptive and inferential statistics (including ANOVA and chi-square tests).

4. Data Analysis and Discussion

4.1 Research Questions

Research Question 1: What are the key operational practices adopted by cooperatives under the 1937 and 1966 ICA frameworks, and how do they align with the foundational cooperative principles? In order to answer the research question, descriptive analysis was performed on the data collected (Table 4.1).

The descriptive results in table 4.1 indicate that both the 1937 and 1966 ICA frameworks share core operational practices, though their levels of emphasis differ. Democratic member control remains the most consistently practiced principle under both frameworks (91.30% for 1937; 86.86% for 1966). However, cooperatives aligned with the 1966 framework demonstrate higher adherence to education, community concern, cooperation among cooperatives, and voluntary membership, reflecting the broader, more socially conscious orientation of the revised principles. Hybrid cooperatives show moderate consistency across all areas but less emphasis on community engagement. These results support the premise that the 1966 principles promote a more holistic and externally engaged cooperative model, while the 1937 framework remains more member-centric and internally operational. To complement table 4.1 analysis, the qualitative thematic analysis of interviews revealed three dominant themes in operational practice:

Principle Interpretation and Local Understanding: Respondents noted that while ICA principles are formally adopted, their application is often shaped by local culture, literacy levels, and operational realities. The principles are sometimes implemented in practice rather than in structured form due to varying levels of member awareness. For example, president of a multipurpose cooperative in Enugu State, stated:

“We claim to follow the ICA principles, but if you ask many members to list or explain them, they can’t. It’s through our practices like meetings and elections that people actually understand democracy or participation.”

Similarly, a treasurer of a women’s agricultural cooperative in Kano State, shared:

“In our society, what we do reflects those international ideas, but not everyone knows they are part of a global framework. For many, it’s about trust and group rules.”

Community vs. Member-Centered Focus: A noticeable difference emerged between cooperatives aligned with the 1937 framework, which prioritize internal member services, and those following the 1966 framework, which exhibit broader community outreach and capacity-building efforts. For example, secretary of a cooperative in Ibadan, Oyo State, stated:

“We are focused on thrift and credit. That’s what our members want such as loans, dividends, savings. We don’t do much community work because our job is to help members first.”

In contrast, a chairperson of a youth cooperative in Abuja (FCT) stated:

“After adopting the revised principles, we started organizing trainings and health awareness in our district. We see the cooperative as part of community development, not just for members.”

Also, a manager in Lagos State, emphasized:

“We partnered with NGOs and ran workshops on entrepreneurship. That’s part of the education and cooperation principle from 1966. It’s beyond just loans now.”

Operational Tensions and Resource Constraints: Respondents highlighted several barriers to full implementation of ICA principles, including limited funding, low member education, and regulatory inconsistency. However, many cooperatives make pragmatic adjustments to align with the spirit of the principles despite constraints.

For example, a leader in a fishery cooperative in Akwa Ibom State, observed:

“Education is a big issue. We want to hold training sessions, but members can’t leave their work, and we lack the funds to organize them properly.”

In contrast, a cooperative secretary in Rivers State, noted:

“We use a hybrid model. Some of our policies are based on the 1937 format, but we’ve adopted newer ideas like community outreach and inter-cooperative collaboration.”

Research Question 2: How does the operational efficiency of cooperatives differ between those aligned with the 1937 framework and those with the 1966 framework, in terms of governance structure, financial performance, and member satisfaction? In order to answer the research question, descriptive analysis was performed on the data collected (Table 4.2).

The descriptive results in table 4.2 show notable differences in operational efficiency between cooperatives aligned with the 1937 and 1966 frameworks. Those under the 1966 framework consistently performed better across all key indicators: governance (90.51%), financial reporting (86.13%), and member satisfaction (88.32%). The 1937-aligned cooperatives, though still operationally viable, showed lower performance, especially in member retention (61.41%) and surplus transparency (64.67%). Hybrid cooperatives showed performance levels between the two main categories, indicating partial adoption may improve efficiency, though not as effectively as full integration. To complement table 4.2 analysis, the qualitative thematic analysis of interviews revealed key themes explaining the operational differences in efficiency:

Governance Structure and Member Involvement: According to a chairman from a consumer cooperative in Kano, remarked:

“Our leadership is elected, but we follow the same model used since the 1980s. There is no new structure or evaluation system. So, it works, but not very efficiently.”

Also, a cooperative director in Abuja, aligned with the 1966 framework, observed:

“We conduct annual general meetings, publish our reports, and use digital tools to update members. That’s why members trust us and stay committed.”

Financial Transparency and Performance: According to a treasurer of a credit cooperative in Oyo State using the 1937 framework:

“Our reporting is mainly manual and delayed. We do audits, but not frequently, and some members are suspicious of how surpluses are shared.”

In contrast, a manager of a multipurpose cooperative in Rivers State, stated:

“We adopted a proper accounting software last year, and now our financial records are updated monthly. Members even request to see them, that’s real accountability.”

Member Satisfaction and Retention: A secretary from a 1937-aligned cooperative in Enugu, shared:

“We have loyal members, but we lose younger ones. They say our system is too slow and lacks benefits.”

Conversely, a youth-focused cooperative leader in Lagos, said:

“The revised principles made us more member-focused. We offer training, health packages, and flexible savings plans. Satisfaction has grown and so has our membership.”

Research Question 3: What are the fundamental differences between the 1937 and 1966 ICA frameworks, and how do these differences influence cooperative effectiveness in different states? In order to answer the research question, descriptive analysis was performed on the data collected (Table 4.3).

The descriptive results in table 4.3 highlights substantial contrasts between the two ICA frameworks. The 1937 model strongly emphasizes traditional cooperative values (89.67%) and member-based governance, but scores lower in aspects like education (47.83%), community engagement (50.00%), and global collaboration (39.67%). Meanwhile, the 1966 model integrates modern cooperative strategies particularly in community development (86.13%), training (85.40%), and institutional adaptability (90.51%). Hybrid cooperatives reflect moderate scores, suggesting partial transformation toward broader cooperative goals. These trends were consistent across urban regions (e.g., Lagos, Abuja) where the 1966 framework is more dominant, and rural areas (e.g., Kano, Oyo) where traditional structures persist. To complement table 4.3 analysis, the qualitative thematic analysis of interviews insights into fundamental framework differences and regional institutional dynamics:

Structural and Ideological Divergence: Respondents repeatedly emphasized that the 1937 framework is more inward-focused, emphasizing self-help, thrift, and democratic governance,

whereas the 1966 revision broadened the cooperative mission to include social responsibility, education, and inter-cooperative solidarity. For example, a regional cooperative advisor in Akwa Ibom, noted:

“The 1937 model is like an old constitution, a very member-loyal but outdated for modern realities. The 1966 version made cooperatives part of national development.”

Also, a chair of cooperative union in Kano, said:

“Our elders used the older model because it worked locally. But the new principles bring global ideas that don’t always match our cultural setting.”

Regional Receptiveness and Implementation Challenges: Framework implementation often depends on local governance, infrastructure, and education. Southern regions (Lagos, Abuja, Enugu) favored the 1966 model, citing its flexibility and modern features, while Northern and some South-Western zones preferred the 1937 structure, valuing its simplicity and cultural alignment. For instance, a youth cooperative leader in Lagos, stated:

“We’re using the 1966 approach. It fits our tech-savvy members and supports partnerships with external agencies. That’s harder to do with the old model.”

On the contrary, an elder cooperative leader in Kano, emphasized:

“The new model is complex. Too many principles and partnerships confuse members. We stick to what we know works for our people.”

Institutional Effectiveness and Framework Fit: The effectiveness of each framework varies with the cooperative's age, sector, and institutional goals. Older cooperatives, especially in agriculture and credit unions, leaned toward the 1937 framework due to its established systems, while new-generation cooperatives (ICT, youth, health) aligned better with 1966 principles, which encourage dynamism and broader engagement. For example, director of a digital service cooperative in Enugu, commented:

“The 1966 model supports innovation. We run financial literacy campaigns, train our members online, and interact with other cooperatives globally.”

Meanwhile, a manager in a rural savings cooperative in Oyo State, shared:

“We care more about loans and savings. As long as we manage funds and resolve disputes, other principles are not our priority.”

4.2 Discussion of Findings

Operational Practices Adopted by Cooperatives under the 1937 and 1966 ICA Frameworks

The findings of this study reveal a shared operational base between cooperatives implementing the 1937 and 1966 ICA frameworks, though with notable divergence in emphasis and implementation patterns. Quantitatively, democratic member control was affirmed as the most consistently practiced operational principle, scoring 91.30% under the 1937 framework and 86.86% under the 1966 model. This aligns with foundational ICA ideology, which emphasizes autonomy and democratic control as core cooperative tenets (Birchall, 1997; Craig, 1993). However, cooperatives aligned with the 1966 framework show heightened engagement with socially-oriented principles—education, cooperation among cooperatives, and community concern—reflecting the broader social vision embedded in the

1966 revision (International Co-operative Alliance, 1995; MacPherson, 1998). The qualitative findings further suggest that operational practices are often shaped more by contextual realities than by strict theoretical alignment. This supports findings by Chukwu (1990) and Develtere (1994), who argued that the practical meaning of ICA principles is often localized, particularly in developing economies where formal education levels, awareness, and institutional support are varied. Respondents in Kano and Enugu confirmed that principles are known more in function than in formal articulation, a reflection of the contextual embodiment of cooperative norms, which resonates with Fairbairn's (2003) assertion that cooperatives evolve organically within their sociocultural frameworks. A major divergence observed was the contrast between internal member servicing (1937) and external community engagement (1966). The 1937 model maintains a conservative, member-focused identity, centering operations around thrift, credit, and savings—a finding also echoed in Zeuli and Cropp (2004), who noted that early cooperatives prioritized member protection. On the other hand, cooperatives adopting the 1966 model incorporate training, partnerships, and social interventions, indicating a paradigm shift toward development-oriented practices as advocated by later ICA declarations (ICA, 1995; Birchall, 2005). This mirrors findings from Nyoro and Ngugi (2007) in Kenya and Wanyama (2009), who found that newer cooperatives integrated community-based initiatives in response to the evolution of cooperative values. However, the gap between aspiration and implementation remains. Respondents from Akwa Ibom and Rivers State identified financial and human resource constraints, hindering full alignment with either framework. These findings echo concerns raised by Satgar (2007) and Munkner (2001), who caution that principle implementation, especially in the Global South, is often undermined by structural limitations and institutional weakness. Thus, while the frameworks provide guiding philosophies, their operationalization is largely dictated by local capacity, awareness, and socio-economic realities.

Difference in Operational Efficiency of Cooperatives between those aligned with the ICA 1937 framework and those with the 1966 Framework

The findings indicate that cooperatives aligned with the 1966 framework outperform their 1937 counterparts in key operational efficiency metrics, namely governance effectiveness (90.51%), financial transparency (86.13%), and member satisfaction (88.32%). This is consistent with empirical studies such as Birchall (2004) and Majee & Hoyt (2011), who noted that modernized governance models enhance transparency, member trust, and adaptability. The emphasis on education and open membership in the 1966 model supports more participatory and informed governance practices, as shown in the responses from Lagos and Abuja, where members cited digital communication tools, regular audits, and collaborative decision-making structures. In contrast, cooperatives under the 1937 model, while operationally viable, face difficulties in member retention (61.41%) and financial transparency (64.67%). These figures are in line with the findings of Chambo (2009) and Ortmann & King (2007), who observed that traditional cooperatives, particularly in rural Africa, are often constrained by outdated structures and inadequate training, leading to inefficiencies in financial reporting and reduced member engagement. The qualitative responses corroborate this efficiency gap. Respondents from Kano and Oyo indicated reliance on manual processes, irregular reporting, and hierarchical leadership inherited from historical cooperative culture. Meanwhile, 1966-aligned cooperatives in Rivers and Lagos demonstrate how alignment with modern frameworks fosters responsiveness and accountability. This supports the arguments of Wanyama et al. (2008) and ICA (2015), who asserted that cooperatives embracing continuous training, ICT integration, and participatory governance structures tend to be more efficient and sustainable. Moreover, the 1966 framework's inclusion of education and inter-cooperative collaboration aligns with the enabling institutional environments necessary for operational growth, as observed by Develtere et al. (2008). The hybrid cooperatives fall between the two extremes, reflecting incremental adoption of new frameworks. These findings suggest that while traditional principles remain relevant, cooperatives require institutional innovation and modern tools to improve operational efficiency in contemporary contexts.

Fundamental Differences between the 1937 and 1966 ICA Frameworks and Cooperative Effectiveness in Different States

This study reveals that the primary differences between the 1937 and 1966 frameworks lie in their ideological scope, institutional orientation, and strategic vision. The 1937 principles center on member protection, autonomy, and self-help, while the 1966 revision expanded the cooperative vision to encompass community responsibility, global collaboration, and continuous education. These findings reinforce the conceptual divergence described by MacPherson (1995) and Zamagni (2005), who argued that the 1966 revision marked a shift from isolated member-based models to integrative, development-driven cooperatives. The study confirms that cooperatives operating under the 1937 model thrive in states where traditional communal norms and informal governance still hold sway (e.g., Kano, Oyo), whereas the 1966 model dominates in states with stronger institutional capacity and urban populations (e.g., Lagos, Abuja, Enugu). This regional variation echoes the observations by Birchall (2004), who found that cooperative frameworks must be contextually adapted to match local governance cultures and developmental needs. The qualitative data further validate that the 1966 principles are more adaptable to contemporary challenges. The broader societal orientation of the 1966 model allows cooperatives to engage with public health, entrepreneurship, and youth employment, particularly relevant in Nigeria's urban and peri-urban zones. Meanwhile, the 1937 model, though dependable, appears rigid and less responsive to institutional innovation. These findings are in line with the comparative regional studies by Kurimoto (2010) and Karunanethy & Suresh (2020), who noted that flexibility and openness to partnerships increase cooperative resilience. Importantly, several cooperatives reported hybridization a merging of both frameworks which suggests a pragmatic approach to institutional development. As the cooperative movement evolves, the synthesis of traditional principles with modern strategies appears to be a viable path forward, as advocated by Satgar (2011) in his South African case study.

5. Conclusion

This study critically examined the operational practices, efficiency, and contextual adaptability of cooperatives operating under the 1937 and 1966 ICA frameworks in Nigeria. Drawing from mixed methods research across seven diverse Nigerian states including, Akwa Ibom, Rivers, Abuja, Lagos, Kano, Oyo, and Enugu, the study provided a nuanced understanding of how cooperative principles are interpreted and implemented within varying institutional and socio-cultural contexts. The findings revealed that while both frameworks share foundational cooperative values, they diverge in strategic emphasis and practical execution. Cooperatives aligned with the 1937 principles tend to focus on member-centric goals such as thrift, savings, and internal governance. In contrast, those operating under the 1966 framework demonstrate broader social engagement, enhanced governance structures, financial transparency, and a commitment to community development and education core elements of the revised ICA orientation. The study further highlighted that operational efficiency is higher among cooperatives implementing the 1966 framework, especially in terms of member satisfaction, governance participation, and financial reporting. However, successful implementation often depends on contextual factors such as literacy levels, access to technology, and regulatory environments. The hybrid model adopted by some cooperatives shows promise, suggesting that strategic blending of the two frameworks can enhance institutional resilience and adaptability. Finally, the research supports the conclusion that cooperative effectiveness in Nigeria is influenced not just by the formal adoption of ICA principles but also by local realities, leadership structures, and member participation. The continued relevance of both ICA frameworks depends on how flexibly they can be interpreted and localized to meet changing economic and social demands. Ultimately, empowering cooperatives through capacity building, regulatory support, and principle-based innovation will be crucial in advancing their contributions to inclusive economic development in Nigeria.

6. Policy and Practice Recommendations

Based on the study's findings, the following actionable recommendations are proposed to enhance cooperative performance, sustainability, and alignment with global standards, while respecting local realities:

1. Cooperative leaders and board members should adopt a flexible hybrid model that incorporates the internal governance focus of the 1937 principles with the development-oriented provisions of the 1966 framework.
2. The Federal and State Ministries of Commerce and Industry, along with Cooperative Development Departments, should develop structured, multilingual training programs to educate members and leaders on ICA principles, governance responsibilities, and cooperative ethics.
3. The Corporate Affairs Commission (CAC) and State Cooperative Registrars should establish comprehensive compliance systems including periodic audits, annual reporting requirements, and transparency checks to ensure accountability across cooperatives operating under either framework.
4. Federal and State ICT agencies, in partnership with NGOs and donor organizations, should provide cooperatives with access to affordable digital tools for accounting, communication, membership management, and performance tracking. This will improve operational efficiency and member satisfaction, particularly for cooperatives aligned with the 1966 framework.
5. National and state cooperative unions and apex organizations should establish platforms for knowledge exchange, mentorship, and joint ventures to reinforce the ICA principle of "cooperation among cooperatives." This could include digital forums, annual conferences, and regional networks that promote partnership-driven growth.
6. The Nigerian Educational Research and Development Council (NERDC) and the Ministry of Education should include cooperative education in school and university curricula, especially in business, social studies, and civic education. This will foster a cooperative culture from an early age and build future cooperative leaders.
7. National Assembly committees on commerce and cooperative policy, along with state legislative assemblies, should create enabling laws and guidelines that allow cooperatives to select ICA frameworks based on their sector (e.g., agriculture, ICT, services) and location (urban vs. rural). This would recognize the contextual effectiveness of both frameworks without imposing a one-size-fits-all model.

INVENTORY MANAGEMENT AND PROFITABILITY OF LISTED PHARMACEUTICAL COMPANIES IN NIGERIA

ABSTRACT

This study examined the effect of inventory management on profitability of listed pharmaceutical companies in Nigeria. However, the specific objectives were to examine the effect of inventory turnover on gross profit margin of listed pharmaceutical companies in Nigeria, to access the effect of inventory holding cost on gross profit margin of listed pharmaceutical companies in Nigeria and to determine the effect of economic order quantity on gross profit margin of listed pharmaceutical companies in Nigeria. The study adopted an ex-post facto research design and utilized a panel data of seventy (70) pooled observations gathered from seven (7) listed pharmaceutical firms in Nigeria over ten (10)-year period (2014-2023) and employed a panel multiple regression technique to analyze the data via E-views 10.0 statistical package. The study findings revealed that inventory turnover has a significant positive relationship (Coeff. = 0.414078 {0.0005}) with gross profit margin of listed pharmaceutical firms in Nigeria while inventory holding cost has a significant negative relationship (Coeff. = -3.100747 {0.0298}) with gross profit margin of listed pharmaceutical firms in Nigeria. It also revealed that economic order quantity has a non-significant negative relationship (Coeff. = -0.000525 {0.4067}) with gross profit margin of listed pharmaceutical firms in Nigeria. The study provided conclusive evidence on the importance of effective inventory management in driving profitability in the pharmaceutical industry. The recommendations made included that listed pharmaceutical firms in Nigeria should implement cost-saving measures to reduce their inventory holding costs. This can be achieved by renegotiating storage contracts, implementing just-in-time inventory systems, and reducing inventory obsolescence.

INTRODUCTION

Inventory management is the process of overseeing and controlling the flow of goods or products within a business. It involves the planning, organizing, and tracking of inventory levels to ensure that the right quantities of items are available at the right time and at the right place (Obeidat, 2021). Effective inventory management is essential for businesses to meet customer demand, minimize costs, and optimize operational efficiency. Parma and Shukla, (2021) postulated that inventory management is a critical aspect of operations for pharmaceutical companies, as it directly impacts profitability and overall financial performance. In the context

of listed pharmaceutical companies in Nigeria, efficient inventory management practices can significantly influence their success in a competitive market (Golas, 2020). The pharmaceutical industry in Nigeria is one of the largest and most important sectors, catering to the healthcare needs of the population. With increasing demand for healthcare products and services, pharmaceutical companies face challenges in managing their inventory effectively to meet customer demands while minimizing costs (Mensah et al., 2019).

Effective inventory management involves maintaining optimal levels of stock to ensure timely availability of products, reducing holding costs, and avoiding stockouts (Dave et al., 2021). For pharmaceutical companies, this is crucial as the industry is characterized by stringent regulations, expiration dates for certain products, and the need for proper storage conditions. Listed pharmaceutical companies in Nigeria are subject to scrutiny from regulatory bodies, investors, and stakeholders regarding their financial performance. Golas (2020), recorded that profitability is a key metric that reflects the company's ability to generate revenue and manage costs efficiently. Efficient inventory management practices can contribute to improved profitability through reduced wastage, lower carrying costs, and increased sales due to product availability (Mensah et al., 2019).

Therefore, studying the relationship between inventory management practices and the profitability of listed pharmaceutical companies in Nigeria is essential to understand the impact of inventory management on financial performance. Bagshaw (2019) stated that evaluating factors such as inventory turnover, days of sales of inventory, and gross margin, researchers can gain insights into how inventory management practices influence the profitability of pharmaceutical companies in Nigeria.

Statement of the Problem

The relationship between inventory management and business profitability poses a critical challenge for listed companies for instance the pharmaceutical companies. The issue at hand revolves around the inefficiencies and operational complexities that arise from suboptimal inventory management strategies within these companies. Inadequate inventory control practices may lead to stockouts, overstocking, or inaccurate demand forecasting, ultimately affecting the financial performance and bottom line of pharmaceutical companies as opined by Obeidat, (2021). These challenges are compounded by the stringent regulatory requirements and quality standards imposed on the pharmaceutical sector in Nigeria, which further hinder effective inventory management practices and compliance with industry regulations. Moreover, the dynamic nature of the market, characterized by intense competition, changing consumer preferences, and external economic factors, adds complexity to the inventory management-profitability relationship, necessitating a deeper understanding of how inventory-related decisions impact the overall financial health of listed pharmaceutical firms in Nigeria (Bagshaw, 2019).

Furthermore, the issue of inventory management and its impact on the profitability of listed pharmaceutical companies in Nigeria underscores the broader concern of sustainable business operations and long-term growth prospects (Dave et al., 2021). Inaccurate demand forecasting, inefficient inventory turnover, and lack of coordination in supply chain management can erode profit margins, reduce liquidity, and impede investment in research and development initiatives for pharmaceutical companies (Onikoyi and Ojo, 2019). Golas, (2020) recorded that the inability to strike a balance between maintaining adequate inventory levels and optimizing working capital utilization can result in increased costs, decreased revenue, and diminished competitiveness in the market.

Thus, the central problem lies in the need to enhance inventory management practices to align with strategic business objectives and improve financial performance while navigating the complex regulatory landscape and industry dynamics inherent in the Nigerian pharmaceutical sector (Parmar& Shukla, 2021). Addressing this problem requires a comprehensive analysis of inventory control mechanisms, process efficiencies, technology integration, and

organizational capabilities to foster a sustainable and profitable business model for listed pharmaceutical companies operating in Nigeria.

Objectives of the Study

The main objective of this study was to evaluate the effect of inventory management on profitability of listed pharmaceutical companies in Nigeria. However, this was carefully achieved through the following specific objectives:

1. To examine the effect of inventory turnover on gross profit margin of listed pharmaceutical companies in Nigeria
2. To access the effect of inventory holding cost on gross profit margin of listed pharmaceutical companies in Nigeria.
3. To determine the effect of Economic order quantity on gross profit margin of listed pharmaceutical companies in Nigeria

Research Questions

This study sought to provide reliable answers to the following questions;

1. What is the effect of inventory turnover on gross profit margin of listed pharmaceutical companies in Nigeria?
2. How does inventory holding cost affect gross profit margin of listed pharmaceutical companies in Nigeria?
3. To what magnitude of effect does economic order quantity have on gross profit margin of listed pharmaceutical companies in Nigeria?

Research Hypotheses

Based on the research objectives and the research questions, the following null hypotheses were formulated for the study.

- Ho₁:** There is no significant relationship between inventory turnover and gross profit margin of listed pharmaceutical companies in Nigeria.
- Ho₂:** No significant relationship exists between inventory holding cost and gross profit margin of listed pharmaceutical companies in Nigeria.
- Ho₃:** Economic order quantity has no significant relationship with gross profit margin of listed pharmaceutical companies in Nigeria.

Scope of the Study

Content scope: This study examined the relationship between inventory management and profitability of Pharmaceutical companies listed on the floor of the Nigerian Exchange Group (NGX). The independent variable (inventory management) was proxied by inventory turnover, inventory holding cost and Economic order quantity (EOQ), while the dependent variable (profitability) was proxied gross profit margin.

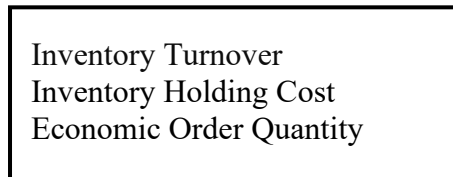
Geographical scope: This study focused on listed pharmaceutical companies on the floor of Nigerian exchange group (NGX) for the period of 10 years, that is from 2014 to 2023.

Unit scope: The unit of analysis of this study consisted of seven pharmaceutical companies listed on the floor of the Nigerian Exchange group (NGX). They include; Ekocorp PLC, Fidson Healthcare PLC, Glaxo Smithline PLC, May and Baker Nigeria PLC, Morison industries PLC, Neimeth international pharmaceuticals PLC and Pharma-Deko PLC.

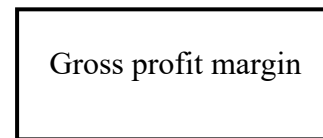

Concept of Inventory Management

Takeeto et al., (2020) recorded that inventory management refers to the process of storing, ordering, and selling of goods and services. The discipline also involves the management of various supplies and processes. One of the most critical aspects of inventory management is managing the flow of raw materials from their procurement to finished products. Inventory management plays a critical role in the profitability and operational efficiency of pharmaceutical firms in Nigeria. It involves the planning, control, and optimization of inventory levels to ensure that the right amount of stock is available at the right time while minimizing costs and maximizing profitability (Parma and Shukla, 2021) as all businesses that are profitable have goal achievement as their top priority (Okurebia & Udo, 2023). Effective inventory management in pharmaceutical firms requires striking a delicate balance between maintaining adequate stock levels to meet customer demand and avoiding excess inventory that ties up capital and incurs holding costs. Onikoyi and Ojo, (2019) exposed that implementing sound inventory management practices, such as utilizing tools like Economic Order Quantity (EOQ) calculations, Just-In-Time (JIT) inventory systems, and ABC analysis, pharmaceutical companies can streamline their supply chain operations and enhance overall profitability.

Inventory management in the pharmaceutical industry in Nigeria extends beyond the traditional focus on cost control and supply chain optimization. It encompasses considerations related to demand forecasting, market trends, regulatory changes, and product life cycles. Pharmaceutical firms need to proactively manage their inventory levels based on demand fluctuations, seasonal variations, and emerging healthcare needs in the Nigerian market as opined by Mensah et al., (2019). This requires leveraging data analytics, technology solutions, and collaboration with suppliers and distributors to adapt quickly to changing market dynamics while maintaining sustainable inventory practices. By aligning inventory management strategies with market insights and regulatory requirements, pharmaceutical companies can improve their competitiveness, sustainability, and profitability in a dynamic and challenging business environment (Parma and Shukla, 2021).

Dimensions of Inventory Management

Inventory Turnover

Inventory turnover is a fundamental financial metric that measures how efficiently a company manages its inventory by evaluating the rate at which inventory is sold and replenished over a specific period. Usman et al., (2020) stated that it is a crucial indicator of a company's operational performance, supply chain management effectiveness, and overall inventory control. At its core, inventory turnover reflects the frequency with which a company's inventory is sold and replaced within a certain time frame, typically a year. A high inventory turnover ratio signifies that a company is effectively converting its inventory into sales and generating revenue, while a low ratio may indicate excessive inventory levels, slow-moving goods, or potential liquidity issues (Akinola et al., (2024).

A high inventory turnover ratio is generally viewed favourably as it suggests that a company is efficiently managing its inventory and quickly converting it into sales. This can lead to reduced carrying costs, lower obsolescence risks, improved cash flow, and increased profitability. On the other hand, a low inventory turnover ratio may indicate overstocking, slow-moving inventory, deteriorating demand trends, or inefficiencies in supply chain operations as postulated by Obeidat, (2020). It is important to note that the optimal inventory turnover ratio varies across industries and business models. For instance, industries with perishable goods or fast-changing consumer preferences may require higher turnover rates to avoid wastage or obsolescence. Conversely, manufacturers of durable goods or capital equipment may have lower turnover ratios due to longer product life cycles and specialized customer requirements (Kamau and Kagiri, (2020). According to Obeidat, (2020) analyzing inventory turnover trends over time can provide valuable insights into a company's inventory management practices, supply chain efficiency, and overall business performance.

Inventory Holding Cost

Inventory holding cost, also known as carrying cost or holding cost, refers to the expenses associated with storing and maintaining inventory over a period of time. Inventory holding costs are typically expressed as a percentage of the inventory's value or as a fixed amount per unit. Accurate calculation of inventory holding costs is essential for businesses to optimize their inventory management and minimize unnecessary expenses. Inventory holding cost in the context of pharmaceutical companies refers to the expenses incurred in storing and managing inventory over a specific period. These costs are critical for businesses in the pharmaceutical industry, given the diverse range of products they deal with, including raw materials, active pharmaceutical ingredients (APIs), intermediates, finished goods, and packaging materials. Goronduste et al., (2019) explained that storage costs play a significant role in inventory holding costs for pharmaceutical companies, as many products require specialized storage conditions like temperature-controlled environments. Rent, utilities, maintenance, and security of these facilities contribute to the overall holding costs. In addition to storage costs, insurance is another key component of inventory holding costs in pharmaceutical companies.

Economic Order Quantity (EOQ)

Economic Order Quantity (EOQ) is a fundamental concept in inventory management and supply chain optimization. It represents the optimal quantity of inventory that a company should order at any given time to minimize its total inventory costs. The EOQ model takes into account the trade-off between the costs of ordering inventory (such as transportation and handling costs) and the costs of holding inventory (such as storage and maintenance costs). Economic Order Quantity (EOQ) is a vital concept in inventory control that aims to determine the optimal quantity of goods a business should order to minimize total inventory costs. EOQ is based on the idea that there is an optimal balance between ordering costs and holding costs for inventory (Althagi, 2020). Ordering costs include expenses such as placing orders, transportation, and processing invoices, while holding costs consist of expenses related to storing and managing inventory, such as storage, insurance, and obsolescence. By calculating EOQ, businesses can identify the most cost-effective order quantity that will help them maintain an adequate level of inventory without excessive holding costs. The goal is to strike a balance between carrying too much inventory, leading to high holding costs, and carrying too little, resulting in stockouts and potential lost sales. Achieving the optimal EOQ allows companies to streamline their inventory levels, reduce costs, and enhance overall profitability (Althagi, 2020).

The Concept of Profitability

Profitability is a fundamental concept in business and finance that refers to the ability of a company or organization to generate earnings or profits from its operations. It is a measure of how effectively a company uses its resources to produce goods or services that generate revenue, while also managing its costs and expenses to maximize its profits. At its core,

profitability is about creating value for stakeholders, including shareholders, employees, customers, and suppliers. Companies that are profitable are able to reinvest their earnings in the business, pay dividends to shareholders, and reward employees for their hard work and contributions. Profitability is also a key indicator of a company's financial health and its ability to sustain itself over the long term. There are several factors that can impact a company's profitability, including its revenue growth, cost structure, pricing strategy, and operating efficiency. Companies that are able to generate strong revenue growth, while also managing their costs and expenses effectively, are more likely to be profitable. Additionally, companies that are able to differentiate themselves from their competitors through innovative products, services, or business models are also more likely to be profitable (Golas, 2020).

Profitability can be measured in a variety of ways, including through the use of financial metrics such as gross margin, operating margin, and net profit margin. Gross margin, for example, is a measure of a company's profitability at the product or service level, and is calculated by dividing gross profit by revenue. Operating margin, on the other hand, is a measure of a company's profitability at the operating level, and is calculated by dividing operating income by revenue. Net profit margin, meanwhile, is a measure of a company's overall profitability, and is calculated by dividing net income by revenue. In addition to these financial metrics, companies can also use non-financial metrics to measure their profitability, such as customer satisfaction, employee engagement, and market share. These metrics can provide valuable insights into a company's underlying profitability drivers, and can help companies to identify areas for improvement. Profitability is also closely tied to a company's return on investment (ROI), which is a measure of the return generated by a company's investments, relative to their cost. Companies that are able to generate strong returns on investment are more likely to be profitable, as they are able to earn a return on their investments that exceeds their cost of capital as stated by Dave et al., (2021). Kungu, (2020) mentioned that profitability is not just important for companies, but also for investors, creditors, and other stakeholders. Investors, for example, use profitability metrics to evaluate a company's potential for future growth and returns. Creditors, meanwhile, use profitability metrics to assess a company's ability to repay its debts. By focusing on profitability, companies can create value for their stakeholders, while also ensuring their long-term sustainability.

Dimension of Profitability

Gross Profit Margin

Gross profit margin is a financial metric that measures the percentage of a company's revenue that exceeds its cost of goods sold (COGS). In other words, it indicates how efficiently a company is producing goods or services before accounting for other operating expenses such as selling, general, and administrative costs. Gross profit margin is a fundamental concept in accounting and finance that plays a crucial role in inventory management and profitability of listed pharmaceutical companies in Nigeria. It is a metric that measures the difference between revenue and the cost of goods sold, expressed as a percentage of revenue. In other words, gross profit margin represents the profit earned by a company from the sale of its products or services, before deducting operating expenses, taxes, and other non-operating items by Bagshaw et al., (2019).

In the context of inventory management, gross profit margin is a critical metric that helps pharmaceutical companies in Nigeria to evaluate the profitability of their products. Ali et al., (2020) propounded that analysing the gross profit margin of each product, companies can identify which products are generating the highest profits and which ones are not performing well. This information can be used to make informed decisions about inventory management, such as which products to stock more of, which products to discontinue, and how to optimize pricing strategies.

For listed pharmaceutical companies in Nigeria, gross profit margin is a key performance indicator (KPI) that is closely watched by investors and analysts. A high gross profit margin indicates that a company is able to maintain high prices for its products while keeping costs

under control. This can be a sign of a company's strong market position, effective cost management, and ability to generate profits. On the other hand, a low gross profit margin can indicate that a company is facing intense competition, struggling with cost management, or experiencing declining demand for its products (Althagafi, 2020).

Relationship between Inventory Management and Gross Profit Margin

Effective inventory management plays an important role in the financial performance of pharmaceutical companies, especially concerning their gross profit margin. Proper inventory management involves maintaining optimal inventory levels to meet demand while minimizing holding costs. For pharmaceutical companies, carrying excess inventory can lead to higher storage costs, obsolescence, and wastage. On the other hand, inadequate inventory levels can result in stockouts, lost sales, and dissatisfied customers. By managing inventory levels effectively, companies can control costs and enhance gross profit margins by reducing unnecessary expenses and maximizing sales opportunities (Sonko and Akinlabi, 2020). Inventory turnover ratio, which measures how quickly a company sells its inventory and replaces it over a specific period, is a critical metric in evaluating inventory management efficiency. High inventory turnover indicates that a company is selling products quickly, minimizing holding costs, and efficiently utilizing resources.

In the pharmaceutical sector, efficient inventory turnover is essential for maintaining cash flow, reducing carrying costs, and improving gross profit margins through increased sales velocity and operational efficiency (Bah et al., 2023). Accurate demand forecasting and product mix optimization are essential components of effective inventory management in pharmaceutical companies. Sonko and Akinlabi (2020), opined that by analysing historical data, market trends, and customer preferences, companies can anticipate demand patterns, optimize their product portfolios, and align inventory levels with expected sales volumes. Effective demand forecasting helps reduce stockouts, minimize excess inventory, and enhance gross profit margins by ensuring the right products are available at the right time to meet customer needs efficiently. Strong supplier relationships and efficient supply chain management are vital for maintaining optimal inventory levels, controlling costs, and improving gross profit margins in pharmaceutical companies. Collaborating closely with reliable suppliers, negotiating favourable terms, and implementing supply chain best practices can help streamline procurement processes, reduce lead times, and enhance inventory management effectiveness (Gokhale and Kaloji, 2019).

Sonko and Akinlabi, (2020) concluded that the relationship between inventory management and gross profit margin in listed pharmaceutical companies in Nigeria is multifaceted and critical to their overall financial performance and competitiveness in the market. By adopting sound inventory management practices, optimizing supply chain operations, leveraging technology, and making data-driven decisions, pharmaceutical companies can enhance their operational efficiency, control costs, improve customer satisfaction, and ultimately drive higher gross profit margins for sustainable growth and success in the industry.

Theoretical Framework

The Agency Theory (Michael C. Jensen and William H. Meckling, 1976).

Agency Theory, as developed by Michael Jensen and William Meckling in (1976) provides a valuable framework for understanding the relationship between inventory management and profitability of listed pharmaceutical companies in Nigeria. The theory focuses on the principal-agent relationship within organizations, where conflicts of interest may arise between company owners (principals) and managers (agents). In the phase of inventory management in pharmaceutical companies, the agency theory suggests that there may be a divergence of goals between shareholders seeking to maximize profitability and managers responsible for day-to-day operations, including decisions related to inventory levels (Kungu, 2020). Managers may prioritize objectives such as minimizing stockouts or maintaining high levels of safety stock, which can lead to increased holding costs and inefficiencies that affect profitability. Agency theory underscores the importance of aligning the interests of both principals and

agents to mitigate agency problems and improve organizational performance. In the case of pharmaceutical companies in Nigeria, effective inventory management practices can serve as a mechanism for aligning the interests of shareholders and managers towards maximizing profitability. By implementing transparent reporting systems, performance-based incentives, and clear communication channels, companies can ensure that inventory decisions are made in the best interest of the firm's financial health.

Moreover, agency theory highlights the role of monitoring and control mechanisms in influencing managerial behavior with regards to inventory management. Pharmaceutical companies can implement governance structures, such as board oversight, internal controls, and performance evaluation systems, to reduce agency costs associated with suboptimal inventory management practices. By holding managers accountable for their decisions and incentivizing value-creating behaviors, companies can enhance profitability through improved inventory control and cost management.

Empirical Framework

Ubabuduet *et al.*, (2024), investigated the effectiveness of inventory management on the profitability of manufacturing sectors in Nigeria: Bottling Company, Kaduna. Inventory management plays a crucial role in the profitability of manufacturing sectors, including the Nigeria Bottling Company in Kaduna. The study aimed to assess the effectiveness of inventory management on the profitability of manufacturing sectors in Nigeria Bottling Company, Kaduna. The study is quantitative and utilizes both primary and secondary data. A survey instrument was developed to collect primary data from a sample of 100 managers and employees within the Nigeria Bottling Company, Kaduna. Additionally, secondary data was collected from annual reports and financial statements of the company. The primary data collected was analysed using statistical techniques such as descriptive statistics and regression analysis, while the secondary data was analysed using content analysis. This mixed-method approach allowed for a comprehensive examination of the effectiveness of inventory management on the profitability of the manufacturing sectors in the Nigeria Bottling Company, Kaduna. From the result of data analysis, the hypothesis there is a positive relationship between inventory management and prompt delivery in manufacturing sectors (Nigerian Bottling Company) Kaduna, was rejected and the alternate was accepted. The study concludes that although inventory management is a key factor in prompt service delivery, it is not the only factor. The organization must balance its operations by putting in place important management and operational policies that support service delivery. Some of which are recommended to include the implementation of advanced inventory management techniques, enhancing demand forecasting and production planning processes, among other things.

Bah *et al.*, (2023), researched on an empirical evidence of the impact of inventory management on the profitability of manufacturing companies. This study examined the impact of inventory management on the profitability of a manufacturing company. A case study research design was applied on the inventory system of a reputable manufacturing company. The secondary data employed in this study was collected from the financial statement the company for the period 2015- 2020, in which the data were analysed using the Multiple linear regression model. The result shows that Raw Material Cost and Storage Cost are having negative and insignificant relationship on the profitability of a manufacturing company. On the other hand, Inventory Conversion Period is having a positive and significant relationship on the Returns on Assets. The study therefore recommended that the management of manufacturing companies need to adopt proper inventory management systems in order to control raw materials costs, reduced the working capital cycle, and minimize storage cost such as holding costs, ordering costs among others hence increasing company profitability.

METHODOLOGY

This section focused on the methods and procedures used in collecting and analysing data for the study (Attih, 2024; Attih *et al.*, 2023; Essien *et al.*, 2023). It consists of research design, population of the study, sample size and sampling procedure, sampling technique, sources

and method of data collection, method of data analysis, model specification, and measurement/ operationalization of variables.

Research Design

This study adopted an ex-post facto research design. This design was suitable because the data for the analysis had already existed, leaving no room for the researcher to manipulate the variables under study.

Population of the Study

According to Eke and Udonde (2023), population is the totality of all elements (human and material) being studied. In this study, the population comprised of 7 pharmaceutical firms listed on the floor of the Nigerian Exchange Group from 2014 to 2023. These firms were as follows: Ekocorp PLC, Fidson Healthcare PLC, Glaxo Smithline PLC, May and Baker Nigeria PLC, Morison industries PLC, Neimeth international pharmaceuticals PLC and Pharma-Deko PLC.

These pharmaceutical companies were selected because they were continuously listed by Nigeria stock exchange group (NGX) during the period (2014-2023) and their financial statements and reports are available and have been consistently submitted to Nigeria stock exchange for the period under study.

Sample Size Determination and Sampling Procedure

Since the study population was sizeable enough to handle. The sample size of 7 Pharmaceutical firms were also selected for the study. The sample size of the study and the population were the same. Thus, complete enumeration was used to obtain the data for the study. According to Udonde, Akpan and Awah (2021), complete enumeration is used when the assembled sample has the same proportion of individuals as the entire population.

That means $n=N$

Where;

n = sample size and N = population

Sources and Method of Data Collection

The data for the dependent and independent variables were extracted from financial reports of sampled listed pharmaceutical firms in Nigeria using contents analysis method and collated with the aid of Microsoft excel software. The panel data methodology was adopted because the study combined time series and cross-sectional data that is, seven (7) cross-sectional observations for each year and ten-time series for each pharmaceutical firm regressor and explained variables, a total of seventy (70) pooled observations.

Method of Data Analysis

The study utilized robust regression to analyse the cause-effect linkage between the dependent variable and the independent variables, as well as to evaluate the formulated hypotheses. This approach was chosen due to the presence of variances in the error term and the inability of the data to follow the standardized regression assumptions, that is, linearity, homoscedasticity, normality and independence of data. The decision was based on 5% level of significance.

Accept null hypothesis (H_0) if probability value (i.e. P-value or Sig.) is greater than or equals to (\geq) stated 5% level of significance (α); otherwise, reject and accept alternate hypothesis (H_1), if p-value or sig calculated is less than 5% level of significance.

Model Specification

The model for this study was adopted from the study of Matope and Vaye, (2022) but modified to suit the hypotheses of this study. Hence, the author specified the econometric function as;

DATA PRESENTATION, ANALYSIS AND DISCUSSION OF FINDINGS

Data Presentation

The data comprise a panel data of seventy (70) pooled observations across seven (7) listed pharmaceutical firms in Nigeria for ten (10)-year period (2014-2023). The data include the dependent variable –Gross profit margin of listed pharmaceutical firms in Nigeria and the independent variables which were inventory turnover (IT), inventory holding cost (IHC) and economic order quantity (EOQ) of listed pharmaceutical firms in Nigeria

Data Analysis

Various statistical techniques were utilized in the analysis of data. These include descriptive statistics, regression assumption tests and simple linear regression analysis. The results from the Ordinary least squares regression analysis were used in the testing of the research hypotheses as stated in the first section of this work.

1. Descriptive Statistics

This was conducted to understand the behaviour of the data using various statistics including mean, standard deviation, skewness, and kurtosis. The result for the descriptive statistics analysis is as presented in Table 4.1 below;

Table 4.1 above shows that Gross profit margin (GPM), inventory turnover (IT), inventory holding cost (IHC) and economic order quantity (EOQ) of listed pharmaceutical firms in Nigeria have mean scores of approximately 7.923%, 21.22 times, N1.19million and 2,557 units respectively. This indicates the central or average values for these variables from 2014 to 2023. The median values obtained for Gross profit margin (GPM), inventory turnover (IT), inventory holding cost (IHC) and economic order quantity (EOQ) of listed pharmaceutical firms in Nigeria were approximately 7.818%, 22.38 times, N0.521million and 2,329 units respectively. These constitute the middle values for the distributions of these variables under the period covered in this study (2014-2023).

In terms of the level of variability and dispersion in the distribution of these variables, the standard deviations obtained for the variables- Gross profit margin (GPM), inventory turnover (IT), inventory holding cost (IHC) and economic order quantity (EOQ) of listed pharmaceutical firms in Nigeria were 5.445, 5.498, 1382573 and 982.46 respectively. This indicates varying levels of variability in the distribution with inventory holding cost (IHC) indicating high variations in the distributions. Similarly, the skewness values obtained for these variables were 0.657, -0.687, 1.527, 0.328 respectively. This quantifies the asymmetry of the distributions.

In addition, the Kurtosis values obtained for Gross profit margin (GPM), inventory turnover (IT), inventory holding cost (IHC) and economic order quantity (EOQ) of listed pharmaceutical firms in Nigeria were given as approximately 3, 3, 4 and 2 respectively. Since the values of the kurtosis are greater than zero (0), it indicates a leptokurtic distribution, hence the presence of outliers in the data.

2. Model Evaluation

The suitability of the data was assessed through coefficient and residuals diagnostics. These include normality test, multicollinearity test and heteroscedasticity test.

1. Normality Test

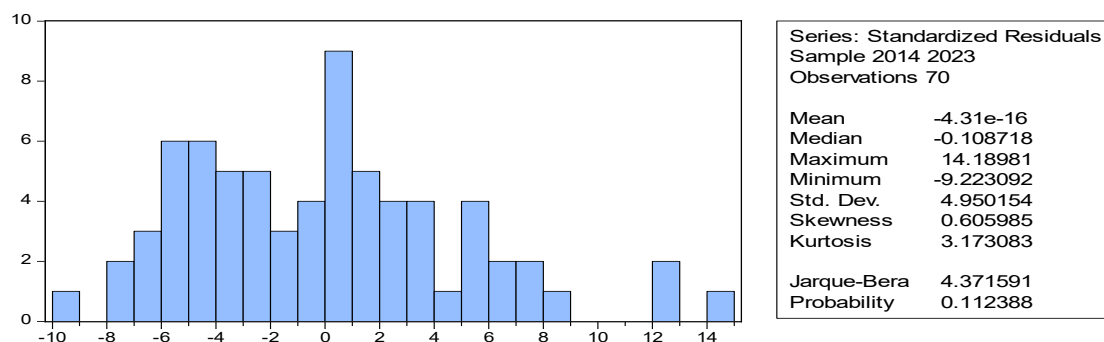


Fig. 4.1 Jarque-Bera Normality test results

A significant Jarque-Bera test result implies that the data do not follow a normal distribution. On the other hand, a non-significant result indicates that there is insufficient evidence to reject the assumption of normality. If the p-value associated with the Jarque-Bera test is below a predetermined significance level ($p < 0.05$), then we reject the null hypothesis and conclude that the data do not follow a normal distribution. With a p-value of 0.112388, there is sufficient evidence to conclude that the data were normally distributed.

2. Multicollinearity Test

In examining the association among the variables, the study employed the Spearman Rank Correlation Coefficient (correlation matrix), and the results are presented in the table below.

The correlation analysis showed that all independent variables- inventory turnover (IT), inventory holding cost (IHC) and economic order quantity (EOQ) of listed pharmaceutical firms in Nigeria over the period under study have coefficients lesser than 0.80 respectively confirming absence of multicollinearity issues.

3. Heteroscedasticity Test

The statistics and probability value associated with the Breusch-Pagan LM test otherwise known as the Breusch-Pagan Godfrey test help determine whether there is evidence of heteroscedasticity in the regression model. A low p-value ($p < 0.05$) suggests evidence against the null hypothesis in favour of the alternate hypothesis which indicates the presence of

heteroscedasticity in the regression model. With a p-value of 0.9441, there is sufficient evidence to accept the null hypothesis, thus, conclude that the predictor variables were homoscedastic.

4. Autocorrelation

Autocorrelation tests examine whether the residuals are independently distributed or if there is a systematic pattern of dependence. The Durbin-Watson statistic is commonly used to test for autocorrelation, with values close to 2 indicating no significant autocorrelation. The Durbin-Watson statistic value of 1.563850 suggests a mild positive autocorrelation present in the residuals of the regression model.

Test of Hypotheses

Each of the hypotheses in this study was tested based on the result obtained from the panel multiple regression analysis. The result that relates to these hypotheses is summarized in table 4.5 below;

The multiple regression line is as written below:

Based on the regression result above, when the independent variables- inventory turnover (IT), inventory holding cost (IHC) and economic order quantity (EOQ) of listed pharmaceutical firms in Nigeria are held constant (equal Zero), the dependent variable- Gross profit margin increased at a constant average of approximately 0.8457% over the years. However, a one percent rise in inventory turnover (IT) increases gross profit margin by approximately 0.414% while a similar variation in inventory holding cost (IHC) and economic order quantity (EOQ) decreases gross profit margin by approximately 3.10% and 0.00052% respectively.

Hypothesis One

H₀: There is no significant relationship between inventory turnover and gross profit margin of listed pharmaceutical companies in Nigeria

H₁: There is no significant relationship between inventory turnover and gross profit margin of listed pharmaceutical companies in Nigeria

By way of testing whether the variations in gross profit margin of listed pharmaceutical firms in Nigeria caused by inventory turnover is significant. The T-test was carried out at .05 significance level with Ttab of 1.995 given at T0.05,7. From the result above, the Tcal of

3.648588 is greater than T_{tab} given at $T_{0.05,7}$. Hence, the null hypothesis which states there is no significant relationship between inventory turnover and gross profit margin of listed pharmaceutical companies in Nigeria fails to hold, thus rejected, and the alternative hypothesis accepted. The null hypothesis is further rejected given that at $T_{0.05,7}$, its probability value (p -value = 0.0005) is less than 0.05.

Hypothesis Two

- H_0 : No significant relationship exists between inventory holding cost and gross profit margin of listed pharmaceutical companies in Nigeria
- H_1 : Significant relationship exists between inventory holding cost and gross profit margin of listed pharmaceutical companies in Nigeria

For inventory holding cost, the T-test was also employed at .05 significance level with T_{tab} of 1.995 given at $T_{0.05,7}$. From the results as shown in table 4.5, the T_{cal} of 2.678535 is greater than T_{tab} given at $T_{0.05,7}$. Hence, the null hypothesis which states no significant relationship exists between inventory holding cost and gross profit margin of listed pharmaceutical companies in Nigeria fails to hold, thus rejected, and the alternative hypothesis accepted. The null hypothesis is further rejected given that at $T_{0.05,7}$, its probability value (p -value = 0.0298) is less than 0.05.

Hypothesis Three

- H_0 : Economic order quantity has no significant relationship with gross profit margin of listed pharmaceutical companies in Nigeria
- H_1 : Economic order quantity has significant relationship with gross profit margin of listed pharmaceutical companies in Nigeria

In addition, the T-test was also employed for economic order quantity at .05 significance level with T_{tab} of 1.995 given at $T_{0.05,7}$. From the results as shown in table 4.5, the T_{cal} of 0.8349 is less than T_{tab} given at $T_{0.05,7}$. Hence, the null hypothesis which states that Economic order quantity (EOQ) has no significant relationship with gross profit margin of listed pharmaceutical companies in Nigeria holds, thus accepted, and the alternative hypothesis rejected. The null hypothesis is further accepted given that at $T_{0.05,7}$, its probability value (p -value = 0.04067) is greater than 0.05.

Discussion of Findings

Inventory Turnover and Gross Profit Margin

The finding that inventory turnover has a significant positive relationship with gross profit margin of listed pharmaceutical firms in Nigeria is consistent with theoretical expectations. A higher inventory turnover ratio indicates that a company is selling its inventory more quickly, which can lead to increased liquidity, reduced holding costs, and increased profitability. This is particularly important in the pharmaceutical industry, where inventory obsolescence and expiration can result in significant losses. The positive coefficient of 0.414078 suggests that a one-unit increase in inventory turnover is associated with a 0.414078-unit increase in gross profit margin, holding all other variables constant. This finding highlights the importance of efficient inventory management in enhancing the profitability of listed pharmaceutical firms in Nigeria. Obeidat (2021) found a significant positive relationship between inventory turnover and return on assets. Similarly, Bah et al. (2023) found that inventory turnover has a positive significant relationship with return on assets.

Inventory Holding Cost and Gross Profit Margin

The finding that inventory holding cost has a significant negative relationship with gross profit margin of listed pharmaceutical firms in Nigeria is also consistent with theoretical expectations. A higher inventory holding cost can erode a company's profitability by increasing its costs and

reducing its gross profit margin. This is particularly relevant in the pharmaceutical industry, where inventory holding costs can be significant due to the need for climate-controlled storage and handling of perishable products. The negative coefficient of -3.100747 suggests that a one-unit increase in inventory holding cost is associated with a 3.100747-unit decrease in gross profit margin, holding all other variables constant. This finding underscores the importance of minimizing inventory holding costs in order to enhance the profitability of listed pharmaceutical firms in Nigeria. For example, Gołaś (2020) found that increasing inventory days for raw and other materials had a negative impact on return on total assets. Similarly, Anisere-Hameed & Bodunde (2021) found that inventory management has a significant effect on return on asset, investment, net operating margin, and net income of manufacturing firms in Nigeria. These studies suggest that high inventory holding costs can erode profitability.

Economic Order Quantity and Gross Profit Margin

The finding that economic order quantity has a non-significant negative relationship with gross profit margin of listed pharmaceutical firms in Nigeria is unexpected. A higher economic order quantity is typically expected to reduce inventory costs and increase profitability. However, the non-significant coefficient of -0.000525 suggests that economic order quantity does not have a statistically significant impact on gross profit margin. This finding may be due to the fact that listed pharmaceutical firms in Nigeria may not be optimizing their economic order quantities, or that other factors such as inventory holding costs and inventory turnover may be more important drivers of profitability. Further research is needed to explore this finding in more detail. This is consistent with the study by Ali et al. (2022), which found that inventory turnover ratio does not impact operating profits statistically in a significant way. Similarly, Salman et al. (2023) found that inventory turnover and capital work in progress do not significantly affect return on equity and return on assets. These studies suggest that economic order quantity may not have a significant impact on profitability.

SUMMARY, CONCLUSION AND RECOMMENDATIONS

Summary of the Study

This present study examined the effect of inventory management on profitability of listed pharmaceutical firms in Nigeria. The study covered ten (10)-year period with particular emphasis on inventory turnover (IT), inventory holding cost (IHC) and economic order quantity (EOQ). Gross profit margin however represented the dependent variable (profitability). Below is a summary of findings gathered through a panel of simple linear regression analysis;

1. Inventory turnover has a significant positive relationship (Coeff. = 0.414078 {0.0005}) with gross profit margin of listed pharmaceutical firms in Nigeria.
2. Inventory holding cost has a significant negative relationship (Coeff. = -3.100747 {0.0298}) with gross profit margin of listed pharmaceutical firms in Nigeria.
3. Economic order quantity has a non-significant negative relationship (Coeff. = -0.000525 {0.4067}) with gross profit margin of listed pharmaceutical firms in Nigeria.

Conclusion

This study examined the effect of inventory management on the profitability of listed pharmaceutical firms in Nigeria. The findings of this study highlight the importance of effective inventory management in driving profitability in the pharmaceutical industry. Inventory management is a critical component of supply chain management, and its impact on profitability cannot be overstated. By optimizing inventory levels, reducing inventory holding costs, and improving inventory turnover, pharmaceutical firms can improve their profitability and remain competitive in the market. This study contributes to the existing literature on inventory management and profitability, providing insights into the relationship between these variables in the context of the Nigerian pharmaceutical industry.

Recommendations

The following recommendations are in line with the findings of this study

1. Listed pharmaceutical firms in Nigeria should implement strategies to improve their inventory turnover rates. This can be achieved by optimizing inventory levels, reducing lead times, and improving forecasting accuracy.
2. Listed pharmaceutical firms in Nigeria should implement cost-saving measures to reduce their inventory holding costs. This can be achieved by renegotiating storage contracts, implementing just-in-time inventory systems, and reducing inventory obsolescence.
3. Listed pharmaceutical firms in Nigeria should re-evaluate their economic order quantity strategies to ensure that they are optimizing their inventory orders. This can be achieved by conducting regular reviews of inventory demand and supply, and adjusting economic order quantities accordingly.

CASH MANAGEMENT PRACTICES AND MARKET VALUE OF LISTED PHARMACEUTICAL FIRMS IN NIGERIA

ABSTRACT

Poor cash management exposes businesses to illiquidity and insufficiency, hindering the ability to meet daily liquidity requirements. In view of this, the study examined the relationship between cash management practices and market value of listed pharmaceutical firms in Nigeria. The specific objectives were to determine the relationship between cash conversion cycle and market capitalization of listed pharmaceutical firms in Nigeria, to ascertain the relationship between current ratio and market capitalization of listed pharmaceutical firms in Nigeria and to assess the relationship between cash ratio and market capitalization of listed pharmaceutical firms in Nigeria. The study adopted an ex-post facto research design and utilized a panel data of seventy (70) pooled observations gathered from seven (7) listed pharmaceutical firms in Nigeria over ten (10)-year period (2014-2023) and employed a panel multiple regression technique to analyze the data via E-views 10.0 statistical package. The study findings revealed that cash conversion cycle has a non-significant positive relationship (Coeff. = 0.003378 {0.8406}) with the market capitalization of listed pharmaceutical firms in Nigeria while operating cashflow has a significant positive relationship (Coeff. = 0.258792 {0.0469}) with the market capitalization of listed pharmaceutical firms in Nigeria. It also revealed that cash ratio has a significant positive relationship (Coeff. = 2.741821 {0.0007}) with market capitalization of listed pharmaceutical firms in Nigeria. It was however concluded that effective cash management practices, particularly cash ratio enhances the market value of pharmaceutical firms in Nigeria. The recommendations made included that should focus on optimizing their working capital management practices to reduce their cash conversion cycle at all times.

INTRODUCTION

Cash management practices refer to the strategies, policies, and procedures used by a company to manage its cash flows, liquidity, and financial resources. Effective cash management practices are crucial for the profitability and sustainability of pharmaceutical and healthcare organizations. In this sector, just like in others, cash is the lifeblood that enables companies to invest in research and development, meet operational expenses, and maintain liquidity (Ugo & Egbuhuzor, 2022). Efficient cash management involves monitoring and optimizing net cash payments and receipts to minimize disbursements and expenses,

ensuring timely payment of expenses, such as salaries, rent, and utility bills (Nangih et al., 2020). Sound cash control is vital for pharmaceutical companies to manage their working capital, including inventories of raw materials and finished goods, receivables from customers, and marketable securities (Musah & Kong, 2019). Financial managers must strike a balance between liquidity and investment returns, enabling informed decisions on borrowing and investment in research and development, marketing, and expansion (Eton et al., 2025). Accurate cash forecasting is critical for pharmaceutical companies to make informed decisions on resource allocation, investments, and funding requirements (Nwaobia et al., 2016).

Effective cash acquisition and utilization enable companies to meet liquidity requirements, invest in profitable projects, and pursue growth opportunities, such as mergers and acquisitions (Nwaobia et al., 2016). Conversely, poor cash management practices lead to cash flow problems, hindering companies' ability to invest in research and development, meet financial obligations, and respond to market opportunities (Egwu et al., 2021). In the pharmaceutical sector, cash flow issues have severe consequences, including delayed product launches, reduced research and development, and decreased competitiveness (Appah et al., 2021).

In the context of market value, effective cash management practices tend to enhance pharmaceutical companies' market value by demonstrating financial discipline, reducing debt, and increasing profitability as all businesses that are profitable have goal achievement as their top priority (Okurebia & Udo, 2023). Investors seek stable financial growth, profitability, and robust returns, making cash management a critical factor in investment decisions (Olugbenga et al., 2014). By optimizing cash management practices, pharmaceutical companies tend to improve their market value, attract investors, and achieve sustainable growth and profitability. Managers of pharmaceutical firms in Nigeria grapple with various obstacles such as high financial requirements, insufficient capital, and cash flow constraints, ultimately impacting overall performance and expected returns (Appah et al., 2021). Despite these circumstances, effective cash management practices can mitigate risks and enhance the financial performance of these firms. By employing strategic cash management techniques, firms can navigate economic uncertainties, optimize their cash resources, and generate superior investment returns. According to Udo, Baridam & Akpan (2023), an organization's management should place a higher priority on business strategy than on planning. Optimal investment returns necessitate a high level of competence and efficiency in managing cash and other liquid assets. Poor cash management exposes businesses to illiquidity and insufficiency, hindering the ability to meet daily liquidity

requirements (Musah & Kong, 2019). Sufficiency in cash flow ensures prompt fulfillment of financial obligations, safeguarding the survival of firms. Essentially, cash flow represents a company's vascular system, and any depletion jeopardizes its very existence

In addressing these anomalies in corporate setting, this study examined the relationship between cash management practices with particular emphasis on cash ratio, cash conversion cycle and current ratio and how they affect market value of listed pharmaceutical firms in Nigeria.

Objectives of the Study

The main objective of this study was to examine the relationship between cash management practices and market value of listed pharmaceutical firms in Nigeria. The specific objectives were to:

1. Determine the relationship between cash conversion cycle and market capitalization of listed pharmaceutical firms in Nigeria.
2. Ascertain the relationship between operating cashflow and market capitalization of listed pharmaceutical firms in Nigeria.
3. Assess the relationship between of cash ratio and market capitalization of listed pharmaceutical firms in Nigeria.

Research Questions

This study sought to provide reliable answers to the following questions:

1. What is the effect of cash conversion cycle on market capitalization of listed pharmaceutical firms in Nigeria?
2. To what extent does operating cashflow affect market capitalization of listed pharmaceutical firms in Nigeria?
3. How does cash ratio affect market capitalization of listed pharmaceutical firms in Nigeria?

Research Hypotheses

The following hypotheses as stated in their null form were adopted for the study;

- H₀₁:** There is no significant relationship between cash conversion cycle and market capitalization of listed pharmaceutical firms in Nigeria
- H₀₂:** There is no significant relationship between operating cashflow and market capitalization of listed pharmaceutical firms in Nigeria
- H₀₃:** There is no significant relationship between cash ratio and market capitalization of listed pharmaceutical firms in Nigeria

Scope of the Study

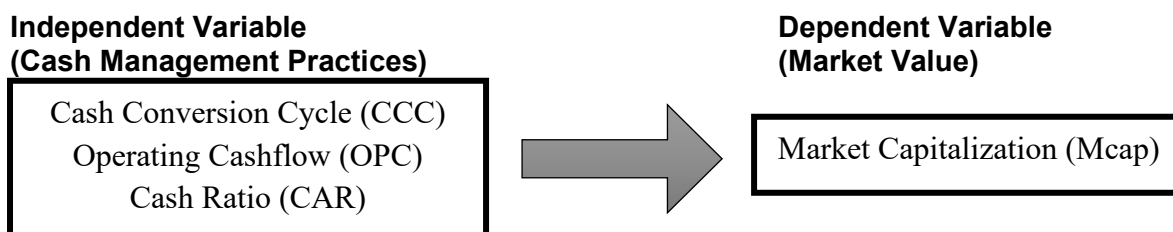
Content Scope: This study examined the relationship between cash management practices and market value of listed pharmaceutical firms in Nigeria. The explanatory variables for cash management practices were cash conversion cycle, operating cashflow and cash ratio. Market capitalization was however used as a surrogate for the dependent variable (market value).

Geographical Scope: This study focuses exclusively on listed pharmaceutical firms in Nigeria, covering a ten-year period from 2014 to 2023. The geographical scope is deliberately limited to Nigeria to provide an in-depth understanding of the cash conversion cycle and its impact on the financial performance of pharmaceutical firms within this specific context

Unit Scope: The unit of analysis for this study is the individual listed pharmaceutical firm in Nigeria. The study operates at a micro level, focusing on the firm-level data and analysis. These firms are; Ekocorp plc, Fidson healthcare plc, GlaxoSmithline plc, May and Baker plc, Morison ind. Plc, Neithmeth pharm plc and Pkarma-Deko plc.

REVIEW OF RELATED LITERATURE

The Concept of Cash Management Practices

Effective cash management practices is crucial for a company's financial health, as it involves monitoring, analyzing, and optimizing the net amount of cash receipts and cash expenses made by business firms (Ogbonnaya et al., 2016). Net cash flow is a vital measure of financial health, and cash management practices, such as frequent cash flow analysis, are essential to address cash flow problems like illiquidity. Cash management performance involves planning, organizing, and controlling cash inflows and outflows in an entity during a particular period (Ejike & Agha, 2018). The amount of cash available significantly influences financial performance, and cash is the lifeblood of any corporate entity, necessary for acquiring assets to generate goods and services, determine profit, and maximize shareholder wealth (Akumu, 2017). Liman and Mohammed (2018) confirmed that corporate investment performance depends on a firm's ability to generate sufficient cash flows from various cash flow statement components. Organizations that prioritize performance management and continuous improvement are more likely to succeed and thrive in today's competitive landscape (Okon & Udo, 2024).

This study explores the effect of cash management practices on market value, considering three explanatory variables as proxies for cash management practices: Cash conversion cycle, operating cashflow, and cash ratio.

Variables of Cash Management Practices

Cash Conversion Cycle

The Cash Conversion Cycle (CCC) measures the duration in days between a company's payment for trade payables and collection from trade receivables, significantly impacting its market value (Richards & Laughlin, 1980). The CCC encompasses days of sales outstanding, days of inventory outstanding, and days of payables outstanding, which correlate with cash inflows and outflows (Nwaiwu & Oluka, 2017). A shorter CCC indicates better liquidity and cash flow management, leading to enhanced market value (Boubker & Hicham, 2021). Effective CCC management supports cash flow forecasting, enabling informed long-term funding and investment decisions, reducing bad debt risk, and improving liquidity, ultimately strengthening performance ratios and creditworthiness.

Good CCC management is crucial for cash flow forecasting, supporting better long-term funding and investment decisions, reducing bad debt risk, and improving liquidity, leading to stronger performance ratios and increased creditworthiness. The incorporation of CCC into traditional indicators provides a more comprehensive assessment of a firm's liquidity status (Boubker & Hicham, 2021). Practical, operational, and commercial limitations exist on how low cash flow levels can drop without harming investment performance, emphasizing the

significance of cash flow management in maintaining a healthy market value. As a result, the management of cash flows has a profound impact on performance indicators such as return on assets, return on capital employed, return on assets, cash value added, and ultimately, market value.

Operating Cashflow

Operating cash flow is a vital indicator of a company's liquidity and working capital management, providing insight into its ability to meet short-term obligations, such as funding research and development, purchasing raw materials, and paying suppliers (Nangih et al., 2020). This metric offers a comprehensive picture of a company's working capital adequacy and its capacity to meet day-to-day payment commitments, making it an essential tool for investors and analysts assessing market value (Oseifuah & Gyekye, 2017). In the pharmaceutical sector, operating cash flow is a critical measure of liquidity, as it considers the overall magnitude of each fund and provides a relative measure for inter-firm comparison (Nwaiwu & Oluwa, 2017). A higher operating cash flow indicates a greater margin of safety for short-term creditors, enhancing market value and investor confidence.

Operating cash flow represents the cash generated by a company's core business operations, such as sales, production, and distribution, minus the cash used to support these operations, such as cost of goods sold, salaries, and other operating expenses (Nangih et al., 2020). A higher operating cash flow indicates a stronger liquidity position, enabling pharmaceutical companies to invest in growth opportunities, respond to market changes, and maintain their competitive edge, ultimately positively impacting market value. Operating cash flow is widely recognized as a key metric for assessing a company's liquidity and working capital management (Nwaiwu & Oluwa, 2017). In the pharmaceutical sector, effective management of operating cash flow is crucial for companies to navigate industry challenges and maintain a healthy market value. A positive operating cash flow is essential for pharmaceutical companies to invest in research and development, expand their product portfolios, and respond to changing market conditions, ultimately driving growth and profitability.

Cash Ratio

In the pharmaceutical industry, the cash ratio is a vital indicator of a company's liquidity and financial health, representing the most liquid assets in its financial statements (Akenga, 2017). This ratio assesses a company's ability to pay its short-term obligations, such as funding research and development, purchasing raw materials, and paying suppliers, within a one-year period. A cash ratio lower than 1 may indicate financial difficulty, but it can also reflect a company's strategic decision to maintain low cash reserves (Akenga, 2017). The cash ratio compares a pharmaceutical company's most liquid assets, including cash, cash equivalents, and marketable securities, to its current liabilities, such as accounts payable, short-term debt, and accrued expenses (Boubker & Hicham, 2021).

A higher cash ratio indicates a stronger liquidity position, enabling pharmaceutical companies to invest in research and development to stay ahead of the competition, respond quickly to changes in the market or industry, maintain a competitive edge through strategic acquisitions or partnerships, and weather financial storms, such as economic downturns or unexpected expenses. Conversely, a lower cash ratio may indicate financial difficulty, making it challenging for pharmaceutical companies to meet their short-term obligations, such as paying suppliers or employees, invest in growth opportunities, such as new product development or marketing initiatives, and respond to changes in the market or industry, making them less competitive. Therefore, the cash ratio is a crucial metric for investors and analysts to assess a pharmaceutical company's financial health and liquidity position. By analyzing the cash ratio, investors and analysts can gain insight into a pharmaceutical company's liquidity position, financial health, and ability to create value for shareholders.

Market Value

The concept of market value has been considered from various perspectives, including earnings quality, financial performance, stock growth, and investment returns (Liman & Mohammed, 2018). Shareholders' wealth maximization model, which is the primary corporate objective, can be expressed as a motivator for the financial objective of public corporations, such as maximizing market value and profitability simultaneously. Effective cash management practices play a crucial role in achieving this objective, as they enable companies to optimize their liquidity, reduce costs, and increase profitability, ultimately leading to an increase in market value. The commonly used financial objectives are to maximize shareholders' wealth, profitability, and growth in market value as seen in Appah et al., (2021).

From the perspective of growth in market value, an increase in market value would mean more wealth for shareholders, either through dividend payouts or retained profits reinvested to further increase market value in the future (Soet et al., 2018). Cash management practices, such as efficient cash flow management, working capital optimization, and short-term investment strategies, are essential in achieving growth in market value. Effective cash management practices, such as minimizing cash conversion cycles and optimizing cash reserves, can contribute to a higher ROA, ultimately leading to an increase in market value. In addition, cash management practices can also impact market value by reducing the risk of liquidity crises, minimizing the cost of capital, and increasing the company's creditworthiness.

Bassey, Attih and Uford (2025) highlight that perceived market value plays a critical role in the service sector, where the inherent intangibility and variability make value perceptions highly subjective. The authors emphasize that brands can enhance perceived market value by delivering superior service quality and fostering strong emotional connections with customers. This approach not only increases customer patronage and willingness to pay a premium but also contributes to long-term business success and sustainable market capitalization.

Variable of Market Value

Market Capitalization (Mcap)

A company's market capitalization, or market cap, reflects its perceived size and value, based on the total value of its outstanding shares (Kimmel et al., 2017). Effective cash management is crucial in driving market capitalization, as it enables companies to boost liquidity, reduce costs, and increase profitability, ultimately enhancing market value (Liman & Mohammed, 2018). Efficient cash flow management and smart short-term investments can minimize liquidity risks and lower capital costs, contributing to increased market capitalization (Soet, et al., 2018). Companies with robust cash management practices are more resilient to financial shocks, can maintain investor trust, and attract new investors, all of which can drive up market capitalization.

Nangih et al., (2020) opined that market capitalization companies are often seen as more stable and less risky, making it easier to secure investors and access capital markets. Conversely, companies with low market capitalization may face challenges in accessing capital markets and managing cash flows, underscoring the importance of effective cash management in maintaining a healthy market capitalization. By grasping the interplay between market capitalization and cash management, companies can refine their financial strategies to achieve their objectives and maximize shareholder value.

Theoretical Framework

The Trade-off Theory (Kraus and Litzenberger, 1973)

Effective cash management practices are crucial for maintaining a healthy market value, as they enable firms to optimize their liquidity, reduce costs, and increase profitability (Kraus & Litzenberger, 1973). The trade-off theory propounded by Kraus and Litzenberger in 1973 postulates that the optimal cash level of a firm is maintained at the breakeven point where the

marginal cost and benefit of holding cash are equal, thereby maximizing shareholders' wealth (Orshi, 2016). This delicate balance is essential, as sufficient cash outflow outweighing inflow can signify weak liquidity control, debt, bad inventory, feeble investment skills, and financial managers' incompetence to critically engage in optimal financing decisions. A firm's cash or liquidity position and performance status are two economic expressions with unidirectional movement, implying that cash flow and investment performance have diametrically opposing ends (Al-Abass, 2017).

The pursuit of one will entail a trade-off of the other, highlighting the importance of maintaining an ideal level of liquidity to create cost and benefits of handling cash symmetry. The liquidity trade-off hypothesis suggests that a firm must aim for an optimal level of liquidity to minimize the opportunity cost characterized by low liquidity return, which can be accredited to liquidity premium and possible tax obligations (Abughniem et al., 2020). Effective cash management practices, such as maintaining a cash buffer against unexpected losses, minimizing the costs of obtaining external capital, and lessening the risk tie nexus with selling the firm's assets, are essential for maintaining a balanced liquid-performance nexus. However, cash handling also has its drawbacks, such as increasing agency costs, particularly for firms with higher leverage (Boubker & Hicham, 2021). To maintain a balanced liquid-performance nexus, an appropriate level of liquid resources is required. Firms must carefully manage their cash flows, short-term assets, and equivalent payables to ensure sustained corporate existence and reputation.

Empirical Framework

Ogbeide and Akanji, (2025) examined the relationship between cash flow and financial performance of insurance companies in a developing economy – Nigeria. Using time series data for the period 2009-2014, twenty-seven listed insurance firms in Nigeria were selected as sample size. The study uses both descriptive and inferential statistics to determine the relationship among the variables. It also employs the series of diagnostic tests to ensure stability of the time series used as well as to ensure the model meets the assumption of ordinary list square. The findings reveal that cash flow was observed to determine insurance firms' financial performance and is statistically significant. Cash flow from operating activities was observed to significantly increase financial performance of insurance companies in the period examined. Cash flow from financing activities was found to increase the financial performance of the sampled insurance firms, but was not statistically significant. The size of the insurance company did not increase the financial performance of the insurance firms and was also not statistically significant.

Eton et al., (2025) sought to establish the effect of cash management on financial performance of business entities in Lira district. A cross-sectional study design was adopted and data was collected by use of structured and closed ended questionnaire. However, the study found that the aforementioned practices were not sustainable with time due to incompetence in forecasting receipts and payments. This led to a conclusion that cash management has an insignificant effect on financial performance. The study recommended that Business associations like Uganda Chamber of Commerce, Uganda Manufacturers Association, in addition to Ministry of Trade and Commerce should consider providing trainings on cash management to existing and upcoming entrepreneurs to support them in developing cash management and other necessary business skills.

Ugo and Egbuhuzor, (2022) examined the effect of cash flow management on financial performance: Evidence from the pharmaceutical industry in Nigeria. The ex post facto research design was adopted for the study with a population of ten (10) listed pharmaceutical companies in Nigeria as listed by the Nigerian Exchange Group in 2021. Data were retrieved from the annual reports of the selected listed pharmaceutical companies for the period 2011 to 2020. Multiple regression analysis and the Pairwise Granger Causality tests were used to analyze the data gathered with the aid of E-Views10 statistical software. The study revealed a positive and insignificant effect of operating activities on liquidity. Also, it revealed a positive and insignificant effect of investing activities on liquidity. And finally, it revealed a negative but

significant effect of financing activities on the liquidity of listed pharmaceutical companies in Nigeria.

METHODOLOGY

This section focused on the methods and procedures used in collecting and analyzing data for the study (Attih, 2024; Attih et al., 2023; Essien et al., 2023). It consists of research design, population of the study, sample size and sample size determination, sampling technique, sources of data and method of data collection, method of data analysis, model specification and measurement of variables.

Research Design

This study adopted an *ex-post facto* research design. This design was suitable because the data for the analysis had already existed, leaving no room for the researcher to manipulate the variables (dependent and independent) under study.

Population of the Study

According to Eke and Udonde (2023), population is the totality of all elements (human and material) being studied. In this study, the population comprised of seven (7) pharmaceutical firms listed on the floor of the Nigerian Exchange Group from 2014 to 2023. These firms were as follows: Ekocorp PLC, Fidson Healthcare PLC, Glaxo Smithline PLC, May and Baker Nigeria PLC, Morison industries PLC, Neimeth international pharmaceuticals PLC and Pharma-Deko PLC.

Sample Size and Sample Size Determination

The sample size for this study stood at 7 with the aid of Taro Yamane (1967) formula with 95% confidence level. The Taro Yamane formula is given as;

$n = 6.88$ (approx. 7). The sample size for this study also stood at 7.

Sampling Technique

Due to the relatively small number of listed pharmaceutical firms, complete enumeration also known as census sampling technique was used to obtain the data for the study where all listed pharmaceutical firms on the stock exchange were included in the sample. According to Udonde, Akpan and Awah (2021), complete enumeration is used when the assembled sample has the same proportion of individuals as the entire population.

That means $n=N$

Where;

n = sample size and N = population

This approach helped to minimize sampling bias and ensure that the results were generalizable to the entire population of listed pharmaceutical firms in Nigeria as a whole.

Sources of Data and Method of Data Collection

The study adopted content analysis to extract data from financial reports, which was then collated using Microsoft Excel software, and utilized panel data methodology to analyze the relationship between cash management practices and market value. A total of seventy (70) pooled observations were obtained, comprising 7 cross-sectional observations for each year and 10 time-series observations for each firm, offering advantages such as more informative data, increased degrees of freedom, enhanced efficiency, and the ability to handle diverse data and examine fixed and random effects on the longitudinal data set.

Method of Data Analysis

The study utilized standardized simple linear regression (Ordinary Least Square-OLS) in Eviews 10.0 to analyze the data. The data met the assumptions of linear regression, including linearity, homoscedasticity, normality, and independence. The Durbin-Watson statistic fell within the acceptable range of 2-3, indicating no serial correlation (Gujarati et al., 2012; Kothari & Gaurav, 2014; Tabachnick & Fidell, 2007). The significance level was set at 5% ($\alpha = 0.05$). The null hypothesis (H_0) was accepted if the p-value was greater than or equal to 0.05, and rejected in favor of the alternative hypothesis (H_1) if the p-value was less than 0.05.

Model Specification and Measurement of Variables

The model for this study was adapted from the study of Idamoyibo, et al. (2021) and modified to suit the scope of this study. It is as presented below;

DATA PRESENTATION, ANALYSIS AND DISCUSSION OF FINDINGS

Data Presentation

The data for this study is presented in Table 4.1 (appendix 1). The data comprise a panel data of seventy (70) pooled observations across seven (7) listed pharmaceutical firms in Nigeria for ten (10)-year period (2014-2023). The data include the dependent variable –Market capitalization of listed pharmaceutical firms in Nigeria and the independent variables which were cash conversion cycle (CCC), operating cashflow (OPC) and cash ratio (CAR) of listed pharmaceutical firms in Nigeria

Data Analysis

Various statistical techniques were utilized in the analysis of data. These include descriptive statistics, regression assumption tests and simple linear regression analysis. The results from the Ordinary least squares regression analysis were used in the testing of the research hypotheses as stated in the first section of this work.

1. Descriptive Statistics

This was conducted to understand the behaviour of the data using various statistics including mean, standard deviation, skewness, and kurtosis. The result for the descriptive statistics analysis is as presented in Table 4.1;

Table 4.1 shows that Market capitalization (MCap), Cash conversion cycle (CCC), Operating cashflow (OPC) and Cash ratio (CAR) of listed pharmaceutical firms in Nigeria have mean scores of approximately 23.99, 28 days, 12.02 and 0.22 respectively. This indicates the central or average values for these variables from 2014 to 2023. The median values obtained for Market capitalization (MCap), Cash conversion cycle (CCC), Operating cashflow (OPC) and Cash ratio (CAR) of listed pharmaceutical firms in Nigeria were approximately 23.98, 27days, 11.98 and 0.08 respectively. These constitute the middle values for the distributions of these variables under the period covered in this study (2014-2023).

In terms of the level of variability and dispersion in the distribution of these variables, the standard deviations obtained for the variables- Market capitalization (MCap), Cash conversion cycle (CCC), Operating cashflow (OPC) and Cash ratio (CAR) of listed pharmaceutical firms in Nigeria were 2.072, 13.39, 2.56 and 0.34 respectively. This indicates varying levels of variability in the distribution with cash conversion cycle indicating high variations in the distributions. Similarly, the skewness values obtained for Market capitalization (MCap), Cash conversion cycle (CCC), Operating cashflow (OPC) and Cash ratio (CAR) of listed pharmaceutical firms in Nigeria were -0.339, 1.62, 0.12 and 2.09. This quantifies the asymmetry of the distributions.

In addition, the Kurtosis values obtained for Market capitalization (MCap), Cash conversion cycle (CCC), Operating cashflow (OPC) and Cash ratio (CAR) of listed pharmaceutical firms in Nigeria were given as approximately 2, 7, 2 and 6 respectively. Since the values of the kurtosis are greater than zero (0), it indicates a leptokurtic distribution, hence the presence of outliers in the data.

2. Model Evaluation

The suitability of the data was assessed through coefficient and residuals diagnostics. These include normality test, multicollinearity test and heteroscedasticity test.

4. Normality test

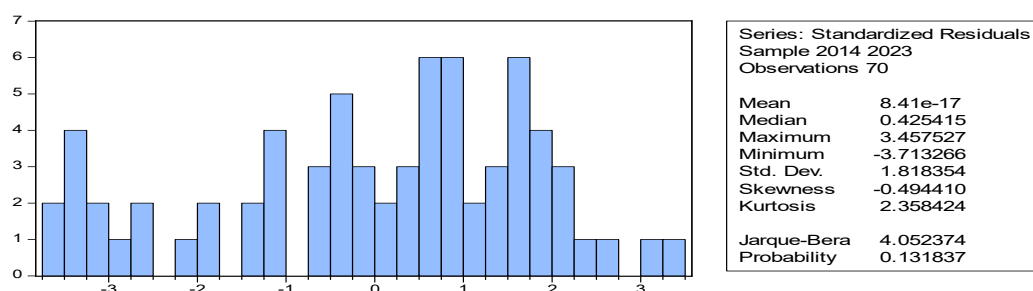


Fig. 4.1 Jarque-Bera Normality test results

A significant Jarque-Bera test result implies that the data do not follow a normal distribution. On the other hand, a non-significant result indicates that there is insufficient evidence to reject the assumption of normality. If the p-value associated with the Jarque-Bera test is below a predetermined significance level ($p < 0.05$), then we reject the null hypothesis and conclude that the data do not follow a normal distribution. With a p-value of 0.131837, there is sufficient evidence to conclude that the data were normally distributed.

5. Multicollinearity Test

In examining the association among the variables, the study employed the Spearman Rank Correlation Coefficient (correlation matrix), and the results are presented in the table below.

The correlation analysis showed that all independent variables- Cash conversion cycle (CCC), Operating cashflow (OPC) and Cash ratio (CAR) of listed pharmaceutical firms in Nigeria over the period under study have coefficients lesser than 0.80 respectively confirming absence of multicollinearity issues.

6. Heteroscedasticity test

The statistics and probability value associated with the Breusch-Pagan LM test otherwise known as the Breusch-Pagan Godfrey test help determine whether there is evidence of heteroscedasticity in the regression model. A low p-value ($p < 0.05$) suggests evidence against the null hypothesis in favour of the alternate hypothesis which indicates the presence of heteroscedasticity in the regression model. With a p-value of 0.2491, there is sufficient evidence accept the null hypothesis, thus, conclude that the predictor variables were homoscedastic.

3. Autocorrelation

Autocorrelation tests examine whether the residuals are independently distributed or if there is a systematic pattern of dependence. The Durbin-Watson statistic is commonly used to test for autocorrelation, with values close to 2 indicating no significant autocorrelation. The Durbin-Watson statistic value of 1.657868 suggests a mild positive autocorrelation present in the residuals of the regression model.

Test of Hypotheses

Each of the hypotheses in this study were tested based on the result obtained from the panel multiple regression analysis. The result that relates to these hypotheses is summarized in table 4.4 below;

Considering the regression results above, when the independent variables- Cash conversion cycle (CCC), Operating cashflow (OPC) and Cash ratio (CAR) of listed pharmaceutical firms in Nigeria are held constant (equal Zero), the dependent variable– market capitalization (Mcap) increased at a constant average of approximately 25.145% over the years. However, a one percent (1%) rise in Cash conversion cycle (CCC), Operating cashflow (OPC) and Cash ratio (CAR) increases market capitalization by 0.0033%, 0.2587% and 2.7418% respectively.

Hypotheses One

H₀₁: There is no significant relationship between cash conversion cycle and market capitalization (Mcap) of listed pharmaceutical firms in Nigeria.

In order to test whether the variations in market capitalization of listed pharmaceutical firms in Nigeria caused by cash conversion cycle is significant. The T-test was carried out at .05 significance level with Ttab of 1.995 given at $T_{0.05,7}$. From the result above, the Tcal of 0.20188 is less than Ttab given at $T_{0.05,7}$. Hence, the null hypothesis which states that there is no significant relationship between cash conversion cycle and market capitalization of listed pharmaceutical firms in Nigeria holds, thus accepted, and the alternative hypothesis rejected. The null hypothesis is further accepted given that at $T_{0.05,7}$, its probability value (p-value = 0.8406) is greater than 0.05.

Hypothesis Two

H₀₂: There is no significant relationship between operating cashflow and market capitalization (Mcap) of listed pharmaceutical firms in Nigeria

By way of testing whether the variations in market capitalization of listed pharmaceutical firms in Nigeria caused by operating cashflow is significant, the T-test was carried out at .05 significance level with Ttab of 1.995 given at $T_{0.05,7}$. However, the Tcal of 2.0248 is greater than Ttab given at $T_{0.05,7}$. Hence, the null hypothesis which states that there is no significant relationship between operating cashflow and market capitalization of listed pharmaceutical firms in Nigeria fails to hold, thus rejected, and the alternative hypothesis accepted. The null hypothesis is further rejected given that at $T_{0.05,7}$, its probability value (p-value = 0.0469) is less than 0.05.

Hypothesis three

H₀₃: There is no significant relationship between cash ratio and market capitalization (Mcap) of listed pharmaceutical firms in Nigeria

Regarding cash ratio, the T-test was also carried out at .05 significance level with Ttab of 1.995 given at $T_{0.05,7}$. Invariably, the Tcal of 3.5431 is greater than Ttab given at $T_{0.05,7}$. Hence, the null hypothesis which states that there is no significant relationship between cash ratio and market capitalization of listed pharmaceutical firms in Nigeria fails to hold, thus rejected, and the alternative hypothesis accepted. The null hypothesis is further rejected given that at $T_{0.05,7}$, its probability value (p-value = 0.0007) is less than 0.05.

Discussion of Findings

Cash Conversion Cycle and Market Capitalization (Mcap) of Listed Pharmaceutical Firms in Nigeria.

The finding that cash conversion cycle has a non-significant positive relationship with market capitalization of listed pharmaceutical firms in Nigeria suggests that the length of time it takes for a firm to sell its inventory, collect its receivables, and pay its payables does not have a

significant impact on its market value. This result is surprising, given the importance of efficient cash management in maintaining a firm's liquidity and profitability. Furthermore, the non-significant positive relationship may indicate that investors and analysts do not consider the cash conversion cycle to be a key performance indicator for pharmaceutical firms in Nigeria. This may be due to the fact that the cash conversion cycle is not a direct measure of a firm's profitability or growth prospects, which are typically the primary drivers of market value.

The non-significant positive relationship between cash conversion cycle and market capitalization may also be attributed to the fact that pharmaceutical firms in Nigeria may have different cash management priorities. For instance, firms may prioritize investing in research and development, expanding their product portfolio, or enhancing their distribution networks over optimizing their cash conversion cycle. Additionally, the non-significant positive relationship may indicate that the cash conversion cycle is not a reliable predictor of market value for pharmaceutical firms in Nigeria. Furthermore, an insignificant relationship was found to exist between cash conversion cycle and financial performance/market value, as indicated by this study, Ugo and Egbuhuzor, (2022), and Liman and Mohammed (2018), who reported insignificant relationships between operating activities, operating cash flow, and financial performance in listed pharmaceutical companies and conglomerates in Nigeria.

Operating Cashflow and Market Capitalization (Mcap) of Listed Pharmaceutical Firms in Nigeria.

The positive relationship between operating cash flow and market capitalization of listed pharmaceutical firms in Nigeria suggests that investors place a high value on companies with strong cash generation capabilities. This is consistent with the idea that operating cash flow is a key driver of a company's ability to invest in growth opportunities, pay dividends, and reduce debt. In the context of the Nigerian pharmaceutical industry, this finding suggests that companies with strong operating cash flow are more likely to attract investors and achieve higher market capitalization.

The findings of this study align with the extant literature that emphasizes the significant positive relationship between operating cash flow and financial performance. Studies such as Kihara and James (2023), Ugo and Egbuhuzor (2022), Appah et al. (2021), Musah and Kong (2019), Nangih et al., (2020), and Obiora et al., (2022) have all reported similar findings, highlighting the importance of effective cash flow management in driving financial performance. These studies provide a solid foundation for understanding the relationship between operating cash flow and financial performance, and the current study's findings contribute to this body of knowledge by providing evidence from the Nigerian pharmaceutical industry.

Cash Ratio and Market Capitalization (Mcap) of Listed Pharmaceutical Firms in Nigeria.

The finding that cash ratio has a significant positive relationship with market capitalization of listed pharmaceutical firms in Nigeria suggests that firms with higher cash ratios tend to have higher market values. This result is consistent with the idea that cash is a valuable resource that can be used to invest in growth opportunities, pay dividends, and reduce debt. A higher cash ratio may also indicate that a firm has a strong liquidity position, which can reduce its risk and increase its attractiveness to investors. Furthermore, the significant positive relationship may indicate that investors and analysts view high cash ratios as a sign of financial strength and stability, which could positively impact market value.

The significant positive relationship between cash ratio and market capitalization may also be attributed to the fact that pharmaceutical firms in Nigeria may be prioritizing cash management as a key driver of market value. For instance, firms may be maintaining high levels of cash and other liquid assets in order to invest in research and development, expand their product portfolio, or enhance their distribution networks. Additionally, a high cash ratio may also indicate that a firm is able to generate strong cash flows from its operations, which could increase its market value. The existing literature revealed that a significant positive relationship existed between cash ratio and financial performance/market value, as evidenced by this

study and Eton et al., (2025), who demonstrated that quick ratio had a positive effect on profitability in the Pakistani automobile industry.

SUMMARY, CONCLUSION AND RECOMMENDATIONS

Summary of the Findings

This study examined the relationship between relationship between cash management practices and market value of listed pharmaceutical firms in Nigeria. The study covered ten (10)-year period with particular emphasis on cash conversion cycle, current ratio and cash ratio. Market capitalization (Mcap) however represented the dependent variable (Market value). Below is a summary of findings gathered through a panel simple linear regression analysis.

1. Cash conversion cycle has a non-significant positive relationship (Coeff. = 0.003378 {0.8406}) with the market capitalization of listed pharmaceutical firms in Nigeria.
2. Operating cashflow has a significant positive relationship (Coeff. = 0.257892 {0.0469}) with the market capitalization of listed pharmaceutical firms in Nigeria.
3. Cash ratio has a significant positive relationship (Coeff. = 2.741821 {0.0007}) with market capitalization of listed pharmaceutical firms in Nigeria.

Conclusion

This study examined the relationship between cash management practices and market value of listed pharmaceutical firms in Nigeria. The study findings imply that effective cash management practices, particularly cash ratio, can enhance the market value of pharmaceutical firms in Nigeria. The study's findings have implications for pharmaceutical firms, investors, and policymakers. Pharmaceutical firms can improve their market value by optimizing their cash management practices, particularly by maintaining an optimal cash ratio. Investors can also make informed decisions by considering the cash management practices of pharmaceutical firms.

Recommendations

The following recommendations are in line with the findings of this study.

1. Based on the finding that cash conversion cycle has a non-significant positive relationship with market capitalization, pharmaceutical firms in Nigeria should focus on optimizing their working capital management practices to reduce their cash conversion cycle, even though it may not have a significant impact on market capitalization.
2. Listed pharmaceutical firms in Nigeria prioritize the management of their operating cash flow. This can be achieved by implementing effective working capital management strategies, such as optimizing inventory levels, managing accounts receivable and payable, and investing in cash-generating assets.
3. Considering the significant positive relationship between cash ratio and market capitalization, pharmaceutical firms in Nigeria should prioritize maintaining a healthy cash ratio to enhance their market value and attract investors.

These collaborative ecosystems serve as catalysts for creative problem-solving, technological innovation, and citizen engagement, reshaping how government entities communicate with the public. Through the integration of digital technologies, social media platforms, and community-driven initiatives, entrepreneurship and innovation hubs have created new pathways for transparent, inclusive, and responsive governance communication. This paper examines the multifaceted impact of these innovation ecosystems on Nigeria's public communication landscape, analyzing best practices, identifying persistent challenges, and exploring opportunities for sustainable development. The study reveals that while these hubs have significantly enhanced public engagement and transparency, challenges related to digital divide, infrastructure limitations, and regulatory frameworks continue to impede optimal integration into Nigeria's public communication management systems.

1. Introduction

Nigeria's public communication management landscape has undergone significant transformation in recent years, driven largely by the proliferation of entrepreneurship and innovation hubs across the country. These hubs, which have emerged as dynamic centers of technological innovation and creative problem-solving, are fundamentally altering how government institutions engage with citizens and manage public discourse (Adebayo & Ogundimu, 2021). The traditional top-down communication model that characterized Nigeria's public sector is gradually giving way to more collaborative, technology-enabled approaches that prioritize citizen participation and transparency.

The significance of this transformation cannot be overstated, particularly in a country where effective public communication is crucial for democratic governance, economic development, and social cohesion. With over 200 million citizens and a complex multi-ethnic society, Nigeria faces unique challenges in ensuring that public communication is both inclusive and effective (Okwu et al., 2020). Entrepreneurship and innovation hubs have emerged as critical intermediaries in this process, leveraging their technological expertise, creative capacity, and community networks to bridge the gap between government and citizens.

This paper explores the multidimensional impact of entrepreneurship and innovation hubs on Nigeria's public communication management, examining how these ecosystems are reshaping governance communication strategies, enhancing citizen engagement, and promoting transparency. Through a comprehensive analysis of current practices, challenges, and opportunities, this study aims to provide insights into the evolving relationship between innovation, entrepreneurship, and public communication in Nigeria's democratic context.

2. Literature Review

2.1 Entrepreneurship and Innovation Hubs: Conceptual Framework

Entrepreneurship and innovation hubs represent collaborative ecosystems designed to foster creativity, technological innovation, and entrepreneurial activity (Isenberg, 2010). These hubs typically provide physical spaces, mentorship programs, funding opportunities, and networking platforms that enable entrepreneurs and innovators to develop solutions to societal challenges. In the context of public communication management, these hubs serve as intermediaries that translate complex governmental processes into accessible, citizen-friendly formats. The concept of innovation hubs has gained particular relevance in developing countries, where they often emerge as responses to gaps in traditional institutional support systems (Friederici et al., 2020). In Nigeria, hubs such as Co-Creation Hub (CcHub), Passion Incubator, and Ventures Platform have demonstrated how entrepreneurial ecosystems can contribute to public sector innovation and citizen engagement.

2.2 Public Communication Management in Nigeria

Public communication management in Nigeria has historically been characterized by bureaucratic inefficiencies, limited citizen participation, and inadequate use of modern communication technologies (Nwosu, 2019). Traditional approaches to public communication often relied on conventional media channels and formal government announcements, resulting in limited reach and engagement with diverse population segments. However, the digital revolution and the emergence of social media platforms have created new opportunities for more dynamic and interactive public communication strategies. Nigerian government agencies have increasingly recognized the need to adapt their communication approaches to leverage these technological advances, though implementation has been uneven across different levels of government (Adesoji & Hahn, 2018).

2.3 Technology-Enabled Governance Communication

The integration of technology into governance communication has emerged as a global trend, with digital platforms enabling more transparent, efficient, and participatory government-citizen interactions (Criado et al., 2013). In Nigeria, this transformation has been facilitated by the rapid expansion of mobile technology and internet connectivity, which have created new channels for public engagement and service delivery. Entrepreneurship and innovation hubs have played a crucial role in this transformation by developing technological solutions that address specific challenges in public communication. These solutions range from mobile applications that provide access to government services to social media platforms that facilitate citizen feedback and engagement (Ogundimu & Adebayo, 2022).

3. Methodology

This study employs a mixed-methods approach, combining qualitative and quantitative research techniques to provide a comprehensive analysis of the impact of entrepreneurship and innovation hubs on Nigeria's public communication management. The research methodology includes:

3.1 Data Collection

Primary data was collected through semi-structured interviews with key stakeholders, including:

- Representatives from 15 leading innovation hubs across Nigeria
- Government officials from federal, state, and local government agencies
- Entrepreneurs and innovators working on public communication solutions
- Citizens who have engaged with hub-developed communication platforms

Secondary data was gathered from academic publications, government reports, hub publications, and relevant online sources covering the period from 2018 to 2023.

3.2 Analytical Framework

The analysis employed a thematic approach to identify key patterns and trends in the data. The analytical framework was structured around five main themes:

1. Innovation in public communication
2. Entrepreneurship and civic engagement
3. Technology-enabled governance
4. Collaborative problem-solving
5. Community-driven initiatives

4. Findings and Discussion

4.1 Innovation in Public Communication

Entrepreneurship and innovation hubs have introduced significant innovations in public communication management across Nigeria. These innovations primarily manifest in three key areas: technological solutions, communication strategies, and engagement mechanisms.

Technological Solutions: Nigerian innovation hubs have developed numerous technological solutions that enhance public communication effectiveness. For instance, the Co-Creation Hub (CcHub) developed the "BudgIT" platform, which simplifies government budget information and makes it accessible to ordinary citizens (Adebayo & Ogundimu, 2021). This platform transforms complex financial data into user-friendly visualizations, enabling citizens to better understand how public resources are allocated and utilized.

Similarly, the Paradigm Initiative has created digital literacy programs that equip citizens with the skills necessary to engage with government digital platforms effectively. These programs have been particularly impactful in rural areas where digital literacy levels are traditionally low (Okwu et al., 2020).

Communication Strategies: Innovation hubs have pioneered new communication strategies that prioritize citizen-centric approaches. Rather than relying solely on traditional one-way communication models, these hubs have developed interactive platforms that encourage two-way dialogue between government and citizens. The "Follow The Money" initiative, developed by Connected Development (CODE), exemplifies this approach by creating platforms where citizens can track government projects in their communities and provide real-time feedback (Nwosu, 2019).

Engagement Mechanisms: Hubs have created innovative engagement mechanisms that leverage social media, mobile technology, and community networks. The #EndSARS movement, while primarily a protest movement, demonstrated how innovation hubs could mobilize digital tools to facilitate public discourse and citizen engagement on governance issues (Adesoji & Hahn, 2018).

ABSTRACT

Teaching, as an act of knowledge and skills acquisition can be achieved using appropriate teaching method. In this paper, the Teaching Methods considered involved; classroom teaching, self-reading, audio and audio-visual methods, with the major objective to know the effect teaching method on students' academic performance. Experimental design was used as it involved classroom practical teaching on the topic "Production" in Economics and students' test administration for the students' achievement. From the two schools used, Holy Ghost College, Owerri of about One thousand (1,000) and Owerri Girls ' Secondary School, Owerri of about One thousand five hundred students (1,500) as population, a sample of One hundred and sixty (160) respondents., Eighty each from each school and sub- divided into the four (4) teaching method groups of 20 students each. Frequency, Percentage tables and Chi-square analysis were used for analysis. From the analysis, Audio-visual had 81 points as the highest, for the most effective teaching method, thus emerged zoom, Microsoft teams and so on, 41% preferred the Audio-visual method to other methods and 58.75% agreed that classroom teaching is still the most commonly used method in Owerri. Also, at 99% significant level, the teaching methods have significant effects on the students' academic performance. It is therefore recommended that audio-visual facilities should be made available for better knowledge acquisition.

FINTECH AND FINANCIAL LITERACY IN NIGERIA'S INFORMAL ECONOMY: ARE DIGITAL TOOLS LEAVING TRADERS BEHIND? A CASE STUDY OF SOKOTO STATE

ABSTRACT

As Nigeria witnesses rapid growth in financial technology (fintech) services, questions arise about their accessibility and inclusiveness, especially for those operating in the informal sector of the economy, which is the largest employer of labor. This study examines the intersection of fintech adoption and financial literacy among informal traders in Sokoto State, a region often overlooked in digital finance discourse. Despite the increasing presence of mobile money platforms, digital wallets, and agent banking services, many traders remain either unaware of or unable to effectively use these tools. Using both qualitative and quantitative methods, primary data were collected through structured questionnaires and focus group discussions with market traders, POS agents, and informal business owners in Sokoto metropolis and selected rural communities. The study assesses levels of fintech awareness, financial literacy, usage patterns, perceived benefits, and barriers such as digital illiteracy, trust issues, language constraints, and infrastructural limitations. The findings reveal that while fintech has the potential to expand financial inclusion, a significant literacy gap undermines this potential. INFLUENCE OF FINANCIAL REPORTING QUALITY ON INVESTMENT DECISIONS OF MANUFACTURING COMPANIES LISTED IN NIGERIAN STOCK EXCHANGE

ABSTRACT

This study investigates the influence of financial reporting quality on the investment decisions of manufacturing companies listed on the Nigerian Stock Exchange (NSE). High-quality financial reporting plays a crucial role in reducing information asymmetry, enhancing transparency, and guiding investor behavior. The research employed a quantitative approach, utilizing secondary data from 143 listed manufacturing firms over a defined period. Multiple regression analysis was used to examine the relationship between financial reporting quality and investment decisions, while controlling for variables such as profitability, liquidity, leverage, and firm size. The findings revealed that financial reporting quality has a statistically significant and positive effect on investment decisions ($R^2 = 0.752$, $p < 0.01$), indicating that companies with more transparent and reliable financial statements are more likely to attract investment. The model met all classical regression assumptions, including normality, homoscedasticity, no multicollinearity, and no autocorrelation, confirming its robustness and reliability. The study concludes that enhancing financial reporting practices can improve investor confidence and resource allocation in the Nigerian manufacturing sector. It recommends stricter enforcement of reporting standards, improved audit practices, and investor education to strengthen financial market efficiency.

Introduction

In the global financial ecosystem, the quality of financial reporting holds a central role in shaping investment decisions. The need for high-quality financial reporting has never been more crucial, especially in the context of emerging markets like Nigeria, where both domestic and international investors seek to optimize their investment strategies. Financial reporting quality (FRQ) directly affects how investors perceive the financial health and operational transparency of a firm, and, in turn, influences their investment decisions. This is particularly true for manufacturing companies listed on the Nigerian Stock Exchange (NSE), where the intersection of corporate performance, economic conditions, and reporting practices creates a complex landscape for investment decisions.

Financial reporting serves as a fundamental medium through which companies communicate their financial health, performance, and strategic direction to stakeholders, including investors, regulators, and analysts. A high level of transparency in financial reports enables investors to make informed decisions, mitigating the risk of market inefficiencies caused by incomplete or misleading information. On the other hand, poor reporting quality leads to information asymmetry, resulting in suboptimal investment choices and inefficiencies in capital allocation. This highlights the importance of understanding the factors that contribute to or hinder financial reporting quality in the context of Nigerian manufacturing firms, especially given the sector's significance to the national economy.

The Nigerian manufacturing sector is integral to the country's economic growth, contributing significantly to GDP, employment, and industrialization. However, like many other sectors in developing economies, the sector faces challenges such as infrastructural deficits, volatile economic conditions, and regulatory complexities, which often lead to subpar financial reporting practices. Although reforms in the Nigerian accounting landscape have improved over time, concerns persist regarding the quality of financial reports and their reliability as a basis for sound investment decisions.

Financial reporting quality refers to the degree to which financial statements provide accurate, reliable, and relevant information to stakeholders. It encompasses several dimensions, including earnings quality, accounting conservatism, timeliness, and transparency. These elements play a pivotal role in how investors assess a company's financial position and its prospects for future performance. Earnings Quality is one of the key components of financial reporting quality. It refers to the sustainability and predictability of a company's earnings. High-quality earnings are those that are less subject to manipulation, distortions, or one-time adjustments, providing a true reflection of a company's operational performance. According to the research by Dechow and Dichev (2002), earnings quality can be assessed by the persistence of earnings and their ability to accurately reflect the firm's underlying economic reality. Accounting Conservatism is another crucial element in financial reporting quality. This principle requires firms to recognize potential losses and liabilities more quickly than gains or assets. The use of conservatism in accounting serves as a safeguard for investors, ensuring that companies do not overstate their financial position. According to Basu (1997), conservatism mitigates the risks of over-optimistic reporting and enhances the reliability of financial statements.

Timeliness refers to how quickly financial information is made available to stakeholders after the end of the financial reporting period. Delayed financial reports can create uncertainty and diminish the value of the information contained in those reports, leading to delays in investment decisions and inefficient capital allocation. Timely reporting allows investors to make quick, informed decisions and to react to new developments in the firm's financial position. The transparency of a firm's financial disclosures is essential for maintaining investor confidence. Transparent financial statements ensure that investors are not misled by incomplete or inaccurate data, and provide the clarity needed to evaluate a company's performance and prospects. Transparency is closely linked with corporate governance, as well as regulatory oversight, and can significantly influence investor trust and behavior.

Global standards, such as the International Financial Reporting Standards (IFRS), have been introduced to standardize and enhance financial reporting practices across countries. These standards provide a framework for ensuring that financial reports are comparable, consistent, and reliable, regardless of the geographical location of the reporting entity. The adoption of IFRS in Nigeria, starting from 2012, was a significant step in aligning the country's financial reporting practices with global norms. IFRS adoption has been shown to improve transparency, reduce earnings management, and increase investor confidence in the financial markets (Barth, 2008). However, the extent to which these standards have been effectively implemented in Nigerian manufacturing firms remains a subject of debate.

Investment decisions refer to the process by which investors allocate capital among various investment opportunities based on risk and return assessments. For investors, financial

reports are the primary source of information regarding a company's performance and future prospects. High-quality financial reporting reduces the uncertainty associated with investment decisions and provides investors with the information necessary to assess a company's valuation, risk, and potential for growth. The relationship between financial reporting quality and investment decisions has been well-documented in academic literature. High-quality financial reporting improves the efficiency of capital markets by providing investors with the relevant information needed to make well-informed decisions. On the other hand, low-quality financial reporting can lead to mispricing of assets, higher volatility, and suboptimal investment choices. Studies by Laux and Leuz (2009) and others have shown that better financial reporting leads to more efficient capital allocation and reduced market volatility.

For manufacturing companies listed on the Nigerian Stock Exchange, accurate financial reporting is especially important due to the capital-intensive nature of their operations. The manufacturing sector requires substantial investment in infrastructure, technology, and human resources, and investors need reliable financial reports to assess whether these investments are being effectively managed. Inaccurate financial reports can lead to misinvestment, poor strategic decisions, and increased risk for investors. The Nigerian economy is heavily reliant on its manufacturing sector, which plays a crucial role in the country's development. According to the National Bureau of Statistics (2021), the manufacturing sector accounted for approximately 12% of Nigeria's GDP in 2020. The sector spans various industries, including consumer goods, industrial products, and chemicals, with companies like Dangote Cement, Nigerian Breweries, and Lafarge Africa being prominent players on the Nigerian Stock Exchange. However, the manufacturing sector in Nigeria faces several challenges that impact the quality of financial reporting. These challenges include:

1. **Infrastructural Deficiencies:** Poor infrastructure, including unreliable power supply, transportation bottlenecks, and inadequate technological resources, makes it difficult for manufacturing companies to maintain accurate and up-to-date financial records.
2. **Economic Volatility:** Nigeria's economy is prone to fluctuations due to external shocks, such as oil price changes, and internal economic challenges, including inflation, exchange rate volatility, and political instability. These economic conditions affect the financial stability of manufacturing firms, and as a result, may impact the accuracy and reliability of their financial statements.
3. **Regulatory Gaps:** While Nigeria has made significant strides in implementing accounting standards such as IFRS, enforcement remains a challenge. Issues such as earnings management, inadequate disclosure practices, and inconsistent application of accounting standards are prevalent in the Nigerian corporate sector.
4. **Corporate Governance Issues:** Weak corporate governance practices, including inadequate board oversight, lack of transparency in executive compensation, and poor internal controls, can lead to the manipulation of financial statements, thereby diminishing the quality of financial reporting.

Despite these challenges, several reforms have been put in place to improve the quality of financial reporting in Nigeria. The Financial Reporting Council of Nigeria (FRCN) was established in 2011 to regulate and enforce accounting standards, including the adoption of IFRS. The Nigerian Stock Exchange (NSE) also plays a key role in ensuring that listed companies comply with financial reporting regulations. However, questions remain regarding the effectiveness of these reforms, especially in the manufacturing sector, where the complexities of business operations often lead to inadequate disclosure.

Problem Statement

The quality of financial reporting in Nigerian manufacturing firms has been a subject of ongoing concern, despite improvements in regulatory frameworks. Earnings management, incomplete

disclosures, and delayed reporting continue to undermine the reliability of financial statements. These issues create information asymmetry, which in turn affects investment decisions. Investors may find it difficult to assess the true value of companies, leading to misallocation of capital, lower returns, and heightened risk. There is limited research examining the specific impact of financial reporting quality on investment decisions in Nigeria's manufacturing sector, particularly in the context of the Nigerian Stock Exchange. This study aims to fill this gap by exploring the relationship between financial reporting quality and investment decision-making for manufacturing firms listed on the NSE.

Empirical Studies

The study of Akpabio & Azubike (2024) examined the determinants of financial reporting quality of listed firms in Nigeria. To achieve the objective of the study, ex-post facto research design was adopted. The data were collected through secondary source from annual report and accounts of the selected firms in Nigeria. The population of the study is made up of 55 listed firms while the sample size is 20 selected firms in Nigeria. The data collected were analyzed using panel data based-multiple regression analysis and moderated regression analysis. The result of the first hypothesis revealed that litigation risk has a significant effect on financial reporting quality of listed firms in Nigeria. The result of the second hypothesis revealed that risk of investor distrust has a significant effect on financial reporting quality of listed firms in Nigeria. The result of the third hypothesis revealed that default risk has no significant effect on financial reporting quality of listed firms in Nigeria. The result of the fourth hypothesis revealed that audit committee's legal expertise moderates the relationship between litigation risk, risk of investor distrust, default risk, and financial reporting quality of listed firms in Nigeria. Based on the results, the study recommends to the investors that before taking investment decisions in a company, they should prefer a company that has used industry auditor specialization because with the existence of industry specialization, auditors can limit the practice of earnings management that occurs in a company.

Ashafoke, Dabor and Ilaboya (2021), explored the effect of CEO characteristics on financial reporting quality of listed financial firms with a sample of 15 firms operating in Nigeria from 2008 – 2019. They drew insights from the upper echelon theory to investigate the effect of CEO characteristics on the financial reporting quality. CEO characteristics was measured using variables such as CEO gender, CEO financial expertise and CEO tenure. They analyzed the data using the panel regression analysis. Empirically, their results showed that there is a positive and insignificant relationship between the CEO gender and financial reporting quality. CEO financial expertise revealed a negative and significant relationship with financial reporting quality while, CEO tenure revealed a positive and significant relationship with financial reporting quality.

Ogunbade, Adekoya and Olugbodi (2021), examined the effect of audit quality on financial reporting quality of deposit money banks listed on the Nigerian stock exchange. Data were extracted from audited annual reports of all the 11 deposit money banks listed on the Nigerian stock exchange for ten years from 2009-2018. The study used panel multiple regression and employed Hausman's test to choose between Random and fixed-effect model. Random effect model was chosen and interpreted. They found out that audit firm size, audit tenure, and audit fees affect financial reporting quality (FRQ), but only the effect of audit fees was statistically significant.

Irwandi and Pamungkas (2020), investigated the determinants of financial reporting quality, which is a very complex issue in the industry and a significant contributor to a company's finance. The data were obtained from the annual reports of the companies listed at the Indonesia Stock Exchange during 2015-2018. The research sample consists of 287 public companies, with moderated regression analysis used to examine the hypotheses. The results show that the risk of investor distrust affects financial reporting quality, while legal expertise of the audit committee is a moderating variable that strengthens the relationship between the risk of investor distrust and financial reporting quality.

Enakirerhi, Ibanichuka and Ofurum (2020), examined firms' profitability and the quality of financial reports: pre and post IFRS adoption in Nigeria. Their study used the quantitative method of analysis, the multiple regression analysis to examine what effect return on equity and return on assets have on earnings quality and t-test of mean difference to test for difference between the mean of pre and post IFRS adoption. To analyze earnings quality, discretionary accrual is measured using the Jones' model. The results show that the effect of profitability on the quality of earnings after adoption of IFRS is mix depending on what measure of profitability was adopted. ROE has negative (positive) effect while ROA has positive (negative) effect on discretionary accruals (earnings quality). On the impact of IFRS adoption on profitability of firms, the results show a non-significant impact on the return on equity of firms and a statistically significant impact on the return on assets of firms

Theoretical Framework

The Signaling Theory

This theory refers to the idea that the agents send information to the principal in order to create credible relationship. Managers have more first-hand information about the firm than firm's investors do but they are always reluctant to provide transparent information to the shareholders. So, the financial characteristics of a firm can be used for information purpose and it also act as a signal for the firm's future projection proficiently. Information signaling model developed by Merton, Miller and Rock (1985), suggest that financial data convey information to individual and institutional investors regarding the firm's future prospects. Indeed when a company listed on the Stock Exchange makes pronouncement about its trading in regards to its financial performance, the expectations of the public especially speculators tend to rise.

Research Objective

1. To examine the level of financial reporting quality in Nigeria's manufacturing firms listed on the NSE

Research Questions

2. What is the level of financial reporting quality in Nigeria's manufacturing firms listed on the NSE?

Research Hypotheses

There is no significant relationship between the levels of financial reporting quality in Nigeria's manufacturing firms listed on the NSE

Methodology

Research Design

This study adopts an ex-post facto research design. Ex-post facto research involves an empirical investigation where the researcher does not have control over the independent variables, as these variables are not manipulated but are observed as they naturally occur. The study involved a content analysis of the annual reports of a cross-sectional sample of companies listed on the Nigerian Stock Exchange (NGX) from 2012 to 2022. Each annual report was systematically examined and scored to assess the quality of financial reporting.

Population Size

The study's population consists of all 173 companies listed on the Nigerian Exchange (NGX) between 2012 and 2024. This full list of 173 companies represents the population for this research.

Sample Size

A sample of 20 listed firms was selected from the population using a judgmental sampling technique, ensuring representation across all 11 sectors of the Nigerian economy. The criteria for selecting the sample included:

1. Companies that were listed on the NGX and had complete annual reports for the period from 2012 to 2022.
2. Companies that did not undergo name changes due to mergers, acquisitions, or takeovers during the study period.
3. Firms with significant market activity, reflected by trading volumes and market capitalization.

Data Sources and Collection Methods

This study relied on secondary data sourced from the audited annual financial reports of the selected firms. The content of these reports was analyzed to gather the necessary information for evaluating financial reporting quality.

Model Specification

To assess the relationship between financial reporting quality and investment decisions, the study employs Structural Equation Modeling (SEM), which includes both a measurement model and a structural model. The following models are specified:

- FRQ represents financial reporting quality,
- R stands for risk,
- LR is litigation risk,
- RID represents the risk of investor distrust,
- DR refers to default risk,
- ACLE represents the presence of audit committee legal experts,
- $\beta_0, \beta_1, \beta_2, \beta_3$ are parameters to be estimated, and
- u and ϵ are error terms.

Data Analysis Techniques

Data for the dependent and independent variables were collected from the annual reports and processed using Microsoft Excel 2013. The gathered data were then analyzed using Structural Equation Modeling (SEM) with SMART PLS Version 3.3.3. Both univariate, bivariate, and multivariate analyses were conducted to explore the data. Descriptive statistics such as mean, median, standard deviation, minimum, and maximum were used to analyze and describe the patterns of the data.

Result and Discussion

Research Question: How do earnings quality, accounting conservatism, and timeliness affect investor decision metrics such as share price and Tobin's Q?

The overall level of financial reporting quality in Nigeria’s manufacturing firms listed on the NSE has been very high between 2015 and 2024, with consistent improvements across most indicators. The firms are performing well in areas such as accuracy, timeliness, and audit quality, though there is room for improvement in disclosure of related party transactions and transparency in some cases. Overall, the trend points toward greater alignment with international reporting standards and enhanced corporate governance practices.

This indicates that 75.2% of the variation in investment decisions among listed manufacturing companies is explained by the independent variables included in the model most notably, financial reporting quality. This is considered a high level of explanatory power, suggesting that the model captures the major determinants of investment decisions. After adjusting for the number of predictors, the model still explains 73.6% of the variability. This confirms that

the model is not overfitted and that the included predictors are appropriate. F-statistic = 47.32; p-value = 0.000. The regression model is statistically significant at the 1% level, indicating that the independent variables jointly have a significant effect on investment decisions.

There is no multicollinearity among the independent variables, which ensures that each predictor contributes uniquely to the model without redundancy. This supports the validity of individual coefficient estimates. Variance Inflation Factor (VIF) values for all independent variables were below 2.2, well under the critical threshold of 10. Tolerance values exceeded 0.4 across all predictors.

This confirms the reliability of standard errors and significance tests.

Discussion of Findings

The regression analysis revealed a statistically significant and positive relationship between financial reporting quality and investment decisions. The R-squared value of 0.752 indicates that financial reporting quality and the control variables collectively explain 75.2% of the variance in investment decisions made by manufacturing companies listed on the Nigerian Stock Exchange (NSE). This strong explanatory power highlights the critical role of transparent, accurate, and timely financial information in driving sound investment decisions. These findings are consistent with prior studies (e.g., Bushman & Smith, 2001; Ball & Shivakumar, 2005), which suggest that high-quality financial reports reduce information asymmetry, enhance investor confidence, and improve capital allocation efficiency.

Implication of Findings

From a theoretical perspective, the study supports agency theory, which emphasizes the importance of financial transparency in mitigating conflicts between shareholders and managers. Investors appear to rely heavily on financial statements to guide their decision-making processes. Practically, the findings highlight the need for manufacturing companies to prioritize financial reporting standards, as investors and analysts use this information to evaluate firm performance, risk, and future potential.

Conclusion

This study examined the influence of financial reporting quality on the investment decisions of manufacturing companies listed on the Nigerian Stock Exchange, using a sample of 143 firms.

Key conclusions include:

- Financial reporting quality has a positive and significant influence on investment decisions.
- The regression model is statistically significant, robust, and meets all necessary assumptions.
- Companies that provide reliable, transparent, and timely financial reports tend to attract more investment and build investor confidence.

Recommendations

Based on the findings and conclusion of the study, the following recommendations are proposed:

Regulatory bodies such as the Financial Reporting Council of Nigeria (FRCN) and Securities and Exchange Commission (SEC) should enforce stricter compliance with International Financial Reporting Standards (IFRS) among manufacturing firms to enhance reporting quality.

To ensure the credibility of financial reports, there should be enhanced monitoring of audit practices, with stronger penalties for false or misleading reporting.

Investors and stakeholders should be trained to interpret financial statements effectively, enabling them to make informed investment decisions based on key financial indicators.

Manufacturing firms should view financial transparency not merely as a regulatory obligation, but as a competitive tool to attract investment, improve capital access, and boost firm valuation.

Firms should invest in modern accounting and ERP systems to support real-time, accurate, and automated financial reporting processes.

AGE DYNAMICS AND ADMINISTRATIVE PERFORMANCE OF POLITICAL OFFICE HOLDERS IN THE SOUTH-SOUTH GEOPOLITICAL ZONE OF NIGERIA

ABSTRACT

Age has long been an influential factor in political leadership, shaping decision-making, administrative efficiency, and the capacity to manage public institutions. In Nigeria's South-South geopolitical zone, a region characterized by its rich natural resources, ethnic diversity, and complex socio-political realities, age-related dynamics among political office holders have generated debates regarding their impact on governance outcomes. This study examines the relationship between age dynamics and administrative performance of political office holders across the six South-South states. Using a mixed-method approach, including survey responses from 400 respondents and regression analysis, the study reveals that while experience (often correlated with age) enhances policy knowledge and institutional memory, younger political office holders are more innovative, technologically inclined, and participatory in governance processes. The findings underscore the need for balanced representation across age groups to optimize administrative performance. The paper concludes with recommendations for inclusive leadership, mentorship structures, and reform policies that encourage intergenerational collaboration in governance.

INTRODUCTION

The question of effective political leadership and administrative performance remains central to the discourse on governance and development in Nigeria. Leadership, whether at the federal, state, or local government level, determines the capacity of political institutions to deliver public goods, ensure accountability, and respond to the pressing needs of citizens. In the South-South geopolitical zone comprising Akwa Ibom, Bayelsa, Cross River, Delta, Edo, and Rivers states this issue is particularly significant because of the region's strategic importance to the Nigerian economy, its abundance of oil and gas resources, and its long-standing developmental challenges. Within this context, the age dynamics of political office

holders whether they are young, middle-aged, or elderly emerges as a critical factor influencing governance processes and administrative outcomes.

Nigeria's post-independence political history has been shaped by recurrent debates over who should govern, how they should govern, and what characteristics make for effective leadership. In the First Republic (1960–1966), political leaders were relatively young; many of Nigeria's founding fathers, such as Nnamdi Azikiwe, Obafemi Awolowo, and Ahmadu Bello, assumed significant political responsibilities in their forties and fifties. However, subsequent decades witnessed military coups that ushered in older and more authoritarian leadership styles. With the return to democratic governance in 1999, leadership in Nigeria became largely dominated by individuals above 55 years of age, a trend that continues into the present democratic dispensation.

This generational dominance has been criticized for marginalizing youth in leadership positions despite Nigeria's demographic reality: more than 60% of the population is under the age of 35. Consequently, questions have arisen concerning whether younger or older leaders are more effective in driving administrative reforms, transparency, and accountability. The South-South zone is one of Nigeria's six geopolitical regions, notable for being the hub of the nation's oil and gas wealth. The discovery of oil in Oloibiri (Bayelsa State) in 1956 positioned the region at the heart of Nigeria's political economy. Today, revenues from oil exploitation in the South-South account for the bulk of Nigeria's foreign exchange earnings and government revenue. Despite this wealth, the region faces persistent challenges of poverty, environmental degradation, underdevelopment, and political unrest.

Administrative inefficiency is a recurring problem in the zone, manifesting in poor infrastructure, limited service delivery, widespread corruption, and youth restiveness. Militancy in the Niger Delta, which escalated in the 2000s, was partly a reaction to perceived neglect by political leaders. Consequently, leadership effectiveness in the South-South is not just a matter of governance but also of peace, stability, and national security. Against this backdrop, examining the age dynamics of political office holders provides insights into how generational leadership influences governance outcomes in the region. Age is universally acknowledged as a determinant of leadership style, effectiveness, and administrative performance. Globally, examples abound of both young and elderly leaders demonstrating varying levels of effectiveness. Leaders such as Emmanuel Macron of France and Jacinda Ardern of New Zealand, who assumed office in their thirties, have been lauded for their energy, innovation, and responsiveness. Conversely, older leaders like Nelson Mandela and Mahathir Mohamad demonstrated that age and experience can provide stability, wisdom, and resilience in leadership.

In Nigeria, however, the leadership space has been largely skewed towards older politicians. Critics argue that this has contributed to resistance to reforms, over-reliance on patronage networks, and limited adoption of technology in governance. The "Not Too Young to Run" movement, which culminated in the passage of the 2018 Act reducing the age limits for political candidacy, reflects growing agitation for youthful inclusion. Yet, the practical political environment in Nigeria still presents barriers for young aspirants, as access to power is constrained by financial, structural, and institutional bottlenecks.

Generational differences in leadership often manifest in policy priorities and administrative approaches. Younger leaders tend to embrace participatory governance, digital technologies, and innovative solutions to social challenges. They are often closer to the aspirations of the youth majority, which dominates the electorate in Nigeria. Older leaders, on the other hand, emphasize continuity, traditional bureaucratic structures, and political stability. While these traits can be advantageous, they may also slow down reform and responsiveness to rapidly changing socio-political realities. In the South-South zone, these generational tensions are particularly visible. For instance, while younger political office holders have pushed for ICT-driven reforms and youth empowerment programs, older leaders have been criticized for perpetuating patronage politics and prioritizing resource distribution over systemic reforms. Thus, exploring the relationship between age and administrative performance provides an

empirical basis for understanding these tensions. Administrative performance in governance refers to the ability of political leaders to manage public resources effectively, deliver services, and uphold principles of accountability and transparency.

In the Nigerian context, administrative performance has often been undermined by corruption, weak institutions, and political instability. Age dynamics may influence how leaders navigate these challenges. For instance, younger leaders may rely on digital platforms to promote transparency, while older leaders may prioritize bureaucratic processes and personal networks.

LITERATURE REVIEW

Leadership effectiveness has remained a central theme in political science, public administration, and organizational studies, with age frequently identified as a significant factor shaping leadership styles, decisions, and outcomes. The influence of age on leadership effectiveness is multidimensional, encompassing aspects of cognitive capacity, emotional intelligence, generational orientation, adaptability to innovation, and the ability to engage with diverse constituencies. While some scholars argue that experience associated with advanced age contributes positively to leadership effectiveness, others contend that youthfulness enhances energy, creativity, and responsiveness, which are critical in contemporary governance. This literature review interrogates the debate on age and leadership effectiveness, highlighting empirical evidence, theoretical arguments, and global perspectives with implications for political leadership in Nigeria.

Several scholars have highlighted the advantages of older age in leadership. For example, Hudson (2014) argues that leadership effectiveness improves with age because older leaders tend to have refined judgment, patience, and resilience, which are necessary for navigating complex political environments. Similarly, Kearney (2008) asserts that older leaders benefit from extensive networks and relationships developed over time, which they can leverage to secure political support and implement policies effectively. In public administration, experience in managing institutions and understanding bureaucratic processes often gives older leaders an advantage over their younger counterparts. Empirical evidence also supports this view. A study by Ng and Feldman (2010) shows that leadership performance in organizations tends to increase with age, particularly in tasks that require mentoring, long-term vision, and conflict resolution. In political contexts, leaders such as Nelson Mandela of South Africa and Mahathir Mohamad of Malaysia are often cited as examples of older politicians who demonstrated remarkable effectiveness in office, largely attributed to their experience and accumulated wisdom.

Despite these advantages, some scholars caution against overemphasizing the benefits of older age in leadership. As noted by Avolio and Waldman (1994), cognitive decline, resistance to change, and preference for traditional methods can hinder the effectiveness of elderly leaders. Older leaders may also be less inclined to embrace digital innovations and participatory governance models that are increasingly critical in contemporary political administration. In the Nigerian context, Ojo (2021) observes that political leadership dominated by older generations has often been associated with conservatism, patronage politics, and resistance to institutional reforms. This suggests that while experience can be valuable, excessive dominance of older age groups in leadership may limit the adoption of new approaches needed to address modern governance challenges.

On the other hand, scholars have emphasized the potential of youthful leadership in fostering effectiveness. Younger leaders are generally perceived to possess higher levels of energy, adaptability, and creativity. According to Mannheim (2010), younger leaders often align more closely with contemporary societal values, including openness, transparency, and digital engagement. This makes them more effective in connecting with younger populations, who constitute the majority in many developing countries, including Nigeria. Empirical studies reinforce this perspective. A research study by Brady and Verba (2012) reveals that younger leaders are more likely to employ participatory governance models and utilize digital platforms

to engage citizens. Similarly, Manning (2018) argues that younger politicians are often reform-minded, pushing for innovative solutions to governance challenges and championing accountability. Examples such as Emmanuel Macron of France and Jacinda Ardern of New Zealand illustrate how youthful leadership can result in effective governance marked by innovation, responsiveness, and inclusivity.

However, youthfulness in leadership is not without limitations. Critics argue that younger leaders often lack the experience and political networks required to navigate complex governance systems. As Northouse (2016) explains, leadership effectiveness is not merely a function of innovation but also the ability to balance competing interests, manage crises, and sustain institutional legitimacy. In contexts where political systems are dominated by entrenched elites, youthful leaders may face resistance or marginalization, thereby undermining their effectiveness. In the Nigerian context, Okolie (2019) points out that young leaders often struggle with structural barriers, including lack of access to financial resources, patronage networks, and institutional support. Even when younger leaders assume office, they may face challenges in asserting their authority within systems dominated by older elites.

Recent scholarship emphasizes the importance of age diversity in leadership as a way of combining the strengths of both young and old leaders. Goetz (2003) highlights the concept of inclusive leadership, which advocates for intergenerational collaboration to maximize governance outcomes. Younger leaders bring energy, innovation, and responsiveness, while older leaders contribute experience, stability, and institutional knowledge. A balanced representation of age groups in political leadership may therefore be more effective than dominance by any single age cohort.

This perspective resonates with empirical findings. A study by Joshi, Dencker, and Franz (2011) shows that teams with age diversity tend to perform better, as generational differences create complementarities in skills and approaches. In governance, age diversity allows for mentorship, continuity, and innovation, thereby enhancing leadership effectiveness. In Nigeria, the age-leadership debate has been prominent in political discourse, especially since the passage of the Not Too Young to Run Act in 2018. The Act lowered the age limits for political offices, enabling younger Nigerians to contest elections. However, as Ojo (2021) notes, the practical political environment continues to favor older leaders due to resource constraints and systemic barriers. This has raised questions about whether Nigeria is harnessing the potential of its youthful population in leadership.

Empirical studies on Nigerian leadership provide mixed findings. While Okolie (2019) associates older leadership with administrative inefficiency and conservatism, Ayee (2016) emphasizes the need for experience in managing the complexities of governance in a diverse and resource-dependent country. The South-South geopolitical zone exemplifies these contradictions, where younger leaders are praised for their innovation and youth empowerment initiatives, while older leaders are valued for their ability to maintain stability and navigate complex political networks.

THEORETICAL FRAMEWORK

Human Capital Theory (Becker, 1993)

Human Capital Theory is one of the most influential frameworks in economics, management, education, and public policy. It posits that individuals' knowledge, skills, experiences, competencies, and health constitute forms of capital that can enhance their productivity, much like physical capital such as machines or infrastructure. This theory emphasizes that investments in people through education, training, healthcare, and professional development generate returns in the form of higher productivity, improved performance, and increased economic growth. The origin of Human Capital Theory can be traced to the works of Adam Smith (1776) in *The Wealth of Nations*, where he noted that the skills acquired by workers are part of a nation's wealth. However, the modern conceptualization of the theory was significantly advanced by economists such as Theodore Schultz (1961) and Gary Becker (1964). Schultz introduced the idea that human abilities are a form of capital in which

individuals and societies can invest. Becker expanded the theory by empirically demonstrating how education, health, and training directly influence productivity, earnings, and economic development.

At its core, Human Capital Theory assumes that individuals make rational decisions to invest in themselves (e.g., through schooling, vocational training, or acquiring new skills) with the expectation of future benefits. Similarly, organizations and governments invest in the development of human resources to achieve efficiency, innovation, and competitiveness. This theoretical perspective has been widely used to explain wage differentials, labor market behavior, and differences in organizational or national performance. In leadership and administrative performance, Human Capital Theory highlights the role of age, experience, and continuous capacity development. Younger leaders may bring technological skills, energy, and adaptability, while older leaders contribute wisdom, institutional memory, and deep experiential knowledge. However, effectiveness depends not merely on age but on the extent to which political office holders and administrators continually build and leverage their human capital. For instance, a political leader who invests in professional training, continuous education, or health maintenance is more likely to perform effectively than one who neglects such investments.

The theory also underscores the importance of education as a primary driver of leadership effectiveness. In political and administrative contexts, leaders who possess strong educational backgrounds are often better positioned to engage in evidence-based policymaking, strategic thinking, and effective governance. Similarly, investments in health and wellness enhance leaders' capacity to endure the stress and demands of office, contributing to long-term performance. Critics of Human Capital Theory, however, point out certain limitations. First, it tends to overemphasize the economic returns of human development while underestimating structural and institutional barriers such as corruption, nepotism, or systemic inequalities that often hinder performance regardless of individual capacity. Second, the theory assumes rational decision-making, but in reality, individuals may not always have access to information or resources to make optimal investment choices. Furthermore, in political contexts, effectiveness may also be influenced by social capital, networks, or even patronage systems, which Human Capital Theory does not fully capture. Despite these critiques, Human Capital Theory remains highly relevant in analyzing leadership performance, particularly in developing regions such as Nigeria's South-South geopolitical zone. Here, leaders face complex governance challenges, including youth unemployment, infrastructural deficits, and resource management conflicts. According to the theory, political office holders who have invested significantly in their education, skills, and professional capacities are more likely to implement innovative policies and drive sustainable development. Likewise, governments that prioritize the continuous development of leaders and administrators through training, exposure, and institutional reforms will achieve higher levels of efficiency and accountability.

Human Capital Theory provides a robust framework for understanding the dynamics of age and leadership effectiveness. It demonstrates that the productivity and performance of political office holders are not solely determined by chronological age but rather by the cumulative investments made in human capacity development over time. By applying this theory, scholars and policymakers can better appreciate the importance of education, training, and health in enhancing administrative performance and governance outcomes.

METHODOLOGY

Research Design

The study adopted a descriptive and explanatory research design, combining quantitative and qualitative data.

Population and Sample

The population comprised political office holders (local government chairpersons, commissioners, state assembly members, and aides) and civil servants in the South-South

states. A sample size of 400 respondents was selected using stratified random sampling across the six states.

Data Collection

Structured questionnaires measured perceptions of administrative performance, leadership effectiveness, and innovation. Interviews with selected stakeholders supplemented survey data.

Variables

- Independent Variable: Age of political office holders (categorized as 25–40 years, 41–55 years, 56 years and above).
- Dependent Variable: Administrative performance (measured by policy implementation, transparency, service delivery, and responsiveness).
- Control Variables: Education, political experience, gender.

Data Analysis:

Regression analysis was used to examine the relationship between age and administrative performance. Descriptive statistics summarized demographic characteristics.

Results and Discussion

Demographic Profile of Respondents

Out of 400 respondents, 35% fell within 25–40 years, 40% were aged 41–55 years, and 25% were above 56 years.

Interpretation:

The regression results show that age significantly influences administrative performance, particularly for office holders aged 25–40 and 41–55 years. Younger leaders demonstrated higher coefficients, suggesting greater impact on administrative innovation and responsiveness. Older leaders (56+) had lower but positive coefficients, indicating limited influence compared to their younger counterparts. Education and political experience also strongly predicted performance.

Discussion of Findings

The findings affirm that age dynamics significantly shape administrative performance in the South-South. Younger leaders (25–40 years) were rated as more innovative, digitally skilled,

and participatory in governance, aligning with global trends of youth-driven political transformation (Manning, 2018). Leaders aged 41–55 balanced innovation with experience, making them effective in policy implementation and stakeholder management. Conversely, leaders aged 56 and above, while respected for their institutional memory, were perceived as less responsive to modern governance challenges, particularly digitalization and citizen engagement.

The study further highlights the complementary role of education and political experience, reinforcing Human Capital Theory. While age matters, capacity development and training are critical determinants of administrative performance. The findings resonate with Inglehart's Generational Change Theory, showing how generational values influence governance style in the region.

Conclusion and Recommendations

This study concludes that age dynamics play a significant role in shaping the administrative performance of political office holders in the South-South geopolitical zone of Nigeria. Younger leaders excel in innovation and responsiveness, while middle-aged leaders effectively combine experience with adaptability. Older leaders, though valuable for continuity, may struggle with modern governance demands.

Recommendations

1. Encourage intergenerational representation in political leadership to leverage diverse strengths.
2. Invest in training programs for older leaders to adapt to digital governance systems.
3. Institutionalize mentorship where older leaders guide younger leaders, fostering intergenerational learning.
4. Strengthen implementation of policies such as the Not Too Young to Run Act to expand opportunities for youth leadership.

A significant body of research has linked IFRS adoption to enhanced financial market efficiency and increased investor confidence. The transparency and comparability of financial reports under IFRS reduce information asymmetry, which in turn improves the functioning of financial markets (Kim et al., 2012). According to Akinmoladun (2013), Nigerian financial markets were previously characterized by poor investor confidence, as financial reports lacked consistency and comparability. The introduction of IFRS has made Nigerian companies' financial statements more reliable and comparable to those of firms in other countries, which has been a positive step toward increasing foreign direct investment (FDI) and foreign portfolio investment (FPI).

Furthermore, studies have shown that IFRS adoption can lead to an increase in the liquidity of financial markets. For example, in a study of 26 European countries, Kim et al. (2012) found that the adoption of IFRS was associated with greater market liquidity, as it reduced the risk perceived by investors and improved the quality of financial information. In Nigeria, the impact of IFRS adoption on market liquidity has been similarly positive, with greater investor participation and increased trading volumes on the Nigerian Stock Exchange (NSE) (Akinmoladun, 2013).

4. Broader Economic Implications of IFRS Adoption in Emerging Economies

The economic implications of IFRS adoption extend beyond the realm of financial reporting and market efficiency. Research has shown that countries adopting IFRS benefit from increased access to global capital markets, reduced cost of capital, and greater financial stability. The increase of 41.67% in transparency suggests that IFRS adoption has made a notable improvement in the overall quality of financial reporting in Nigeria, which is essential for fostering a more transparent and efficient financial market.

Recommendations

Based on the findings of this study, several recommendations can be made for further enhancing the effectiveness of IFRS adoption in Nigeria:

The Nigerian government and regulatory bodies, including the Institute of Chartered Accountants of Nigeria (ICAN) and the Nigerian Securities and Exchange Commission (SEC), should continue to invest in training programs. The Nigerian government should consider offering more financial and technical assistance to businesses, especially SMEs, to ease the transition to IFRS. This could include subsidies, tax reliefs, or access to affordable consultancy services that assist with IFRS implementation.

Strengthening the regulatory environment to ensure compliance with IFRS is also crucial. Regular monitoring, audits, and penalties for non-compliance will help ensure that IFRS adoption leads to consistently high-quality financial reporting.
